Facts giving rise to instant appeal are as under;-

## FACTS:

That father of appellant i.e Deputy Mehmood served in Forest Department Abbottabad as Class-IV / Chowkidar and got retired on 10.03.2016.

That appellant was appointed on the same post in the office of respondent No.1 vide appointment order 87 dated 15.03.2016 on the quota reserved for retired employees son's quota. Same is also evident from the said order. Copy of appointment order dated 15.03.2016 is annexed as Annexure "A".

That appellant and another employee were terminated without any prior notice, any hearing and without any sort of defence vide order No.92 dated 13.04.2016. The plea taken by the respondent No.1 was involvement in criminal activity and police custody on 13.04.2016. Copy of termination order dated 13.04.2016 is annexed as Annexure "B".

That appellant among the others, was implicated in case FIR No.379 dated 20.03.2016 registered under section 381-A/411 PPC at Police Station Cantt. Copy of FIR and challan are annexed as Annexure "C" and  $\vec{c} - \vec{t}$  "

That appellant approached respondent No.2 in appeal but the same was dismissed only on point of time limitation on dated 26/08/2016. Copy of appeal and order dated 26/08/2016 are annexed as annexure "D" & "E". 4

That respondent No.1 appointed respondent No.3 in collusion with respondent No.2 in unlawful, illegal and unauthorized manner soon after dismissal of appellant vide order 105 dated 02/05/2016. Copy of appointment order of respondent No.3 bearing No.105 dated 02/05/2016 is annexed as Annexure "F".

7. That appellant had to face ordeal and rigors of trial in criminal case and ultimately he has been acquitted of the charges by the learned Judicial Magistrate-I, Abbottabad vide order dated 17.03.2021. Copy of acquittal order dated 17.03.2021 is annexed as Annexure "G".

That appellant who is sole responsible figure for aged parents and orphaned nephews and niece of his late brother, submitted written application to respondents No.1 for re-instatement in service on 24.05.2021 after acquittal, **c**opy of application submitted on 24.05.2021 is annexed as Annexure "H".

That appellant running from pillor to post also moved application to Deputy Commissioner Abbottabad for the redressal of his grievance, who referred the matter to Additional Deputy Commissioner and then he directed

That respondent No.1 declined to reinstate the appellant in service vide order No.825/PS dated 28.05.2021 and appellant even could not get relief from respondent No.2 when his appeal has also been dismissed on 05.07.2021. Copy of order dated 28.05.2021, letter of information about dismissal of application dated 08.06.2021, appeal and final order in appeal dated 05.07.2021 are annexed as Annexure "", "K", "K" & "M",

That appellant, being aggrieved and dissatisfied from the order dated 28.05.2021 and 05.07.2021 impugns the same in appeal, inter-alia on the following grounds.

#### <u>GROUNDS;-</u>

a)

That the appellant was dismissed from service in malafide, unlawful, void and prejudiced manner without any notice, hearing and inquiry and as such legal and fundamental rights of appellant were violated by respondent No.1. So much so, respondent No.1 and 2 both have not considered and protected the same even after his acquittal in criminal case vide order dated 17.03.2021. In this way, orders of respondent No.1 and 2 are void, illegal and based on malafide palpable from record and are liable to be struck down.

That appellant has not been treated in accordance with law at all whose legal and service rights have been affected at the hands of respondents despite the fact affected at the hands of respondents despite the fact affected at the hands of respondents despite the fact article 2A, 4, 25 and 27 of the constitution, provisions of civil servants Act, 1973, and framed there-under and principles laid down by August Superior Courts protect and guarantee his all such rights. Respondents have ignored the above mentioned provisions of law and principles and hence impugned orders are liable to be setaside.

c) That appellant was implicated false criminal case of theft of motorcycle having been shown to have recovered from forest colony Abbottabad. He has been acquitted in this case vide order dated 17.03.2021 and he has a lawful right to be reinstated in service after termination of criminal proceedings but respondents turned deaf and declined relief to appellant in malafide, tainted and unwarranted manner.

b)

That it is also evident from record that respondent No.3 who is not son of retired employee has been appointed against the reserved post of employees' son quota in collusion with respondent No.1 and 2 vide order No.105 dated 02.05.2016 soon after dismissal order of appellant dated 13.04.2016. In order to protect their illegal order, and nepotism impugned order has been passed so that respondent No.3 can be retained in service without lawful justification. On this score, appointment order of respondent No.3 may be declared illegal and without lawful authority and appellant deserves for re-instatement in service.

e)

That orders passed by the respondents impugned herein are void and ineffective upon right of appellant and highle to be set aride.

f)

That other points shall also be argued at the time of hearing.

In view of foregoing pleas and grounds, it is humbly prayed that on acceptance of instant appeal, order dated 28.05.2021 and 05.07.2021 passed by respondent No.1 and 2 be set-aside on account of being illegal, unlawful, arbitrary and against the legal, constitutional and service rights of appellant; that appointment of the respondent No.3 be declared void, illegal, against the rules and without lawful authority on the post of Ex-Employees' Son Quota in the office of respondent No.1; that respondent No.1 be directed to reinstate the appellant in service since dated 13.04.2016 alongwith all back benefits till reinstatement and that any other relief which Honourable



Perusal of the record reveals that accused facing trial have been charged in case FIR # 379, dated 20.03.2016 u/s 381-A/411 PPC, PS Cantt, Abbottabad.

From perusal of the record it found that prosecution has submitted instant complete challan before the court on 19.01.2017. Accused were summoned who appeared before the court, provision of section 241-A Cr.P.C was complied with. Formal charge was framed on 24.02.2020. Thereafter, prosecution was invited to produce their evidence.

Prosecution produce Mr. Mehboob FC # 51 as PW-1 who stated that during the days of occurrence he was posted as FC in PS Cantz, Abbottabad. He is the marginal witness of recovery nemo vide which IO took into possession motorcycle Honda 125, engine # 6569671 chassis # 253495 from the possession of accused Aizal and prepared the recovery memo Ex PW-1/1 in his presence as well as in the presence of co-marginal witness. He has seen the recovery memo Ex PW-1/1 in the court which is in the handwriting of IO correct and correctly bears his signature, signature of IO and co-marginal witness. Similarly, he is also marginal witness of recovery memo dated 18.04.2016 vide which IO took into possession one carry van bearing # 2334 CD/karachi, about which during investigation Aamir Qureshi and Muhammad Ali accused made the disclosure that the said carry van is in possession of Muhammad Sajid who is using the same in different crimes. They got an information that Muhammad Sajid and Muhammad Ali alongwith the carry van was present in Subzi Mandi Mor, upon which they raided there and recovered the said carry van, which IO took into possession and prepared the recovery memo Ex PW-1/2 in his presence as well as in the presence of comarginal witness. He has seen the recovery memo in the court which is in the handwriting of IO, correct and correctly bears of his signature, signature of IO, and co marginal witness. IO recorded his statement u/s161 Cr.P.C. During cross examination conducted by learned counsel of accused namely Afzal and

The motorcycle in Ex PW-1/1, was recovered on the pointation of Qasim and Aamir Qureshi from a garage situated at Forest Colony, Abbottabad. He also admitted that accused Afzal was not present at that time neither he made any pointation. IO also prepared the recovery sketch of said recovery, the same is exhibited as Ex PW-1/D-1. During the cross examination conducted by the counsel of accused Aamir Qureshi, PW-I Mehboob FC admitted that nothing incriminating was recovered from the possession of accused Aamir Qureshi and no pointation was made out by accused Aamir Qureshi. In light of statement of PW-1, the story of prosecution is doubtful, novelistic one and incredible. Instant case pending before the court since 2017 but is complainant did not appear before the court despite several notices which shows his disinterest in prosecution of instant case. Moreover, local police have recovered so many motorcycles but none of the victim appear before the court for prosecution of instant case including complainant namely Muard Ali. 10 of the case did not associate any private person with recovery proceeding despite the fact that place of recovery was forest office/public office and many people used to visit the office on daily basis. So far as, recovery of carry van is concerned, a separate case FIR # 1200, dated 16.11.2015 u/s 381-A/411 PPC PS Cantt is pending before this court against one of the co-accused namely Muhammad Ali and fixed for evidence. So, in these circumstances, when the recovery of the alleged stolen motorcycle is doubtful, if the remaining evidence in the instant case will be collected, no fruitful purpose can be served resultantly, the fate of case is acquittal of accused because of weak evidentiary point of view.



It is submitted that the decision / court order attached with the above appeal reveals that Mr. Amir Qurashi was acquitted from the charge leveled against him for stolen of Motorcycle vide FIR No.379, dated 20/3/2016 U/S 3810A/411 PPC. Brief facts of the case are as under:-

1-Mr. Amir Qurashi was appointed as Chowkidar if Patrol Squad Forest Division Abbottabad vide office order No.87, dated 15.3.2016 for a probation period of two years.

2-Before completion of probation period as laid down in term 01 of above office order, just after appointment i.e 15.3.2016 he was found involved in the above criminal case on 20.3.2016, when he had served only five (5) days of his service in the department.

3-As per terms and condition of S.No.4 of appointment order he alongwith other accused were terminated from Government Service vide office order No.87, dated 15.3.2016, due to sheir involvement in the criminal case in view of FIR lodged against them in Police Station Abbottabad.

4-Mr.Amir Qurashi Ex-Chowkidar preferred an departmental appeal against termination order which was rejected by the Appellant authority (Conservator of Forests Lower Hazara. Forest Circle Abbottabad) vide his letter No. 1931-32/GE, dated 26.8.2016





5-It is also to clarify here that the appellant has been acquitted from the criminal case charged in FIR No. 379, dated 20/3/2016 U/S 3810A/411 PPC, therefore his appeal regarding reinstatement into service cannot be considered as no service appeal was filed by him nor decided in his favour.

Moreover, he was not entitle to be reinstated in service in the light of Rule 6(3) of Government of Khyber Pakhtunkhwa Civil Servants Act 1973 as provided in last paragraph of ibid rules "that in the case of initial appointment to a service or post, a civil servant shall not be deemed to have completed his period of probation satisfactorily until his character and antecedents have been verified as satisfactory in the opinion the appointing authority" and similarly provided in Rule 15 (3) of ibid rules (updated virgin of 1989) " on successful completion of probation period, the appointing authority shall, by specific order terminate the probation of the officer or official concerned within two months after the expiry of probation period prescribed in sub rules (1)", as he could not completed his probation period of service satisfactorily, therefore, , he is not liable to be reinstated in Government Service and recommended that the appeal preferred by the Ex-Chowkidar may kindly be filed please.


