NO.73 IN THAT SENIORITY LIST BY MAINTAINING INTER-SE-SENIORITY OF THE APPELLANT ON PROMOTION TO THE POST OF PMS OFFICER (BPS-17) AS PER **EXPLANATION II OF RULE-17 OF APPOINTMENT POSTING TRANSFER RULES 1989 AND AGAINST NOT** TAKING ACTION ON THE DEPARTMENTAL APPEAL FOR THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

**PRAYER:** 

THAT ON ACCEPTANCE OF THIS APPEAL, THE RESPONDENT MAY KINDLY BE DIRECTED TO PLACE THE NAME OF THE APPELLANT AT SERIAL NO.326 ABOVE YASIR SALMAN KUNDI IN THE SENIORITY LIST OF PMS OFFICER (BPS-17) BY MAINTAINING **INTER-SE-SENIORITY** OF THE **APPELLANT ON PROMOTION TO THE POST OF PMS** OFFICER (BPS-17) AS PER EXPLANATION II OF **RULE-17 OF APPOINTMENT POSTING TRANSFER RULES 1989 AS THE APPELLANT WAS DEFERRED** FROM PROMOTION TO THE POST OF PMS OFFICER IN PSB HOLD ON 19.04.2019, WHILE YASIR SALMAN KUNDI WAS PROMOTED TO PMS OFFICER(BPS-17) **ON THAT BASIS OF THAT PSB.** 

#### **RESPECTFULLY SHEWETH:**

FACTS:

- 1. That the appellant joined the department as Assistant in BPS-16 in the year 2011 and then promoted to the post of Tehsildar (BPS-16) on 16.11.2017 and was Sr.No.72 in the seniority list of Tehsildar issued on 31.08.2018, while Yasir Salman Kundi was at Sr. No.73 in that seniority list. (Copy of seniority list of Tehsildar is attached as Annexure-A)
- 2. That opportunity of mandatory training was provide to Yasir Salman Kundi and others, while the appellant was not sent for mandatory training necessary for promotion to the post of PMS Officer (BPS-17). PSB was hold on 19.04.2019 for the promotion to the post of PMS Officer BPS-17in which Yasir Saleem Kundi was recommended for promotion the post of the PMS officer (BPS-17) and consequently he was promoted to PMS Officer (BPS-17) vide notification dated 09.05.2019, while the appellant was deferred from promotion in that PSB. (Copies of PSB meeting minutes and promotion notification 09.05.2019 are attached as Annexure-B&C)

- 3. That the Board of Revenue issued seniority list of Tehsildar (BPS-16) on 18.03.2020 stood on 31.12.2019 in which the name of the appellant was present at Sr. No.38, while Muhammad Yar was present on Sr. No.41 in that seniority list. The PSB was hold on 09.06.2020 in which the appellant was again deferred, while Mr. Yar Muhammad who was junior in seniority list was promoted to PMS officer BPS-17 vide notification dated 02.07.2020. (Copics seniority list, PSB meeting Minutes and notification dated 02.07.2020 are attached as Annexure-D,E&F)
- 4. That the appellant was promoted to PMS Officer (BPS-17) on regular basis vide notification dated 18.03.2021. The respondent department issued a seniority list of PMS officer stood on 05.10.2020, wherein the name of the Yasir Salman Kundi is present at Sr. No.326 and the appellant is entitled to be placed at Sr. No.326 above Yasir Salman Kundi in the seniority list of PMS Officer (BPS-17) as the appellant was senior to Yasir Salman Kundi in the seniority list of Tehsildar (BPS-16), but the appellant was deferred from promotion to the post of PMS Officer (BPS-17) on the basis of PSB hold on 19.04.2019, while Yasir Salman Kundi was promoted on that PSB and the appellant is entitle to

retain his inter-se-seniority in PMS Officer-17 on his promotion to the post of PMS Officer as per explanation II of Rule-17 APT Rules 1989. (Copy of seniority list dated 05.10.2020 is attached as annexure-G) 虚素

- 5. That the appellant filed departmental on 14.04.2021 for placing his name at Sr. No.326 above Mr. Yasir Salman Kundi in the seniority list of PMS Officer (PMS-17), which was not responded within the statutory period of ninety days. (Copy of the departmental appeal is attached as Annexure-H)
- 6. That the appellant has no other remedy except to file this service appeal in this Honourable Tribunal on the following grounds amongst others.

#### **<u>GROUNDS</u>**:

- A. That the appellant is entitled to be placed at Sr. No.326 above Yasir Salman Kundi in the seniority list of PMS Officer as the appellant was senior to Yasir Salman Kundi in the seniority list of Tehsildar (BPS-16), but the appellant was deferred from promotion to the post of PMS Officer (BPS-17) on the basis of PSB hold on 19.04.2019, while Yasir Salman Kundi was promoted on the basis of that PSB and the appellant is entitle to retain his inter-se-seniority in PMS Officer-17 on his promotion to the post of PMS Officer as per explanation II of Rule-17 APT Rules 1989.
- B. That the appellant was Sr.No.72 in the seniority list of Tehsildar issued on 31.08.2018, while Yasir Salman Kundi was at Sr. No.73 in that seniority list. Yasir Saleem Kundi was promoted to PMS Officer (BPS-17) vide notification dated 09.05.2019 on the basis of PSB hold on 19.04.2019, while the appellant was deferred from promotion in that PSB and the appellant is entitle to be placed above Yasir Salman Kundi in the seniority list of PMS-Officer (BPS-17) on his promotion to PMS Officer (BPS-17) by maintaining their inter-se-seniority as per explanation II of Rule-17 of APT Rules 1989.
- C. That the appellant was deferred from promotion to PMS Officer (BPS-17) in the PSB hold on 19.04.2019 and not superseded, therefore, he is entitled be placed above his juniors on his

promotion to PMS Officer (BPS-17) as per explanation II of Rule -17 APT Rules 1989.

D. That the whole service career of the appellant will be at stake as the long earned seniority maturing his right of promotion to the next scale will be blocked if not treated him as per explanation II of Rule-17 APT Rules 1989.

- E. That if the appellant is not treated as per explanation II of Rule -17 APT Rules 1989, he will deprive from his due right of seniority, promotion.
- F. That under Article 25 of the Constitution of the Islamic Republic of Pakistan 1973, all citizen are equal before law, and that no discrimination is permitted in the similarly placed citizens, thus the discrimination meted out to the appellant by not placing name on due place of seniority list is illegal, highly discriminatory and not sustainable.
- G. That the state is bound to ensure the elimination of all torms of exploitation and the gradual fulfillment of the fundamental principles. It is also the duties of the state to remove disparity in the income and earning of individuals under Article 37 & 38 of the Constitution.
- H. That the Hon' able Supreme Court of Pakistan in case reported as 2010-SCMR-1301, has held that in matter of seniority, promotion, rules are to be followed and where the discretion of authority is involved, then that must be exercised with fairness. It is also held in the said judgment that promoting the juniors by ignoring seniors will not advance the object of achieving good governess. It is further pointed out in the said judgment that the Constitution is the supreme law and there is no room to allow the authority to make departure from law, rules and Article 4 and 25 of the constitution.
- I. That even in latest judgment of the Hon' able Supreme Court reported as PLD 2013 (SC)-195. (Case of Anita Turab), it is held that the statutory provisions, rules, regulations which govern the matter of appointment of Civil Servants must be followed honestly and scrupulously.

- J. That the conduct and attitude of the respondents as well as not including the name of the appellant in the final seniority list at proper place and also not recommended for the mandatory training is based on discrimination against the spirit of Article 2-A, 4, 9 and 25 of the Constitution.
- K. That the appellant has a spotless service career at her credit, the discrimination meted out to the appellant will affect his service career.
- L. That the appellant seeks permission of this Honorable Tribunal to advance other grounds and proofs at the time of hearing.

It is, therefore, humbly prayed that the appellant of the appellant may kindly be accepted as prayed for.







Respected Sir,

With due respect, it is requested that the appellant is promoted from Tehsildar (BPS-16) to PMS (BPS-17) vide Order No.SOE-II(ED)2(192)2020 dated 18/03/2021 (Annex-A).

That the appellant was at S.No.72 of the seniority list of Tehsildar dated 31/12/2018, whereas, Tehsildar at S.No.73 (Mr. Yasir Salman Kundi) to S.No.82 (Mr.Younas Khan) were all junior to him (Annex-B Seniority List dated 31/12/2018).

That all above mentioned Tehsildar were provided the opportunity of mandatory training and were subsequently promoted on dated 09/05/2019 (Annex-C), while the appellant was deferred on the ground that he was not gone through mandatory training and his length of service was not completed (Annex-D) Minutes of PSB Meeting dated 19/04/2019).

That again PSB held on 09/06/2020 and Tehsildar Mr. Muhammad Yar at S.No.41 and onward others promoted to the post of PMS. (Annex-E Seniority List dated 31/12/2019 and Promotion Order of Mr. Muhammad Yar and Others are attached as Annex-F) whereas, the appellant again differed on the same plea that he is not gone through mandatory training (Annex-G Minutes of PSB Meeting dated 09/06/2020).

That on 6 February 2020 more 21 Tehsildars were sent to training by Board of Revenue. All junior to the appellant were sent to trading and the appellant was not considered (Annex-H). The appellant was fortunate that the training of said Tehsildars could not complete due to COVID-19 Pandemics, if those Tehsildars had completed training they would be senior to appellant. After that the appellant reached to the conclusion that selection to training is not on merit and it is through Pick and Choose manner.



After that, the appellant submitted application to Chief Secretary, Khyber Pakhtunkhwa wherein it was requested that "all Tehsildars from S.No.21 Mr. Tahir Ashraf to S.No.84 Mr. Nawab Gul are gone through mandatory training, but only the applicant and few other Tehsildars are not given opportunity of mandatory training (Application to Chief Secretary, Khyber Pakhtunkhwa at Annex-III).

That\_in\_response to the said application / departmental appeal, the appellant was provided opportunity of mandatory training and subsequently promoted\_vide order\_dated\_18/03/2021. (From\_serial\_No-326-to-305-of-seniority\_list\_of PMS-BPS-17)-(Annexure-J)
