JOINT PARA WISE REPLY ON BEHALF OF RESPONDENTS NO. 1 TO 4

Respectfully Sheweth:

Preliminary Objections:

- i. The Appellant has got no cause of action to institute the instant appeal.
- ii. The Appellant has not come to the Service Tribunal with clean hands.
- iii. The appeal is not maintainable in its present form.
- iv. The Appellant has concealed the material facts from this Honorable Tribunal.
- v. The Appeal is not maintainable and barred by law and limitation.
- vi. That Appeal is liable to be dismissed.
- vii. That the appeal is bad for miss joinder of necessary parties.

ON FACTS

- 1. Pertains to petitioner's service record.
- 2. Pertains to his appointment order.
- 3. Pertains to Appellant's record.
- 4. The Appellant was appointed as Accounts Officer in attached formation of Local Government, Elections and Rural Development Department, Khyber Pakhtunkhwa.
- 5. The Executive Allowance is allowed to those employees who are working in Provincial Management Services and Pakistan Administrative Services whereas the appellant is neither working as PMS Officer nor PAS officer to claim such allowance, as the same allowance is not admissible to employees of attached formations (Annex-A).
- 6. The appellant has not followed the proper channel and the departmental appeal is not covered under the appeal rules 1986.
- 7. Already explained in Para-05 of the grounds.

- The Provincial Government vide Notification dated 19.10.2018 sanctioned Technical Allowance to those Engineers who are holding Engineering qualification from universities duly recognized by the Government of Khyber Pakhtunkhwa, Higher Education Commission and registered with Pakistan Engineering Council and serving against the sanctioned posts in C & W, Irrigation, Public Health Engineering and Local Government Departments w.e.f. 01.11.2018 Annex-B.
- 9. The Provincial Government of Khyber Pakhtunkhwa, Finance Department vide Notification dated 11.11.2019 sanctioned Planning Performance Allowance @1.5 of initial basic pay as per Basic Pay Scales-2017 for Planning Cadre Officers working against the sanctioned strength of Planning & Development Department Annex-C.
- 10. Correct. The Provincial Government of Khyber Pakhtunkhwa, Finance Department has sanctioned Health Professional Allowance too for doctors, keeping in view their job description. Similarly, Judicial Allowance has been sanctioned for Judicial Officers such as Judges of Peshawar High Court and Subordinate Judiciary Annex-D&E.
- 11. The Provincial Government of Khyber Pakhtunkhwa in Finance Department vide Notification dated 07-07-2021 has sanctioned IT Professional Allowance at the rate of one initial Basic Pay Scale per month as per Basic Pay Scales-2017 to all IT officers working against sanctioned posts of BPS-17 & above under the Administrative Control of Government of Khyber Pakhtunkhwa Annex-F.
- 12. Correct to the extent that the above mentioned allowances are not regular allowances but specific in addition to salaries and shall not be counted towards pension and gratuity.
- 13. Incorrect. As per Government of Khyber Pakhtunkhwa, Finance Department Notification dated 07.07.2021 Executive Allowance will not be counted towards pension and gratuity.
- Provincial Government in Finance Department vide Notification dated 06-02-2008 14. sanctioned Special Allowance (Secretariat Performance Allowance) @ 20% of the basic pay to the officers & officials (BS-01 to 22) which was later-on revised up to 50% only to those employees working against sanctioned posts of Establishment Department, Chief Secretariat/House, however, Secretariat/House, and Governor Minister aforementioned increase will not be applicable to all those who are drawing scheduled posts allowance /technical allowance/planning allowance/health professional allowance or any other allowance having high quantum of financial benefits. Furthermore, Provincial Government granted Disparity Allowance to the tune of 15% to those employees who were deprived from special allowance i.e., Secretariat Performance Allowance and Executive Allowance Notifications are Annexed as Annex-G.

- A. The appellant has been treated in accordance with rules and has been equally treated as per rules/policy. No violation of right of citizen has been violated.


