REPLY TO INQUIRY OF INCIDENT HELD IN THE PROVINCIAL EXCISE WAREHOUSE.

R/Sir.

It is submitted that I Mr. Majid Hussain, working in the department as Assistant Sub-Inspector since 2012. Sir, I have been posted and performed duties in different district offices. I belong to a very noble and respectable family. Sir, recently I have been posted as ASI in the newly established Excise Police Station, Peshawar, and made a good progress in seizure of Narcotics and other contrabands, my progress report is attached as ready reference please.

Sir, a report has been submitted by the Line Officer. Provincial Excise Warehouse, Peshawar, in which a baseless allegation of replacing tyres of Hine Truck has been leveled against me while I have been performing duties in the Excise Police Station on 01-08-2020 for round the clock (on the first day of Eid ul Azha). It is a very impossible process for a single man to take out ten tyres out of a truck in a short time and in the presence of vigilant staff of Excise Warehouse. Opening ten tyres from a truck then loading new tyres, this process requires at least a day, and this will also create huge noise on the part of replacing them. This is not possible without at least ten men to work on same time.

Here it is worth mentioning that while performing night duty in Excise Police Station, two of my relatives brought dinner around at 08:00 pm for me to the Police Station which may be evident from the CCTV footage of the Excise Warehouse. They spent some time with me and then left, at about 1200 Hrs, I also closed the duty of the Police Station and left the jurisdiction in my official vehicle. Which may also be inquired from the staff.

Sir, it is submitted that I have no concern with the said matter and this is a baseless allegation against me. It is a very laborious and tough job on the part of a single person. It is also a hard and heavy work and requires skillful persons for exchanging ten tyres. Being a baseless and false allegation against me without any proof that I am not involved in this.

Sir, the Line Officer has just submitted a report of the replacement to withdraw the attention of Higher Authorities regarding his inefficiency and irresponsible behavior.

The appeal was sent to Director General, Excise, Taxation & Narcotics Control for a detailed report.

- 2. The Director General, Excise, Taxation & Narcotics Control submitted a report intimating that an inquiry was conducted by Mr. Ishtiaq Khan, Director (Admn) ET&NC, wherein the official was provided opportunity to rebut the charges levied against him but he failed to do so. The Inquiry Officer found him guilty of misconduct and disciplinary action was recommended against him
- 3. In the light of recommendation of Inquiry Officer, his two (02) annual increments for the year 2020 and 2021 were withheld for a period of two years and he was barred from the duty at the Excise Police Stations and field operations for a period of one (01) year.
- 4. In light of Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011, Sub Rule-17 Departmental appeal & review provides that: -
 - (1) An accused who has been awarded any penalty under these rules may, within thirty days from the date of communication of the order, prefer departmental appeal to the appellate authority:

 Provided that where the order has been passed by the Chief Minister, the accused may, within the aforesaid period, submit a review petition directly to the Chief Minister.
 - (2) The authority empowered under sub-rule (1) shall call for the record of the case and comments on the points raised in the appeal from the concerned department or office, and on consideration of the appeal or the review petition, as the case may be, by an order in writing-
 - (a) Uphold the order of penalty and reject the appeal or review petition; or
 - (b) Set aside the orders and exonerate the accused; or
 - (c) Modify the orders or reduce the penalty.
 - (3) An appeal or review petition preferred under these rules shall be made in the form of a petition in writing, and shall set forth concisely the grounds of objection in impugned order in a proper and temperate language.

BREIF FACTS

- 1. Correct.
- 2. Incorrect. The service record of the official contain complaints from Excise and Taxation Officer-III, Peshawar regarding negligence, flouting office decorum/ discipline, unprofessional attitude, non-compliance of orders etc (copy attached as Annex-I). Besides a complaint from resident of KDA also exist complaining his corruption (copy attached as Annex-II).

- 4. Incorrect. The allegations levelled against him were proved by the inquiry officer and penalty was awarded as per the Khyber Pakhtunkhwa, Efficiency & Discipline rule; 2011.

SO(Admn)E&T/1-20/2020:-/المحددرا Mr. Majid Hussain, Assistant Sub Inspector, O/o Excise Police Station, Peshawar submitted an appeal to Secretary (Appellate Authority), against the minor penalty of withholding of "his two (02) annual Increments for the year 2020 and 2021 and that he was barred from the duty at the Excise Police Stations and field operations for a period of one (01) year" Imposed upon him by the Director General, Excise, Taxation & Narcotics Control on account of replacement of the tyres of one Hino Truck parked at Warehouse near the main gate of the Excise Police Station, Peshawar through some private persons brought by him alongwith jack and old tyres in a pickup vehicle on 01-08-2020 at 11:30 PM. The appeal was sent to Director General, Excise, Taxation & Narcotics Control for a detailed report.

- 2. The Director General, Excise, Taxation & Narcotics Control submitted a report intimating that an inquiry was conducted by Mr. Ishtiaq Khan, Director (Admn) ET&NC, wherein the official was provided opportunity to rebut the charges levied against him but he falled to do so. The Inquiry Officer found him guilty of misconduct and disciplinary action was recommended against him
- 3. In the light of recommendation of Inquiry Officer, his two (02) annual increments for the year 2020 and 2021 were withheld for a period of two years and he was barred from the duty at the Excise Police Stations and field operations for a period of one (01) year.
- 4. In light of Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011, Sub Rule-17 Departmental appeal & review provides that: -
 - (1) An accused who has been awarded any penalty under these rules may, within thirty days from the date of communication of the order. prefer departmental appeal to the appellate authority: Provided that where the order has been passed by the Chief Minister, the accused may, within the aforesaid period, submit a review petition directly to the Chief Minister.
 - (2) The authority empowered under sub-rule (1) shall call for the record of the case and comments on the points raised in the appeal from the concerned department or office, and on consideration of the appeal or the review petition, as the case may be, by an order in writing-

Omeyal liphold the order of penalty and reject the appeal or review

Organian; or Organian orders and exonerate the accused; or Dy: Different the orders or reduce the penalty.

An appeal of review petition preferred under these rules shall be made fifth of a petition, in writing, and shall set forth concisely the grounds-of-objection in impugned order in a proper and temperate language. 2
