

Pakhtunkhwa Service Tribunal Act, 1974 against  
Notification dated 19-11-2022.**

**Respectfully Sheweth,**

Brief but relevant facts of the case are as follows:

1. That the appellant was initially appointed as SST (BPS-16) vide appointment order dated 12-07-1999 in the respondent Department.
2. That later on, the appellant after rendering ten years continuous regular service as SST and ADO in BPS-16 was awarded BPS-17 (Personal) on the recommendation of the departmental promotion committee vide Notification dated 25-05-2010. Name of the appellant is at Serial No 1013 of the said Notification. (Copy of Notification is filed herewith and annexed as **Annex-A**)
3. That on the bifurcation of the teaching cadre and management cadre in the respondent department, few posts of ADEO (M) (BPS-16) were advertised, the appellant being eligible applied for it through proper channel, qualified the test and interview, and was appointed against the post of ADEO (M) vide Notification dated 05-05-2011. Name of the appellant is at Serial No 55 of the said Notification. (Copy of Notification is filed herewith and annexed as **Annex-B**)

4. That at the time of appointment against the post of ADEO (M), the appellant was drawing his pay and allowances in BPS-17, which was awarded to him vide Notification dated 25-05-2010. The appellant after appointment against the post of ADEO (M), was under legitimate expectancy that he will be granted pay protection and will be allowed to draw pay and allowances in BPS-17 but to his utter surprise respondent No 4 issued revised pay slip and fixed his pay in BPS-16 instead of BPS-17. (Copies of Salary slips are filed herewith and annexed as **Annex-C**)
5. That it is pertinent to mention here that the office of respondent No 3 has time and again requested the respondent No 4 to allow the appellant to get pay and allowances of BPS-17 but to no fruitful result. (Copy of letter is filed herewith and annexed as **Annex-D**)
6. That feeling aggrieved of the aforesaid act of respondents, the appellant approached the respondents by filing the departmental appeal, which was not decided. After the lapse of the statutory time for deciding the Departmental Appeal, the Appellant filed Service Appeal No 11407/2020 before this Honorable Tribunal wherein this Honorable Tribunal vide Judgment and Order dated 28-10-2021 was pleased to remit back the Service Appeal to the Respondent No 1 i.e., (E & S) Edu Department with the directions to take up the case with respondent No 2 i.e., Finance Department and thereafter decide the departmental appeal of the appellant. (Copy of Departmental Appeal and Judgment and Order dated 28-10-2021 is filed herewith and annexed as **Annex-E & F**)
7. That in pursuance of the aforesaid Judgment and Order of this Honorable Tribunal, the respondents issued the impugned Order dated 19-11-2022. Copy of the order received by appellant on 26-11-22. (Copy of the impugned order dated 19-11-2022 is filed herewith and annexed as **Annex-G**). Hence the instant Service Appeal on the following amongst other grounds:

**Grounds:**

- a. That the treatment met to the appellant is against the law, unlawful, without lawful authority, void and ineffective upon the rights of the Appellant.
- b. That in the Notification dated 05-05-2011 whereby the appellant was appointed as ADEO (M), full protection has been given to the previous terms of his appointment, thus his pay is protected in BPS-17 (Personal).
- c. That the treatment met to the appellant is based on discrimination, the colleagues of the appellant who were granted BPS-17 (Personal) along with the appellant vide Notification dated 25-05-2010 are getting its benefits, whereas the appellant is deprived from it which is not warranted under the law. For instance one Mr Nisar Ahmad was initially appointed as SET (BPS-

16), later on upgraded to BPS-17 vide Notification dated 27-09-2008 applied along with the Appellant for appointment against the post of ADEO (M) (BPS-16) and was appointed along with Appellant against the post of ADEO(M). After appointment against the post of ADEO (M), the pay of Nisar Ahmad was fixed in BPS-17 whereas the pay of Appellant was fixed in BPS-16. (Copy of pay slip, up-gradation Notification and appointment Notification as ADEO(M) of Nisar Ahmad is filed herewith and attached as **Annex-H, I & J**)

- d. That the colleagues of the appellant who were appointed along with the appellant against the post of SET (BPS-16) and did not join Management Cadre are being promoted to the BPS-17 and BPS-18 and getting its perks and privileges, whereas the appellant is deprived from it.
- e. That the treatment met to the Appellant is against the Fundamental Rule 22 and against the judgment dated 28-10-21 of this Honorable Tribunal in Service Appeal No 11407/2020.
- f. That the Appellant craves permission of this Honorable Tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of his Service Appeal.

It is, therefore, prayed that on acceptance of this Service Appeal, the impugned Order dated 19-11-2022 be declared as against the law and ineffective upon the rights of the Appellant and the act of respondents of withdrawing the benefits of BPS-17 (Personal) from appellant be declared as against the law and without lawful authority and the respondents may kindly be directed to grant and fix the pay, and allowances of the appellant in BPS-17 with effect from 05-05-2011 with arrears and all other back benefits.

**OR**

Respondents be directed to revert back the appellant to Teaching Cadre with effect from 05-05-2011 and be granted same perks and privileges i.e., Pay Scale, Seniority, Pay etc as his colleagues are getting who were appointed along with Appellant as S.E.T.

Any other relief which has not been specifically prayed for and deemed fit and appropriate by this Honorable Tribunal in the circumstances may graciously be granted.



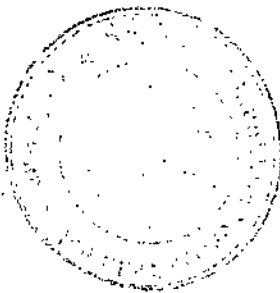

Preliminary arguments have been heard and copies of record annexed therewith have been perused. The appellant has invoked the jurisdiction of this Hon'ble Tribunal with a particular prayer based on a factual accounts that he while holding the post of SST BPS-16 was awarded BPS-17 (Personal) on the recommendation of the Departmental Promotion Committee vide Notification dated 25.05.2010. Thereafter, the Teaching Cadre and Management Cadre were bifurcated. In wake of said bifurcation, the posts of ADEO (Male) (BPS-16) were advertised whereupon the appellant applied under due course and remained successful in getting recommendation and appointment on the said post of Management Cadre originally in BPS-16. After his appointment vide notification dated 25.05.2010, he joined the Management Cadre against the post of ADEO (Male) BPS-16 but the respondent No. 4 revised the Pay Slip and fixed his pay in BPS-16 instead of BPS-17. Despite request of the respondent No. 3 being departmental authority, the respondent No. 5 paid no heed to allow the appellant to get pay and allowance of BPS-17. the appellant filed departmental appeal to the respondent No. 2 whereupon the views / comments of respondent No. 3 were sought who is response submitted the same vide letter No. 27.102016 addressed to the Section Officer (Primary), Government of Khyber Pakhtunkhwa E&SE Department, Peshawar; which in nutshell augment the claim of the appellant. Obviously, no decision was made on the said departmental appeal as per stance of the appellant, and he followed the next course for remedy through this Service Appeal. From the comments sent by respondent No. 3 to the Department, it does not appear that the department is having any contrary view than the averments of the appellant in his appeal. The case of the appellant seems to have become a

bone of contention between the department and the controllers of accounts i.e. respondents No. 4 & 5. Therefore, without touching the relief as prayed for in the Memorandum of Appeal, this appeal is remitted back to respondent No. 1 for decision of the departmental appeal in the manner as hereinbefore indicated. This order shall not bar the right of appellant for fresh appeal before the Tribunal in case his grievance is not redressed departmentally. The appellant shall take certified copy of this order, Memorandum of Appeal and submit the same in the office of respondent No. 1 alongwith copies of other record as annexed with this appeal for the needful as directed. The appeal is disposed of in the above terms. File be consigned to the record room.



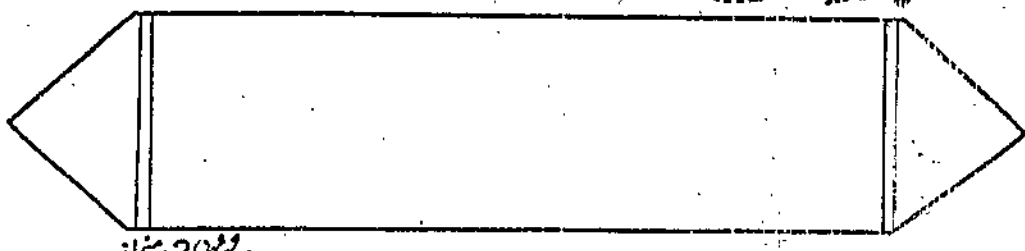
