ON ACCEPTANCE OF THIS APPEAL THE IMPUGNED TERMINATION ORDERS OF THE APPELLANT BY RESPONDENTS THROUGH IMPUGNED LETTER NO. AD LG (MRD)/ESTB/SERVICE/2020-M499-A DATE. 23.10.2020. MAY PLEASE BE SUSPENDED AND RESPONDENTS MAY KINDLY DIRECTED TO RELEASE THE SALARIES AND **OUTSTANDING** ARREARS **OF** THE APPELLANT AND MAY ALSO PAY MONTHLY SALARY TO THE APPELLANT WITHOUT ANY STOPPAGE.

Respectfully Sheweth,

The Appellant Most humbly submit as under: -

Brief Facts:

- 1. That the appellant is a law-abiding citizen and bona fide resident of Mohallah Tawas Khel, Village Sangao Tehsil Katlang& District Mardan.
- 2. That respondent No.4 advertised some 164 posts of NaibQasid (BPS-03) per advertisement published in the daily newspaper. (Copy of the advertisement is attached as Annexure-A).



- 3. That the Appellant applied for the vacant post and in this regard, the meeting of the District Selection Committee was conducted and the Appellant along with others were recommended and selected for recruitment.
- 4. That on for the aforesaid post after passing through the proper procedure the Appellant was appointed, per "Appointment Order" dated: 09.03.2020 being the deserving/successful candidate and posted in VC Rorya-01 Tehsil & District Mardan. (Copy of the Appointment Order is attached as Annexure-B).
- 5. That in compliance with the said office order, the Appellant reported in VC Rorya-01 Tehsil & District Mardan and after taking over the charge on the direction of Respondent No.4 the Appellant performed duties in the office of respondent No.5. the Appellant passed through a medical examination and police clearance certificate for service book preparation. The appellant from the appointment to august 2020 performed his duties but without any reason, the salary was stopped and the appellant was orally informed that there is no vacant post for the appellant. (Copy of medical & charge report is attached as annexure C&D).
- 6. That the salary of the Appellantwas stopped by the respondents without any reason for which the Appellant approached respondent No.2 and submitted a written application but to date no response, that's why the appellant filed A Writ Petition No. 3364-P/ 2020 for redressal of his grievances. The Comments were called from the respondents, but the respondents delayed the matter in submitting comments that's why The Honorable Court was pleased to attach the salary of the respondent. (Copy of the application is attached as Annexure-E).
- 7. That when the comments were filed the respondents malafiddly withdraw the appointment order of the appellant vide impugned Letter No.NO. AD LG(MRD)/ESTB/SERVICE /2020-M499-A DATED. 23.10.2020, during the pendency of the Writ Petition on the ground that another employee Muhammad Arsalan was reinstated and once Yousaf Shah was appointed. It was surprising that the person namely Yousaf Shah in active service of KP Police. (Copy of the Withdrawal Order and Appointment Order of Yousaf Shah are attached as Annexures F & G).
- 8. That the Writ Petition No.3662-P2021 Title: Shahid Akbar versus Govt. Of KPK & Others was dismissed by the Honorable Divisional Bench of their Lordship Mr. Justice Lal Jan Khattak & Mr. Justice Abdul Shakoor Vide Judgment Dated: 12.05.2022. (copy of writ petition & judgment is annexure H & I as attached).
- 9. That the appellant filed a review petition of Order / Judgment dated: 12.05.2022 but the same is also dismissed vide Order / Judgment dated: 30.11.2022. (Copy of Order / judgment dated: 30.11.2022 is attached)

10. That after dismissal of Review Petition the appellant filed a departmental appeal but respondent No.3 but a few days before the filling of this Appeal the Respondent No.3 returned the departmental appeal with observation that the appeal of the appellant is not maintainable, hence this appeal on the grounds interalia:-

GROUNDS: -

- A. That the Appellant was appointed by the respondent department on the post of NaibQasid through proper channel vide office order and after joining the said post the Appellant is performing his duties regularly but the stoppage of the salary respondents is against the law and unjustifiable.
- B. That the Appellant for the sake to keep his service safe regularly providing his service but the respondents department taking duty from the Appellant like in a government beggar camp and not paying salary to the Appellant violating his fundamental rights, hence, the appellant approached this Honorable Tribunal for release of his salary and the respondent No.4 issued the impugned Order of withdrawal of appointment order during the pendency of the Writ Petition, the respondents have no prerogative to issue the impugned without adopting the legal procedure, hence, this Hon'ble Court have the prerogative to interfere in such like matters.
- C. That the Appellant has an excellent service record and performed duty and was too excellent, hence not paying the salary to the Appellant by the respondents is great discrimination and the impugned order of withdrawal of the appointment order during the pendency of Writ Petition had no legal footing.
- D. That the Appellant is assiduous and punctual in his duty, therefore no complaintwas received by the respondents against the Appellant but the respondents unlawfully stopped the salary of the Appellant, which is against the law and fundamental rights and the Appellant was approached before the Peshawar High Court in Writ Petition No. 3364-P/2020 and during pendency the salary of respondent No. 4 was attached by the Honorable Court due to non-compliance of submission of comments and the respondent No. 4while taking revenge from the meagre the respondent issued impugned order dated: 23.10.2020, which is illegal, unlawful and inoperative upon the right of the Appellant and liable to be set aside and the appellant has right of reinstatement in service with all consequential benefits from the date of the impugned order.
- E. That the Appellant having minor children, and the Appellantis the only person to earn livelihood for his family, so the illegal and unlawful act of the respondents has fallen the Appellantas well as his family in a great finical crisis, so needs interference of this Honorable tribunal on humanitarian grounds too.
- F. That unless an order of reinstatement in service and payment of salary of the Appellantis not issued, serious miscarriage of instice would be caused to the Appellantand would be suffered



by the orders of the Respondents which are fanciful, suffering from patent perversity and material irregularity, needs correction from this Hon'ble Court.

- G. That the Appellant, after running from pillar to post but of no avail, finally decided to approach this Honorable Court for seeking justice as no other adequate and efficacious remedy is available to him.
- H. That the Appellantreserves the right to advance other points at the time of hearing this petition.

ON ACCEPTANCE OF THIS APPEAL THE IMPUGNED TERMINATION ORDERS OF THE APPELLANT BY RESPONDENTS THROUGH IMPUGNED LETTER NO. AD LG(MRD)/ESTB/SERVICE/2020-M499-A DATED. 23.10.2020. MAY **PLEASE** setaside AND THE RESPONDENTS MAY KINDLY BE DIRECTED TO RELEASE **SALARIES** AND OUTSTANDING THE ARREARS OF THE APPELLANT AND MAY ALSO PAY MONTHLY SALARY TO THE APPELLANT WITHOUT ANY STOPPAGE.

ANY OTHER RELIEF DEEMS FIT IN THE CIRCUMSTANCES, WHICH IS NOT SPECIFICALLY ASKED FOR MAY PLEASE ALSO BE GRANTED TO THE APPELLANT.

INTERIM RELIEF.

IT IS FURTHER PRAYED THAT DURING THE PENDENCY OF THIS SERVICE APPEAL THE RESPONDENTS MAY KINDLY BE DIRECTED TO RELEASE THE SALARY AND OUTSTANDING ARREARS OF THE APPELLANT.

That the salary of the petitioner was stopped by the respondents without any reason for which the petitioner approached to respondent No.2 and submitted a written application but no response that's why the petitioner filed writ petition No.3346-P/2020 for redressal of his grievances. The comments were called from the respondents but the respondents delayed the matter in submission of comments that's why this court was pleased to attached the salary of the respondents. (Copy of application is attached as annexure-E).
- 7. That when the comments were filed the respondents mala-fidly withdraw the appointment order of the petitioner vide impugned Letter No. AD LG(Mrd)/Estb/Service/2020-M499-A dated October, 23 2020 during pendency of writ petition on the ground that another employee Muhammad Arsalan has been reinstated and one Yousaf Shah has been appointed. It is surprising that the person namely Yousaf Shah is in the active service of KP Police. (copy of withdrawal Order and appointment order of Yousaf Shah are attached as annexure-F&F)
- 8. That during pendency of WP No.3346-P/2020 after filing of comments by the respondents the petitioner got knowledge the impugned Letter No. AD LG(Mrd)/Estb/Service/2020-M499-A dated October, 23 2020 vide which the appointment order of the petitioner has been withdrawn, the petitioner submits before the Hon'ble bench for withdrawal of petition No.3346-P/2020 with WP3662-2021 SHAHID AKBAR VS GOVI CF.pdf

permission to file a afresh one, which was allowed, hence, this petition.

 That the petitioner having no other alternate adequate remedy, hence this writ petition is filling on the grounds inter-alia;-

GROUNDS:-

- A. That the petitioner has been appointed by the respondents department on the post of Naib Qasid through proper channel vide office order and after joining of the said post the petitioner is performing his duties regularly but the stoppage of the salary and withdrawal order by respondents is against law and unjustifiable.
- B. That the petitioner for the sake to keep his service safe regularly providing his services but the respondents department taking duty from petitioner like in government beggar camp and not paying salary to petitioner violating his fundamental rights, hence, the petitioner approaches this Hon'ble Court for release of his salary and the respondent Novel issued the impugned Order of withdrawal of appointment order during pendency of case, the respondents have no prerogative to issue the impugned order without adopting the legal procedure and this Hon'ble Court have the prerogative to interfere in such like matters.
- C. That the petitioner has excellent service record and performed duty and was too excellent, hence not paying the salary to petitioner by the respondents is great discrimination and the impugned order of withdrawal of the appointment order during pendency of petition have no legal footing.
- D. That the petitioner is very hardworking and punctual in his duty, but the respondents had unlawfully stopped the salary of the petitioner, which was against the law and fundamental rights and the petitioner approached this Hon'ble Court vide WP No.3346-P/2020 and during pendency the salary of Respondent No.4 had been attached by this Hon'ble Court due non compliance of submission of comments and the respondent No.4 while taking revenge the poor the petitioner impugned Order dated:23.10.2020, which is wp3662-7091 sualid akparys govi cf. nd inoperative upon the

- E. That the petitioner having minor children, and the petitioner is only person to carry livelihood for his family, so the illegal and unlawful act of the respondents has fallen the petitioner as well as his family in a great finical crises, so needs interference of this Hon'ble Court on humanitarian grounds too.
- F. That unless an order of reinstatement in service and payment of salary of the petitioner is not issued, serious miscarriage of justice would be caused and the petitioner would be suffered by the orders of the Respondents which are fanciful, suffering from patent perversity and material irregularity, needs correction from this Hon'ble Court.
- G. That the petitioner, after running from pillar to post but of no avail, finally decided to approach this Hon'ble Court for seeking justice as no other adequate and efficacious remedy is available to him.
- H. That the petitioner reserves rights to advance other points at the time of hearing this petition.
 - IT IS, THEREFORE, PRAYED THAT IN VIEW OF THE ABOVE SUBMISSIONS THE INSTANT WRIT PETITION MAY GRACIOUSLY BE ACCEPTED AND THE RESPONDENTS MAY KINDLY BE DIRECTED:
 - i. To declare the impugned Letter No. AD LG(Mrd)/Estb/Service/2020-M499-A dated October, 23 2020, ultra vires, unconstitutional, void abinitio, illegal and inoperative upon the rights of the petitioners.

"It is, therefore, prayed that in view of the above submissions the instant Writ Petition may graciously be accepted and the respondents may kindly be directed:



2. Facts, in brief, are that the petitioner, has applied for the post of Naib Qasid (BPS-03) in Local Government & Rural Development, Government of KPK, duly advertised/published in Daily News Paper. After due process, petitioner was appointed as per "Appointment Order", dated 09.03.2020, and posted in VC Rorya-01. Thereby, the petitioner reported for duty and has served in the office of respondent No.5 till August, 2020, without being paid any salary and thus the petitioner was orally informed that there is no vacant post for the petitioner. Due to salary stoppage, petitioner moved written application to respondent No.2, but was in vain, thereafter he filed W.P No.3346-P/2020, the comments were filed and during pendency of the said writ petition, the respondents vide impugned Letter No.AD LG(Mrd)/Estb/Service/2020-M499-A, dated October, 23, 2020, withdraw the appointment of petitioner on the ground that another employee Muhammad Arsalan has been reinstated and one Yousaf Shah has been appointed. Subsequently, after getting knowledge of the impugned letter, petitioner has submitted before the Court for withdrawal of aforesaid writ petition bearing No.3346-P/2020, with permission to file a fresh one, which was allowed, hence, the instant petition.







- 3. Arguments heard and record gone through.
- 4. Admittedly, the petitioner has served the Education Department for certain period of time and Article 212 of the Constitution of Islamic Republic of Pakistan clearly stipulates that the Tribunal constituted by an appropriate legislature by way of Act shall have an exclusive jurisdiction in respect of matters related to the terms & conditions of service who are or have been in the service of Pakistan including disciplinary matters.
- 5. For ready reference, the relevant section of Article 212 is reproduced herein below:

"212(1): Notwithstanding anything hereinbefore contained the appropriate Legislature may by Act I [provide for the establishment of] one or more Administrative Courts or Tribunals to exercise exclusive jurisdiction in respect of—

(a): matters relating to the terms and conditions of persons 2 [who are or have been] in the service of Pakistan, including

disciplinary matters."

withdrawn but petitioner through the instant petition has sought a relief of his reinstatement in service with effect from his initial appointment with all back benefits, thus, in essence, he is admitting that his service has been terminated which undoubtedly falls within the contemplation of terms &
