Respectfully Sheweth:

1. That the appellant has been appointed as P.E.T BPS-09 by Divisional Director of Education, Kohat Division vide appointment order dated: 02/10/1995.

(Copy of order is attached as "A")

2. That due to her hard work and diligence toward her official duties, the appellant has been promoted step by step under the prevailing rules and regulations and finally promoted to the post of SIPE (BPS-18) and presently working in the same post.

## (Copy of notification is attached as "B")

- 3. That during her entire service in Education Department, the appellant tried her best to become fully acquainted with the modern education techniques and for this purpose, she attended all compulsory trainings and courses in time, not only for the purpose of promotion but to impart standard education to the students also.
- 4. That the Education Department vide notification No.SO(S)6-2/90/1 dated: 18/10/1994 laid down the method of recruitment, qualification and other condition as well as the promotion criteria as well.

## (Copy of notification is attached as "C")

5. That the Education Department vide Notification No.SO(S)6-2/98/service rules dated: 15/01/1999 made further amendments in Notification No.SO(S)6-2/90/1 dated: 18/10/1994 and since 1999 the subsequently amended notification shall have to be followed.

## (Copy of notification is attached as "D")

6. That the Education Department by following the same promotion criteria as mentioned in Notification dated: 15/01/1999 prepared various seniority lists on annual basis as per their requirement. Here the appellant annexed only two seniority lists of the year 2004 and 2006 for ready reference.

# (Copy of seniority lists are annexed as "E" & "F")

7. That by following the amended criteria for promotion as referred in Notification dated: 15/01/1999, the following formulas shall be adopted for reckoning the seniority position of the official and the same is reflected in the 2006 seniority list.

SENIORITY RECKONING FORMULA FROM DPE POST TO SDPE POST

- a. If SDPE degree was obtained before 1<sup>st</sup> appointment, the seniority shall be reckoned from date of 1<sup>st</sup> appointment.
- b. If the SDPE degree was obtained after 1<sup>st</sup> appointment, the seniority of the officer shall be reckoned from the declaration of result of SDRE.
- c. If the date of declaration of result of SDPE of the officers were same, the seniority of the officer shall be reckoned from the date of 1st appointment.
- d. If the date of 1<sup>st</sup> appointment of the officers were same, the seniority of the officer shall be reckoned from the date of birth.
- 8. That despite the clear rules are available for reckoning the seniority position but the appellant was shocked while seeing the tentative seniority list where she was placed at serial No.22 after Mst: Nigar Akhtar. Although, the appellant passed SDPE examination on 16/07/10995 where as Mst: Nigar Akhtar passed her SDPE examination in 1996. Therefore, she should have been considered junior to the appellant under the amended rules.

9. That the appellant soon after getting knowledge of such discrimination and violation of rules, made objection on the tentative list and requested the concerned officers for making correction.

10. That the appellant once again shocked where the Education Department issued a final seniority list vide letter No.64/A-25/SIPE(F) seniority list dated: 27/04/2020 and she was again placed junior to Mst: Nigar Akhtar which is gross violation of the available rules as well as discrimination with the appellant.

- 11. That the appellant was aggrieved from the impugned seniority list issue by the Education Department as the same is illegal and violation of the prevailing rules as well as discrimination with the applicant.
- 12. That as the appellant request was not positively entertained and no correction was made by the concerned officers, therefore, the appellant filed a departmental appeal before the competent authority bearing Diary No.2228 dated: 18/05/2020.

- 13. That soon after receiving the appeal, the appellant come to know that the respondents with mala-fide intention going to conduct another PSB meeting for the promotion of the officers at the analogy of the old formula without rectifying the previous impugned seniority list due to this reason the respondents has not given any reply of the departmental appeal even after lapse of statutory period.
- 14. That the appellant is aggrieved from the impugned final seniority list 2019 issued by the respondents and from the attitude of the respondent being not entertaing the departmental appeal had no other adequate remedy/speedy justice but to file the instant service appeal on the following grounds interalia: -

# **Grounds:**

- A. That act of the respondents is illegal, against law, facts and natural justice, hence cannot be sustained in the eye of law.
- B. That the respondents had not performed their duties according to the law and have illegally ignored the appellant's seniority by placing the junior officers from the appellant.
- C. That it is the violation of natural justice hence needs interference of this August Court.
- D. That it is against the ends of justice and gross violation of the government enacted laws and rules legislated for the purpose of giving facilities to the Government servants and also infringement of Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Transfer) Rules 1989.
- E. That the respondents have not treated the appellant in accordance with law and rules on the subject and violate the Article 4 of the Constitution of Pakistan 1973.

- F. That the respondents mala-fidely deprived the appellant from promotion being placed junior from the already junior officer Mst: Nigar Akhtar. As she completed her mandatory course later than the appellant.
- G. That other grounds if any will be raised at the time of arguments with prior permission of this Hon'ble court.



That during my entire service in Education Department, I tried my best to become fully acquainted with the modern education techniques and for this purpose, I attended all compulsory trainings and courses in time, not only for the purpose of promotion but to impart standard education to the students also.
- 4. That the Education Department vide notification No.SO(S)6-2/90/1 dated: 18/10/1994 laid down the method of recruitment, qualification and other condition as well as the promotion criteria as well.

5. That the Education Department vide Notification No.SO(S)6-2/98/service rules dated: 15/01/1999 made further amendments in Notification No.SO(S)6-2/90/1 dated: 18/10/1994 and since 1999 the subsequent amended notification shall have to be followed.

6. That the Education Department by following the same promotion criteria as mentioned in Notification dated: 15/01/1999 prepared various seniority lists on annual basis as per their requirement. Here I have annexed only two seniority lists of the year 2004 and 2006 for ready reference.

7. That by following the amended criteria for promotion as referred in Notification dated: 15/01/1999, the following formulas shall be adopted for reckoning the seniority position of the official and the same is reflected in the 2006 seniority list.

#### SENIORITY RECKONING FORMULA FROM DPE POST TO SDPE POST

- i. If SDPE degree was obtained before 1<sup>st</sup> appointment, the seniority shall be reckoned from date of 1<sup>st</sup> appointment.
- ✓ ii. If the SDPE degree was obtained after 1<sup>st</sup> appointment, the seniority of the officer shall be reckoned from the declaration of result of SDPE.
  - iii. If the date of declaration of result of SDPE of the officers were same, the seniority of the officer shall be reckoned from the date of 1<sup>st</sup> appointment.
  - iv. If the date of 1<sup>st</sup> appointment of the officers were same, the seniority of the officer shall be reckoned from the date of birth.
- 8. That despite the clear rules are available for reckoning the seniority position but I was shocked while seeing the tentative seniority list where I was placed at serial No.22 after Mst: Nigar Akhtar. Although, I passed SDPE examination on 16/07/1995 where as Mst: Nigar Akhtar passed her SDPE examination in 1996. Therefore, she should have been considered junior to me under the amended rules.

 That I soon after getting knowledge of such discrimination and violation of rules, made objection on the tentative list and requested the concerned officers for making correction.

10.That I once again shocked where the Education Department issued a final seniority list vide letter No.64/A-25/SIPE(F)seniority list dated: 27/04/2020 and I was again placed junior to Mst: Nigar Akhtar which is gross violation of the available rules as well as discrimination with me.

- 11. That I am aggrieved from the impugned seniority list issue by the Education Department as the same is illegal and violation of the prevailing rules as well as discrimination with the applicant.
- 12. That as my request was not positively entertained and no correction was made by the concerned officers, therefore, if had no other option but to file the instant departmental appeal before the competent authority.

It is therefore, humbly prayed that by accepting the instant departmental appeal, I may be placed senior to Mst: Nigar Akhtar in the seniority list and as and when the competent authority pleased to promote the officers, the undersigned may be considered senior to Mst: Nigar Akhtar.

It is further requested that in the meanwhile, no promotion order/notification of the officer from impugned seniority list may be issued, till final disposal of the instant appeal.


