JUDGMENT

AHMAD SULTAN TAREEN, CHAIRMAN:- The appellant, through the instant appeal, seeks setting aside the order dated 12.02.2020 issued by Respondent No. 3 whereby, he i.e appellant has been dismissed from service and prayed for his reinstatement into service with all consequential back benefits.



2. Factual account as offered in Memo of appeal with supporting annexures precisely tells that the Appellant, while posted as License Clerk, CLD Branch at Hripur, purportedly prepared bogus/fake license for one Farman Ali S/O Arshad Ali resident of District Attock; and owing to his said act, he was issued a charge sheet coupled with a statement describing the allegation as follows: " *That while you posted as Licenses Clerk CLD Branch, it has come to the notice of the undersigned vide preliminary enquiry No. 13 dated* 14.01.2020 conducted by Additional Superintendent of Police Haripur that you are involved in preparation of bogus/fake driving licence of Farman Ali s/o Arshad Ali r/o Demand District Attock (Cantt), who was abroad i.e. Hong Kong, without his personal appearance and driving test in licence branch. You took illegal gratification for the same and got issued license to him. Your act shows dishonesty and malafide on your part. Your action is also gross misconduct in terms of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011. Hence, charge sheeted."

Mr. Ifitikhar Ahmed, SDPO Headquarters, Haripur was appointed as Inquiry Officer. As directed in the Charge Sheet, the Appellant submitted his written defense to the Inquiry Officer. The inquiry report was submitted to the competent authority and was followed by a final show cause notice, which too was replied by the appellant. The competent authority, however, decided to impose penalty upon the Appellant. Consequently, major penalty of dismissal from service under the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 was imposed upon him. Feeling aggrieved, the appellant filed a departmental appeal before the Higher Authority, which did not raise any response and after expiry of statutory waiting period of 90 days; the present service appeal was preferred.

3. After admission of appeal for regular hearing, notice was given to respondents. They after joining the proceedings filed their para-wise reply wherein, they raised several legal and factual objections and asserted for the dismissal of the appeal with cost.

4. We have heard arguments as advanced on behalf of the parties and perused the record.

5. The arguments on behalf appellant by and large were aimed at making a case that charge of taking illegal gratification was not proved against the Appellant. The issuing of disputed license was not a job of single hand and even if there was any role attributable to the Appellant, it was not so grave so as to warrant the punishment of dismissal from his service. While concluding his arguments, he submitted that due to triviality of the appellant's role in the collective fault, the case is fit for setting aside of the impugned penalty by his exoneration from the charge.

6. On the other hand, learned District Attorney argued that the appellant has rightly been dismissed from service as he was involved in preparing fake driving licenses. Further that proper inquiry was conducted in pursuance to the charge sheet coupled with the statement of allegation duly served upon appellant. He concluded his arguments with the submission that the impugned order having been passed after fulfillment of all codal formalities does not suffer from any illegality or irregularity and asserted for dismissal of the appeal with cost.

It is evident from the statement of allegation copied above that the 7. competent authority decided to proceed against the appellant on account of the information deduced from the report of preliminary enquiry No. 13 dated 14.01.2020 conducted by Additional Superintendent of Police Haripur. The copy of said inquiry report is annexed with the written reply of respondents as reliance document. The findings in the said report are significant for determination about role of the appellant in the fateful episode; as accordingly, the process of the disputed license was not a one man doing. The findings in preliminary inquiry maintain that the constable Ali Ajlan handed over photograph and other papers pertaining to Farman Ali (disputed licensee) to Computer Operator Atif for issuing of learning chit. The latter after completing the process of learning chit and test page handed over the papers to Appellant, who deceitfully got the test of disputed licensee passed by intermixing his papers with papers of other successfully tested candidates. It was further observed in pursuance to said description of role of afore-named individuals that they all three were enlightened about the fact that disputed licensee was abroad and his learning chit was prepared from an image; and they without caring about the respect of higher officers managed the issuing of disputed driving

license deceptively, which after its printing was received by constable Ali Ajlan. The validity of the disciplinary proceedings have neither been adequately questioned before us on behalf of the Appellant nor do we find any illegality or material irregularity in such proceedings conducted against him. However, it is an irrefutable position that the inquiry report relied upon by the competent authority does not support the allegation of taking any gratification by the Appellant in lieu of his contributory role in issuing of the disputed license. Obviously, this part of allegation went unsubstantiated because of there being no evidence of such allegation during the formal inquiry. This fact is proved itself by findings of the enquiry officer who conducted enquiry against him on the charge including allegation of illegal gratification purportedly taken in lieu of issuance of disputed license. The enquiry officer fortified his findings simply by admissions of the appellant and co-accused and himself was not able to collect any evidence to substantiate the charge against appellant in totality of allegations. In view of the admissions of appellant and co-accused as discussed in the enquiry report, we hold that they collectively contributed in doings having resulted into issuance of a wrong license and as such, they are not entitled to a clean chit. Simultaneously, we having no cavil to the powers of competent authority to impose the penalty in the appellant's case on satisfaction about proof of his wrong, are of the considered opinion that the punishment imposed upon the appellant is extremely harsh and not commensurate to his guilt. The allegations were not of such a nature that it would have entailed major penalty of dismissal form service inconsiderately when there was a long unblemished service at credit of the appellant.

8. For what has been discussed above, we partially allow the appeal at hand and the impugned major penalty of appellant's dismissal from service is substituted with the minor penalty of withholding of increment for three years without cumulative effect. Consequently, the impugned order of appellant's dismissal from service is set aside with direction to the respondent No. 3 to reinstate him into service with all back benefits. It is further directed that the respondent No. 3 shall give effect to above mentioned substituted penalty under due course. Parties are left to bear their own costs. File be consigned to the record room.

Mr. Mohammad Aslam Tanoli, Advocate, for appellant is present. While being posted as License Clerk, CDL Branch, at Haripur certain allegations of preparation of Driving License of Farman Ali son of Anshed All hailing from a Village in District Attock was leveled, infact one constable Muhammad Ali handed him over the test page of the individual, on clearance the aforesaid official issued driving license by submitting bank challan. It was not in the knowledge of appellant that entry was issued without personal appearance, on inquiring about the matter it was unfolded that the driving license was handed over to him by one telephone operator. He was departmentally proceeded sans observance of the legal requirements. His dismissal from service in consequence thereof is a penalty not commensurate with the quilt. The impugned order did not delineate the reasons. Since he was not invested with any authority to conduct driving test, passing test and signing of driving license, therefore, he did not partake in the issuance of the driving license. His appeal moved to the higher authority did not yield positive hence, the present service appeal.

The point so agitated at the bar needs consideration. The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 15.02.2021 before S.B at Camp Court, Abbottabad.

PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL BOTH THE ORDER DATED 12-02-2020 OF RESPONDENT MAY GRACIOUSLY BE SET ASIDE AND APPELLANT BE REINSTATED IN SERVICE FROM THE DATE OF DISMISSAL WITH ALL CONSEQUENTIAL SERVICE BACK BENEFITS.

That appellant has rendered about 05 years service in the police department. Appellant always performed his duties with devotion, dedication and honesty and never provided a chance of reprimand. Appellant has a good service record at his credit.



 That while appellant posted as License Clerk, CDL Branch, at Haripur was served upon with a Charge Sheet alongwith statement of allegations dated 16-01-2020.
 (Copy of Charge Sheet dated 16-01-2020 is attached as annexure-"A").

- 3. That the aforementioned Charge Sheet was duly replied on 22-01-2020 explaining all facts and circumstances of the matter in detail and denying the allegations incorporated therein against the appellant being incorrect and baseless. (Copy of reply dated 22-01-2020 is attached as annexure- "B").
- 4. That thereafter the appellant was served with a Final Show Cause Notice dated 31-01-2020. (Copy of Final Show Cause Notice dated 31-01-2020 is attached annex-"C").
- 5. That above cited Final Show Cause Notice was also duly replied on 10-02-2020 explaining all facts and circumstances of the matter in detail and the allegations were flatly refuted being incorrect and baseless. **Copy of reply dated 10-02-2020 is attached as annexure-"D"**.
- 6. That ultimately the appellant was awarded with the penalty of "Dismissal from service" vide order dated 12-02-2020 by the District Police Officer, Haripur without any reason and proof. (Copy of order dated 12-02-2020 is attached as annexure-"E").
- 7. That so far as the allegation of preparation of Driving License of Farman Ali S/O Arshad Ali of Deman District



Attock is concerned, in this respect it is submitted that test page of the individual was handed to appellant by Constable Mohammad Atif (Computer Operator). On clearance of the case, Mohammad Asif received it and issued Driving License by submitting Bank Challan. The said Challan was neither filled-in nor signed by appellant. Even said Bank Challan was not stamped by appellant.

- 8. That appellant did know that LP was issued without personal appearance. When on filling of the complaint, appellant enquired from Mohammad Atif, then he disclosed that the said Driving License case was handed over to him by one Telephone Operator. The appellant had no knowledge about the matter.
- 9. That no proper departmental inquiry was conducted to prove the allegations against the appellant even then the Enquiry Officer was fully satisfied that appellant was innocent and was wrongly involved. Enquiry Officer recommended only suitable penalty to the appellant. But the competent authority awarded the appellant with EXTREME PENALTY OF <u>"DISMISSAL FROM SERVICE"</u> without giving any reason.
- 10. That during the so-called inquiry nothing could be brought against the appellant with regard to his involvement in the matter. Even the allegation of receiving gratification from anybody could not be proved against appellant. No malafiedi intention or dishonesty on the part of appellant was found during the course of inquiry.



11. That appellant knows nothing as to how the entire proceeding of preparation and passing of license was completed and by whom. Appellant had nothing to do with the driving test, passing test and signing driving license. It was the duties of higher authorities.

- 12. That the authorities conducting driving test and signing driving license are different and the appellant is the only License Clerk thus not responsible for its passing, signing and issuing.
- 13. That appellant aggrieved of the order dated 12-02-2020 of the District Police Officer Haripur preferred a departmental appeal dated 26-02-2020 before the Regional Police Officer, Hazara Region, Abbottabad but the same was not responded within statutory period of 90 days. (Copy of departmental appeal dated 26-02-2020 is attached as Annexure "F"). Hence instant service appeal, inter alia, on the following amongst others:-

GROUNDS:

- a) That impugned orders dated 12-02-2020 of the District Police Officer Haripur is illegal, unlawful against the facts, departmental rules and regulations and principle of natural justice hence is liable to be set aside.
- b) That no proper departmental inquiry was conducted. Appellant was never confronted with documentary evidence, if any, produced against him. The appellant was also not provided copy of findings if any. Even

opportunity of personal hearing was not afforded to him and the principle of natural justice was seriously violated in the matter of appellant. That the appellant is constantly without job since his dismissal from service and have no source of his livelihood.

- c) That respondents have not treated the appellant in accordance with law, departmental rules & regulations and policy on the subject and have acted in violation of Article-4 of constitution of Islamic Republic of Pakistan 1973 and unlawfully issued the impugned order, which is unjust, unfair hence not sustainable in the eyes of law.
- d) That the appellate authority has also failed to abide by the law and even did not take into consideration the grounds taken by appellant in the memo of appeal and did not responded the appeal. Thus act of respondent is contrary to the law as laid down in the KPK Police Rules 1934 read with section 24-A of General Clause Act 1897 and Article 10A of the Constitution of Islamic Republic of Pakistan 1973.
- e) That appellant had discharged his duties and responsibilities with care, caution, dedication and honesty and had left no stone unturned in performing his duties. However, the appellant has wrongly been awarded the extreme punishment of dismissal from service.
- f. That nothing could be proved perverse against the appellant during so-called inquiry with regard to his involvement in the instant case and the appellant has

been awarded punishment without any reason, cause, justification and proof.

g) That instant appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain and adjudication upon the same.

PRAYER:

It is, therefore, humbly prayed that on acceptance of instant Service Appeal order dated 12-02-2020 of the District Police Officer Haripur may graciously be set aside and appellant be re-instated in his service from the date of dismissal with all consequential service back benefits. Any other relief which this Honourable Service Tribunal deems fit and proper in circumstances of the case may also be granted.

With most reverence the following few lines are laid down before your Highness for kind consideration and favorable order:-

- 1. That while appellant posted as License Clerk, CDL Branch, at Haripur was served upon with a Charge Sheet alongwith statement of allegations dated 16-01-2020. (Copy of Charge Sheet dated 16-01-2020 is attached as "A").
- 2. That the aforementioned Charge Sheet was duly replied on 22-01-2020 explaining all facts and circumstances of the matter in detail and denying the allegations incorporated therein against the appellant being incorrect and baseless. (Copy of reply dated 22-01-2020 is attached as "B").
- That thereafter the appellant was served with a Final Show Cause Notice dated 31-01-2020. (Copy of Final Show Cause Notice dated 31-01-2020 is attached herewith as "C").
- That above cited Final Show Cause Notice was duly replied on -02-2020 explaining all facts and circumstances of the matter in detail and the allegations were flatly refused being incorrect and baseless. Copy of reply dated¹⁰-02-2020 is attached as "D").

That ultimately the appellant was awarded with the penalty of "Dismissal from service" vide order dated 12-02-2020 by the District

Police Officer, Haripur without any reason and proof. (Copy of order dated 12-02-2020 is attached as "E").

- 6. That so far as the allegation of preparation of Driving License of Farman Ali S/O Arshad Ali of Deman District Attock is concerned, in this respect it is submitted that test page of the individual was handed to appellant by Constable Mohammad Atif (Computer Operator) who requested that to get the same passed from MLA which was later on passed. On clearance of the case, Mohammad Asif received it and issued DL by submitting Bank Challan. The said Challan was neither filled-in nor signed by appellant. Even the Bank Challan was not-stamped which was affixed for DL receipts only.
- 7. That appellant was kept in darkness and not informed that LP was issued without personal appearance and photograph was also obtained without Web-Camera. When on filling of the complaint, appellant enquired from Mohammad Atif, he then disclosed that the said DL case was' handed over to him by Ali Ajlan Telephone Operator. The appellant had no knowledge about the matter.
- 9. That no proper departmental inquiry was conducted to prove the allegations against the appellant even then the Enquiry Officer was fully satisfied that appellant was innocent and was wrongly involved. Enquiry Officer recommended only suitable penalty to the appellant. But the competent authority awarded the appeellant with EXTREME PENALTY OF <u>"DISMISSAL FROM SERVICE"</u> without giving any reason if he was not agreed with the recommendation of Enquiry Officer.
- 10. That during the so-called inquiry nothing could be brought against the appellant with regard to his involvement in the matter. Even the allegation of receiving gratification from anybody could not be proved against appellant. No malafiedi intention or dishonesty on the part of appellant was found during the course of inquiry.
- 11. That appellant has rendered more than 05 years service in the police department. There has been no complaint from any corner

Respectfully Sheweth.

The respondents submit as under:-

PRELIMINARY OBJECTIONS:-

- 1. That the instant Service Appeal is not maintainable in the present form.
- 2. That the appellant is estopped by his own conduct.
- 3. That the appellant has not come to the Honorable Tribunal with clean hands.
- 4. That the appellant has suppressed material facts from the Honorable Tribunal.
 - 5. That the instant Service Appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
 - 6. That the instant Service Appeal is badly barred by law and limitation.
 - 7. That the appellant has filed the instant service appeal just to pressurize the respondents.
 - 8. That the orders passed by the authorities are based on facts & rules, after fulfilling all the codal formalities, hence, the appeal is liable to be dismissed without any further proceeding.

REPLY ON FACTS:-

1. Incorrect, appellant Ex-Junior Clerk Mudassir Hussain Abbasi, was posted as License Clerk at CDL, Branch District Haripur, Consulate General of Pakistan in Hong Kong made a complaint at Pakistan Citizen Portal, (PMDU) regarding the issuance a driving license No. (105000037662) to person namely Farman Ali r/o Deman, District Attock who was at Hong Kong and did not travel Pakistan. It was complained that the said license was issued without personal appearance of above mentioned candidate before the license issuing authority. (Copy of complaint is attached as

annexure "A"). The matter was probed in preliminary inquiry through Additional SP Haripur. He conducted inquiry and submitted his findings in which he held the appellant, computer operator constable Muhammad Atif, No.359 and telephone operator Ali Ajlan No.744, responsible for issuance of fake license and recommended them for departmental action. (Copy of Consequently, the preliminary inquiry is attached as annexure "B"). appellant was issued charge sheet and statement of allegations, by the then District Police Officer, Haripur vide office Endst: No.14-16/PA dated 16.01.2020. (Copy of charge sheet with statement of allegations is attached as annexure "C"). Deputy Superintendent of Police, Headquarters Haripur Mr. Iftikhar Ahmad was appointed as enquiry officer, who conducted proper departmental enquiry and submitted his findings vide his office Memo. No.19 dated 30.01.2020, in which he held the charges proved and recommended the appellant for appropriate punishment. (Copy of inquiry finding is attached as annexure "D"). Consequently, the appellant was issued final show cause notice by the then District Police Officer, Haripur, vide this office Endst: No.45 dated 31.01.2020. (Copy of final show cause notice is attached as annexure "E"). The appellant could not give satisfactory reply of final show cause notice and he was called in orderly room for personal hearing. The appellant failed to adduce any defense. Therefore, being found guilty of misconduct the appellant was awarded major punishment of dismissal from service by the then District Police Officer, Haripur vide OB.No 114 dated 12.02.2020. (Copy of dismissal order is attached as annexure "F"). The appellant file departmental appeal against the punishment order to the Regional Police Officer, Hazara Region, Abbottabad, who filed the same vide order No.12828/PA dated 04.06.2020. (Copy of departmental appeal and order is attached as annexure "G").

- 2. Appellant has indifferent record. During service his performance was not up to the mark.
 - 3. Correct to the extent that the appellant was issued charge sheet as he committed gross misconduct, for which he was proceeded against departmentally.
 - 4. Incorrect, the appellant could not give satisfactory reply of charge sheet. Rather, the charges of misconduct were proved through strong evidence.
- 5. Correct to the extent that the appellant was held guilty in the departmental inquiry and recommended for appropriate punishment, thus he was served with final show cause notice under the rules.
- 6. Incorrect, the appellant could not give satisfactory explanation of final show cause notice and he also failed to prove his innocence during his personal hearing in orderly room. The charges of misconduct were proved beyond
 any doubt.
 - 7. Incorrect, the appellant was held guilty of gross misconduct. Therefore, he was awarded major punishment of dismissal from service on lawful ground, evidence and justification. Moreover, the punishment is quite legal and commensurate with the proved charges.

The matter was thoroughly probed and appellant and his accomplices were held guilty. Therefore, they were awarded punishment in accordance with law.

- 9. Incorrect, the appellant earned bad name for the country. He made driving license of Farman Ali without observing the procedural formalities. He in connivance with his staff prepared the driving license. The allegations were probed in preliminary as well as in regular departmental inquires, wherein the appellant and his staff members were held guilty by the inquiry officer.
- 10.Incorrect, proper departmental inquiry was conducted. The appellant was
 given right of personal hearing and self defense. He was held guilty of
 misconduct through strong evidence and charges were proved, hence, he was
 awarded lawful punishment of dismissal from service.
- 11.Incorrect, the appellant issued the license for illegal gratification. He misused his lawful authority and committed gross misconduct. His guilt was proved beyond any doubt. He was awarded punishment on quite legal grounds. Moreover, he defamed the department and country. It was his dishonesty and melafide in discharge of official duties that he did not observe the legal requirements while issuing driving license to a person residing abroad.
- 12.Incorrect, the appellant in coordination with his staff member prepared the driving license. The appellant is adducing false plea. He wants to cheat the authorities. He was held guilty for issuance of driving license to the above mentioned person. He is responsible for issuance of license. He is not innocent; rather, his guilt was proved in the departmental inquiry.
 - 13.Incorrect, the appellant preferred departmental appeal against the order of punishment before the Regional Police Officer, Hazara Region, Abbottabad,
- who filed departmental appeal vide office order No.12828/PA dated 04.06.2020. Moreover, instant service appeal is time barred and not maintainable under the law of limitation interalia on the following grounds.

REPLY ON GROUNDS:-

- A) Incorrect, the order of respondents dated 12.02.2020 and 04.06.2020, are quite legal, based on facts and justice, hence, the orders are lawful and maintainable.
- B) Incorrect, the appellant has been dealt in accordance with law. Proper departmental inquiry was conducted, the appellant was given right of personal hearing, self defense. The appellant could not prove his innocence. He was awarded punishment of dismissal from service on lawful grounds and evidence. Hence, all legal requirements were fulfilled while passing order of punishment to the appellant.

- C) Incorrect, the appellant was dealt in accordance with law/rules. The punishment is lawful and maintainable. Detail reply already given in parasibid.
- D) Incorrect, the departmental appellate authorities abide by the law/rules while disposing of departmental appeal of the appellant. The appellant was held guilty of misconduct through strong evidence. Therefore, his departmental appeal was filed on lawful grounds and evidence.
- E) Incorrect, the appellant committed gross misconduct. His dishonesty, cheating and melafide in official duties were transpired as he prepared driving license without following the legal requirements. So, he was awarded punishment which commensurate with gravity of charges.
 - F) Incorrect, the appellant held guilty of misconduct in the departmental inquiry. There was strong evidence which proved the charges of misconduct against the appellant, hence, he was awarded lawful punishment.

G) Incorrect, the service appeal is badly barred by law and limitation and not maintainable under the law/rules.

FINAL SHOW CAUSE NOTICE

I. Dr. Zahid Ullah, (PSP), District Police Officer, Haripur as Competent Authority under Police Rules 1975, do hereby serve Final Show Cause Notice upon you JC Mudassar Hussain Abbasi on the following grounds: -

"That while you posted as Licenses Clerk CDL Branch, it has come to the notice of the undersigned vide Preliminary enquiry No. 13 dated 14.01.2020 conducted by Additional Superintendent of Police Haripur that you are involved in preparation of bogus/fake Driving license of Farman Ali s/o Arshad Ali r/o Deman District Attock (Čanti), who was abroad i.e, Hong Kong, without his personal appearance and driving test in license branch. You took illegal gratification for the same and issued license to him. Your act shows dishonesty and malafide on your part. Your action is also gross misconduct in term of the Khyber Pakhtankhwa, Government Servant, Efficiency & Discipline Rules 2011."

(1) For the purpose of scrutinizing the conduct on your part with reference to the above allegation, you was serve with Charge Sheet/Statement of allegation and Additional Superintendent of Police, Haripur was appointed as enquiry officer against you for the conduct of proper departmental enquiry vide this office Memo No. 14-16 dated 16.01.2020.

(2) The enquiry officer after conducting proper departmental enquiry submitted his finding vide his office tetter No. 19 dated 30.01.2020, in which he had the charges of misconduct proved and recommended for suitable punishment under section-4 of the EPK Police E&D Rules 1975.

(3) Keeping in view of above allegation on your part, you are hereby called upon. To Show Cause within (07) days of the removed of this Final Show Cause notice as to why you should not be awarded punishment under the Police Rule 1975, if your written reply is not received with in stipulated period. It shall be presumed, that you have no defense to affirm, you are also allowed to appear before the undersigned, if you desired.

With reference to your worthy office Charge Final Show Case Notice No. 45 dated 31/01/2020, I submit my reply here to your office as per rules:-

(2) During my entire service I did not availed any sort of earned leave, absence from duty or any sort of complaint and remained posted as Steno to SDPO HQrs and Ghazi as well for the periodof 05years approximately.

(3) As far as Driving License of Farman Ali s/o Arshad Ali r/o Deman District Attock is concerned, the test page of the individual was handed over to me by a computer operator Muhammad Atif with the request to get pass the case from MLA which was later on passed.

(4) On receipt of compliant, I enquired the matter from Atif who stated that mentioned DL case was handed over to him by Ali Ajlan telephone operator.

(5) After clearance of the case, Atif received back the same case and subsequently, issued DL after submitting Bank Challan which was not filled in by me. Stamp on Bank Challan is off that which is used for DL receipts only and handwriting on it is also not mine.

(6) It is pertinent to mention here that computer operator did not informed me that LPwas issued without his personal appearance and photo of individual was obtained without Web-Camera.

(7) Charges of taking illegal gratification are baseless & fictitious as I did not demanded or taken any sort of amount from Atif or anyone else.

(8) No malafide intention or dishonesty is on my part as I offered by services devotedly and efficiently, and not even a single complaint is available againstme except this during my whole service career.

In eve of above facts and circumstances, it is most earnestly requested that I may kindly be exonerated from the charges and instant Charge Sheet and Summary of allegation may kindly be treated asfiled.

<u>ORDER</u>

Junior Clerk Mudassar Hussain Abbasi, while posted as License Clerk. CDL Branch District. Haripur. It came to the notice of the undersigned vide, preliminary enquiry No.13 dated 14.01.2020, conducted by Mr: Zulfiqar Khan Jidoon Additional Superintendent of Police, Haripur, that he was found involved in Preparation of bogus/fake Driving License of Farman Ali s/o Arshad Ali r/o Deman District Attock (Cantt), who was abroad in Hong Kong. JC Mudassar Hussain Abbasi prepared his Driving License without his personal appearance and driving test in license branch. He took illegal gratification for issuance of driving license. The acts and omissions of defaulter official were misconduct under the Government Servants Khyber Pakhtunkhwa. Efficiency and Discipline Rules 2011. Hence, he was charge sheeted, vide this office Endst: No.14-16/PA dated 16.01.2020.

To probe the matter, Deputy Superintendent of Police. Haripur Mr. Iftikhar Ahmed was appointed as Enquiry Officer, who conducted proper departmental enquiry and submitted his findings, vide his office Memo No. 19 dated 30.01.2020. The charges of misconduct were proved against the accused police official. Therefore, enquiry officer recommended him for appropriate punishment. Hence, he was issued final show cause notice vide this office Endst. No.45/ PA dated 31.01.2020. So, he was called in Orderly Room for personal hearing and was heard in detail, but he could not give any plausible ground or justification in his defense.

Having perused the finding of the enquiry officer, relevant record and personal bearing of appellant, the charges of misconduct are proved against the defaulter police official. Therefore, I, Dr. Zahid Ullah (PSP), District Police Officer, Haripur being competent authority under the Government Servants Khyber Pakhtünkhwa, Efficiency and Discipline Rule 2011, am fully satisfied that Junior Clerk Mudassar Hussain Abbasi committed misconduct. Therefore, he is awarded major punishment of "DISMISSAL FROM SERVICE" with immediate effect.

ORDER

This order will dispose off departmental appeal under Rule 17-1 of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 submitted by Ex. Junior Clerk Mudassar Hussain Abbassi of District Haripur against the punishment order i.e. *Dismissal from service* awarded by DPO Haripur vide OB No.114 dated 12.02.2020.

Brief facts leading to the punishment are that it came to the notice of the Competent Authority that the appellant while posted as License Clerk at CDL branch, Haripur involved himself in preparation of bogus/fake driving license of a person namely Farman Ali r/o Deman, district Attock (who was in Hong Kong) without his personal appearance and driving test. The appellant took illegal gratification for issuance of DL.

The appellant was issued charge sheet alongwith summary of allegations and DSP Hqrs was deputed to conduct departmental enquiry. The EO held the appellant responsible of misconduct. The appellant was issued Final Show Cause Notice and heard in person, however he failed to advance any cogent reason in his defence. Consequently, DPO Haripur awarded him major plinishment of dismissal from service.

After receiving his appeal, comments of DPO Haripur were sought and examined/perused. The undersigned called the appellant in OR and heard him in person. However the appellant failed to advance any plausible justification in his defence. Moreover, the misconduct perpetrated by the appellant is intolerable in a disciplined force as such acts tarnish the image of Police. Therefore in exercise of the powers conferred upon the undersigned under Rule 17-2 (a) of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 appeal of the official is hereby *filed* with immediate effect.
