2. That since the appointment till now Appellant is the only Teacher in the school and is performing her duties honestly and to the entire satisfaction of the supervisors.
3. That for the last 13 years no complaint was ever made by any inhabitant of the illaqa and similarly any Higher Authorities too and no complaint against the Appellant is available.
4. That on 09/02/2011 being seriously ill Appellant rushed to Abbottabad for medical check up and she also made arrangement of the School and an educated young lady of the village was deputed by the appellant to look after the students in her absence.
5. That on 09/02/2011 ADEO (Female) Abbottabad visited the School and at that time School was found close by the Officer so she made a complaint against Appellant to EDO (Female) Abbottabad and

when Appellant came to know about this, she visited the office of the DDO (Female) Abbottabad and submitted a medical Certificate and also explain her position of absence from the School.

6. That the salary of the appellant since 01/02/2011 to 31/08/2011 was not given to the appellant and for this appellant repeatedly requested the Higher Officer but no action was taken so for.

7. That ADEO (Female) Primary Inspection Abbottabad called the explanation about the absent from duty on 09/02/2011 and the appellant submitted the reply on 28/04/2011 and the Officer ADEO (Female) primary being satisfied from the explanation passed the order on 28/04/2011 for the release of the salary of the appellant but not action have been taken so for.

8. That the appellant submitted a presentation to EDO Abbottabad for the release of the salary but the Petition was rejected and the impugned order was

9. That appellant being highly aggrieved from the order of EDO Abbottabad of dated 09/02/2012, submitted an appeal to the DCO Abbottabad for setting aside the order of EDO No.1617-20 dated 09/02/2012. But till now no reply have so far been made by the learned DCO Abbottabad.

10. That now there remains no other remedy except to approach this Honourable Tribunal for the following amongst other grounds:-

GROUNDS:-


a) That the Order of 09-02-2012 of respondent No.3 is against the facts, law and rules. Thus the Order is not maintainable in the eye of law.

b) That appellant is serving as a single Teacher in the Government Girls Primary School Mohri Mera for the last 13 years and not a single complaint was ever made against the Appellant.

c) ²⁰¹¹ That only on 09-02-2012 when the Appellant was seriously sick and went to the Doctor for treatment only at this occasion she was found absent although appellant submitted the Medical Certificate in support of her version which was found correct by the ADEO (Female) Primary Education Abbottabad and recommended for the release of the salary of the Appellant.

d) That the Appellant regularly remained in the above cited school and performed her duties honestly from 01-02-2011 to 31-08-2011 and was never charge sheeted or warned by the Higher Officer. So, treating the period from 01-02-2011 to 31-08-2011 as extraordinary leave without pay is against justice, law and rules and this observation of the Higher Authority is not sustainable and is against the principle of Audi Altrum Partum (No one should be condemned unheard).

3. The learned counsel for the appellant argued that the impugned order was passed without any inquiry under the Khyber Pakhtunkhwa Government Servant (Efficiency and Disciplinary) Rules 2011. That no order could be passed without following the procedure laid down under the rules mentioned above.

4. On the other hand, the learned Deputy District Attorney, argued that the present appeal is time barred and secondly the departmental appeal was addressed to in incompetent authority. He further argued that the appellant herself admitted her absence by filing an affidavit.

CONCLUSION.

5. The delay of four days could not be taken to defeat the appeal of the appellant for the reason that the order was passed on 09.12.2012 and there is no proof of the fact that it was communicated to the appellant on the same day. It definitely takes few days to reach the aggrieved civil servant, therefore, this departmental appeal cannot be held to be time barred. Secondly the departmental appeal was submitted to the DCO. Under the Khyber Pakhtunkhwa Civil Servant (Appeal) Rules, 1986 the departmental appeal is to be made not to the appellate authority but in the office in which the appellant is serving. It is for the office to send the departmental appeal to the concerned authority if he himself is not the appellate authority (Rule-4). The DCO at the relevant time did figure in the hierarchy of the department. He should have referred the appeal to the appellate authority, if he himself was not the appellate authority. Admittedly, the department has not initiated the proceedings under the Khyber Pakhtunkhwa Government Servant (Efficiency and Disciplinary) Rules 2011. The proper procedure for the department was to have initiated the regular proceedings under the Rule-5 or under Rule-9 of the said rules. The competent authority could not decide the same on the basis of any affidavit by the appellant.
