



SUBHAN SHER, CHAIRMAN:-

Brief history stated here necessary for the disposal of the appeal in hand is, Khyber Daking hima

that the appellant was initially appointed against the T.T post vide office order No. 4102-31, dated 25.08.2007, against a vacant seat in GHS, Sia Warghar, Timergra,

District Dir (Lower). In the appointment order mentioned above, his name

appeared at S.No. 11 in merit list prepared by the Departmental Selection

Committee. However, when he approached the above named school for

assumption of charge, there he was told that no post of T.T was lying vacant, so

he rushed to the office of E.D.O (M) E&SE, Dir Lower and appraised the

authorities about the said situation. As per his version, instead of issuance of corrigendum for the purpose of posting him somewhere else, against a vacant T.T post, the said E.D.O asked the Headmaster, Sia Warghar to hand over charge of a T.T post to the appellant. So, in the light of that direction, he took over charge on 16.09.2007 instead of 26.08.2007.

- 2. On 28.05.2013, respondent No. 2 i.e. Director, Elementary & Secondary Education, Khyber Pakhtunkhwa, Peshawar issued promotion order under upgradation to the post of Senior T.T to all other colleagues of the appellant, including junior to him, however, he was not considered as his date of assumption was considered w.e.f 16.09.2007 instead of 26.08.2007. However, during pendency of the appeal, the respondents promoted the appellant as Senior T.T but with immediate effect i.e. 03.02.2017 and the appellant being aggrieved, assailed his promotion w.e.f. 23.05.2013. He preferred departmental appeal before the competent authority which was responded in one line that the said office was unable to consider his appeal due to non-availablity of post of BPS-16. The appellant compelled to approach this Tribunal for redressal of his grievance.
  - 3. Arguments heard and file perused.
  - 4. M/S Muhammad Yar Malezai and Abdul Hakeem, Advocates, learned counsels for the appellant contended that the respondents wrongly and illegally did not consider the appellant for promotion and even juniors to him were promoted which is against his rights. Further contended that the appellant could not assume the charge for the reason which was beyond his control and the same was very much brought into the notice of concerned authority and so he cannot be punished for late assumption of charge, if any. They requested that the promotion order dated 03.02.2017 be modified to the extent that it be given effect from 28.05.2013.

Mr. Muhammad Jan, Deputy District Attorney assisted by Mr. Azizur Rahman, PST opposed the contentions of the learned counsels for the appellant and stated that the appellant did not challenge charge report and remained silent for sufficient time. Further contended that promotion given to the appellant under the policy of upgradation, so neither he is entitled to the said promotion being junior, nor this Tribunal has the jurisdiction to entertain his request. Finally, he requested for dismissal of the appeal.

- 6. From perusal of the available record, it appears that the appellant has succeeded in making out a case for interference by this Tribunal under its appellate jurisdiction to the extent of date of assumption of charge viz-a-viz discrimination committed on the part of respondent No. 2 while issuing the impugned promotion order dated 28.05.2013 as is evident from the discussion given below.
- As already stated, after issuance of appointment order, the appellant was directed to take over the charge of the post of T.T at GHS Sia Warghar but when the appellant approached the said school, he was told that no post of T.T was lying here, so he came back to the office of respondent 3 i.e. EDO(M) E&|SE, Dir (Lower) and disclosed the reason mentioned above. In short, respondent No. 3 was obliged either to post him somewhere else or ask the Headmaster of GHS Sia Warghar to hand over the charge of the post of T.T to the appellant in time, which he did on 16.09.2007. So from this late submission of charge, it is proved that there was no fault on the part of the appellant and for that matter, he cannot be blamed/punished.
- 8. Apart from this, from perusal of impugned initial appointment order dated 25.08.2007 issued in the light of merit list, the appellant figured at S.No. 11

14-12 CV 2/4/2

whereas one Shafiq Zada is at the very bottom of the list i.e S.No. 23 but at the time of promotion, all the remaining juniors were considered for the reason that at that time, their posts were vacant and they had assumed the charge on time. Needless to mention here that seniority could be assessed on the basis of merit list prepared by the Departmental Selection Committee as per Rule 17 Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 and not on the strength of assumption of charge. So on this score too, the appellant is entitled to have been considered for promotion.

- 9. The crux of the above discussion is that after taking into consideration the arguments of the learned counsel for the parties, and going through the available record, this Tribunal reached to the conclusion that the appellant is squarely entitled to the promotion alongwith his colleagues, irrespective of the date of assumption of his charge.
  - 10. So far as the relief sought in respect of upgradation is concerned, this Tribunal, in the light of judgment of august Supreme Court of Pakistan, has already disposed off such matters being fall beyond jurisdiction of this Tribunal. So, the appellant may approach the competent forum, if so advised. With the above observations, the appeal in hand stands disposed off accordingly. Parties are left to bear their own costs. File be consigned to the record room.

Appeal (amended) under section 4 of Khyber Pakhtunkhwa Service Tribunal Act 1974 against the notification dated 28/05/2013 & final order dated 06/074/2013, whereby the departmental appeal of the appellant for the grant of promotion / up gradation to the post of Senior TT (BPS-16) has been rejected, communicated to the appellant on 09/07/2013.

#### PRAYER IN APPEAL

On acceptance of this appeal the notification dated 28/05/2013 & order dated 06/07/2013 may please be varied/ modified to the extent that the respondents No.1 to 3 may be directed to consider the appellant for promotion to the post of Senior TT (BPS-16) w.e.f 28/05/2013 i.e. the date when his juniors / colleagues were promoted with all back benefits.

### Respectfully Sheweth:

This is the amended appeal as per order of this Hon'ble Tribunal dated 04/01/2017 is stated as under: -

T.C.

- 1. That the appellant was initially appointed as TT (BPS-14) after recommendation of the district recruitment committee vide order dated 25/08/2007 against the vacant post at GHS Siawarghar, District Dir Lower. (Copy of the appointment order is attached as annexure "A")
- 2. That though the appellant was appointed against the vacant post, however when he submitted his charge report it was not accepted for the reasons that the said post was not vacant and was occupied by one Inayat-ur-Rehman. He was only handed over charge of his post on 15.09.2007, when the post was vacated by the said Inayat-ur-Rehman. (Copies of the order dated 06.09.2007, reliving chit and charge report and service book are attached as annexure B, C, D & E).
- 3. That during the course of his service the post of the appellant was also up graded from TT (BPS-14) to TT (BPS-15) and is presently serving as such.
- 4. That the Provincial Govt: has vide Notification dated 11.07.2012 accorded sanction to the up gradation of the post in different cadres of Teacher in Elementary and Secondary Education Department. Accordingly 1/3 of the total TT posts were upgraded and re-designated as TT (BPS-16). (Copy of the notification dated 11.07.2012 is attached as annexure "F")
- 5. That in pursuance of the above notification dated 11.07.2012, the promotion of TTS (BPS-15) to the post of Senior TT (BPS-16) were made vide notification dated 25.05.2013, whereby junior / colleagues those who were

appointed with the appellant vide the same order were promoted, however the appellant was not considered for promotion despite his eligibility and fitness. (Copies of the working paper and promotion notification dated 28.05.2013, is attached as annexure "G & H")

- that since he has taken charge of his post on 16.09.2007, therefore, his first appointment dated is mentioned as 16.09.2007 instead of 25.08.2007. It is pertinent to mention that there was no fault on part of the appellant in taking over charge of his post, he duly reported for duty but he was not handed over the charge of his post, rather when he approached the then E.D.O (E& SE) Dir Lower, he directed the concerned Principal vide note on the appointment order of the appellant that he be handed over charge on 15.09.2007.
- 7. That the appellant submitted his departmental appeal dated 11.06.2013, however, it was also rejected vide order dated 06.07.2013, communicated to the appellant on 09.07.2013. (Copies of the departmental appeal dated 11.06.2013 and rejection order dated 06.07.2013 are attached as annexure "I & J")
- 8. That not allowing promotion / upgradation to the appellant is illegal unlawful against law and facts and is discriminatory inter alia on the following grounds:-

#### **GROUNDS:**

A. That the appellant has not been treated in accordance with law, the respondent have not

followed the law and rules governing promotion / up gradation, hence valuable rights secured and granted to the petitioner under the law are badly violated.

- B. That the appellant was initially appointed as TT on regular basis vide order dated 25/08/2007 thus the appellant is perfectly eligible for the upgradation, the denial of promotion to the appellant is illegal and unlawful.
- C. That the appellant has an inalienable right to be treated in accordance with law and should have equal protection of law thus on no ground what so ever this benefits should be denied to him.
- D. That there was no fault on part of the appellant, delay in taking charge of his post, he duly reported for duty after his appointment but he was not handed over the charge of his post due to the reason that the said post was not vacant. Thereafter, the then EDO (E&SE) Dir Lower, has written on the appointment order of the appellant that he be handed over charge on 15.09.2007, thus the appellant cannot be denied promotion on this ground.
- E. That it is pertinent to point out there that since the selection of the appellant was made pursuant to a test and interview hence he should be assigned

seniority in the order of merit and not from the taking over charge.

- F. That the respondents have for the first time prepared seniority list when they considered the cases for upgradation, thus no question of his seniority was previously raised, nor prepared previously.
- G. That despite fit and eligible, the appellant has been ignored promotion while junior to him were promoted, thus accrued rights of the appellants have been infringed.
- H. That the appellant being fit and eligible has thus got every right to be considered for promotion to the post of Senior TT BPS-16, albeit has been ignored illegally.
- I. That not considering the appellant for promotion by the respondents is arbitrary, whimsical and not in accordance with the law and rules governing the subject but for consideration extraneous to the service norms and rules governing promotion.
- J. That the respondents have not followed the law and has based its order on no material rather seems to have bent upon accommodating the blue eyed junior officials.
- K. That since similarly placed employees have been given promotion while the appellant has been denied the same which is highly discriminatory and also against the law.

L. That the appellant seeks the permission of this Hon'ble Tribunal to rely on additional grounds at the hearing of this appeal.

It is therefore, prayed that on acceptance of this appeal both the notification dated 28.05.2013 & the order dated 06.07.2013 may please be varied/modified to the extent that the respondents may be directed to consider the appellant for promotion to the post of Senior TT (BPS-16) w.e.f 28.05.2013, i.e. the date when his juniors/colleagues were promoted with all back benefits and arrears.
