- 1. That vide judgment and order dated 21-12-2015 passed by this Hon'bleTribunal, the order with regard to removal from services of the petitioner dated 15-9-2014 was set-aside and the services of the petitioner were re-instated with the directions to the respondents department to proceed afresh if deemed appropriate. Copy of the judgment and order of this Hon'ble Tribunal is attached herewith as Annexure-A.



ENQUIRY ON SUSPENSION OF MRS. RUKHSANA JAMIL, SWEEPER, ENVIRONMENT DEPARTMENT

On 8/8/2014 the competent authority i.e Secretary, Environment Department checked the presence and performance of the sweeper of Environment Department and found the hygienic system in poor condition. The competent authority has taken serious notice and directed to suspend the concerned sweeper. Consequently, after approval of the competent authority the services of Mrs. Rukhsana Jamil, sweeper were suspended vide Office Order No: SO(G)/ED/6-56/11/Rukhsana Bibi, dated 13/8/2014 and Mr. Muhammad Fayaz, Section Officer (Environment), Environment Department was nominated as Inquiry Officer to conduct an Inquiry and submit his report within 15 days (F/A).

Proceedings:

The inquiry Officer started his proceedings and at first instant Mrs. Rukhsana Jamil, Sweeper. Environment Department was directed to attend the office of the Inquiry Officer on 19/8/2014 for recording her statement (F/B). Accordingly, Rukhsana Jamil, Sweeper attended the office of Inquiry Officer on 20/8/2014 and given her written statement, wherein she stated that she is performing her duties as a Sweeper from 10/5/2007 with full concentration. She further stated that on 8/8/2014 due to illness, she did not attend the duty for which she is regretful and stated that no such mistake will be made in future (F/C).

The Inquiry Officer directed Mr. Jamil (husband of Rukhsana) to submit his written statement to the Inquiry Officer (F/D). Mr. Jamil stated in his statement that his wife is performing her duty as sweeper but due to her illness on 8/8/2014, she did not attend the duty and I also could not attend the duty due to her illness and stated that he is regretful and no such mistake will be made in future (F/E).

The Inquiry Officer also requested the Section Officer (General), Environment Department to submit his written statement to the Inquiry Officer within two days positively (F/F). In reply the Section Officer (General), Environment Department has furnished his statement (F/G) wherein he stated that Mrs. Rukhsana Jamil wife of Saleem Masih was appointed as sweeper on a fixed pay of Rs. 25,00/- per month on 23/5/2003 (F/H) and the services of the said sweeper were regularized on 10/5/2007 (F/J). He further stated that the said Rukhsana Jamil would not attend the office and her husband namely Saleem Masih would attend her duty. He further added that the sweeper was persistently asked to not to leave from duty during office hours but he neglected the instructions of the Section Officer (General), Environment Department. He was also time and again instructed to carry out sanitation of the Department properly so much so that on various occasion the Section Officer (General), Environment Department himself accompanied him but he failed to do so.

Findings:

- 1). Mrs. Rukhsana Jamil, sweeper admitted the fact that on 8/8/2014 due to illness, she did not attend the duty and no proper application for leave had been submitted to this effect, which is negligence on her part.
- 2). Mr. Jamil (husband of Rukhsana) has admitted that due to the illness of his wife he also could not attend his wife's duty.

- 3). As per statement of Section Officer (General), Environment Department the said sweeper Jamil Masih (husband of Rukhsana) was determinedly directed to not leave the office during office hours but he neglected the instructions of the SO (G). He was also time to time instructed to carry out sanitation of the department properly and on various occasions the SO (G) himself accompanied him but he failed to do so.
- 4). It was also observed that at the time of appointment her name was Rukhsana Saleem and according to the marriage certificate now her name is Rukhsana Jamil (F/K).
- 5). There is nothing on the Office Administration record as to who had authorized Mr. Jamil Masih (husband of Rukhsana) to perform the duty of his wife since her appointment till date.

Recommendations:

Rukhsana Jamil (sweeper) has never attend her official duty and her husband Jamil Masih performing the duty of her wife was also avoid the order of Section Officer (General), Environment Department Therefore, the undersigned is in view that major disciplinary action may be taken against Rukhsana Jamil sweeper under the Section-4(b)(iii) Khyber Pakhtunkhwa (Efficiency and Discipline) Rules. 2011 (F/L).

- One Rukhsana Bibi wife of Saleem Masih of Yakatooth, Peshawar City was appointed as sweeperess on a fixed pay of Rs. 25,000/- per month on 23-05-2003. Before change of her name she was Naseem Bibi vide newspaper cutting and affidavit on 30 rupees. The services of Rukhsana Bibi were regularized in BPS-I by the Environment Department vide office order dated 10-05-2007. Since her appointment and subsequent regularization of her services, the said Rukhsana Bibi would not attend the office and her young husband namely Saleem Masih would attend to her duty.
- On 08-08-2014 at about 9 am, the presence and performance of the sweeper in the Department was checked by the competent authority and found him absent from duty. The lack of sanitation was also noticed by the competent authority and ordered to immediately suspend the sweeper for negligence of duty.
