RESPECTFULL SHEWETH.

PRELIMINARY OBJECTIONS.

- 1. That the appellant has got no cause of action.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- 3. That the Appellant has been estopped by his own conduct to file the appeal.
- 4. That the appeal is time barred.

FACTS.

- 1. Pertains to record.
- 2. Incorrect. As the appellant was appointed as Naib Tehsildar on 22.01.2009, therefore Rules of 2001 and 2008 are not applicable upon the appellant.
- 3. Correct to the extent that the appellant was appointed as Naib Tehsildar on 22.01.2009.
- 4. As discussed in Para 2 & 3. The appellant was appointed as Naib Tehsildar on 22.01.2009. Under the rules he become eligible for promotion as Tehsildar after 05 years in case of availability of posts, because Naib Tehsildar shall be promoted as Tehsildars having 05 years' service as such. Since the prescribed length of service was not completed by the appellant, hence was not eligible for promotion as Tehsildar.
- 5. Incorrect. Neither he was eligible nor he was discriminated at any stage. The appellant was promoted as Tehsildar and lateron elevated to the cadre of PMS BS-17 as per law/rules.
- 6. Incorrect. The post of Naib Tehsildar and Sub Registrar are in BPS-14 and have equal rights of promotion, therefore included for promotion to the post of Tehsildar as per joint seniority list.
- 7. Incorrect. The promotion quota of Naib Tehsildars was enhanced from 50% to 60% for promotion as Tehsildar as per joint seniority list of Naib Tehsildar, District Kanungo, District Revenue Accountant and Sub Registrar.
- 8. As in Para-6 & 7 above.
- 9. Incorrect. The promotion notification of those Tehsildars was withdrawn who were not graduate.
- 10. Correct to the extent that the provision of graduation was deleted with the approval of the SSRC as well as Chief Secretary Khyber Pakhtunkhwa and was notified on 23.01.2015.
- 11. As in Para 7, 9 and 10 above.
- 12. Incorrect. As there were no regular vacancies at that time therefore, the appellant was promoted as Tehsildar on Acting Charge Base.
- 13. Correct. On availability of regular posts, the appellant alongwith other was promoted as Tehsildar BS-16 on regular basis.
- 14. Incorrect. The appellant was promoted as Tehsildar on 17.01.2019 and then PMS BS-17 on 02.07.2020 on his own turn and as per availability of regular vacancy.

15. Incorrect. All the proceedings have been carried out according to law/rules and no discrimination has been done with appellant.

- 16. As in Para-15 above.
- 17. Incorrect. The application of the appellant has been examined in the Department and filed by the appellate authority (Chief Secretary) strictly on merits.
- 18. Correct to the extent that Writ Petition of the appellant was dismissed by the Peshawar High Court.
- 19. Incorrect. Appeal of the appellant is not maintainable being time barred.

GROUNDS

- A. Incorrect. The officials of other categories were also in same grade i.e. BS-14 and not to be called as Ministerial Staff, therefore all the proceeding were carried out as per law/rules.
- B. Incorrect. No violation of Article 25 of the Constitution of Islamic Republic of Pakistan was committed.
- C. Incorrect. No violation of Article 4 of the Constitution of Islamic Republic of Pakistan committed.
- D. Incorrect. Verdict of the Apex Supreme Court of Pakistan quoted by the appellant is not applicable in the instant case.
- E. Incorrect. Incumbents of the other cadres who were eligible for promotion were promoted as Tehsildar strictly in accordance with law/rules as per their seniority.
- F. Incorrect. Incumbent of other cadres were promoted as Tehsildars strictly in accordance with law/rules.
- G. Incorrect. The provision of graduation was deleted after conducting the SSRC meeting and all the promotions were made with the approval of the Competent Authority through proper DPC.
- H. Incorrect. Seniority of the appellant has not been affected as all the proceedings were carried out in a fair and transparent manner, strictly following the rules.
- 1. Incorrect. Promotion always is made on seniority cum fitness basis and on availability of posts.
- J. Incorrect. The appellant has been promoted as Tehsildar and then PMS on his own turn in accordance with law/rules.
- K. Incorrect. The proceeding were carried out strictly in accordance with law/rules.
- L. Incorrect. Promotion of all the incumbents have been made in accordance with rules and the Department has shown no malafide.
- M. Incorrect. The appellant has been treated accordance with law/rules.
- N. Incorrect. This Tribunal has jurisdiction to entertain and dispose off the case on its merit and according to law/rules.
- O. Incorrect. The appellant has been treated in accordance with law and no discrimination has been done with the appellant.
- P. The respondents will also argue other additional grounds at the time of arguments.

Keeping in view the above, the appeal of the appellant having no legal grounds may very graciously be dismissed with costs.

They shall, for all intents and purposes, be Civil Servants except for purpose of pension or gratuity.
