Respectfully Sheweth:

The Respondents 1-3 submit as under:-

PRELIMINARY OBJECTIONS.

- 1 *That* the Appellant has got no cause of action/locus standi.
- **2** *That* the Appellant has not come to this Honorable Court with clean hands.
- 3 That the appeal in hand is based on mala fide intentions for illegal service benefits.
- **4** *That* the appellant has concealed material facts from the knowledge of this Honorable Tribunal in the titled matter.
- **5** *That* the case is bad for mis-joinder and non-joinder of the nessacery parties to the appeal.
- **6** *That* the matter is barred by law.
- 7 *That* the appellant has been treated as per law rules of policy by the Department.
- **8** That this Honorable Bench has got no jurisdiction to entertain the tiled case in view of legal bar under the law.
- **9 That** the service rule dated 24-4-2017 are legally competent as the appellant lacks the prescribed qualification of CT ass courses or ADE from the recognized institutions.



- **10** *That* the Appellant is not entitled for the relief he has sought from this Honorable Bench through the instant case.
- 11 That the appellant could not qualify the criteria for promotion to the post of SST (IT) in (BPS-16) on the grounds of lack of Certificate/Diploma/Degree of Certified Teacher Associate Degree of Education (ADE) which is pre-request for promotion to the said post under the rules in field in the Department.
- 12 That the act of the Respondent Department with regard to the DPC meeting held on dated 11-6-2021 is legal & liable to be maintained.

ON FACTS.

- 1 That Para-1 needs no comments.
- 2 That Para-2 is correct vide order dated 15-4-2005, the appellant was inducted against the (IT) Lab in charge in (BPS-16) post in the Department.
- 3 That Para-3 is correct on dated 24-4-2017, Service Structure/Rules for the (IT) Lab in charge cadre was approved, whereby, the designation from the said post was changed & re-designated as Certified Teacher (IT) with the eligibility criteria of Intermediate plus DIT & ADE/certified Teacher, however, the appellant was not promoted to the post of SST (IT) on the grounds of lack of Certificate/Diploma/Degree of Certified Teacher Associate Degree of Education (ADE) which is pre-request for promotion to the said post under the rules in field in the Department. (Copies of the Service Structure 2017 & DPC meeting minutes dated 11-6-2021 are Annexure-A & B).
- 4 That Para-4 is correct to the extent of the grant of promotion vide Notification dated 28-5-2019 to the eligible CT (IT) having the prescribed qualification to the post of SST (IT) in BPS-16 during the DPC meeting held on 11-6-2021, wherein, the appellant could not meet the criteria for promotion as stated above, hence, not recommended under the Rules by the Department.
- 5 That Para-5 is incorrect & denied on the grounds that the appellant could not meet the criteria for promotion as stated above, hence, not recommended under the Rules by the Department.
- **6** That Para-6 needs no comments being pertains to the office record.
- 7 That Para-7 needs no comments being pertains to the office record.

8 That Para-8 is correct that the DPC meeting dated 11-6-2021 the appellant was not recommended for promotion to the post of SST (IT) in BPS-16 on the material grounds lack of Certificate/Diploma/Degree of Certified Teacher Associate Degree of Education (ADE) which is pre-request for promotion to the said post under the rules in field in the Department.

- 9 That Para-9 is correct that the promotion order of all those CT (IT) who have no Certificate/Diploma/Degree of Certified Teacher Associate Degree of Education (ADE) which is pre-request for promotion to the said post under the rules in field in the Department were withdrawn under the Rules & policy is mentioned above.
- 10 That Para-10 is incorrect as the act of the respondent Department with regard to the DPC meeting dated 11-6-2021 is legal & liable to be maintained.
- 11 That Para-11 is incorrect as no Departmental appeal has been filed by the appellant against the DPC meeting as cited above, wherein, he was rejected for promotion to the SST (IT) post on the grounds of lack of the required qualification & criteria.
- 12 That Paara-12 is also denied, as the stand of the appellant is illegal, therefore, the appeal in hand is liable to be rejected on the following grounds inter alia:-

ON GROUNDS.

Ø., 6

- A. <u>Incorrect & not admitted</u>. The plea of the Appellant is without any cogent reason and legal justification as the service rules/structure dated 24-4-2017 is mainly based on natural justice and equality, wherein, each & every teaching cadre has a prospect of promotion to the higher posts in the Department.
- **B.** <u>Incorrect & not admitted.</u> The Appellant has been treated as per law, rules and service Rules & structure as mentioned above, hence, the plea of the appellant is illegal and liable to be rejected.
- C. <u>Incorrect & not admitted</u>. The plea of the appellant is illegal and liable to be rejected in view of the above submission made in foregoing paras of the present reply on behalf of the Respondents.
- D. <u>Incorrect & not admitted</u>. The act of the Respondents with regard to the afore stated service Rules & structure 24-4-2017 & DPC meeting dated 11-6-2021 is within legal sphere & liable to be maintained.
- **E.** Incorrect & not admitted. The act of the Department is legal having no aspect of discrimination towards to the appellant in the aforementioned service Rules. Therefore, the stance of the appellant is liable to be rejected.
- **F.** Incorrect & not admitted. No constitutional violation has been made by the answering Respondents. They have always fulfilled their legal and constitutional obligations.
- G. <u>Incorrect & not admitted.</u> No legal & constitutional violation has been made by the answering Respondents. They have always fulfilled their legal and constitutional obligations & the appellant here in the instant case could not qualify the prescribed qualification for promotion to the upper post under the rules.



- H. Incorrect & not admitted, as replied above.
- I. <u>Incorrect & not admitted.</u> Hence, needs no further comments, however, the Respondents also seek leave of this Honorable Bench to submit additional record, grounds and case Law at the time of arguments of the case.

Therefore, it is most humbly prayed that the appeal of the appellant may kindly be dismissed to in favor of the Respondents in the interest of justice.


