The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standi.
- 2 That the Appellant is not an aggrieved person within the meaning of Article-212 of the Constitution of Islamic Republic of Pakistan 1973.
- **3** That the instant Service Appeal is badly time barred under relevant provision of law of limitation Act 1908.
- **4** That the Appellant has concealed material facts from this Honorable Tribunal in the instant Service Appeal.
- **5** That the Appellant has not come to this Honorable Tribunal with clean hands.
- **6** That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- **8** That this Honorable Court has got no Jurisdiction to entertain the present appeal.
- **9** That the instant Appeal is based on mala fide intentions, just to put extra pressure on the Respondents for gaining illegal service benefits for his promotion as SST (IT) in BPS-16 in violation of the Rules & policy in field as he is lacking the prescribed qualification of ADE (IT).



10 That the instant Appeal is not maintainable in its present form.

11 That the Appeal is bad for mis-joinder & non-joinder of the necessary parties.

ON FACTS.

- **1** That Para-1 needs no comments.
- **2** That Para-2 also needs no comments being pertains to the 1st appointment order as Computer Lab in charge BPS-7 vide order Notification dated 14-10-2014 attached as **Annexure-A**.
- **3** That Para-3 is correct that vide Notification dated 24-04-2017 attached as **Annexure-B**, service Rules for the Computer Lab in charge were framed & notified vide the said Notification by the Respondent No.3, wherein, vide S.No. 3 of the mentioned service structure for CT (IT) in BPS-12 has been framed, wherein the prescribed qualification for the appointment CT (IT) mentioned therein for perusal & ready reference.
- **4** That Para-4 is correct that vide Notification dated 27-02-2019 the service of the appellant was regularized against the CT (IT) post in BPS-12 by the Department which is attached as **Annexure-C.**
- **5** That Para-5 is also correct that vide Notification dated 28-05-2019 promotion order has been issued to the eligible CT (IT) in BPS-12 to the post of SST (IT) in BPS-16 in view of the criteria & policy notified on dated 24-04-2017 by the Respondent No.2 under the Rules & policy.
- **6** That Para-6 is incorrect on the grounds that DPC meeting & working papers dated 24-09-2020 does not accrued any legal right for promotion as SST (IT) in BPS-16 post on the grounds that the appellants does not possess the prescribed qualification of ADE (IT).
- **7** That Para-7 needs no comments.
- 8 That para-8 needs also no comments.
- **9** That Para-9 is correct that the appellants has not been considered for promotion as SST (IT) in BPS-16 post in view of the Rules notified on dated 24-04-2017 to the extent of that the appellant is lacking the prescribed qualification of ADE (IT) which is mandatory for promotion against the noted post.

10 That Para-10 is correct to the extent of order dated 02-08-2021 of the Respondent No.1 on the grounds of not fulfilling the condition No. II of the Service Rules dated 24-04-2017 in the Respondent Department.

- **11** That Para-11 is correct to the extent of order dated 03-08-2021, whereby, the order dated 02-08-2021 has been withdrawn by the Department under the Rules.
- 12 That para-12 is also incorrect & denied, hence, no further comments.
- **13** In reply to Para-13, the Appellant is not an aggrieved person within the meaning of Article-212 of the Constitution of Islamic Republic of Pakistan 1973, hence, the appeal in hand is liable to be dismissed on the following grounds inter alia:-

GROUNDS:-

- **A.** Ground A needs no comments.
- B. Incorrect & not admitted, the stand of the appellant is without cogent reason & legal justification, liable to be rejected by this Honorable Bench as act of the Respondent Department is in accordance with the provision of Law & Rules, whereby, the appellant has not been promoted as SST (IT) in BPs-16 post due to the lack of the prescribed criteria & qualification ADE (IT) as mentioned S. No. II in the Service Rules notified on dated 24-04-2017 by the Department, hence, the act which is legal & liable to be maintained.
- **C.** <u>Incorrect & not admitted</u>, the appellant is misleading the issue as he has been treated in accordance with Law & Rules.
- **D.** <u>Incorrect & not admitted</u>, hence, needs no further comments as detail reply to this ground has been given in the above mentioned paras.
- **E. Incorrect & not admitted**, the appellant is misleading the issue as he has been treated in accordance with Law & Rules & have not violated the provision of Article-4 & 25 of the constitution of 1973 in the instant case, hence, liable to be rejected.
- F. Incorrect & not admitted, as replied above.
- **G.** <u>Incorrect & not admitted</u>, needs no further comments as detail reply to this grounds has been given in the above mentioned paras.
- H. Incorrect & not admitted, the stand of the appellant is without cogent reason & legal justification, liable to be rejected.

I. However, the Respondents also seek leave of this Honorable Tribunal to submit additional grounds, record & case law at the time of arguments on the date fixed.
