Arguments on restoration application heard and record perused.

The record reflects that despite having been noticed on account of her absence recorded on 13.05.2019 the petitioner did not appear nor her counsel attended the Tribunal in pursuance thereof, to deposit security and process fee within the stipulated period of time, therefore, the appeal was dismissed for non deposit of fee and charges as well as for default in appearance whereas the restoration application has been submitted on 22.07.2019 which is time barred. 





This is an appeal filed by Mst. Sabiha Khanum today on 19/11/2018 against the order dated 11/07/2012 against which she preferred/made departmental appeal/ representation on 13.09.2018 the period of ninety days is not yet lapsed as per section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, which is premature as laid down in an authority reported as 2005-SCMR-890.





PRAYER

**On the acceptance of this appeal, the
impugned order/notification be set aside and
respondents be directed to make promotions
according to the seniority list and the
appellant may kindly be given her due right
and the respondents may kindly be directed to**

issue orders of promotion of the appellant and may also kindly be awarded with all back benefits. Any other remedy which deems fit appropriate may also be granted in favour of the appellant.

Respectfully Sheweth

- 1) That appellant is a permanent resident of Nowshera and belongs to a respectable family and a law abiding citizen.
- 2) That the appellant is qualified up to master and was appointed by the respondents department in 2006.
- 3) That the appellant served the department since 1982 with utmost satisfaction of her seniors and kept unblemished record.
- 4) That in 2012 DEO female issued promotion order of some teachers vide Notification No. SO(B&A)/1-18/E&SE/2012 dated 11/07/2012 who were junior to the appellant and thus seniority list was violated without any justification.(Copy of promotion list is annexure A)
- 5) That when the appellant approached the DEO female, she was told that the rest of the teachers will be promoted soon in next pool but no action was taken so far.
- 6) That later on 2014-15 again some junior teachers were promoted by violating seniority list and thus violated the fundamental right of the appellant.
- 7) That now in January 2018 yet again few junior and blue eyed teachers have been promoted by neglecting the appellant and thus shear violation of the seniority list.
- 8) That a departmental representation was made to the appellate authority but the same has not been entertained so far.(Copy of the departmental appeal is annexure B),

9) That appellant is constrained to approach to the Hon'ble Tribunal for redressal of her grievances inter alia on the following grounds:

GROUND:

- A. That the act and omission of the respondents/department is illegal, unconstitutional, without jurisdiction, without lawful authority against facts and materials on the record therefore, needs the interference of this Hon'ble Tribunal.
- B. That the act and omission of the department is not only factually incorrect and legally untenable but also against the principles of natural justice.
- C. That the appellant is senior to those who have been promoted out of turn which is illegal and against the legal norms.
- D. That at the time of the impugned notification/order the long service period and the seniority of the appellant in the department has been completely ignored due to which the appellant has suffer a lot.
- E. That the appellant has performed duties efficiently, honestly and without giving any chance of complaint to her superior which fact also goes in her favor and there is no law which permits the respondents to promote a junior leaving out a senior without any reason and without informing her. It is pertinent to mention here that the appellant was kept ignorant of the fact of promotion.
- F. That the appellant is a civil servant and legal and constitutional guarantee is available to him to be dealt with in accordance with law she however, has not been treated as such.

- G. That the act and omission of the department is clear violation/disregard of the fundamental rights of the appellant, Therefore, the said act and omission of the department is not effective on the right of the appellant and the same has caused gross miscarriage of justice to the appellant.
- H. That the department is legally/constitutionally bound to follow the directions of law and justice.
- I. That the respondents have failed to apply their independent/administrative mind to the matter and therefore have reached to an erroneous conclusion which is not sustainable in the eye of law.
- J. That the appellant has never given any chance of compliant to the seniors and superiors and also cordial to the staff concerned.
- K. That out of turn promotion of the junior teachers without any justification is the clear violation of seniority list which is not the mandate of law and as per superior courts judgments it has strictly been prohibited.
- L. That out of turn promotion has been strictly prohibited as per dictums of the Apex court of the federation but even then the respondents promoted their blue eyed teachers without any reason out of turn.
- M. That the said promotions were kept secret from the knowledge of the appellant and when the appellant came to knowledge and contacted the respondents they used delaying tactics and also assured appellant that her promotion order will be issued soon but so far no order has been issued.
- N. That as the seniority list has been violated by the respondents therefore it's a re-occurring cause of action and limitation does not run against it.

- O. That at the time of promotion of the junior teachers the appellant was not informed about the activity rather the appellant got information at first instance from her personal sources, which shows that the promotions were kept secret.
- P. That when the appellant is otherwise fit and competent she cannot be bypassed in such a manner and in this regard record needs to be examine in order to bring truth to surface.
- Q. That It is the constitutionally guaranteed right of appellant to be treated with equality but here the appellant is being discriminated and was neglected without applying the proper procedure.
- R. That appellant seeks permission of this Honorable Tribunal to raise other grounds at the time of hearing of the instant appeal.

It is, therefore, humbly prayed that On acceptance of this appeal, the impugned promotion be set aside and respondents be directed to make promotions according to the seniority list and the appellant may kindly be given her due right and the respondents may kindly further be directed to issue orders of promotion of the appellant and may also kindly be awarded with all back benefits. Any other remedy which deems fit appropriate may also be granted in favour of the appellant.

- 6) That now in January 2018 yet again few junior and blue eyed teachers have been promoted by neglecting the appellant and thus shear violation of the seniority list.

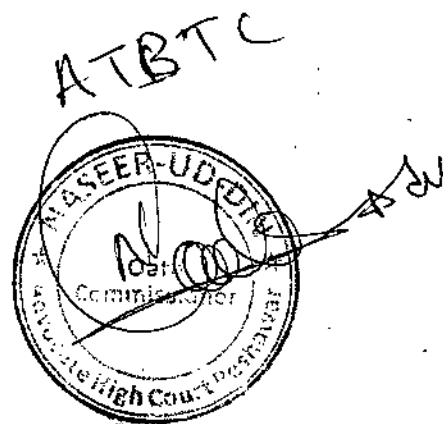

- F. That It is the constitutionally guaranteed right to be treated with equality but here the appellant is being discriminated and was neglected without applying the proper procedure.





- G. That the act and omission of the department is clear violation/disregard of the fundamental rights of the appellant, Therefore, the said act and omission of the department is not effective on the right of the appellant and the same has caused gross miscarriage of justice to the appellant.
- H. That the department is legally/constitutionally bound to follow the directions of law and justice.
- I. That the respondents have failed to apply their independent/administrative mind to the matter and therefore have reached to an erroneous conclusion which is not sustainable in the eye of law.
- J. That the appellant has never given any chance of compliant to the seniors and superiors and also cordial to the staff concerned.
- K. That out of turn promotion of the junior teachers without any justification is the clear violation of seniority list which is not the mandate of law and as per superior courts judgments it has strictly been prohibited.
- L. That out of turn promotion has been strictly prohibited as per dictums of the Apex court of the federation but even then the respondents promoted their blue eyed teachers without any reason out of turn.
- M. That the said promotions were kept secret from the knowledge of the appellant and when the appellant came to knowledge and contacted the respondents they used delaying tactics and also assured appellant that her promotion order will be issued soon but so far no order has been issued.
- N. That as the seniority list has been violated by the respondents therefore it's a re-occurring cause of action and limitation does not run against it.


- O. That at the time of promotion of the junior teachers the appellant was not informed about the activity rather the appellant got information at first instance from her personal sources, which shows that the promotions were kept secret.
- P. That when the appellant is otherwise fit and competent she cannot be bypassed in such a manner and in this regard record needs to be examine in order to bring truth to surface.
- Q. That It is the constitutionally guaranteed right of appellant to be treated with equality but here the appellant is being discriminated and was neglected without applying the proper procedure.
- R. That appellant seeks permission of this Honorable Tribunal to raise other grounds at the time of hearing of the instant appeal.

It is, therefore, humbly prayed that On acceptance of this appeal, the impugned promotion be set aside and respondents be directed to make promotions according to the seniority list and the appellant may kindly be given her due right and the respondents may kindly further be directed to issue orders of promotion of the appellant and may also kindly be awarded with all back benefits. Any other remedy which deems fit appropriate may also be granted in favour of the appellant.
