It is therefore prayed that the application may be allowed keeping in view the above facts.

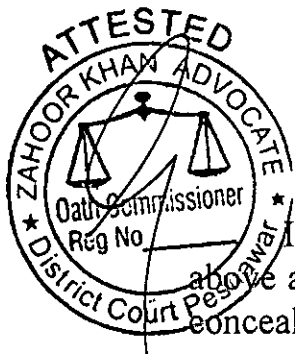

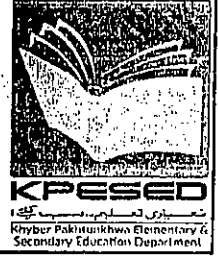
