
ORDER

Umar Ata Bandial, CJ.- This Petition is time barred by 10 days. The application for condonation of delay (C.M.A. No.1072-P of 2018) states that the late supply of documents and the process of obtaining attested copies of the judgment of the learned Khyber Pakhtunkhwa Service Tribunal, Peshawar and the lengthy correspondence between the various tiers of the Petitioner Department led to delay in the filing of this petition.
