The appellant has filed the present service appeal with the prayer of his promotion on the basis of seniority list dated 02.11.2014.</li> <li>3. Learned counsel for the appellant argued that the appellant was appointed against Certified Teacher post on 20.01.2015; that the appellant was promoted as SST vide order dated 06.07.2015;</li> </ol>


that the appellant has filed present service appeal for antedation of his promotion on the ground that in the year 2014 private respondents who were junior to the appellant were promoted while ignoring the appellant; that due to departmental action against the appellant, he was under suspension in the year 2014 as such he was not promoted; that departmental action against the appellant led to the order dated 10.07.2014 regarding deduction/recovery of his salary/pay for the period of four months with effect from 30.11.2013 and the departmental appeal of the appellant against the order dated 10.07.2014 also failed vide order dated 18.08.2014 hence, the appellant filed Service Appeal bearing No. 1280/2014 against the above mentioned order dated 10.07.2014 and appellate order dated 18.08.2014; that the service appeal bearing No.1280/2014 filed by the appellant was accepted and the orders made impugned therein were set-aside. Learned counsel for the appellant stressed that the appellant is therefore entitled to be promoted from the date when his juniors were promoted.


4. On the other hand, learned Deputy District Attorney while resisting the present service appeal on the grounds mentioned in the joint written reply of the official respondents stated that since the appellant was under suspension in the year 2014 therefore, he was not eligible to be promoted in the year 2014.

5. Arguments heard, file perused.

6. Departmental action was initiated against the appellant in the year 2014 and resultantly he was suspended from government





service on account of his long absence from duty, vide order dated 02.04.2014. Departmental action resulted in the issuance of order dated 10.07.2014 regarding recovery of salary/pay of the appellant and departmental appeal of the appellant there against was also rejected. Service Appeal Bearing No. 1280/2014 filed by the appellant against the order dated 10.07.2014 and order of appellate authority dated 18.08.2014 was accepted and resultantly both the orders dated 10.07.2014 & 18.08.2014 were set-aside. This Tribunal is therefore of the consider opinion that the appellant has made out his case for the grant of promotion from the date when his juniors were promoted.

7. In the light of above, the respondent-department is directed to transmit the case of the appellant to Departmental Promotion Committee for consideration of his case for promotion to the post of SST from the date when his juniors were promoted. The present service appeal is accepted in the above noted terms. Parties are left to bear their own costs. File be consigned to the record room.
