SERVICE APPEAL UNDER SECTION. 4 OF THE K.P SERVICE TRIBUNAL ACT 1974, AGAINST THE NOTIFICATION END; NO.8481-86 DATED PEHS; THE ,07/02/2020, IMPUGNED, ISSUED BY THE RESPONDENT NO.1, WHERE BY WRONGLY, THE PRIVAT RESPONDENT NO.4 VIZ, SHAFIQ AHMAD S.A.T, BEING JUNIOR TO THE APPELLANT, HAS BEEN PROMOTED AS S.S.T(SENIOR SCHOOL TEACHER) WHILE NO FINAL SENIORITY LIST OF EITHER CADRES, A.T (ARIBAC TEACHER) OR S.A.T(SENIOR ARIBAC TEACHER) SINCE LONG, EVEN, AFTER 05/04/1999, HAS BEEN CIRCULATED BY EITHER THE RESPONDENT NO.1,2 OR 3, BEING FOUNDATION AND MANDATORY AS A PRE REQUISET BEFORE GIVING ANY PROMOTION TO ANY MEMBER OF A CADRE, WHILE A TENTATIVE SENIORITY LIST OF SATs/ATs (M) OF DATED 31/10/2019 & DATED 02/01/2020, ALSO NOT CIRCULATED BY THE RESPONDENT NO.1 , IN A REQUIRED PROPER MODE AND MANNER BUT AGAINST THE RELEVANT POLICY PROCEEDURE , MODE AND MANNER, HOWEVER BY NOTICING THE SAME , THROUGH FACE BOOK CIRCULATION, HAS TWICE CHALLENGED BY THE APPELLANT, ALSO IMPUGNING THE SAME WHERE IN FRUADLENTLY AGAINST THE ORDER OF MERIT END;2723-2736 DATED,05/04/1999,THE APPELLANT HAS WRONGLY IGNORED WHILE CONSIDERING THE PRIVATE RESP; NO.4 FOR THE PROMOTION ORDER/NOTIFICATION ,IMPUGNED, WHICH THE APPELLANT HAS ALSO TIMELY BEEN CHALLENGED BY THE APPELLANT (WITH NO RESPONSE) WHILE SO FAR THE SAME HAS NOT BEEN CIRCULATED AS A FINAL SENIORITY LIST, HOWEVER THE APPELLANT,(KEEPING IN VIEW TO AVOIDE ANY

ADVORSE EFFECT OF THE EXPECTED PLEA OF TECHNICALITY) CONSIDERING THE SAME AS FINAL HAS ALSO BEEN CHALLENGED AND IMPUGNED.

Respectfully Sheweth;

FACTS

1. That the appellant was initially recruited as Qari BPS 07 vide appointment order End; No.468-74 dated,9/2/1998, then he was posted and appointed as Arabic Teacher(A.T) BPS 9 vide order End; No.2336-2723 dated,5/4/1999 (applied for through proper channel) while on the bases of seniority cum fitness the appellant was promoted as SAT (Senior Arabic Teacher) BPS 16, vide Notification End; No.13036-42 dated,2/3/2013 . Copies of the order are annexed as "A" A-1 & A2.

2. That when the appellant was appointing, vide order dated 5/4/1999 (Annexure "A-1" above), the appellant according to the merit assigned to him was placed at S.No. 2 and one Inaytul Haq was placed at No.3, while the respondent No.4 , was placed at S.No.4 and vide the same order of merit, the appellant having been placed at S.No.2 was senior than the both concerned, ie, from the one , Inaytul Haq and also from the respondent No.4, being placed at S.No.3⁴⁴ of the said order. But contrary to the aforesaid facts that the appellant was senior and as no other seniority list was circulated so far, except the seniority list impugned for the first time, but un lawfully and wrongly the same have also not properly circulated either among the relevant incumbents or through the incharges or Heads of the relevant institutes, but on face book. Which is also wrong and therefore is revisable in favour of the appellant, by placing the appellant at S.No. ²⁹ in place of the respondent No.4, by way of the correction impugned. Copy of the same seniority list impugned is annexed(is annexed)as "B" & "B-1".

3. That though the mode and manner of the circulation of the seniority list was also wrong , tactful and fraudulent and was against the mode and manner and the policy however both the seniority lists, impugned dated 31/10/2019 and also dated 02/01/2020 both are wrong and should be corrected even up to the extent of the appellant by correctly putting the appellant at S.No.29 in place of respondent No.4 and by putting/placing the respondent No.4 at S.No.30, in place of the of the appellant. Because the same is revisable and modifiable under the law up to the same extent definitely. For ready reference copies both of the impugned seniority lists dated 31/10/2019 and dated 02/01/2020 impugned are annexed as "B" & "B-1".

4. That similarly when there was no Final Seniority list of both the cadres i.e A.Ts and S.A.Ts, then the deplorable and crumbling one, impugned Notification End; No.8481-86 dated, 07/02/2020, which being is a superstructure without any foundation ie final seniority list of even SATs and also wherein the respondent No.4 , being a junior than the appellant was wrongly promoted is totally un lawful and illegal, not sustainable in the eyes of law but is liable to be set aside in favour of the appellant by promoting the appellant from the same date and time with all kind of back benefits thereto in favour of the appellant. Which also the appellant by noticing the same, on the same day has challenged and a Departmental ^{was filed} Appeal on dated 6/3/020. Copies of both Departmental appeal and the impugned notification dated,7/2/020, both are annexed as "C" & "C-1".

5. That though twice (on 31/10/2019 & 02/01/2020) the tentative seniority lists, impugned circulated on face Book for the first time, by the respondent No. 2, vide endorsement embodied as a notes thereon that written objections in a shape of appeal if not received with in a stipulated time , the same would be considered as final seniority list. Hence as a matter of fact as the appellant had already filed

Departmental appeal in a shape of written objections against both the tentative seniority lists impugned well in time but with no response, and with no circulation any other final seniority list expected, an application to this effect that if any FINAL SENIORITY LIST what so ever has been circulated, be supplied for taking legal initiatives, has also not been responded with, to which the authorities /respondents concerned were under obligation. Hence the appellant having no other alternative efficacious remedy except to file the instant Service Appeal against both, the impugned seniority list even dated,02/01/2020 and the impugned Notification endors; 8439-44 dated,07/02/2020, being fall joint and aggrieving the appellant at a same time, on the following grounds among other inter alia has been preferred.

GROUNDS

- a. That the impugned Notification End; No.8481-86 dated, 07/02/2020, being based on the tentative seniority list impugned of dated 31/10/2019, which according to the endorsement embodied ,would get finality after 4 days ie on 04/11/2019, but subsequently issuance of an other tentative seniority list on dated02/01/2020, after lapse of 61 days instead 4 while the same also did not gained any finality and also itself was illegal too , is totally un lawful, illegal, irrational as well and not sustainable in the eyes of law but is liable to be set aside in favour of the appellant by promoting the appellant exact from the same date of its issue, with all back benefits.
- b. That both the impugned Seniority list dated 31/10/2019 and dated 02/01/2020 also were not circulated according to the law and policy exists concerned, being fraudulently not to notice by the concerned incumbents, had mala fidely and purposely circulated on face book being ignoring the proper mode and manner either directly signed by summoning the concerned to notice the same or have been circulated through the concerned inchrages of the

institutions concerned where the incumbents concerned were serving . Hence was therefore an act of condemnation unheard in part of the respondents concerned and was not tenable and sustaining in the eyes of law but was void and illegal it self.

- c. That there was no Final Seniority list of both the cadres i.e ATs and SATs, then the deplorable and crumbling one, impugned Notification End; No.8481-86 dated, 07/02/2020, which being is tantamount to a superstructure without any foundation ie final seniority list of even SATs, is totally un lawful and illegal, irrational as well and not sustainable in the eyes of law but is liable to be set aside in favour of the appellant by promoting the appellant exact from the date of its issue with all back benefits.
- d. That the impugned Notification End; No.8481-86 dated, 07/02/2020, is also illegal and a wrong one because wherein the respondent No.4 , being a junior than the appellant was wrongly promoted despite the fact the there was/is no any final seniority list of the cadre to which the appellant and the private respondent No.4 are belonging to had been based for the Notification impugned End; No.8481-86 dated, 07/02/2020. Because no Final seniority list was there to have ever been circulated by any one of the respondents concerned at least since 1999 to date, hence is totally un lawful and illegal, not sustainable in the eyes of law but is liable to be set aside in favour of the appellant by promoting the appellant from the same date with all back benefits.
- e. That neither the objection petition filed against the impugned tentative seniority list by the appellant, was responded nor the departmental appeal was decided either by the respondent No.1 or others while according to the Note recorded on the body of the impugned seniority list the seniority impugned has been gained

finality and was accordingly considered as final seniority list because no other separate seniority list was circulated however the procedure adopted was against the law and policy in vogue and was tantamount to condemnation un heard which was undesirable in the eye of law and was also fraud just to unduly favour the private respondent No.4 and other being eye blue of the official respondents .

f. That wrongly the departmental appeal of the appellant has also not been responded despite lapse and expiry of a considerable period while no attested copy of either documents impugned have provided to which the respondents were under obligation under the law . Hence the instant appeal is within time.

g. That mode and manner of circulation of the impugned seniority list was not desirable and was tactful ,fraudulent and wrong as well however by placing junior the appellant than the respondent No.4 is also wrong and due to it the same is Revisable and correctable in favour of the appellant.


h. That according to the first appointment merit order assigned to the appellant and the respondent No.4 , the appellant is senior than the respondent No.4 and the impugned seniority list is revisable up to the correction sought by the appellant in the subject of the instant appeal is genuine and lawful.

i. That the appellant is entitle under the law and policy exist to be placed at S.No.31 in place of respondent No.4, while the respondent No.4 is entitle t to be placed at S.No.32.


- j. That further supporting grounds will be argued at the time of arguments as a support of the stance of the appellant.

Therefore it is most humbly prayed that on acceptance of this service appeal, the appellant may be placed at S.No.31 of the seniority list impugned in place of the respondent No.4 with further relief to the appellant to which he is entitle under the law may also be granted though not specifically prayed for in the instant appeal.
