**SALAH-UD-DIN, MEMBER:-** The appellant has filed the instant service appeal under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, challenging the impugned office order bearing No. 10893 dated 25.09.2019, whereby the departmental representation of the appellant against the order regarding recommendation of conversion of his detention period with effect from 10.03.2017 to 31.08.2018 as leave, was rejected.

2. The brief facts as alleged by the appellant in his appeal are that he was serving as Teacher in Government High School Gujrat District Mardan, when he was picked up by unknown persons, probably officials of Security Agencies on 09.03.2017, on the basis of suspicion; that the

matter was reported to local Police Station, which was entered vide Daily Diary No. 19 dated 10.03.2017; that the appellant was released on 31.08.2018, who approached the appointing Authority on 01.09.2018 and submitted an application narrating therein the whole episode regarding his arrest by the Security Agencies; that the appellant was found innocent during the inquiry conducted into the matter, therefore, he resumed the duty on 01.09.2018, however upon the order of competent Authority, pay and allowances for the period w.e.f 10.03.2017 till 31.08.2018 have not been paid to the appellant.

- 3. The respondents submitted comments wherein it was mainly alleged that the appellant was adjusted on humanitarian grounds with effect from 01.09.2018 and his detention period with effect from 10.03.2017 to 31.08.2018 has rightly been converted into leave; that the appellant has not performed any duty with effect from 10.03.2017 to 31.08.2018, therefore, he cannot claim any salary for the said period.
- 4. Mr. Amin Ullah Jan, Advocate, representing the appellant has contended that the appellant was taken into custody by Security Agencies on the basis of suspicion on 09.03.2017 and report regarding the same was registered in the concerned Police Station on 10.03.2017; that the appellant was not found involved in an illegal activities, therefore, he was released on 31.08.2018 and on the very next day, he submitted arrival report to the competent Authority through an application, narrating therein the whole episode; that the inquiry officer has given categorical findings in his report that the appellant is a dedicated and punctual Teacher and that his absence is not willful; that the absence of the appellant from duty with effect from 10.03.2017 to 31.08.2018 was not due to any fault of the appellant, therefore, he is legally entitled for salary and allowances of the said period.
- 5. On the other hand, Mr. Riaz Ahmad Paindakheil, Assistant Advocate General has contended that it has not been proved that the appellant was in custody of Law Enforcement Agencies; that it was on compassionate grounds that the appellant was allowed to resume his duty and as he has remained absent with effect from 10.03.2017 to 31.08.2018, therefore, the competent Authority has rightly held that the appellant is not entitled to any salary for the said period; that the



appellant has not produced any clearance certificate issued by the concerned quarter, therefore, his departmental appeal was rightly dismissed.

- 6. We have heard the arguments of learned counsel for the appellant as well as learned Assistant Advocate General for the respondents and have perused the record.
- 7. A perusal of the record would show that the appellant has alleged that he was taken into custody by some unknown person, probably officials of Security Agencies, who kept the appellant in custody for 17 months and 22 days. The appellant was allegedly taken into custody on 09.03.2017 and his brother namely Syed Shakeel Ahmed Shah reported the matter to the local police, which was recorded vide Daily Diary No. 19 dated 10.03.2017 Police Station Choora District Mardan. Copy of the Daily Diary report is available on the record, which is supporting the stance of the appellant regarding his taking into custody by some unknown people. Upon the order of District Education Officer (Male) Mardan, Hafiz Zubair Ahmed Principal GCMHS No. 3 Mardan was appointed as inquiry officer for conducting of inquiry into the matter. The inquiry officer has submitted inquiry report, copy of which is available on record. The inquiry officer has concluded that the nature of absence of the appellant cannot be considered as willful as he was in the custody of Law Enforcement Agencies. The inquiry officer has recommended that the pay of the appellant may be released as per Financial Rules and procedure accordingly, after fulfilling of the required codal formalities. The inquiry officer has not made any recommendation that the detention period of the appellant with effect from 10.03.2017 to 31.08.2018 may be converted into leave, however upon the receipt of inquiry report office order bearing Endorsement No. 7907-09/V:I/E:file/Aziz Ahmed Shah/SCT dated 17.10.2018 was issued by District Education Officer (Male) Mardan with a note that the detention period of the appellant with effect from 10.03.2017 to 31.08.2018 for conversion into leave may be sent for further process of the case. The departmental appeal of the appellant against the recommendation regarding the considering of the period of his detention with effect from 10.03.2017 to 31.08.2018 as leave was also rejected with the remarks that no clearance certificate has been provided by the appellant. In view



of the inquiry report, it is clear that the absence of the appellant from 10.03.2017 to 31.08.2018 cannot be considered as willful absence because appellant was in custody of Law Enforcement Agencies. Keeping in view the facts and circumstances of the case, it was beyond control of the appellant to attend his duty for the period from 10.03.2017 to 31.08.2018, therefore, the respondents have wrongly and illegally considered the period of absence of the appellant as leave.

8. In light of the above discussion, the appeal in hand is accepted by setting-aside the impugned order and it is directed that the appellant shall be considered to have remained on duty for the period from 10.03.2017 to 31.08.2018 and he shall be paid the pay as well as allowances for the said period in accordance with the relevant law/rules. Parties are left to bear their own costs. File be consigned to the record room.

APPEAL U/S 4 OF THE KPK SERVICES TRIBUNAL ACT 1974, AGAINST THE IMPUGNED OFFICE ORDER NO. 10893 DATED 25/09/2019 OF DEO MARDAN, WHEREBY THE RESPONDENT NO 1 HAS REJECTED THE APPLICATION OF THE APPELLANT ON REMARKS THAT "NO CLEARANCE CERTIFICATE HAS BEEN PROVIDED" BUT IN FACT THE APPELLANT SUBMITTED THE CLEARANCE DOCUMENTS OF CONCERN POLICE STATION, FOR FURTHER PROCEEDING BEFORE THE IMPUGNED ORDER DATED 25-09-2019, BUT IN VAIN, HENCE THIS APPEAL.

#### PRAYER

On acceptance of the instant appeal, the Impugned office order No. 10893 dated 25/09/2019 of the Respondent No.1 DEO Mardan, may kindly be set aside, and the Respondents may kindly be directed to release all the Arrears of Pay and Allowances / salaries which is outstanding almost 17 Months and 22 days may pleased kindly be handed over to appellant, And any other relief and remedy deems justified by this Hon'ble Tribunal may also be passed in favour of the appellant.

Respectfully Sheweth.

The appellant humbly submits as under: -

That the appellant is a law abiding citizen of the Pakistan.

That the appellant was appointed as a Senior Theology Teacher (STT) in GHS Gujrat, District Mardan vide KPK Education Department Order No. 1532/G dated 22/02/2007 on regular basis.

(Copy of Appointment Order is attached as Annexure A).

- That the appellant has performed his duty upto the entire satisfaction of Public and his department professional sincerity and sobriety.
- 4. That on 09/03/2017, the appellant was picked up / arrested by Unknown person while going with brother from Bakhshali to Mardan on Motorcycle and was taken by them to unknown location for investigation on mere suspicious grounds. The report about picking up / abduction of the appellant was also reported to Police Station by his real brother of the appellant on dated 10/03/2017 and Mad Report to this effect was also chalked out by Police Station Choora District Mardan.

(Copy of Mad Report dated 10/3/2017 is attached as Annexure B).

- 5. That the appellant was detained for 17 Months and 22 days by this unknown person (probably the state Law Enforcement Agencies/ Security Agencies) and the appellant was kept / detained at different locations/places and was investigated at length and thoroughly, the appellant also feels wretchedness to have no any contact with his family during detention period.
- 6. That during the time of appellant detention with the unknown person/ institution, the family of the appellant not only faced the agony of losing appellant on one hand and on the other hand, the salary / monthly pay of the appellant was stopped by the Education Department DEO Male Mardan nor a single penny of stipend / sustenance allowance has been paid to the family of the appellant during detention period as the appellant was the only source of income of his family.
- 7. That the appellant was released from detention on 31/08/2018 and thereafter on the very next day i.e 01/09/2018, the appellant reported to his concerned authority and presented his narration of the entire facts in shape of application. That upon the said request/application of appellant, a proper inquiry was conducted, which declared the appellant as innocent and recommended for re-instatement in service after going through all the material facts and circumstances culminated on the release of appellant from theses unknown person/ institution and thereafter submission of application for re-joining on service.

(Copy of application dated 01-09-2018 along with school principal letter No. 248 dated 4/9/2018 of GHHS Mardan, & Inquiry Report dated 1/10/2018 are attached as Annexure C, D, & E)

8. That upon the inquiry report the appellant was re-instated on his service / adjusted against his original STT post in the same school with effect from 01/09/2018 in the interest of public service and thereupon the appellant join his service and resume his duty on 01/09/2018.

(Copies of office order no. 7907-09 dated 17/10/2018 AND Charge resumption letter No. 1093 dated 5/10/2018 are attached as Annexure F & G).

9. That the appellant requested to his high ups for release of his outstanding salary/ pay and allowances, however the same has been rejected/ turned down by the DEO Mardan with the direction that "No Clearance certificate has been provided". Which is illegal, void against the law and facts, and ineffective upon the rights of the appellant.

(Copy of Departmental appeal of the appellant dated 20-10-2018 and school principal letter No 230 dated 31-10-2018 And impugned order no. 10893 of DEO Mardan dated 25/09/2019 are attached as Annexure H, I & J,)

10. That the appellant has submitted the clearance documents from the concern police station as per the requirements of the Respondents, but the Respondents has not given any preference to the said clearance of the Appellant.

(Copy of Police Station Clearance Report dated 19/2/2019 is attached as Annexure K)

11. That being aggrieved from the said impugned office order of the respondent No 1, the appellant approaches to this Hon'ble Forum / Tribunal for setting aside the above mentioned impugned office order on the following grounds amongst others: -

#### GROUNDS.

- A. That the impugned order of the respondents is against law, facts, and violation of the procedure.
- B. That absence of the appellant from duty was neither habitual nor willful but due to the above mentioned compelling circumstances.
- C. That inquiry Report has also recommended for release of pay of the appellant vide para 2 of the Recommendation of inquiry Report conducted upon the instruction of Competent Authority i.e. DEO (Male) Mardan.
- D. That the order of the respondent is without any legal justification and against due course of law which is ineffective, unlawful, illegal and void upon the rights of the appellant and is liable to be set aside on this score alone.

- E. That the order of the respondent by declining to pay the outstanding salary of 17 Months & 22 days to the appellant without assigning any proper, valid and justified reason is highly unjust and prejudicial to the rights of the appellant.
- F. That the appellant is a poor citizen of the state having no any other source of income and family of the appellant has taken/ obtained loan from different relative for their feeding/ sustenance and also faced extreme starvation during detention period of the appellant.
- G. That precedents of the superior courts favour the stance of the appellant beside humanitarian consideration.
- H. That the appellant totally stand condemned unheard, and the appellant could not be deprived of his due rights without any due process of law, such orders being void ab-initio could not be allowed to remain in field.
- I. That liberty of the appellant was jeopardized during the time of detention period which could not be measured in any manner/ terms as the appellant was also physically incapable to join his duty during the entire detention period, furthermore the appellant was not in position to breath in free environment under the open sky during entire detention period.
- J. That on permission of this Hon'ble Tribunal, the Appellant reserves the right to urge other grounds at the time of arguments.

#### **PRAYER**

It is therefore humbly prayed that on acceptance of the instant appeal, the Impugned Office Order No. 10893 dated 25/09/2019 of Respondent No.1 DEO (Male) Mardan, may kindly be set aside, and the Respondents may kindly be directed to release all the Arrears of Pay and Allowances/salaries which is outstanding almost 17 Months and 22 days may pleased kindly be handed over to appellant, And any other relief and remedy deems justified by this Hon'ble Tribunal may also be passed in favour of the appellant.

### Terms of References (ToRs) of the Inquiry

The following ToRs have already been framed for the said inquiry from the Office order of the undersigned as inquiry officer, issued by the Honorable DEO Male Mardan:

1. To submit report in r/o Aziz Ahmad Shah STT, after having released from the custody of law enforcement agencies, since his arrest on 09.03.2017.

#### History and Background of the Inquiry

Mr Aziz Ahmad Shah is working at GHSS Gujrat against the post of STT since his appointment/posting as per departmental order No 1532/G dated: 22.02.2007. On March 10. 2017, the said teacher remained absent from the school duty consecutively. According to the FIR No. DD 19 *Police Station Choora* dated 10.03.2017, lodged by his brother, the teacher Mr Aziz Ahmad Shah was picked up by some unknown persons while they were going on their motorcycle to Mardan from Bakhshali on 09.03.2017; and since then, he was missing. After receiving the report, the Principal concerned reported to the office and stopped his salary of March 2017. The office conducted an inquiry regarding his attendance and situation after his absence, complete report of which was submitted. On September 01, 2018, the absent teacher Mr Aziz Ahmad Shah reported his arrival to the Principal of the school with request to allow him for joining his duty (annex-1). The application was properly forwarded to the DEO (M) Mardan for consideration accordingly (annex-2). In light of the application, the DEO Mardan, as competent authority, appointed the undersigned for re-inquiry in this regard as per reference mentioned above.

#### Procedure of the Inquir

In light of the DEO's notification, the Inquiry officer, called the applicant through the School Principal for face-to-face personal hearing regarding his absence since 09.03.2017 up to 01.09.2018. The undersigned prepared a questionnaire for the applicant (annex-3) to submit his responses in written form. The Principal of GHSS Gujrat was requested to submit his official report regarding performance of Mr aziz ahmad Shah STT as immediate officer. The Principal submitted his report of satisfaction to the Inquiry Officer in favor of Aziz Ahmad Shah STT (annex-4). The applicant submitted his detailed replies to all areas of the questionnaire (annex-5). On the basis of his responses, the findings were drawn by the inquiry officer.

The following enclosures are therefore attached herewith:

- Application of the applicant regarding resumption of his duty in school. (annex-1)
- Forwarding letter of the School Principal to DEO Mardan (annex-2)
- Statement of the Principal for favor regarding joining of duty (annex-3)
- Questionnaire for the applicant (10 questions): (annex-4)
- Statement/Responses of the Questions by the applicant, (annex-5)

#### Findings of the Inquiry

After thorough analysis of the required documents, personal hearing and responses submitted in written, the inquiry officer therefore reached the following fact finding conclusion:

1. Mr Aziz Ahmad Shah STT remained absent after he was picked up by unknown persons, reported by the teacher as belonging the law enforcement agencies, on 09.03.2017 on his way when he was going to Mardan on motorbike with his brother who, later on, launched FIR on 10.03.2017. Report was registered by his brother on 10.03.2017 in Thana Choora regarding his brother's missing status.

- 3. The applicant was in no position to communicate either with his office of even his family. What is concluded of his situation is that he was totally helpiess in front of the long procedure of investigation of the law enforcement agencies.
- 4. Out of all his interviews and written replies, his patriotism and respect for nationhood was found up to the mark. No feeling of anti-state nature could be found
- 5. He was released from custody after his innocence was ensured during the investigation, and no charge of anti-state activities was witnessed.

#### 6. Conclusion of the Inquiry

Mr Aziz Ahmad Shah remained missing /absent from 10.03.2017 up to 31.08.2018. \*However, absence of this nature cannot be declared as "willful" as he was totally helpless in getting himself released from the custody of the law enforcement agencies. According to the previous inquiry report and report of satisfaction by the School Principal as immediate Boss. Mr Aziz Ahmad Shah STT has always been found punctual and dedicated sometiments his love for duty. Further, he has reported his arrival and resumed his duty on 01.09.20t 8 and is regularly coming since then. The absence on behalf of Mr Aziz Ahmad Shah STT is neither willful nor habitual. His salary is stopped from 01.03.2017 up to 31.08.2018 (18 months)

#### Recommendations

On the basis of the above facts and figures, the following recommendations are increfore submitted:

- As Mr Aziz Ahmad Shah STT is neither willfully absent nor habitually absent from his duties, so his application of reinstatement may be favorably considered, being a dedicated and punctual teacher as per report of the school Principal
- 2. The absence of Mr Aziz ahmad Shah STT may be taken as " in the " because he was being investigated in the larger interest of the country against any investment in

any anti-state activities, unless otherwise reported by the concerned law enforcement

- 3 Keeping in view the nature of absence, (neither habitual nor willful) in respect of Aziz Ahmad Shah, it is recommended that his pay may be released as per financial / rules and procedure accordingly after fulfilling all the required codal formalities in this regard.
- 4. As findings and recommendations of this report are based mainly on the information provided by the applicant Mr Aziz Ahmad Shah STT, so he will be responsible for all his truthfulness or otherwise, if found wrong, false or contradictory in any course of future time, either by the department or the concerned law enforcement agencies.




