



**R/SHEWETH:  
FACTS:**

1. That the appellant was appointed as PST Teacher on 12.05.2010 and being qualified DPED and was promoted SPST Teacher on 24.10.2020 and appellant applied for post of PET (BPS-15) and departmental committee was held by the respondents for preparing of promotion and seniority structure and in this respect a seniority list was prepared and in that seniority list the appellant was enlisted being eligible.. **(Copy of seniority list is attached as annexure A).**
2. That after preparing of seniority list the respondents issued a notification on 05.03.2021 and according to that notification only two candidates respondent No. 06 & 07 was promoted on the post of PET (BPS-15). **(Copy of notification is attached as annexure B).**
3. That appellant filed an appeal on 15.03.2021 to the respondent's office as per diary No. 2090 against the impugned notification dated 05.03.2021. **(Copy of appeal is attached as annexure C).**
4. That where after the appellant waited for the reply but no reply has been received from the respondents.

That appellant feeling aggrieved and having no other remedy filed the instant service appeal on the following grounds amongst others.

**GROUND:**

- A That the action and inaction of the Respondents regarding not promoting of the appellant on the post of PET being eligible is illegal, against the law, facts, norms of natural justice.
- B That the Appellant has not been treated by the Respondent Department in accordance with law and rules on the subject noted above and as such the Respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C That the action of the Respondent No. 01 to 05 is without any legal authority, discriminatory and in clear violation of fundamental rights duly guaranteed by the Constitution and is liable to be declared as null and void.
- D That as the act of the Respondents is illegal, unconstitutional, without any legal authority and discriminatory but is also the result of malafide on the part of respondents.
- E That Appellant has vested right of equal treatment before law and the act of the Respondents to deprive

the Appellant from not promoting being eligible for the said post i.e. PET is unconstitutional and clear violation of fundamental rights.

F That the Appellants seeks permission of this Hon'ble Court to raise any other grounds available at the time of arguments.
