Any other remedy, which this august Tribunal deems fit and appropriate that may also be awarded in favour of the appellant.



# RESPECTFULLY SHEWETH:

### **FACTS:**

- 1. That the appellant was initially appointed as Accountant on fixed pay/contract basis on 26.11.2009 in the respondent department. The appellant performed his duties with full zeal and zest, and that no complaint has been filed against him regarding his performance of duty. (Copy of appointment order dated 26.11.2009 is attached as Annexure "A").
- 2. That the appellant vide notification dated 03.03.2011 was again appointed as Accountant (BPS-16) in the Directorate of Information Technology, KP on <u>ad-hoc</u> basis for a period of one year. (Copy of notification dated 03.03.2011 is attached as Annexure "B").
- 3. That the appellant, every year got yearly extension in his ad-hoc appointment from 2011 till 2016, until his regularization in the year 2016. (Copies of extension notifications are attached as Annexures "C, C1, C2, C3, & C4").
- 4. That the appellant along with other employees of the Directorate of Information Technology got regularization on 29.09.2016 under the Khyber Pakhtunkhwa Adhoc Employees of Directorate of Information Technology (Regularization of Services) Act, 2016 which was further endorsed in the departmental notification dated 07.12.2016. (Copies of Regularization Act, 2016 and departmental notification dated 07.12.2016 are attached as Annexures "D" & "E").
- 5. That the tentative seniority list in the Directorate of Information Technology (ST & IT) Department, Peshawar was issued on 30.12.2016 in which the date of regular appointment/ promotion to present post of the appellant is recorded as 02.03.2011. (Copy of Tentative Seniority List dated 30.12.2016 is attached as Annexure "F").
- 6. That thereafter, under The Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018; the appellant along with others got absorbed in the Directorate of Science and Technology, Khyber Pakhtunkhwa by opting to be remained as civil servant as per requirement of the law. (Copies of The Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018 and Absorption Notification dated 06.04.2018 are attached as Annexure "G" & Annexure "H").
- 7. That on 08.06.2020 a tentative seniority list was notified in which the appellant seniority has been counted from 07.12.2016 which is the date of notification of regularization in the Directorate of Information and Technology and he was shown junior to the private respondent

namely, Mr. Amir Muhammad (BPS-16) Accountant which is against the law and rules as well as various judgments of the superior courts. (Copy of Tentative Seniority List dated 08.06.2020 is attached as Annexure - "I").

- 8. That the appellant filed objections against the tentative seniority list on 22.06.2020 which was rejected on 27.07.2020. (Copies of objection application against the tentative seniority list and further rejection order are attached as Annexures "J" & "K").
- 9. That the department notified Final Seniority List on 04.08.2020 in which he was again shown junior to the private respondent; against which the appellant filed departmental appeal on 12.08.2020 which was not responded within the statutory period of 90 days. (Copies of Final Seniority List dated 04.08.2020 and second departmental appeal are attached as Annexures "L" & "M").
- 10. That now the appellant comes to this August Tribunal on the following grounds amongst others:

#### **GROUNDS:**

- A. That the impugned seniority list dated 04.04.2020 and not deciding the departmental appeal of the appellant within 90 days, is against the law, facts, norms of justice and material on record. Therefore, such action and inaction of the respondent department is illegal and unlawful.
- B. That the appellant's service was regularized in the light, of Regularization Act of 2016 dated 29.09.2016 wherein the appellant's appointment has been ad-hoc with effect from 2011 and is being declared valid, and since then (03.03.2011) the appellant has been continuously performing his duties as civil servant. Therefore, as per law regarding seniority is to be counted with effect from the date of regular/ continuous officiation.
- C. That upon the creation of IT Board under the Act of 2018 dated 05.03.2018 all those employees who opted to remain as civil servant shall be absorbed in the Directorate of Science and Technology. Therefore, keeping in view the principle of restructuring/ absorbtion an the spirit of Rule-17 of the Khyber Pakhtunkhwa APT Rules, 1989 the seniority of the appellant was required to be counted with effect from the date of continuous officiation.
- D. That before the creation of the IT Board the appellant date of regular appointment was recorded as 02.03.2011 in the tentative seniority list and that remained in field for a long period. Therefore, keeping in



view the judgement reported as 2014 PLD 338 and the Principle of Locus Poenitentiae the appellant seniority could not be disturbed.

- E. That as per the spirit of Section-8 of the KP Civil Servant Act, 1973 and Rule-17 of the APT Rules, 1989; the appellant has wrongly been placed at serial no. 2 and as such the same final seniority list needs rectification.
- F. That there are numerous judgements of the superior courts wherein it has been held that regularization is the continuation of the previous appointment and cannot be termed as fresh appointment. Therefore, the official is entitled to the seniority from the date of first appointment.
- G. That the appellant has not been treated as per law and rules, and has been deprived from the seniority benefits by exercising authority in a fanciful manner.
- H. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

# THE KHYBER PAKHTUNKHWA ADHOC EMPLOYEES OF DIRECTORATE OF INFORMATION TECHNOLOGY (REGULARIZATION OF SERVICES) ACT, 2016

(KHYBER PAKHTUNKHWA ACT NO. XIX OF 2016)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 29th September, 2016).

AN ACT

to provide for regularization of services of certain employees appointed on adhoc basis in the Directorate of Information Technology, Khyber Pakhtunkhwa.

**Preamble:-** WHEREAS it is expedient to provide for regularization of certain employees appointed in the Directorate of Information Technology in 2011 on adhoc basis and other ancillary matters hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement.-- (1) This Act may be called the Khyber Pakhtunkhwa Adhoc Employees of Directorate of Information Technology (Regularization of Services) Act, 2016.
  - (2) It shall come into force at once.
- 2. **Definitions.** (1) In this Act unless the context otherwise requires,-
  - (a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
  - (b) "Department" means Science & Technology and Information Technology Department;
  - (c) "employees" means employees the Deputy Director (BPS-18), Network Manager (BPS-17) IIS Manager (BPS-17), Accountant (BPS-16) and Computer Operator (BPS-12) appointed on adhoc basis by the Government in the Directorate of Information Technology of Khyber Pakhtunkhwa, in 2011;
  - (d) "Government" means the Government of Khyber Pakhtunkhwa;
  - (e) "Law or Rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and
  - (f) **"Post"** means the posts of the Deputy Director (BPS-18), Network Manager (BPS-17), IIS Manager (BPS-17), Accountant (BPS-16) and Computer Operator (BPS-12) in the Department and is required to be filled on the recommendation of the Commission.
- (2) The expression "adhoc appointment" shall have the same meanings as respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Civil Servants Act No. XVIII of 1973).
- 3. Regularization of services of certain employees of the Directorate of Information Technology.--(1) All employees appointed on adhoc basis by the Government in the Directorate of Information Technology in the year of 2011 and holding posts till the commencement of this Act, shall be deemed to have validly been appointed to those posts on regular basis from the date of the commencement of this Act:

#### Provided that-

(a) such employees were appointed against those posts which falls within the ambit of the Commission;


- (b) the services of such employees shall be deemed to have been regularized under this Act only on the publication of their names in the official Gazette; and
- (c) such employees possess the qualification and experience prescribed for the posts to which they are appointed on regular basis.
- 4. <u>Determination of pay scales.</u>-- All employees whose services are regularized under this Act or in the process of attaining service at commencement of this Act shall be placed on basic pay scale, given as under:
  - i. Deputy Director (BPS-18)
  - ii. Network Manager (BPS-17)
  - iii. IIS Manager (BPS-17)
  - iv. Accountant (BPS-16)
  - v. Computer Operator (BPS-12)
- 5. <u>Determination of seniority</u>.-- (1) Those employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior under the services tenure spent on adhoc basis against approved posts to all civil servant ongoing to the same service or cadre as the case may be who are in service on regular basis on the commencement of this Act and shall also rank junior to such other person, if any who, in pursuance the recommendation of the commission or committee, or body, constituted for the purpose, made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.
- (2) The inter-se-seniority of the employees, whose services are regularized under this Act with in the same service or cadre, shall be determined on the basis of their continuous officiating in such service or cadre.
- 6. Overriding effect.--Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of in consistency to this Act shall cease to have effect.

# THE KHYBER PAKHTUNKHWA ESTABLISHMENT OF INFORMATION TECHNOLOGY BOARD (AMENDMENT) ACT, 2018

(KHYBER PAKHTUNKHWA ACT NO. IV OF 2018)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 5th March, 2018).

AN ACT

further to amend the Khyber Pakhtunkhwa Establishment of Information Technology Board Act; 2011

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Establishment of Information Technology Board Act, 2011 (Khyber Pakhtunkhwa Act No. XI of 2011), for the purposes hereinafter appearing;

1. Short title and commencement.—(1) This Act may be called the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018.

- (2) It shall come into force at once.
- 2. Substitution of Preamble of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the Khyber Pakhtunkhwa Establishment of Information Technology Board Act, 2011 (Khyber Pakhtunkhwa Act No. XI of 2011), hereinafter referred to as the said Act, for the existing Preamble, the following shall be substituted, namely:

"WHEREAS it is expedient to provide for the establishment of the Khyber Pakhtunkhwa Information Technology Board for promotion, planning, execution, supervision, evaluation and regulation of the Information and Communication Technology, Information and Communication Technology enabled services and education for public and private sectors of the Province of the Khyber Pakhtunkhwa and for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:".

- 3. Insertion of new section in the Khyber Pakhtunkhwa Act No. XI of 2011.—In the said Act, after section 3, the following new section 3A shall be inserted namely:
  - "3A. Status of the Directorate of Information Technology and its employees.-On commencement of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018,-
    - (i) the Directorate of Information Technology, shall cease to be an Attached Department of Science and Technology and Information Technology Department of Government, and shall be merged into Board and the Board shall, take over the functional, administrative, financial and regulatory control over all the activities, offices, projects, centers, etc. of the Directorate of Information Technology, for the disposal of its functions;
    - (ii) all the movable and immovable assets and liabilities including furniture, fixture, equipment, vehicles, record, data etc. of the Directorate of information Technology shall be transferred to the Board and ownership of such assets shall vest in the Board;
    - (iii) all the civil servants serving in Directorate of Information Technology, shall be given an option, either to continue to serve as civil servant or may opt for the employment of the Board. The option shall be exercised within a period of thirty days after the commencement of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018. Those employees, who do not opt for their absorption in the Board, shall be absorbed in the Directorate of Science and Technology where they can continue to be governed and regulated in accordance with the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made there under; and



- (iv) projects of the Directorate of Information Technology along with its employees shall be transferred to the Board for the completion of remaining activities of such projects.".
- 4. Amendment of section 4 of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the said Act, in section 4.—
  - (i) for sub-section (5), the following shall be substituted, namely:
    - "(5) Government may at any time terminate the nomination of any member mentioned at clause (h) of sub-section (1), by assigning cogent reasons."; and
  - (ii) for sub-section (7), the following shall be substituted, namely:
    - "(7) The members at clause (h) of sub-section (1), shall be entitled to an amount of rupecs twenty thousand as honoraria for attending a meeting of the Board."
- 5. Amendment in section 7 of the Khyber Pakhtunkhwa Act No. XI of 2011.--In the said Act, in section 7, in sub-section (2),-
  - in clause (a) for the words "private sector", the words "public and private sectors" shall be substituted;
  - (b) in clause (c), the word "and" appearing at the end shall be deleted;
  - (c) for clause (d), the following shall be substituted, namely:
    - "(d) supervise, evaluate and lead telecom regulators, operators and service providers for provision of wide range of high quality, efficient, cost effective and competitive information and communication technology services throughout the Province, in order to reduce broadband bandwidth tariffs, improve access, protect consumer rights and interests and regulate arrangements with the service providers of sharing their revenue with the Board, derived from provision of services in the Province;";
  - (d) for clause (e) the following shall be substituted, namely:
    - "(e) plan, develop and establish Software Technology Parks, Technology Cities for Information and Communication Technology and Electronic manufacturing and Information Technology Parks in the Province;"; and
  - (e) in clause (m), the full stop appearing at the end shall be replaced by semicolon and thereafter the following new clauses shall be added, namely:

- "(n) finance, promote, train and develop the human resource and entrepreneurs of the Province in the field of information and communication technology, within Pákistan as well as abroad;
- (o) launch Research and Development Programs and up-gradation of its infrastructure:
- (p) monitor and evaluate the outcome and results of Information and Gommunication Technology projects initiated by Government in the Province and provide policy guidelines to Government departments, Government organizations, semi-autonomous and autonomous agencies under the administrative control of Government, Research and Development institutions for their restructuring and enhancement of Information and Communication Technology activities;
- (q) advise and regulate Government departments, Government organizations, semi-autonomous and autonomous agencies under the administrative control of Government on the introduction and usage of Information and Communication Technology;
- (r) promote usage of Information and Communication Technology by awarding scholarships, awards, certificates, holding of conferences, expos, seminars, workshops, in-service training and acquiring higher education;
- (s) plan, execute, monitor, evaluate and regulate computerization, automation and all Information and Communication Technology related initiatives, activities and projects in Government departments, Government organizations, semi-autonomous and autonomous agencies under the administrative control of Government;
- (t) plan, execute, monitor and regulate electronic governance and mobile governance of Government departments;
- (u) promote, establish, monitor, evaluate and regulate electronic commerce, electronic payments, electronic payment gateways and electronic payment service providers in the Province;
- (v) establish venture capital fund, angel investment fund, crowd sourcing fund, private equity fund or any other variant of fund, for financing, investing and holding equity share in technology startup businesses;
- (w) enter into Concession Contract under the Khyber Pakhtunkhwa Public Private Partnerships Act, 2014, for promoting Public Private Partnership;
- (x) establish academia-industry linkages; and



- (y) ensure that the shares of the Province in all Federal Information and Communication Technology related services, including autonomous bodies and corporations established by, or under the control of, Federal Government, such as, Universal Service Fund, National Information and Communication Technology Research and Development Fund etc, shall be secured.".
- 6. Amendment in section 8 of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the said Act, in section 8, for sub-section (1) the following shall be substituted, namely:
  - (a) "(1) The Managing Director shall be appointed by the Board, on the recommendations of a Search and Scrutiny Committee, to be constituted by the Board, on such salary and terms and conditions as may be prescribed.";
  - (b) for sub-section (5), the following shall be substituted, namely:
    - "(5) The Managing Director shall hold office for a term of five years and shall be eligible for re-appointment for such further term or terms, not exceeding five years at any one time, as the Board may deem fit.";
  - (c) in sub-section (6), for the word "Government", the word "Board," shall be substituted;
  - (d) in sub-section (7), for the words "the Chairman may appoint any Director or member of the Board"; the words "the Board may appoint any Director of the Board" shall be substituted; and
  - (e) after sub-section (7), the following new sub-sections shall be added, namely:
    - "(8) The Search and Scrutiny Committee, under sub-section (1), shall comprise of five members, who shall be members of the Board, with majority of members nominated under clause (h) of sub-section (1) of section (4).
    - (9) The Search and Scrutiny Committee, shall seek applications through public advertisement, and recommend to the Board, a candidate with the highest score on the merit list, for appointment as Managing Director.".
  - 7. Amendment in section 9 of the Khyber Pakhtunkhwa Act No. XI of 2011,--In the said Act, in section 9, after sub-section (4), the following new sub-section (5) shall be inserted, namely:
    - "(5) A person appointed by the Board, under sub-section (1) and (3) of section 9, shall, on satisfactory completion of probation, be deemed confirmed in service with effect from initial appointment.".


- 8. Amendment in section 11 of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the said Act, in section 11, in sub-section (3), for clause (a), the following shall be substituted, namely:
  - "(a) one-line budget from Government;".
- 9. Amendment in section 12 of the Khyber Pakhtunkhwa Act No. Xi of 2011.--In the said Act, in section 12, the words "as grant-in-aid" shall be deleted.
- 10. Amendment in section 13 of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the said Act, in section 13, after sub-section (2), the following new sub-section (3) shall be inserted, namely:
  - "(3) The Board may, in addition to the audit under sub-section (2), cause its accounts to be audited by any other external auditor.".

The undersigned has been appointed in Directorate of Information Technology, Government of 1. Khyber Pakhtunkhwa and first entered into Government Servant in 2007. The undersigned have been appointed to the present post in 03-03-2011 in Directorate of Information Technology. In The same services holding the same post the service of undersigned has been regularized through Act on 29-09-2016 and Notification was issued on 07-12-2016 under pursuance of Khyber Pakhtunkhwa Ad-hoc Employees of Directorate of Information Technology (Regularization of Services) Act 2016. Directorate of IT, the Employees Regularization Act 2016 provides the legal frame work for "regularization of certain employees appointed on ad-hoc basis in the Directorate of IT, KP". The Act has further clarified and settled the service conditions of the employees of Directorate IT through notification dated 07-12-2016 and subsequent issuance of the seniority lists of the employees of IT Directorate dated 30-12-2016 (Annexed) in which the Date of entry into the Government Service is mentioned as 01-07-2007 and Date of appointment/promotion to present post is mentioned as 02-03-2011. This tentative seniority list has been dully approved by Administrative Secretary ST&IT Department for Accountant BS-16 of Directorate of Information Technology. However, it has been observed that the subject tentatively seniority list required corrections/considerations in the light of already approved tentative seniority issued by Administrative Department which is higher forum than this Directorate.

In pursuance of clause (iii) of Section 3A of Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment)Act, 2018, "all the civil servants in Directorate of Information Technology, shall be given an option, either to continue to serve as civil servant or may opt for the employment of the Board. The option shall be exercised within a period of thirty days after the commencement of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act 2018. Those employees, who do not opt for their absorption in the Board, shall be absorbed in the Directorate of Science and Technology where they can continue to be governed and regulated in accordance with the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made there under, To justify this clause it is suffice it to say that the express provisions of the KP IT Board Amended Act 2018, regarding in the merger and absorption of the employees of Directorate of IT staff has been definitively determined by the Act itself. Section3, Clause (iii), requires the absorption of the Directorate of IT employees in the Directorate of Science and Technology. The Administrative Department has issues Notification (annexed) on 06-04-2018 in which all the regular employees of Directorate of Information Technology were hereby absorbed in Directorate of Science and Technology to continue as civil servant, which clearly means that these staff has been absorbed from one attached department to



another attached department under same Administrative Department i.e. ST&IT Department. Furthermore, the employees has been absorbed in continuations of their services as civil servants and has not been placed/absorbed/transferred from any Surplus pool, as no Surplus pool has been generated/created by Administrative Department or whatsoever the authority is for these employees. In the meanwhile, rules/regulation for surplus employees are also not applicable to this kind of absorption. Furthermore, during the merger nor the Act the has any provision for fixation of staff seniority nor the Notification has any provision of placing the absorbed employees will be treated as junior. It is to bring into to your kind consideration that the committee has totally neglected the already issued tentative seniority list by Administrative Department or they should have taken advised/guidance/opinion by the Administrative Department which was also not considered.

- After the absorptions of Directorate of IT employees and Employees absorbed from regularized projects all officers are from IT background and higher in numbers than of Science & Technology background, it has been observed that the constituted committee members are from Science & technology and no such member has been considered from IT side which may leads this fixation of seniority as biased and self-promotion. The committee has also included the member who has already placed complaints in the same seniority fixation to Administrative Department which should be not considered as the case may be controversial from his side as well. It was also observed that constituted Committee may not have that experience of catering such important issue related to employee's promotion and future protectives.
- 4. In view of above, it is requested to please consider the observation and reconstitute the committee for fixation of seniority list in the best interest of Directorate staff. It is further requested to consider my seniority as per the approved tentative seniority issued by Administrative Department in 30-12-2016 as no such interventions has been made after merging of Directorate of IT or to take opinion/clarification/guidance from Administrative Department or Establishment Department in the matter please.





### **PRELIMINARY OBJECTIONS:**

- 1. The appellant has not come to the learned Tribunal with clean hands.
- 2. The appellant has no locus standi to file this service appeal.
- 3. The case is not maintainable to file.
- 4. The appellant has been treated equally after observance of all codal formalities laid down for all provincial Govt. Departments.
- 5. The instant appeal is based on equivocal and ambiguous statements.
- 6. The appellant has misled& misguided this tribunal in filing the instant appeal.
- 7. Based on malafide intentions, the petitioner wants to stop the promotion process and career progression of other servants.
- 8. That the appellant has been estopped by his own conduct.

#### FACTS:

- 1. Correct, Pertaining to the petitioner's personal identity, character and profile, hence need no comment.
- 2. Correct, the appellant Mr. Shah Saood was appointed on adhoc basis in Erstwhile Directorate of IT by Departmental Selection Committee till the regular appointment from the Khyber Pakhtunkhwa Public Service Commission vide



ST&IT Department Notification No. SO(E)ST&IT/KP/2-36/S.Rules-IT/08 dated 03-03-2011 (ANNEXED "E").

- 3. Correct, as pointed out by the appellant himself that his services and appointment was regularized in 29<sup>th</sup>September, 2016 and not earlier.
- 4. Correct, as mentioned in Para No. 2, Mr. Shah Saood along with other Adhoc employees of the erstwhile Directorate of Information technology were regularized under the Khyber Pakhtunkhwa Adhoc Employees of Directorate of Information Technology "Directorate of Information Technology (Regularization of Services) Act, 2016 (Khyber Pakhtunkhwa Act No. XIX of 2016), dated 29-09-2016. (ANNEXED "F"). Consequent upon the enactment, the Department of ST & IT issued a Notification in pursuance of the Khyber Pakhtunkhwa Adhoc Employees of Directorate of Information Technology "Regularization of Services" Act, 2016 vide Notification No. SOE/ST&IT/KP/2-5/IT Dirtt:/2016 dated 07-12-2016 wherein the services of the Appellant Mr. Shah Saood were regularized erstwhile Directorate ofInformation along with other officials of the Technology from the date of commencement of the above mentioned Act (ANNEXED "G").
- 5. Incorrect, Regular appointment can only be considered from the date of regularization and not on initial appointment on adhoc basis. It is further elaborated in the Directorate of Information Technology (Regularization of Services) Act, 2016 (Khyber Pakhtunkhwa Act No. XIX of 2016) in Section 3, Clause (1) "All employees appointed on adhoc basis by the Government in the Directorate of Information Technology in the year of 2011 and holding posts till the commencement of this Act, shall be deemed to have validly been appointed to those posts on regular basis from the date of the commencement of this Act: Provided that- (a) such employees were appointed against those posts which falls within the ambit of the Commission; (b) the services of such employees shall be deemed to have been regularized under this Act only on the publication of their names in the official Gazette; and (c) such employees possess the qualification and experience prescribed for the posts to which they are appointed on regular basis". This clearly mentions that the regular appointment will be considered on the regular posts of erstwhile DoIT after the commencement of this Act. In addition, the Section 5 of the Act is also reproduced herein as, " **Determination of seniority.—** (1) Those employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior under the services tenure spent on adhoc basis against approved posts to all civil servant ongoing to the same service or cadre as the case may be who are in service on regular basis on the commencement of this Act and shall also rank junior to such other person, if any who, in pursuance the recommendation of the commission or committee, or body, constituted for the purpose, made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.(2) The inter-se-seniority of the employees, whose services are regularized under this Act with in the same service or cadre, shall be determined on the basis of their continuous officiating in such service or cadre.



- 6. Correct, The Appellant along with other regular employees of the Erstwhile Directorate of Information Technology were given an option to continue their regular services in the Directorate of Science & Technology or accept being absorbed in the KP IT Board as per Section 3(A) of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act 2018 (Khyber Pakhtunkhwa Act No. IV of 2018) dated 5<sup>th</sup> March, 2018 (ANNEXED "H "). The regular employees of the erstwhile Directorate of Information Technology did not opt for absorption in the KP IT Board and opted for continuation of their services in the Directorate of Science & Technology. Consequently, Department of Science & Technology andInformation Technology issued a Notification regarding absorption notification No.SOE/ST&IT/KP/1-9/Merging of DoIT-KPITB/17/V-II dated April 06, 2018 of regular employees of erstwhile Directorate of InformationTechnology in the Directorate of Science & Technology (ANNEXED "I").
- 1. The respondent No. 3 Mr. Amir Muhammad was appointed on 08-06-2016 on regular basis in the Directorate of Science & Technology through KP Public Service Commission (ANNEXED " J"). Whereas, the appellant was appointed by Departmental Selection Committee (DSC) on adhoc basis as shown in the seniority list (ANNEXED " K ") therefore, he is senior to the appellant as per Khyber Pakhtunkhwa Civil Servants Act 1973 and prevailing Khyber Pakhtunkhwa Appointment, Promotion and Transfer(APT) Rules 1989. Therefore adhoc appointment and adhoc service rendered by the appellant Mr. Shah Saood cannot be considered as regular service as per Government Rules. It is therefore not a correct and valid plea that the appellant services may considered for seniority from 03-03-2011. The rules & regulations of Esta Code pages 134-135 do not count the adhoc service towards Seniority/promotions in following words:



### "Counting of Ad hoc Service:

- (ix) Special conditions with regard to Ad hoc Service-Ad hoc appointments will not confer any right on the Government servants in the matter of regular appointment to the same post nor the service will count towards seniority.
- (x) Service in an Ad hoc capacity will count as experience for the purpose of minimum qualification of a post."(ANNEXED " L").
- 7. The private respondent Mr. Amir Muhammad was appointed in the Directorate of Science &Technology through KP Public Service Commission on 08-06-2016. Whereas the services of the appellant were regularized from the date of commencement of the relevant Act. In light of the factual position, this directorate issued a Tentative seniority list wherein Mr. Amir Muhammad was

shown senior to the appellant Mr. Shah Saood on the basis of regular appointment to the post of Accountant. It has been explained in the earlier paras that the length of adhoc service cannot be considered as regular service under the prevalent rules. Rather adhoc appointment is made to ensure that the office work continues without any hindrance until a regular appointee duly recommended by the KP Public Service Commission comes in. It is further elaborated through the initial appointment order of the Appellant Mr. Shah Saood that services rendered by him under the adhoc appointment would not be considered towards the seniority. In his subsequent appointment orders, it is clearly written that his services were regularized after the commencement of the above-mentioned act.

8. The appeal against the issuance of seniority list was properly examined and replied videDirtt:/S&T/KP/3399 dated 27-07-2020 which was not covered under the rules and laws. Therefore, it was turn downed (ANNEXED "M").

### **GROUNDS:**

- A) Appeal is incorrect and illegal, as Adhoc appointment is an aberration rather than a norm. Therefore, terming adhoc appointment as regular service is tantamount to meeting injustice to those employees who are appointed through proper channel after going through the rigorous procedures of recruitment by the Public Service Commission.
- B) As stated in earlier paras continuous adhoc service cannot be termed as regular servicetoward seniority as the appellant was appointed on adhoc basis. Whereas, in the regularization Act, it is clearly written that the employees of Directorate of IT would be considered regular from the date of commencement of this Act and not vice versa.
- C) It is a wrong interpretation of the Rule-17 of the Appointment, Promotion &Transfer Rules, 1989.As the appellant was regularized vide Directorate of Information Technology (Regularization of Services) Act, 2016 (Khyber Pakhtunkhwa Act No. XIX of 2016)in which Section 3& 5 clearly determine the seniority and later on being absorbed in Directorate of Science & Technology through KP IT Board as per Section 3(A) of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act 2018 (Khyber Pakhtunkhwa Act No. IV of 2018) dated 5<sup>th</sup> March, 2018 of the Act.
- D) Incorrect, Therefore, the seniority of the appellant is determine in the light of the erstwhile Directorate of Information Technology (Regularization of Services) Act, 2016 (Khyber Pakhtunkhwa Act No. XIX of 2016)in which Section 3& 5 clearly determine the seniority and later on being absorbed in Directorate of Science &

Technology through KP IT Board as per Section 3(A) of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act 2018 (Khyber Pakhtunkhwa Act No. IV of 2018) dated 5<sup>th</sup> March, 2018 of the Act. Therefore the respondent No. 3 Mr. Amir Muhammad was considered senior as far as their cadre is concerned in relation to the appellant Mr. Shah Saood. The same has been reflected in the seniority list issued by this directorate dated 08-06-2020.

- E) Incorrect, In this regard, reference of the Khyber Pakhtunkhwa Civil servants Act, 1973 is made towards the Section 8 Clause(4) which states that, "Seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post" (ANNEXED "N"). As the appellant was appointed on regular basis from the date of commencement of the Regularization Act, Therefore, his services on regular basis can only be considered from that date and not vice versa.
- F) Incorrect statement of the grounds. The appellant seniority is determined in the light of above mentioned acts 2016 & 2018 accordingly.
- G) This statement is wild conjecture. The Directorate General of Science & Technology and the Department of Science & Technology and Information Technology has treated the appellant as per law and rules. A person cannot be granted seniority as per his whims and wishes.
- H) No Comments.

APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA, SERVICE TRIBUNAL ACT, 1974 04.08.2020 NOTIFICATION WHEREBY THE APPELLANT'S NAME HAS BEEN WRONGLY PLACED AT S.NO.2 OF THE FINAL SENIORITY LIST AND AGAINST THE INACTION OF THE RESPONDENTS FOR NOT DECIDING THE DEPARTMENTAL APPEAL WITHIN STATUTORY PERIOD OF NINETY DAYS.

### PRAYER:

That on acceptance of this appeal the impugned senority list may be set-aside with the directions to the respondent to place the name of the appellant at S.No.1 of the final seniority list by modifying the same as per law and rules. Any other remedy, which this august Tribunal deems fit and appropriate that may also be awarded in favour of the appellant.



### RESPECTFULLY SHEWETH:

### FACTS:

- 1. That the appellant was initially appointed as Accountant on fixed pay/contract basis on 26.11.2009 in the respondent department. The appellant performed his duties with full zeal and zest, and that no complaint has been filed against him regarding his performance of duty. (Copy of appointment order dated 26.11.2009 is attached as Annexure "A").
  - 2. That the appellant vide notification dated 03.03.2011 was again appointed as Accountant (BPS-16) in the Directorate of Information Technology, KP on <u>ad-hoc</u> basis for a period of one year. (Copy of notification dated 03.03.2011 is attached as Annexure "B").
    - 3. That the appellant, every year got yearly extension in his ad-hoc appointment from 2011 till 2016, until his regularization in the year 2016. (Copies of extension notifications are attached as Annexures "C, C1, C2, C3, & C4").
    - 4. That the appellant along with other employees of the Directorate of Information Technology got regularization on 29.09.2016 under the Khyber Pakhtunkhwa Adhoc Employees of Directorate of Information Technology (Regularization of Services) Act, 2016 which was further endorsed in the departmental notification dated 07.12.2016. (Copies of Regularization Act, 2016 and departmental notification dated 07.12.2016 are attached as Annexures "D" & "E").
      - 5. That the tentative seniority list in the Directorate of Information Technology (ST & IT) Department, Peshawar was issued on 30.12.2016 in which the date of regular appointment/ promotion to present post of the appellant is recorded as 02.03.2011. (Copy of Tentative Seniority List dated 30.12.2016 is attached as Annexure "F").
        - 6. That thereafter, under The Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018; the appellant along with others got absorbed in the Directorate of Science and Technology, Khyber Pakhtunkhwa by opting to be remained as civil servant as per requirement of the law. (Copies of The Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018 and Absorption Notification dated 06.04.2018 are attached as Annexure "G" & Annexure "H").
          - 7. That on 08.06.2020 a tentative seniority list was notified in which the appellant seniority has been counted from 07.12.2016 which is the date of notification of regularization in the Directorate of Information and Technology and he was shown junior to the private respondent

namely, Mr. Amir Muhammad (BPS-16) Accountant which is against the law and rules as well as various judgments of the superior courts (Copy of Tentative Seniority List dated 08.06.2020 is attached as Annexure - "I").

- 8. That the appellant filed objections against the tentative seniority list on 22.06.2020 which was rejected on 27.07.2020. (Copies of objection application against the tentative seniority list and further rejection order are attached as Annexures "J" & "K").
- 9. That the department notified Final Seniority List on 04.08.2020 in which he was again shown junior to the private respondent; against which the appellant filed departmental appeal on 12.08.2020 which was not responded within the statutory period of 90 days. (Copies of Final Seniority List dated 04.03.2020 and second departmental appeal are attached as Annexures "L" & "M").
  - 10. That now the appellant comes to this August Tribunal on the following grounds amongst others:

### GROUNDS:

- A. That the impugned seniority list dated 04.04.2020 and not deciding the departmental appeal of the appellant within 90 days, is against the law, facts, norms of justice and material on record. Therefore, such action and inaction of the respondent department is illegal and unlawful.
- B. That the appellant's service was regularized in the light of Regularization Act of 2016 dated 29.09.2016 wherein the appellant's appointment has been ad-hoc with effect from 2011 and is being declared valid, and since then (03.03.2011) the appellant has been continuously performing his duties as civil servant. Therefore, as per law regarding seniority is to be counted with effect from the date of regular/ continuous officiation.
- C. That upon the creation of IT Board under the Act of 2018 dated 05.03.2018 all those employees who opted to remain as civil servant shall be absorbed in the Directorate of Science and Technology. Therefore, keeping in view the principle of restructuring/ absorbtion an the spirit of Rule-17 of the Khyber Pakhtunkhwa APT Rules, 1989 the seniority of the appellant was required to be counted with effect from the date of continuous officiation.
  - D. That before the creation of the IT Board the appellant date of regular appointment was recorded as 02.03.2011 in the tentative seniority list and that remained in field for a long period. Therefore, keeping in

view the judgement reported as 2014 PLD 338 and the Principle of Locus Poenitentiae the appellant seniority could not be disturbed.

- E. That as per the spirit of Section-8 of the KP Civil Servant Act, 1973 and Rule-17 of the APT Rules, 1989; the appellant has wrongly been placed at serial no. 2 and as such the same final seniority list needs rectification.
  - F. That there are numerous judgements of the superior courts wherein it has been held that regularization is the continuation of the previous appointment and cannot be termed as fresh appointment. Therefore, the official is entitled to the seniority from the date of first appointment.
  - G. That the appellant has not been treated as per law and rules, and has been deprived from the seniority benefits by exercising authority in a fanciful manner.
  - H. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 29th September, 2016).

AN ACT

to provide for regularization of services of certain employees appointed on adhoc basis in the Directorate of Information Technology,

Khyber Pakhtunkhwa.

**Preamble:-** WHEREAS it is expedient to provide for regularization of certain employees appointed in the Directorate of Information Technology in 2011 on adhoc basis and other ancillary matters hereinafter appearing;

It is hereby enacted as follows:-

- Short title and commencement.-- (1) This Act may be called the Khyber Pakhtunkhwa Adhoc Employees of Directorate of Information Technology (Regularization of Services) Act, 2016.
  - It shall come into force at once. (2)
  - Definitions.- (1) In this Act unless the context otherwise requires,-2.
    - "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
    - "Department" means Science & Technology and Information Technology (a) (b)Department;
      - "employees" means employees the Deputy Director (BPS-18), Network Manager (BPS-17) IIS Manager (BPS-17), Accountant (BPS-16) and Computer Operator (BPS-12) appointed on adhoc basis by the Government in the Directorate of (c). Information Technology of Khyber Pakhtunkhwa, in 2011;
        - "Government" means the Government of Khyber Pakhtunkhwa; (d)
        - "Law or Rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and (e)
        - "Post" means the posts of the Deputy Director (BPS-18), Network Manager (BPS-17), IIS Manager (BPS-17), Accountant (BPS-16) and Computer Operator (BPS-12) in the Department and is required to be filled on the recommendation of the Commission.
    - The expression "adhoc appointment" shall have the same meanings as respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Civil Servants Act No. XVIII of 1973).
    - Regularization of services of certain employees of the Directorate of Information Technology.--(1) All employees appointed on adhoc basis by the Government in the Directorate of Information: Technology in the year of 2011 and holding posts till the commencement of this Act, shall be deemed to have validly been appointed to those posts on regular basis from the date of the commencement of this Act:

### Provided that-

such employees were appointed against those posts which falls within the ambit of the Commission;

- (b) the services of such employees shall be deemed to have been regularized under this Act only on the publication of their names in the official Gazette; and
- (c) such employees possess the qualification and experience prescribed for the posts to which they are appointed on regular basis.
- 4. <u>Determination of pay scales.</u>-- All employees whose services are regularized under this Act or in the process of attaining service at commencement of this Act shall be placed on basic pay scale, given as under:
  - i. Deputy Director (BPS-18)
  - ii. Network Manager (BPS-17)
  - iii. IIS Manager (BPS-17)
  - iv. Accountant (BPS-16)
  - v. Computer Operator (BPS-12)
  - 5. <u>Determination of seniority.</u>— (1) Those employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior under the services tenure spent on adhoc basis against approved posts to all civil servant ongoing to the same service or cadre as the case may be who are in service on regular basis on the commencement of this Act and shall also rank junior to such other person, if any who, in pursuance the recommendation of the commission or committee, or body, constituted for the purpose, made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.
  - (2) The inter-se-seniority of the employees, whose services are regularized under this Act with in the same service or cadre, shall be determined on the basis of their continuous officiating in such service or cadre.
  - 6. Overriding effect.--Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of in consistency to this Act shall cease to have effect.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Establishment of Information Technology Board Act, 2011 (Khyber Pakhtunkhwa Act No. XI of 2011), for the purposes hereinafter appearing;

1. Short title and commencement—(1) This Act may be called the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018,

2. Substitution of Preamble of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the Khyber Pakhtunkhwa Establishment of Information Technology Board Act, 2011 (Khyber Pakhtunkhwa Act No. XI of 2011), hereinafter referred to as the said Act, for the existing Preamble, the following shall be substituted, namely:

"WHEREAS it is expedient to provide for the establishment of the Khyber Pakhtunkhwa Information Technology Board for promotion, planning, execution, supervision, evaluation and regulation of the Information and Communication Technology, Information and Communication Technology enabled services and education for public and private sectors of the Province of the Khyber Pakhtunkhwa and for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:".

3. Insertion of new section in the Khyber Pakhtunkhwa Act No. XI of 2011.--In the said Act, after section 3, the following new section 3A shall be inserted namely:

"3A. Status of the Directorate of Information Technology and its employees.-On commencement of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018.-

- (i) the Directorate of Information Technology, shall cease to be an Attached Department of Science and Technology and Information Technology Department of Government, and shall be merged into Board and the Board shall, take over the functional, administrative, financial and regulatory control over all the activities, offices, projects, centers, etc. of the Directorate of Information Technology, for the disposal of its functions;
- (ii) all the movable and immovable assets and liabilities including furniture, fixture, equipment, vehicles, record, data etc. of the Directorate of Information Technology shall be transferred to the Board and ownership of such assets shall yest in the Board;
- (iii) all the civil servants serving in Directorate of Information Technology, shall be given an option, either to continue to serve as civil servant or may opt for the employment of the Board. The option shall be exercised within a period of thirty days after the commencement of the Khyber Pakhtunkhwa Establishment of Information Technology Board (Amendment) Act, 2018. Those employees, who do not opt for their absorption in the Board, shall be absorbed in the Directorate of Science and Technology where they can continue to be governed and regulated in accordance with the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made there under; and

- (iv) projects of the Directorate of Information Technology along with its employees shall be transferred to the Board for the completion of remaining activities of such projects.".
- 4. Amendment of section 4 of the Khyber Pakhtunkhwa Act No. XI of 2011.—In the said Act, in section 4.-
  - (i) for sub-section (5), the following shall be substituted, namely:
    - "(5) Government may at any time terminate the nomination of any member mentioned at clause (h) of sub-section (1), by assigning cogent reasons."; and
  - (ii) for sub-section (7), the following shall be substituted, namely:
    - "(7) The members at clause (h) of sub-section (1), shall be entitled to an amount of rupees twenty thousand as honoraria for attending a meeting of the Board."
- 5. Amendment in section 7 of the Khyber Pakhtunkhwa Act No. XI of 2011.--In the said Act, in section 7, in sub-section (2),-
  - (a) in clause (a) for the words "private sector", the words "public and private sectors" shall be substituted;
  - (b) in clause (c), the word "and" appearing at the end shall be deleted;
  - (c) for clause (d), the following shall be substituted, namely:
    - "(d) supervise, evaluate and lead telecom regulators, operators and service providers for provision of wide range of high quality, efficient, cost effective and competitive information and communication technology services throughout the Province, in order to reduce broadband bandwidth tariffs, improve access, protect consumer rights and interests and regulate arrangements with the service providers of sharing their revenue with the Board, derived from provision of services in the Province;":
  - (d) for clause (e) the following shall be substituted, namely:
    - "(e) plan, develop and establish Software Technology Parks, Technology Cities for Information and Communication Technology and Electronic manufacturing and Information Technology Parks in the Province;"; and
  - (e) in clause (m), the full stop appearing at the end shall be replaced by semicolon and thereafter the following new clauses shall be added, namely:

- "(n) finance, promote, train and develop the human resource and entrepreneurs of the Province in the field of information and communication technology, within Pakistan as well as abroad;
- (o) launch Research and Development Programs and up-gradation of its infrastructure;
- (p) monitor and evaluate the outcome and results of Information and Communication Technology projects initiated by Government in the Province and provide policy guidelines to Government departments, Government organizations, semi-autonomous and autonomous agencies under the administrative control of Government, Research and Development institutions for their restructuring and enhancement of Information and Communication Technology activities;
- (q) advise and regulate Government departments, Government organizations, semi-autonomous and autonomous agencies under the administrative control of Government on the introduction and usage of Information and Communication Technology;
- (r) promote usage of Information and Communication Technology by awarding scholarships, awards, certificates, holding of conferences, expos, seminars, workshops, in-service training and acquiring higher education;
- (s) plan, exocute, monitor, evaluate and regulate computerization, automation and all Information and Communication Technology related initiatives, activities and projects in Government departments, Government organizations, semi-autonomous and autonomous agencies under the administrative control of Government;
- (t) plan, execute, monitor and regulate electronic governance and mobile governance of Government departments;
- (u) promote, establish, monitor, evaluate and regulate electronic commerce, electronic payments, electronic payment gateways and electronic payment service providers in the Province;
- establish venture capital fund, angel investment fund, crowd sourcing fund, private equity fund or any other variant of fund, for financing, investing and holding equity share in technology startup businesses;
- (w) enter into Concession Contract under the Khyber Pakhtunkhwa Public Private Partnerships Act, 2014, for promoting Public Private Partnership;
- (x) establish academia-industry linkages; and

- (y) ensure that the shares of the Province in all Federal Information and Communication Technology related services, including autonomous bodies and corporations established by, or under the control of, Federal Government, such as, Universal Service Fund, National Information and Communication Technology Research and Development Fund etc, shall be secured."
- 6. Amendment in section 8 of the Klyber Pakhtunkhwa Act No. XI of 2011.--In the said Act, in section 8, for sub-section (1) the following shall be substituted, namely:
  - (a) "(1) The Managing Director shall be appointed by the Board, on the recommendations of a Search and Scrutiny Committee, to be constituted by the Board, on such salary and terms and conditions as may be prescribed.";
  - (b) for sub-section (5), the following shall be substituted, namely:
    - "(5) The Managing Director shall hold office for a term of five years and shall be eligible for re-appointment for such further term or terms, not exceeding five years at any one time, as the Board may deem fit.";
  - (c) in sub-section (6), for the word "Government", the word "Board," shall be substituted;
  - (d) in sub-section (7), for the words "the Chairman may appoint any Director or member of the Board", the words "the Board may appoint any Director of the Board" shall be substituted; and
  - (e) after sub-section (7), the following new sub-sections shall be added, namely:
    - "(8) The Search and Scrutiny Committee, under sub-section (1), shall comprise of five members, who shall be members of the Board, with majority of members nominated under clause (h) of sub-section (1) of section (4).
    - (9) The Scarch and Scrutiny Committee, shall seek applications through public advertisement, and recommend to the Board, a candidate with the highest score on the merit list, for appointment as Managing Director.".
- 7. Amendment in section 9 of the Khyber Pakhtunkhwa Act No. XI of 2011. In the said Act, in section 9, after sub-section (4), the following new sub-section (5) shall be inserted, namely:
  - "(5) A person appointed by the Board, under sub-section (1) and (3) of section 9, shall, on satisfactory completion of probation, be deemed confirmed in service with effect from initial appointment.".

### Counting of Ad hoc Service

### Ad hoc Service Ad hoc Appointment

This Department's letter No.SOIV(S&GAD)16-14/64(Policy), dated 20th October, 1969, on the subject noted above, and to say that in view of the complaints of favoritism and irregularities in the making of Ad hoc appointments, a decision was taken by Government to withdraw these powers from the Administrative Departments. An Ad hoc Appointments Committee was constituted with the Chairman Public Service Commission as its head.

- 2. The position has since been reviewed by the Government. The Administrative Departments have been pressing for restoration of powers of making Ad hoc appointments. It has been urged that powers of making appointments on an emergency basis, would give greater operational freedom to executing agencies and would speed up the implementation of projects and programmes. The grant of these powers to the Administrative Departments will ensure that responsibility for failure to fulfill the prescribed targets rests squarely on the Administrative Departments. In view of the considerations mentioned above, it has been decided to restore the powers of making Ad hoc appointments to the Administrative Departments and other authorities. The Ad hoc Appointments Committee has been abolished with immediate effect.
- 3. To ensure that there is no repetition of complaints with regard to favoritism and irregularities, it has been decided that the following procedure/instructions shall be observed strictly by appointing authorities:-
  - (i) Requisition to Public Service Commission:- a requisition must be sent to the Public Service Commission before action is taken to fill up the post on an ad hoc basis.
  - (ii) Advertisement of vacancies:- The vacancies for direct recruitment should be filled up after proper advertisement only.
  - (iii) Appointment to conform to recruitment rules:- The appointments should conform to the provisions of the service/ recruitment rules and in particular, the regional quotas prescribed by Government should be strictly adhered to.
  - (iv) Criteria for selection- (a) The selection should be made on the basis of merit and objective criteria should be used.
    - (b) In the absence of any other important factor, the selection of direct recruits should be based on the marks obtained by the candidate in the examination for the degree/diploma, etc. which is prescribed as the minimum qualifications for the post.
    - (c) In the case of promotions, the selection should be based strictly on the service record.



- (d) The particulars of all candidates applying for the post should be tabulated in appropriate form, and signed by the Chairman of the Selection Board. Where candidates have been eliminated on the basis of a qualifying minimum e.g, examination/grades(it would not be necessary to list all the particulars of the candidates).
- (v) Setting up of Selection Board The Selection should be made by a Selection Board consisting of three officers and headed by an officer not below the rank of Secretary/additional Secretary of the Administrative Department for class I and by the Regional Head/Divisional Commissioner for Class II. Immediate steps should be taken to constitute Selection Boards at the two levels.
- (vi) Appointment Orders- The appointment order should certify that a requisition for direct recruitment or promotion has been sent to the Public Service Commission.
- (vii) Appointment orders will indicate that it is subject to revocation at the discretion of the Review Board.
- (viii) Appointment orders of Ad hoc appointment will be published in Gazette.
- (ix) Special conditions with regard to Ad hoc Service-Ad hoc appointments will not confer any right on the Government servants in the matter of regular appointment to the same post nor the service will count towards seniority.
- (x) Service in an Ad hoc capacity will count as experience for the purpose of minimum qualification of a post.
- (xi) The Ad hoc appointment will only last till the recommendations of the Commission have been received and Government has approved the selection of a candidate for the vacancy. On this the services of Ad hoc appointees, if not approved by the Commission, shall be terminated.
- (xii) Provision for disposal of representation-
  - (a) Class-I Persons aggrieved by an Ad hoc appointment to a Class I post may submit representations to a Review Board consisting of a Member, Board of Revenue and Additional Chief Secretary, Services and General Administration Department. The representation will be submitted within 15 days of the publication of the Gazette notifying the appointment. The Review Board would have the authority to pass appropriate orders including the revocation of an appointment already made. The revised order will also be published in the Gazette.
  - (b) Similarly, representations against orders of Ad hoc appointments to Class-II posts will lie to the Administrative Secretary. As in the case of Class-I, the representation will be submitted within 15 days of the publication of the appointment orders in the official Gazette. The Administrative Secretary would have the authority to pass appropriate



orders, including the revocation of an appointment order. The revised order will also be published in the Gazette.

#### Ad hoc Appointments

Rule-14 of the NWFP Civil Servants (Appointment, Promotion & Transfer) Rules, 1989, provides that when the appointing authority considers it to be in the public interest to fill a post falling within the purview of the Public Service Commission urgently, pending nomination of candidate by the Commission, proceed to fill such post on ad hoc basis for a period not exceeding one year by advertising the same as in Part.III of the Rules ibid. In this connection, attention is invited to this Department's letter of even number dated 10-12-1989, wherein factual position with regard to ad hoc appointments was clarified to all concerned and it was stressed to stop making appointments on ad hoc basis. These instructions were reiterated vide this Department circular letter No.SORI(S&GAD)4-17/89(A) dated 5/3/1990.

- 2. Rule-3 of the NWFP Public Service Commission (Functions) Rules,1983, inter alia provides that the Commission shall conduct tests and examination, including Psychological test for initial recruitment to services and posts in connection with the affairs of the Province specified in the Schedule. The nomenclature of the services and posts included in the Schedule are as under:
  - i) Services and Posts in Basic Pay Scale 16 to 20 except the following posts.
    - (a) Chairman and Members of the Commission;
    - (b) Additional District and Session Judges;
    - (c) Comptroller, Governor's House, Peshawar.
    - (d) Assistant Cypher Officer in the Provincial Cypher Centre.
  - ii) Post of Assistant Sub-Inspectors of Police.
  - iii) Naib Tehsildars.
  - iv) Zilladars.
  - v) Sub-Engineers.
- 3. According to the provision of the aforesaid rules, no ad hoc appointment is permissible against any post other than the one included in the Schedule as well as all posts in the Autonomous/Semi-Autonomous Bodies and Corporations which are outside the purview of the NWFP Public Service Commission.
- 4. It has, however, come to the notice of this Department that ad hoc appointments are being made by the Autonomous/Semi-Autonomous Bodies and by certain Government Departments against posts in B-15 and below (other than those recruitment to which is within the purview of the Commission) and despite the ban imposed by Government on making ad hoc appointments. This is not at all desirable.
- 5. I am, therefore, to reiterate to strictly abide by the aforesaid instructions and stop making appointments on ad hoc basis.
