**PARA-WISE COMMENT ON BEHALF OF RESPONDENTS**

**PRE-LIMINARY OBJECTIONS:**

1. The appellant has got no cause of action to file this service appeal.
2. That the appeal is not maintainable in its present form.
3. That the appellant has no locus standi or cause of action to file the present service appeal.
4. The appeal is badly time bared. Therefore, the appeal is not maintainable.
5. That the Health Professional Allowance was granted / allowed by the Federal Govt. only to the employees of Directorate General of Special Education, Govt of Pakistan Islamabad and its allied Institutions in pursuance of the judgment of the Federal Services Tribunal. The petitioners were neither devolved employees of the Directorate General of Special Education, Govt. of Pakistan Islamabad nor they have been appointed by the Federal Govt in the Directorate General of Special Education Govt. of Pakistan, Islamabad and its allied institutes, therefore the said allowance is not admissible to the appellants.
6. The said allowance was also allowed by Provincial Govt. to the devolved employees of Directorate General of Special Education, Govt. of Pakistan devolved under the 18<sup>th</sup> constitutional amendment, therefore, the appeal is not maintainable.

**FACTS:**

1. Pertain to record.
2. Correct. The petitioner himself admitted that he was appointed by the Provincial Govt of Khyber Pakhtunkhwa on 10.08.1987 while the said allowance is only admissible to the


employees of Directorate General of Special Education and its allied institutions devolved under the 18<sup>th</sup> constitutional amendment hence is not entitled.


3. As per record, the department does not have any record of such appeal.
4. Incorrect, hence denied. Factual position has been explained in the preceding paras.


**GROUND**


- A. Incorrect, hence denied. The Respondents are law abiding civil servants and respect the Constitution of Islamic Republic of Pakistan & did not violate any article of the Constitution of Islamic Republic of Pakistan. Moreover, as per Notification of the Finance Department the appellants are not eligible for the said relief.
- B. Incorrect, hence denied. The factual position has been explained in the preceding para.
- C. Correct only to the extent of judgments of various Honorable Courts passed in respect of employees of Federal Govt devolved to provincial govt. under the 18<sup>th</sup> Constitutional amendment.
- D. Incorrect, hence denied. The factual position has been explained in the preceding paras.

In the view of above factual position it is humbly prayed that the appeal being devoid of any merit may graciously be dismissed with cost.
