

1. Instant appeal is directed against the order dated 11.04.2016 and 16.11.2016 circulated on 12.01.2017. Through the former, promotion order of appellant as Officiating Sub Inspector dated 25.01.2015 was withdrawn while through the latter his departmental appeal was rejected.

- 2. It is the case of appellant that he joined respondent department as constable at Malakand Division and was later promoted to the rank of Head Constable. During the course of service the appellant was promoted to the rank of Officiating ASI w.e.f. 03.02.2011 vide order dated 28.05.2011. Subsequently, the name of appellant was inserted in List-E and he was confirmed in the rank of ASI from the date of joining i.e. 03.02.2011. The said order was made through notification dated 16.03.2015. On 25.01.2016 the appellant, alongwith others, was recommended for Officiating promotion to the rank of Sub Inspector, however, on 11.04.2016 the confirmation of appellant as ASI and his admission to List-E was revised and the order dated 25.01.2016 was withdrawn. The appellant, feeling aggrieved from the impugned order preferred departmental appeal which could not find favour and was rejected, hence the appeal in hand.
 - 3. We have heard learned counsel for the appellant and learned Deputy District Attorney on behalf of the respondents and have also gone through the available record with their assistance.

It was mainly contended by the learned counsel that the treatment meted out to the appellant was based on discrimination and in clear violation of law. The principle of locus-poenitentiae was also disregarded by the respondents while passing the impugned order. The appellant was not given any opportunity of personal hearing before issuing the impugned order dated 11.04.2016. Learned counsel produced copy of judgment passed in appeal No. 872/2015 by this Tribunal on 03.04.2018 alongwith
