Respectfully Sheweth: -

PRELIMINARY OBJECTIONS: -

- 1. That the appellant has got no cause of action and locus standi to file the appeal.
- 2. That the appeal is badly barred by law and limitation.
- 3. That the appellant is estopped by his own conduct to file the instant appeal.
- 4. That the appeal is not maintainable in its present form.
- 5. That the appellant has not come to the Honourable Tribunal with clean hands.
- 6. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.

Reply on Facts: -

- 1. Para pertains to record, hence, needs no comments.
- 2. Incorrect. Appellant has never been devoted to duty, which is evident from his service record as the same is tainted with bad entries. (Detail of bad entries is annexure "A").
- 3. Incorrect. Appellant while posted at Police Station, Akbarpura, remained absent vide daily diary No. 11 dated 04-02-2018, daily diary No. 14 dated 04-02-2018 and daily diary No. 18 dated 07-03-2018 till the time of his dismissal. Later on appellant took this plea of his alleged illness only to justify his long absence. If appellant was in deed ill, he should have submitted application for proper leave but he did not do so. It is worth to mention here prior to instant dismissal appellant had also been dismissed from service in the year 2017 for his absence with effect from 14-07-2017 till the time of his dismissal i.e 26-09-2017. (Copy of dismissal order is annexure "B").

- 4. Para correct to the extent that appellant was dismissed from service, due to his absence from lawful duty on 31-05-2018.
- 5. Incorrect. Appellant was dismissed from service on 31-05-2018 while he submitted departmental appeal on 01-03-2019 which was badly time barred by almost 10 months therefore, appeal of the appellant was filed by the appellate authority being badly time barred. (Copy of departmental appeal is annexure "C").
- 6. Para is for the appellant to prove.
- 7. Appeal of the appellant is liable to be dismissed inter alia on the following grounds: -

Reply on GROUNDS

- A. Incorrect. Orders passed by the respondents are in accordance with law and rules and were passed after fulfillment of all legal and codal formalities.
- B. Incorrect. Appellant was issued Show Cause Notice to which he also submitted his reply but the same was found unsatisfactory. (Copy of Show Cause Notice and reply of the appellant are annexure "D").
- C. Incorrect. Appellant was awarded punishment for his long absence for which statement of witness was not required.
- E. Incorrect. During his service appellant has remained countless time absent meaning thereby that he was habitual absentee and was not interested in his official duty.
- F. Incorrect. As discussed in the preceding paras that prior to instant dismissal, appellant had also been earlier dismissed from service due to his long absence. However, he was reinstated by the appellate authority and his punishment of dismissal from service was converted into major punishment of reduction in time scale for 02 years. The appellant even then did not mend his way and started remaining absent from duty on one pretext or other.
- H. Incorrect. Appellant despite so many minor punishments and one punishment of dismissal from service, did not mend his way. Therefore, there was no other way but to dismiss him from service.
- I. Incorrect. Appellant was a habitual absentee and continuously remained absent. He had never been interested in his duties during his entire service, therefore, conducting enquiry was of no use as his previous record was enough for ascertaining his conduct.
- J. The respondents also seek permission of this Honourable Tribunal to advance additional grounds at the time of arguments.

<u>Prayers</u>

It is, therefore, most humbly prayed that on acceptance of above submissions, the appeal of the appellant may very kindly be dismissed with costs, please.
