

Astonishingly, the appellant is appointed in the year of 2005, but the respondent No's.5-89 are appointed in the year of 2007, respondent No.90-244 in the year of 2008 & 2009. 5. That the appellant is having no other efficacious and alternative remedy, hence approaches this Hon'ble Tribunal, inter alia on the following grounds

GROUND

- A. That it is the constitutional vested rights of the appellant to be dealt in accordance with law.

- B. That the action of official respondents by ignoring the true seniority of appellant is illegal, unlawful, against the Law & discriminatory towards him.

(COPIES OF OTHER DEPARTMENTS SENIORITY LIST ARE ATTACHED AS ANNEXURE G" & "H" RESPECTIVELY)

- C. That the appellant is appointed in the year of 2005, but the respondent No's.5 to 89 are appointed in the year of 2007, respondent No.90 to 244 are in the year of 2008 & 2009. The Subject specialist teachers appointed later on than him are given seniority by ignoring the appellant.

- D. That the impugned seniority list/order has been issued in surmises and conjectures rather based on misreading and non-reading of the law and facts of the case hence, deserves to be set at naught. Furthermore, the respondents have no lawful authority to ignore the rights of appellant without any justified reasons.

- E. That, the services of appellant is regularized through Regularization of Services Act, 2009, vide office order dated: 31.05.2010, with effect from 24.09.2009, but his seniority is denied by the official respondents by ignoring the precedent of apex Court of Pakistan rendered in 2014 SCMR 1289, moreover, in light of Article 189 of the Constitution of Islamic Republic of Pakistan, 1973, the decision/judgment of the Supreme Court is binding on all the subordinate Courts, however, the Respondents issued the impugned seniority, wherein, the appellant's seniority is given effect from the date of regularization not from the date of initial appointment, thus the act of respondent is infringement of law, regulation/rules governing the subject. The relevant article is reproduced hereinafter.

Decisions of Supreme Court Binding on Other Courts:

Any decision of the Supreme Court shall, to the extent that it decides a question of law is based upon or enunciates a principle of law, be binding on all other Courts in Pakistan.

- F. That appellant approached respondent No.2, through application and departmental appeal against the ignorance of

his seniority from the date of appointment, but his both of the applications against the tentative seniority and the final seniority list is still in an abeyance throughout.

G. That any other ground will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is therefore, most humbly prayed, that on the acceptance of instant appeal, the respondents may please be directed to reckon & modify the seniority of appellants in order of induction into service in accordance with law and rules with all back benefits, and they may further be directed to stop the discriminatory treatment towards the appellants, So as to secure the ends of justice and equity.







AN
ACT

to provide for the regularization of the services of certain employees appointed on adhoc or contract basis.

WHEREAS it is expedient to provide for the regularization of the services of certain employees appointed on adhoc or contract basis, in the public interest, for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**---(1) This Act may be called the ⁵[Khyber Pakhtunkhwa] Employees (Regularization of Services) Act, 2009.

(2) It shall come into force at once.

2. **Definitions.**---(1) In this Act, unless the context otherwise requires,-

(a) "Commission" means the ⁶[Khyber Pakhtunkhwa] Public Service Commission;

(aa) "contract appointment" means appointment of a duly qualified person made otherwise than in accordance with the prescribed method of recruitment;

(b) "employee" means an adhoc or a contract employee appointed by Government on adhoc or contract basis or second shift/night shift but does not include the employees for project post or appointed on work charge basis or who are paid out of contingencies;

- (c) "Government" means the Government of the ¹[Khyber Pakhtunkhwa];
- (d) "Government Department" means any department constituted under rule 3- of the ²[Khyber Pakhtunkhwa] Government Rules of Business, 1985, and does not include any section of a Department or an organization which is federally funded;
- (e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and
- (f) "post" means a post under Government or in connection with the affairs of Government to be filled in on the recommendation of the Commission.

(2) The expressions "ad hoc or contract appointment" and "civil servant" shall have the same meanings as respectively assigned to them in the ³[Khyber Pakhtunkhwa] Civil Servants Act, 1973 (⁴[Khyber Pakhtunkhwa] Act No. XVIII of 1973).

3. Regularization of services of certain employees.—All employees including recommendees of the High Court appointed on contract or ad hoc basis and holding that post on 31st December, 2008, or till the commencement of this Act shall be deemed to have been validly appointed on regular basis having the same qualification and experience for a regular post:

Provided that the service promotion quota of all service cadres shall not be affected.

4. Determination of seniority.—(1) The employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

(2) The seniority interse of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre:

Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

4A. Overriding effect.---Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of inconsistency to this Act shall cease to have effect.

5. Repeal.---The North-West Frontier Province Employees (Regularization of Services) Ordinance, 2009 (N.-W.F.P. Ordinance No. VII of 2009) is hereby repealed.


