



3. That on 20/3/2022 an FIR No 186 was lodged in PS Nawagal wherein the appellant was falsely charged for an ineffective fire upon the complainant along with others. (FIR No 186 attached as an x B)
4. That after the aforesaid FIR the appellant was sent to judicial lockup and pursuant to that the respondent No 1 sent a letter to the respondent No 1 for suspension of the appellant but astonishingly the respondent No 1 in total derogation of law, rules and natural justice withdrawn the appointment order of the appellant vide impugned order of withdrawal Endst No 7878.81 dated 14/7/2022. (letter of the respondent No 1 and impugned order of withdrawal of the respondent No 1 attached as an x C and C1).
5. That as the appellant came to know regarding the aforesaid impugned order he filled a departmental appeal within 3 days against the aforesaid impugned order but the same was not decided within statutory period. (copies of the deptt appeals along with post office receipts are attached as annex D, and D1)
6. That the appellant was serving as SST in GHS kalan and without any show cause notice and hearing was ousted from his service despite the fact that he had also excellently passed the induction exam. (certificate of service in GHS kaln, Monthly salary statement, induction result attached as an x E, F and G).
7. That vide Khyber pakhtunkhwa teachers (appointment and regularization of service) Act, 2022 all the colleagues of the appellant were regularized in service but the appellant was not regularized due to the abovementioned impugned Malafide withdrawal order (regularization act 2022 attached as An x H).

charged for ineffective firing just to involve him in the case who was later on released on bail.

7. That the appellant have not been treated according to the law applicable to the civil servants, hence the impugned order is against the spirit of the law.
8. That the appellant seek the permission of this worthy tribunal to rely on additional grounds at the time of arguments.

It is therefore kindly prayed that on acceptance of this appeal the impugned withdrawal order dated 14.7.2022 of the appellant's appointment order dated 14/9/2018 may kindly be set aside and the appellant be re-instated in service with all back benefits

Any other relief not specifically prayed for and which this worthy tribunal deem fit and appropriate, in the facts and circumstances of the instant case may also kindly be granted for the end of justice.

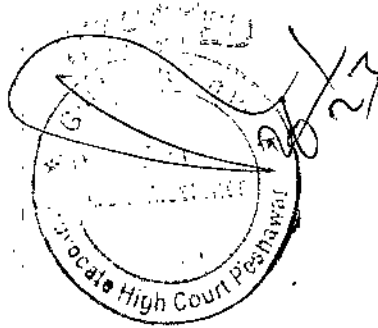

WHEREAS, it is expedient to provide for the appointment and regularization of the services of certain teachers appointed on ad-hoc/ contract basis in the Elementary and Secondary Education Department in the Province of Khyber Pakhtunkhwa in the public interest:

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title, application and commencement. --- (1) This Act may be called the Khyber Pakhtunkhwa Teachers (Appointment and Regularization of Service) Act, 2022.
(2). It shall apply to all the teachers as defined in clause (d) of sub-section (1) of section 2 of this Act.
(3). It shall come into force at once.
2. Definitions.--- in this Act. Unless the context otherwise requires:

- (a) "Government" means the Government of Khyber Pakhtunkhwa;
- (b) "law or rules" means the law or rules, for the time being in force, governing the selection and appointment of civil servants;
- (c) "post" means a post of teacher in the Elementary and Secondary Education Department; and
- (d) "teachers" mean duly qualified persons: who are appointed as Primary School Teachers, Certified Teachers, Drawing Masters, Physical Education Teachers, Theology Teachers, Arabic Teachers, Qari/Qaria Teachers, Certified Teachers II, Primary Teachers and Secondary School Teachers, having different pay scales, in the Elementary and Secondary Education Department, on ad-hoc/contract basis, through National Testing Service/the Khyber Pakhtunkhwa Educational Testing and Evaluation Agency (ETEA) or any other testing service, but does not include the teachers engaged on work charge basis or who are paid out of contingencies or engaged by Parent Teachers Council.

(2) The expressions "ad-hoc appointment" shall have the same meaning as is respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).

3. **Regularization of services of teachers.**---(1) Notwithstanding anything contained in any law or rules, for the time being in force, all the teachers, who are holding various posts from 08.03.2017 till the commencement of this Act, shall be validly appointed, on regular basis, from the date of their initial appointment; provided that:-

- (a) they possess the same qualification and experience required for a regular post;
- (b) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the commencement of this Act;
- (c) the service promotion quota of all service cadres shall not be affected; and
- (d) they shall be entitled for seniority and pay from the date of their initial appointment on ad-hoc/contract basis.

(2) The services of the teachers shall be deemed to have been regularized only on the publication of their names in the official Gazette.

4. **Overriding effect.**--- Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules, to the extent of inconsistency to this Act, shall cease to have effect.



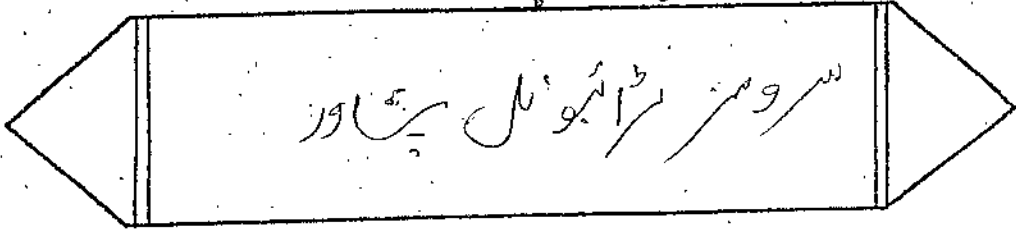
