APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE NOTIFICATION DATED 30-03-2021 OF RESPONDENT NO 2, TO THE EXTENT OF METHOD OF RECRUITMENT MENTIONED AT SERIAL NO 1 & 2 OF THE APPENDIX, WHEREBY THE POST OF ASSISTANT DIRECTOR IT (BPS-17) OF FINANCE DEPARTMENT INFORMATION GROUP IS TO BE FILLED, FIFTY PERCENT BY PROMOTION ON THE BASIS OF SENIORITY CUM FITNESS, FROM AMONGST THE COMPUTER OPERATORS IN THE DISTRICT FINANCE OFFICES WITH AT LEAST TEN YEARS' SERVICE AS SUCH AND FIFTY PERCENT BY **INITIAL RECRUITMENT AND THE POST OF DEPUTY DIRECTOR IT** (BPS-18) IS TO BE FILLED BY PROMOTION ON THE BASIS OF SENIORITY CUM FITNESS FROM AMONGST ASSISTANT DIRECTOR IT IN THE DISTRICT FINANCE OFFICES (BPS-17) WITH AT LEAST 5 YEARS' SERVICE AS SUCH, AND AGAINST WHICH DEPARTMNETAL APPEAL OF THE APPELLANT HAS NOT BEEN **RESPONDED SO FAR DEPSITE THE LAPSE OF MORE THAN THE** STATUTORY PERIOD OF NINETY DAYS

PRAYER:-

On acceptance of this appeal the impugned Notification dated 30-03-2021, to the extent of method of recruitment mentioned at Serial No 1 & 2 of the Appendix, whereby the post of Assistant Director IT (BPS-17) of Finance Department Information Group is to be filled, fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices with at least ten years' service as such and fifty percent by initial recruitment and the post of Deputy Director IT (BPS-18) is to be filled by promotion on the basis of seniority cum fitness from amongst Assistant Director IT in the District Finance Offices (BPS-17) with at least 5 years' service as such, may kindly be set at naught, and be expunged from the impugned Notification from the date of its issuance with any subsequent Order/Notification/promotion etc. on



the basis of impugned Notification with directions to respondents to fill the posts mentioned at Serial No 1 and 2 of the impugned Notification from the Computer Operators/Assistant Directors IT of the Deputy Commissioner Office

Respectfully Submitted:-

- 1. That the appellant was initially appointed as Computer Assistant on 23-10-2003 in the office of respondent No 5, which posted waslater on upgraded to BPS 12 vide Notification dated 12-07-2010 and was upgraded to BPS-16 vide Notification dated 29-07-2016. Since appointment the appellant performed his duties with honesty and full devotion and to the entire satisfaction of his high ups. (Copies of Notifications dated 12-07-2010 & Notification dated 29-07-2016 is enclosed as Annexure A& B).
- 2. That the rules regarding method of recruitment, promotion and seniority etc have been framed and notified vide Notification dated 13-06-2006 which were amended vide Notification dated 02-07-2010 according to which the post of Assistant is to be filled by promotion on the basis of seniority cum fitness from amongst Junior Scale Stenographers (BPS-12) with at least five years' service as such in the office of Divisional Commissioners, Additional Commissioners, District Co-Ordination Officers, District Officers (Revenue & Estate)/Collectors, Executive District Officers (Finance & Planning), & the then Political Agents at Divisional Level & Data Control Assistants/Commissioners, Additional Commissioners at Divisional level. (Copy of Notification dated 13-06-2006& Notification dated 02-07-2010 is enclosed as Annexure C & D).
- 3. That consequent to the cabinet decision dated 12-12-2012, administrative arrangements were made in Khyber Pakhtunkhwa, the posts of Assistant Co-ordination Officer, Human Resource Development Officer & Deputy District Officer (Finance) & Executive District Officer were abolished at District level, thus the set-up of Finance & Planning no more existed at District level in Khyber Pakhtunkhwa and were integrated into the Deputy Commissioner concerned vide Notification dated 27-12-2012, which were further clarified in the meeting held on 08-01-2013 for the implementation of cabinet decision under the chair of Secretary Finance Khyber Pakhtunkhwa by the Secretary Establishment Department that the District Officer Finance & Planning has not been conferred with an independent office in the new setup. Administratively DO F & P is constituent part of the office of DC & so are Finance Officer with Board of Revenue as their administrative department and from where their salaries and other expenditures will be budgeted. The entire moveable and immoveable property of defunct EDO F & P and Technical, Clerical & Class-IV staff stand inherited by DO Finance in his capacity as a Section of DC office and not as independent office. (Copy of Notification dated 27-12-2012 & Minutes of meeting, circulated vide letter dated 16-01-2013 are enclosed as Annexure E & F).
- **4.** That it is worth to note that since 2015 joint seniority list of all Computer Operators working under respondent No 5 is maintained

which has never been objected by the Finance Department. (Copies of Seniority Lists are enclosed as Annexure G).

- 5. That respondent No 2 has issued notification wherein method of recruitment, promotion etc has been laid down for the post of Computer Operators in Finance Department as well as District Finance Offices vide Notification dated 30-03-2021, whereas the District Finance Department has been abolished vide mentioned Notification, thus the impugned Notification dated 30-03-2021 to the extent of method of recruitment mentioned at Serial No 1 &2 of the Appendix, whereby the post of Assistant Director IT (BPS-17) & the post of Deputy Director (IT) (BPS-18) of Finance Department Information Group(no mention of District) is to be filled fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices with at least ten years' service as such and fifty percent by initial recruitment is illegal and unlawful which fact the appellant and his colleagues time and again brought into the notice of high ups. (Copy of Notification dated 30-03-2021 is enclosed as Annexure H).
- 6. That the impugned Notification is based on malafide and is aimed at favoring nears and dears, as strangely one RazaBangash Computer Operator (BPS-16) Hangu has been posted as Assistant Director IT while one AmanUllah Assistant Director IT District Finance Office Hangu has been authorized to hold the additional charge of the post of Assistant Director IT, District Finance Office Kohat vide Notifications dated 08-09-2022, of the Finance Department, thus violating all norms of justice. Under the garb of impugned Notification, the junior most Computer Operator has been promoted. (Copies of Notifications dated 08-09-2022 are enclosed as Annexure I).
- 7. That the appellant filed representation against the Notification dated 30-03-2021 of respondent No 2 to the extent of method of recruitment mentioned at Serial No 1 & 2 of the Appendix, whereby the post of Assistant Director IT (BPS-17) & the post of Deputy Director (IT) (BPS-18) of Finance Department Information Group(no mention of District) is to be filled fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices, on 07-10-2022 which has not been responded so far despite the lapse of more than the statutory period of ninety days. **(Copy of Departmental appeal is enclosed as Annexure J)**.
- **8.** That as the District Finance Department/Office do not exist at District level being abolished in the province, so the farming of rules is something beyond understanding, thus the impugned Notification dated 30-03-2021 of the respondent No 2 to the extent of method of recruitment mentioned at Serial No 1 & 2 of the Appendix, whereby the post of Assistant Director IT (BPS-17) & the post of Deputy Director (IT) (BPS-18) of Finance Department Information Group(no mention of District) is to be filled fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices, is against the

law, facts and principles of justice on the following on grounds interalia as follows:-

<u>GROUNDS:-</u>

- A. That the impugned Notification dated 30-03-2021 to the extent of method of recruitment mentioned at Serial No 1 &2 of the Appendix, whereby the post of Assistant Director IT (BPS-17) & the post of Deputy Director (IT) (BPS-18) of Finance Department Information Group(no mention of District) is to be filled fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices, is illegal, unlawful, without lawful authority and void ab-initio.
- **B.** That mandatory provisions of law and rules have badly been violated and the appellant has not been treated according to law and rules in violation of Article 4 and 25 of the Constitution and law of the land.
- **C.** That the impugned Notification is also in violation of the General Clauses Act 1897, which provide procedure for framing/changing law, rules and amendment etc. and thus too is liable to be struck down.
- **D.** That even the impugned amendment is not in accordance with the procedure meant for rules making/amendment as the mandatory provisions having not been complied with duly provided in the Appointment, Promotion & Transfer Rules 1989.
- **E.** That the impugned Notification is based on malafide and is aimed at favoring nears and dears, as strangely one RazaBangash Computer Operator (BPS-16) Hangu has been posted as Assistant Director IT while one AmanUllah Assistant Director IT District Finance Office Hangu has been authorized to hold the additional charge of the post of Assistant Director IT, District Finance Office Kohat vide Notifications dated 08-09-2022, of the Finance Department, thus violating all norms of justice. Under the garb of impugned Notification, the junior most computer operator has been promoted.
- **F.** That in order to reform the IT personals, the Deputy Commissioner Kohat in response to letter dated 08-07-2020, responded vide letter dated 11-08-2020 which depicts that there are 24 posts of Computer Operators in the Deputy Commissioner Kohat Office. **(Copy of letter dated 11-8-2020is enclosed as Annexure K).**

G. That as the District Finance Department has been merged into Deputy Commissioner Offices throughout the province, so how rules have been framed for an abolished department. It merits mention that the administrative secretary, Principal Accounting Officer and DDO code are the same of all the Computer Operators including Computer Operators of District Finance Department, Assistant Director IT and Deputy Director IT as evident from the Budget Book and other documents. Besides no budget is allocated for the District Finance as reflected from the budget book as the budget is of DDO Code No KT 6316. **(Copy of Budget Book is enclosed as Annexure L)**.

- **H.** That the above budget book also depicts that the Finance Officer BPS-17 and Planning Officer BPS-17 being constituent part of DC Office are working under Deputy Commissioner as well as Board of Revenue.
- I. That since 2015 joint seniority list of all Computer Operators working under the DC including those of District Finance is maintained which has never been objected by the Finance Department, however the mentioned RazaBangash has even challenged his seniority position with reference to others working under the DC Kohat in Service Appeal No 1328/2017 which is still subjudice before the honorable KP Service Tribunal. Even strangely the Finance Department has recently issued letter dated 28-09-2022 for finalizing the Seniority List of Computer Operators working in District Finance Offices of the Finance Department for reasons other than fair and bonafide being abolished. (Copy of Notice & Letter dated 28-09-2022 is enclosed as Annexure M & N).
- J. That joint seniority list in the offices of Secretariat has been maintained and the promotion of Computer operators of various departments were made to the post of AD IT as vide Notification dated 31-05-2019. Recently the sports culture tourism department also maintained joint seniority list of Computer operator and has been promoted to the post of AD IT vide Notification dated 31-05-2022. (Copies of Notification dated 31-05-2019, Notification dated 27-01-2017 & Notification dated 31-05-2022 is enclosed as Annexure O, P & Q].
- K. That this honorable Tribunal has allowed the like appeals including Service Appeal No 251/2011 titled as MianFarooqIqbal VS Chief Secretary & others vide Judgment dated 29-01-2013 and which was also upheld by the Apex Court. (Copy of Judgment dated 29-01-2013 is enclosed as Annexure R).
- L. That the appellant being stake holder was not associated before amending the rules on the subject which being his fundamental right.
- **M.** That the appellant hasabout 20years of service with unblemished service record.
- **N.** That the appellant seeks the permission of this honorable Tribunal for further/additional grounds at the time of arguments.



- the functions of cratwhile District Coordination Officer and District Officer (Revenue & Estate) are Integrated in the office of Deputy Commissioner with the provision of Additional Deputy Commissioner in each district. The sub-divisional setup of Deputy District Officers (Revenue) and District Officers (Judicial) is replaced with Assistant Deputy Commissioners and Additional Assistant Commissioners. The Board of Revenue will process relocating the functions of Collector and Assistant Collector in the office of Deputy Commissioners and Assistant Commissioner in accordance with the new administrative setup;
 - iii) each district shall be provided a District Officer (Finance and Planning), a Planning Officer, a Finance Officer and a Secretary District Public Safety Commission. The positions of Assistant Coordination Officer, Human Resource Development Officer and Deputy District Officer (Finance) shall stand abolished.
 - iv) the positions of Executive District Officer at district level shall stand abolished;
 - v) Local Government Elections and Rural Development Department shall notify constitution of each Local Council and make transitional interim arrangement/management in pursuance of section 224 of the Act;
 - vi) the Agriculture Dopartment at district level shall be re-organized as under.
 - a. Agriculture (Extension) shall be manned by District Director, Subject Matter Specialists, Agriculture Officers, Plant Protection Officers, Assistant Horticulture Officers and Assistant Agronomists.
 - b. Livestock & Dairy Development (Extension) shall have District Director, Senior Veterinary Officers and Veterinary Officers.
 - c. On Farm Water Management shall have District Directors, District Officers and Water Management Officers.
 - d. Soll Conservation shall have District Officers Soll Conservation and Soil Conservation Assistants.
 - vii) Elementary and Secondary Education Department at district level shall be re-organized under District Education Officers separately for Malo and Female assisted by Deputy District Education Officers (Male and Female) and Sub Divisional Education Officers;

- Health Department at district level shall be re-organized under District Heath Officers assisted by Deputy District Health Officered and
- ix) the Public Health Engineering Department and Communication and Works Department will continue with their existing organizational hierarchy at the sub-divisional, district and regional level;



MINUTES OF THE MEETING HELD ON 8-1-2013 IN THE CONFERENCE ROOM OF FINANCE DEPARTMENT:

A meeting to discuss implementation of the Cabinet decision taken in its meeting held on 12-12-2012 and subsequently notified vide Government of Khyber Pakhtunkhwa, Establishment and Administration Department Notification No SO (E-1) E&AD/4-49/2012 dated 27-12-2012 was held in Finance Department on 8-1-2013. The meeting was chaired by Secretary Finance Department. List of participants of the meeting is annexed.

Secretary Finance Department welcomed the participants and thanked them for sparing time to attend the meeting.

In his opening remarks Secretary Finance Department informed the participants that establishment of new administrative setup at district level and enforcement of Local Government Act 2012 (LGA) with effect from 1-1-2013 which was notified on 27-12-2012 require the attention of all concerned for smooth implementation. He further informed that in this regard the Finance Department has identified certain areas which require collective wisdom of the participants of this meeting to ensure smooth implementation of the new setup. This meeting has been convened with a view to evolving consensus among participants in these areas.

These areas were brought one by one into the notice of the participants and consensus was developed after due discussion among them as follow:

OPERATION OF ACCOUNT IV AS PER NOTIFICATION.

Secretary Finance Department explained the background of Account-IV and mentioned that Account-IV was established for maintenance of expenditures and receipts of district governments. It was kept in accordance with the principles laid down in section 114 of the transformer. Ordinance 2001 (LGO). Moreover, District

Secretary Establishment Department clarified that DO F&P has not been conferred with an independent office in the new setup. Administratively, DO F&P is constituent part of the office of DC and so are Finance Officer and Planning Officer with Board of Revenue as their Administrative Department and from where their salaries and other expenditure will be budgeted. The entire moveable and immoveable property of defunct EDO F&P and technical, clerical and class-IV staff stands inherited by DO Finance in his capacity as a section of DC office and not as independent office.

Senior Chief PSDP, Planning and Development Department observed that his department was severally affected first at the time of promulgation of the LGO and now after enforcement of the LGA. In 2001, 321 positions in various pay scales in P&D Department were reduced to 170. Resultantly 14 posts of Chief of Section (BPS-19) were reduced to 6 posts and similarly Assistant Chief and Research Office positions were also reduced. Under the new setup at district level office of the EDO F&P stands defunct. As a result 25 posts of District Planning Officers (BPS-18), 25 posts of Planning Officers (BPS-17), 25 posts of Technical Officers (BPS-17) and 25 posts of Sub Engineer (BPS-11) have been abolished despite the fact that District Development Committee and its functions have not been discarded in the district. Most of these positions offered chances of professional development and promotion prospects to officers of P&D Department. However there has been drastic curtailment in posts for them now which needs to be considered by the competent authority. He further pointed out that after 18th Constitutional Amendment and consequent enhancement of workload both at Department and District levels as well as restoration of pre 2001 scenario there is a need to strengthen P&D Department at these two levels.

CONCENSUS:

After detail response by Secretary Establishment to these observations all the participants agreed that:

1. DO F&P will work as constituent part of the office of DC under Board of Revenue and guidelines regarding posting/transfer of officers and lower staff posted in this office will be prepared in due course by Establishment Department.

- 2. The technical work of Data Processing Cells in the DO F&P office will be coordinated by FMIU Finance Department as before.
 - 3. Secretary Establishment will shortly convene meeting of Establishment, Finance and P&D Departments and appropriate measures regarding the issue raised by Senior Chief PSDP will be taken in the light of decision of the proposed meeting.

DISTRICT DEVELOPMENT FUND.

Additional Secretary Provincial Finance Commission invited the attention of participants toward the issue of ownership in the new setup of ongoing development schemes at district level which are being funded out of District Development Fund (DDF). Under Provincial Commission (PFC) Award, 70% of DDF was being apportioned to District Governments and the remaining 30% to TMAs for development. In case of former various (devolved) departments or TMAs were executing the schemes whereas in case of later TMAs themselves were the executing agencies. He added that in the new setup:

1. It is obvious that those executing agencies which were

- erstwhile devolved department of District Government or Development Authorities will continue executing their respective schemes now under the provincial ambit. They will also be responsible for M&R of the completed schemes as before.
- Since TMAs stand defunct therefore it is very important to specify their successor executing agencies at the earliest to avoid delay or discontinuity in execution.



- That the appellant was initially appointed as Computer assistant on 23-10-2003 in the office of Deputy Commissioner Kohat later on upgraded to BPS 12 and was upgraded to BPS-16 in the year 2016. Since appointment he performed his duties with honesty and full devotion and to the entire satisfaction of his high ups.
- 2. Human Resource Development Officer & Deputy District Officer (Finance) & Executive District Officer were abolished at District level, thus the set-up of Finance & Planning no more existed at District level in Khyber Pakhtunkhwa and were integrated into the Deputy Commissioner concerned vide Notification dated 27-12-2012, which were further clarified in the meeting held on 08-01-2013 for the implementation of cabinet decision under the chair of Secretary Finance Khyber Pakhtunkhwa by the Secretary Establishment Department that the District Officer Finance & Planning has not been conferred with an independent office in the new setup. Administratively, DO F & P is constituent part of the office of DC & so are Finance Officer with Board of Revenue as their administrative department and from where their salaries and other expenditures will be budgeted. The entire moveable and immoveable property of defunct EDO F & P and Technical, Clerical & Class-IV staff stand inherited by DO Finance in his capacity as a Section of DC office and not as independent office. (Copy of Notification dated 27-12-2012 & Minutes of meeting circulated vide letter dated 16-01-2013 are enclosed as Annexure C & D).

- **4.** That it is worth to note that since 2015 joint seniority list of all Computer Operators working under the DC is maintained which has never been objected by the Finance Department. **(Copies of Seniority Lists are enclosed as Annexure E)**.
- 5. That the Finance Department Khyber Pakhtunkhwa has issued notification wherein method of recruitment, promotion etc has been laid down for the post of Computer Operators in Finance Department as well as District Finance Offices vide Notification dated 30-03-2021, whereas the District Finance Department has been abolished vide mentioned notification, thus the impugned Notification dated 30-03-2021 to the extent of method of recruitment mentioned at Serial No 1 & 2 of the Appendix, whereby the post of Assistant Director IT (BPS-17) & the post of Director (IT) (BPS-18) of Finance Deputy Department Information Group(no mention of District) is to be filled fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices with at least ten years' service as such and fifty percent by initial recruitment is illegal and unlawful which fact the appellant and his colleagues time and again brought into the notice of high ups. - A. That the impugned Notification dated 30-03-2021 to the extent of method of recruitment mentioned at Serial No 1 & 2 of the Appendix, whereby the post of Assistant. Director IT (BPS-17) & the post of Deputy Director (IT) (BPS-18) of Finance Department Information Group(no mention of District) is to be filled fifty percent by promotion on the basis of seniority cum fitness, from amongst the Computer Operators in the District Finance Offices, is illegal, unlawful, without lawful authority and void ab-initio.

Under the garb of impugned Notification, the junior most computer operator has been promoted. **(Copies of Notifications are enclosed as Annexure G)**.

F. That in order to reform the IT personals, the Deputy Commissioner Kohat in response to letter dated 08-07-2020, responded vide letter dated 11-08-2020 which depicts that there are 24 posts of Computer Operators in the Deputy Commissioner Kohat Office. (Copies of letters are enclosed as Annexure H).

- **G.** That as the District Finance Department has been merged into Deputy Commissioner Offices throughout the province, so how rules have been framed for an abolished department. It merits mention that the administrative secretary, Principal Accounting Officer and DDO code are the same of all the Computer Operators including Computer Operators of District Finance Department, Assistant Director IT and Deputy Director IT as evident from the Budget Book and other documents. Besides no budget is allocated for the District Finance as reflected from the budget book as the budget is of DDO Code No KT 6316. **(Copy of Budget Book is enclosed as Annexure I)**.
- **H.** That the above budget book also depicts that the Finance Officer BPS-17 and Planning Officer BPS-17 being constituent part of DC Office are working under Deputy Commissioner as well as Board of Revenue.

I. That since 2015 joint seniority list of all Computer Operators working under the DC including those of District Finance is maintained which has never been objected by the Finance Department, however the mentioned Raza Bangash has even challenged his seniority position with reference to others working under the DC Kohat in Service Appeal No 1328/2017 which is still subjudice before the honorable KP Service Tribunal. Even strangely the Finance

Reference your office letter No AD(IT)/ST&IT/KP/2-1/IT Cadre/2019-20/2523-559 dated: 8/07/2020, on the subject cited above.

In view of draft IT/e-Governance report and revamping of IT staff into a performance oriented and cohesive structure as referred in the letter under reference, it is intimated that previously the post of Computer Operator was in BPS-12 which had been up-graded to BPS-16 in the year 2016 by the Government of Khyber Pakhtunkhwa. However, no further service structure was devised by the government i.e. promotion of Computer Operators / IT persons etc. Moreover, it pertinent to mention here that Computer Operators / IT officials play an important and vital role in quick disposal of official works while on the other hand they are deprived for further promotion/benefits due to which resentment exists amongst them towards their future career.

During the proceedings in the case, the learned counsel for the appellant submitted an application for allowing him to delete, prayers at S.No. I, II, and IV. His application was allowed on 5.12.2012 and the case was considered only for prayer No. iii, wherein it has been prayed that on acceptance of the appeal, restore the previous clause (b) of notification No. SOI(IND)1-6/88-Vol-V dated 10.12.2003 for appointment to the post of Director General Mines and Minerals.

Facts of the case briefly stated are that the appellant is serving in Mines Mineral Department as Chief Inspector of Mines in BPS-19 since 18.11.2004 having degree in Masters in Mining Engineering from University of Engineering & having Peshawar and is the senior most officer in BPS-19. The appeal was admitted to regular hearing on 10.2.2011 and notices were issued to the respondents. The official respondents have filed their joint written reply and contested the appeal. The appellant also filed rejoinder in probuttal.

STIF.

4: Counsel for the appellant stated that Directorate of Mineral and Mines was created subsequent to detail study by Aus AID (Australian Consultation) in view of National Mineral Policy (NMP) in 1995. The post of Director General Mines & Mineral was designated to be a technical post. This has also been confirmed vide Para 7 of Reply of the respondents. Rules of appointment, promotion etc. of D.G Mines & Mineral were notified on 10.12.2003. Method of recruitment for Director General in Service Rules is as follows:-

'ía)

Section 23

By promotion, on the basis of selection on merit, from amongst the holders of the posts of Director Mineral Exploraton, Director Mineral Licensing and Chief Inspector of Mines Labour Weifare having at least 17 years shrife in BPS-17 and above, provided that in case of persons initially appointed in BPS-18, the length of service for promotion shall be 12 years in BPS-18 and above, or

By transfr, from persons having Bachelor's Degree in Mining Engineering or Master Degree in Geology."

The above rules were abruptly modified on 17.10.2010 where in Clause (b) was. malafidely modified to defeat decision of the Tribunal dated 23.4.2010 in Service Appeal No. 1876/2009 (not to give charge to junior person on transfer of the then Director General Mines & Mineral), to appoint its own blue eyed person and not to allow qualified and professional officers of the department to get promotion. Clause (b) was replaced "by transfer from the provincial Government Department". Furthermore in clause (a) the words "Selection on merit" be changed to selection on "Seniority-cum-fitness" as was the case in Punjab Government Service Rules.

5. The procedure for making rules or by-Jaws as specified in Section 23 of General Clauses Act 1897 as given below were not followed:-

 the authority having power to make the rules or bye-laws shall, before making them publish a draft of the proposed rules or bye-laws for the information of persons likely to be affected thereby;

(2) the publication shall be made in such manner as that authority deems to be sufficient, or, if the condition with respect to

previous publication so requires, in such manner as the 1 -(government concerned) prescribes;

(3) there shall be published with the draft a notice specifying a date on or after which the draft will be taken into consideration."

2012 PLC (CS) 1330 was relied upon wherein it has been stated that rules cannot be changed to disadvantage of employees. Regarding jurisdiction of Tribunal in the matter and filing of appeal against notification issued by the Government. Reliance was placed on 2011-SCMR-698 and 2012 PLC (C.5)142.

The learned AAG argued that rules have been modified in accordance 6. with Section 21 of the Ganeral Clauses Act. It provides for posting of officers of the department as well as from outside and as such no discrimination has been made.

The Tribunal observes that the change in rules have not been made in 8. accordance with Section 23 of the General Clauses Act 1897. No reason or rational has been stated for the modification, from which malafide on part of respondents can be seen. The appellant has also pleaded for replacing the words "selection on merit" by "selection on seniority-cum-fitness in clause (a) of the Rules. The Knyber Pakhtunkhwa Clvil Servants Act 1973 has clearly elaborated the same vide Section 9-Promotion which is reproduced as below:-

Arguments heard and record parasen.

"9. Promotion:-(1) A civil servant possessing such minimum. qualification as may be prescribed shall be eligible for promotion to a higher past for the time being reserved under the rule for departmental promotion in the service or cadre to which he belongs.

(2) A post referred to in sub-section(1) may either be a selection post or a non-selection post to which promotion shall be made as may be prescribed-

in the case of a selection post, on the basis of (a) selection on merit; and in the case of non-selection post, on the basis of (b) ' seniority-cum-fitness. ri akh wa

bunal, ^{pr}Furthermore, the matter has also been explained in the Esta-Code (Establishment

Code) Khyber Pakhtunkhwa- Promotion Policy-Section 6 S.No. 4 as below:-

"After careful consideration and in super session of all previous orders and instructions on the subject the Government of What Pakistan have decided that the principle for promotion from one post to anothr should be "by selection on merit with due regard to seniority" and that this principle should be applied uniformaly all along the line from the lowest to the highest posts and from one class of service to another.

For this purpose; "merit" does not mean good service record 2. only, but also includes experience, qualification and suitability for the post or service to which promotion is being made. The value of all these different factors has to be assessed in rating the officer's fitness for promotion. The words "with due regard to seniority" imply that, while emphasis is to be placed on good service record qualifications and aptitude for the higher post, the officer's relative seniority in the cadre, from which promotion is being made, should be given due weight, the greater the disparity in seniority the greater should be the junior officer's superiority in point of merit."

In view of the above, the Tribunal concluded to set aside modification in rules notified on 17.10.2010 and clause (b) of notification No. SOI(IND)1-688-Vol-V dated 10.12.2003 is restored and further more that promotions should be made strictly keeping in view Section 9(2) (a)(b) of Civil Servants Act 1973 and Esta Code directions stated above. This appeal alongwith connected appeal No. 455/2011 titled "Obaiduliah Versus Chief Secretary Khyber Pakhtunkhwa" having common question of law are disposed off accordingly. Parties are left to bear their own costs. File be consigned to the record. ANNOUNCEL
