Prayer in Appeal:-

On acceptance of instant appeal the impugned seniority list dated 28.06.2022 may kindly be set aside/ modified/ corrected to the extent of appellant and the appellant may be re-legated to his original position in the seniority list, and the Respondents may further be directed to give back benefits and promotion which have been effected from impugned seniority list.

Respectfully Sheweth:

1. That the appellant was appointed as Constable in 1995 and was promoted to the post of Head Constable in 2004. (Copies of Appointment Order and Promotion Order are attached as Annexure A, B).
2. That in 2007 the appellant was promoted to the post of Assistant Sub-Inspector BPS-II and to the post of Sub-Inspector BPS-14 in 2009. (Copies of Promotion Order are attached as Annexure C & D).
3. That for confirmation on the post of Sub-Inspector the appellant filed Service Appeal before this Hon'ble Tribunal and was allowed on 31.01.2013. (Copy of judgment dated 31.01.2013 is attached as Annexure E).
4. That after decision of this Hon'ble Tribunal the appellant was confirmed as Sub-Inspector and promoted to the post of Inspector on 09.05.2013 with effect from 01.07.2010. (Copies of confirmation and promotion order are attached as Annexure F& G).

- 5. That the appellant was promoted to the post of Deputy Superintendent of Police (DSP) on 27.08.2019 and is placed at Serial No. 120 of the seniority list dated 30.04.2020 of DSPs BPS-17. **(Copy of Seniority List is attached as Annexure H).**
- 6. That in 2022 seniority list of DSPs dated 21.02.2022 was issued by Respondent No. 2 and the appellant was placed on Serial No. 110 of the seniority list. **(Copy of seniority list dated 21.02.2022 is attached as Annexure I).**
- 7. That on 28.06.2022 a subsequent seniority list of DSPs (BPS-17) was issued by the Respondent No. 2 and the seniority of the appellant was disturbed and was placed at Serial No. 184 without any legal justification, reason and opportunity of hearing. **(Copy of seniority list is attached as Annexure J).**
- 8. That the appellant being aggrieved from the impugned seniority list filed departmental representation to Respondent No. 1 on 18.07.2022 but no heed was paid to departmental appeal of appellant. **(Copy of departmental representation is attached as Annexure K).**

Now the appellant being aggrieved from impugned seniority list approached this Hon'ble Tribunal in present service appeal for redressal of his grievances inter-alia on the following grounds:

Grounds:

- A. That the appellant has not been treated in accordance with law and in case of appellant A-4 and 27 are violated by the Respondents and right of fair trial provided by Article 10-A of the constitution has also not been violated.

B. That the impugned seniority list is not only illegal, incorrect, against law but also ineffective upon the rights of appellant and principles laid down by the Superior Court for grant of seniority.

C. That seniority is vested right and cannot be disturbed without assigning any reason and without giving opportunity of hearing to the effected persons before issuing the impugned seniority list. No opportunity of hearing was provided to the appellant and thus the appellant was condemned unheard and the seniority list was issued in violation of principles of natural justice.

2001 PLC (CS) 1064

D. That it was held by august Supreme Court of Pakistan in the case of "Muhammad Bachal Memon Vs Tanveer Hussain Shah"

"Terms and conditions of service including interse seniority between Civil Servants could only be altered/effected by means of an Act of the Provincial Assembly as had been expressly stipulates in A-240 of the Constitution or by rules made within the rules making power given in Section 26 of the Sindh Civil Servants Act, 1973."

2014 SCMR 1539 (Para No. 22)

E. That seniority list issued on 21.02.2022 attained finality in all respect and was not challenged by any other employees than the respondent No. Thus no authority and power do issue another seniority list and disturbed seniority of the appellant.

F. That it was held by the august Supreme Court of Pakistan in the case of "Secretary Labour Department Punjab Lahore and others Vs Raja Muhammad Pasha Janjua and others"

"Civil Servant appointed on regular basis much earlier than others could not be relegated to a Junior Position in the seniority."

2005 SCMR 1142 (Para No.4)

- G. That seniority list issued on 21.02.2022 by the respondent No. 1 has created legal and vested rights in favour of the appellant and due to the applicability of rules of locus poenitentia the said seniority list could not be disturbed.
- H. That it was held by the august Supreme Court of Pakistan in the case of "Dr. Azim Ur Rehman Vs Government of Sindh and others"

"Civil Servants, dispute over seniority list, department issuing new seniority list without any justification or legal determination of interse seniority and placing the Respondents higher composed to civil servant, validity, seniority list was disturbed by the subsequent new seniority list without any basis or any legal determination of intese seniority between the parties and thereafter such arbitrary act of the department could not be sustained."

2012 SCMR 1545

- I. That nay other ground will be adduced at the time of arguments with the kii. permission of this Hon'ble Tribunal.

It is, therefore, respectfully prayed that on acceptance of instant appeal:

- i. The impugned seniority dated 28.06.2022 may be set aside corrected and modified to the extent of appellant and to the appellant may be relegated to his original position in the seniority.

- ii. Respondents may further be directed to give back benefits and promotion to the appellant which had been effected from the impugned seniority list.
- iii. Any other relief not specifically prayed for to which the appellant is entitled in the facts and circumstances of the case may also be granted.

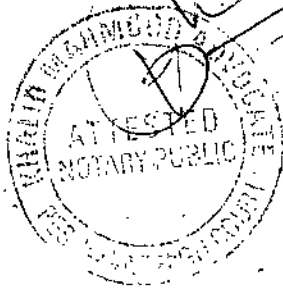

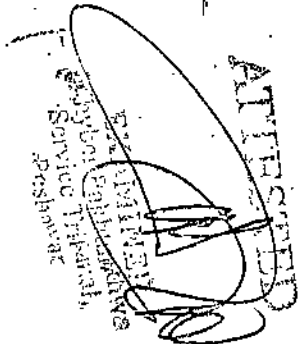

JUDGMENT

NOOR ALI KHAN, MEMBER.- This appeal has been filed by Shakeel Ahmad, the appellant under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, against the order of respondent No. 2 dated 12.11.2012, whereby the application of appellant for confirmation in the rank of Sub Inspector was rejected. It has been prayed that on acceptance of the appeal, the impugned order may be set aside and the appellant be confirmed in the rank of Sub Inspector with retrospective effect enabling the appellant to get equal treatment like his other colleagues.

2. Brief facts of the case as narrated in the memo: of appeal are that the appellant joined the Frontier Reserve Police, on 4.4.1995 as Constable and served efficiently and to the entire satisfaction of his superiors. He was gradually promoted as Assistant Sub Inspector on 28.9.2007 and according to Rule 13.18 of Police Rules 1934, he was confirmed in the rank of ASI and his name was brought on promotion list "E" w.e.f. 1.7.2010 vide order dated 30.7.2010. On 29.1.2009, the appellant was promoted as Sub Inspector and assumed the charge of the post. The appellant was further promoted as Inspector on adhoc basis and posted as Reserve Inspector (Headquarter) Police Lines, Peshawar. The appellant being eligible in all respect, approached the respondent No: 3 for his confirmation/promotion in the rank of Sub Inspector, which was recommended and forwarded to respondent No. 2. The departmental appeal of the appellant was rejected on 12.11.2012 with the remarks that no ASI shall be confirmed in a substantive vacancy in the rank of SI unless he has been tested for at least a year as an officiating SI independent charge of a Police Station in a District other than that in which his home is situated or three years deputation period as Officiating Sub Inspector in Special Branch, PTC Hangu CID according to CPO direction during the year 2000 and two years in investigation/Elite Force as per Standing Orders. Hence the present appeal.

3. The appeal was admitted to regular hearing on 4.12.2012 and notices were issued to the respondents. The respondents have filed their joint written reply and contested the appeal. The appellant also filed rejoinder in rebuttal.

4. Arguments heard and record perused.

5. The learned counsel for the appellant argued that the appellant was promoted as Assistant Sub Inspector on 28.9.2007 and according to Rule 13.18 of Police Rules 1934, he was confirmed in the rank of ASI and his name was brought on promotion list "E". The appellant has been promoted as Sub Inspector on 29.1.2009 and served for sufficient time and eligible for confirmation/promotion in the rank of S.I Substantively. He also qualified upper College Course with excellent service record. As per Police Orders the duties and responsibilities of Frontier Reserve Police are the same as those of Regular Police and in the light of the notification dated 15.1.1983, Police Rules are fully applicable to Frontier Reseve Police. In the financial year 2002-03, the Finance

Department had also declared the FRP as a permanent budgetary force. So the appellant has the fundamental right to be dealt with in the same manner as the officers of the regular police. Under Rule 13.18 of Police Rules 1934, after successful completion of two years as Offtg. S.I he has to be confirmed w.e.f. 1.7.2010. He stated that the appellant could not post himself as independent SHO to meet the requirement for confirmation. It was the responsibility of the respondents to post him as independent SHO. He produced a copy of judgment dated 23.5.2011, in Service Appeal No. 407/2011 of this Tribunal and stated that in similar circumstances, confirmation has been granted to appellant in the aforementioned service appeal without spending a period of one year independent SHO. The appellant is also entitled to the same treatment. He requested that the appeal may be accepted as prayed for.

6. The learned AAG argued that the appellant was promoted to the rank of ASI on 28.9.2007 and was later on confirmed into the same rank on 1.7.2009. He was promoted as SI but on officiating basis on 29.1.2009. For confirmation in the same rank he has to fulfill the requirements under the rules. The appellant has not spent one year as independent SHO which was one of the basic criteria for confirmation as Sub Inspector, hence he was not entitled for confirmation under Police Rules and Standing Orders. Hence his application for confirmation has rightly been turned down by the competent authority. He requested that the appeal may be dismissed.

7. The Tribunal observes that the main issue which falls for determination in the present case is that whether the appellant has rightly been ignored by the respondent department from confirmation/promotion as S.I on the ground of his not fulfilling the requirement to serve as SHO for a period of at least one year outside his home district before he is confirmed as S.I. The appellant was promoted as ASI on 28.9.2007 and according to Rule 13.18 of Police Rules 1934, he was confirmed and his name was brought on promotion list "E" w.e.f. 1.7.2010 vide order dated 30.7.2010. On 29.1.2009, he was promoted as Sub Inspector on officiating basis and assumed the charge of the post. The appellant also passed the Upper College Course and further promoted as Inspector on adhoc basis on 27.8.2010 and posted as Reserve Inspector (HQ) Peshawar, where he is still serving in that capacity. It was the prerogative/discretion of the departmental authority to post him as SHO, for which the appellant cannot be held responsible and ^{should not} suffer for the acts of others. Under Rule 13.18 of Police Rules 1934, he has to be confirmed on successful completion of two

years period of probation or reverted back to his substantive rank. Since the appellant has not been reverted, and has further been promoted as Inspector on adhoc basis, was entitled for confirmation.

8. In view of the above, the appeal is accepted, the impugned order is set aside and the respondent department is directed to confirm the appellant as Sub Inspector w.e.f. 1.7.2010 as per rule 13.18 of Police Rules 1934. Parties are left to bear their own costs. File be consigned to the record.

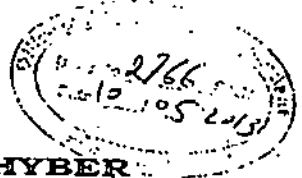


