**Preliminary Objections.**

- 1 That the Appellant has got no cause of action/locus standi.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant Service Appeal is based on mala-fide intentions.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the instant Appeal is based on mala fide intentions just to put extra pressure on the Respondents for gaining illegal service benefits.
- 9 That the instant Service Appeal is not maintainable in its present form.
- 10 That the instant Service Appeal is bad for mis-joinder & non-joinder of the necessary parties.
- 11 That the instant Service Appeal is barred by law.

12 That no Departmental Appeal has been filed by the appellant to the Respondent Department.

13 That the appellant is not entitled for promotion as SS under the relevant policy in field in the Respondent Department due to the lack Physics in his BSc as a subject.

### ON FACTS.

1 That Para-1 needs no comments, being pertains to the Service & Academic/Professional Record of the appellant in the Respondent Department.

2. That Para-2 also needs no comments being pertains to the service record of the appellant against the CT post in the Respondent Department.

3 That Para-3 also needs no comments being pertains to the service record of the appellant against the SCT B-16 (P) post in the Respondent Department.

4 That para-4 is correct that to the extent of his promotion as SCT but was rejected from promotion as SST & SS due to his passing of BSc without Physics is a subject by the Respondent Department under the policy.

5 That Para-5 is incorrect & denied on the grounds that the appellant is not entitled for promotion as SS B-17 in statistics due to reason as mentioned above with his batch mates in the Respondent Department.

6 That Para-6 is incorrect & denied on the grounds that, no Departmental Appeal has been filed by the Appellant, hence the act of the Respondents No 1-3 with regard to the non-grant of promotion to the appellant against the SS B-17 post with his batch mates is legal & liable to mentioned.

7 That Para-7 is incorrect & denied, hence, no further comments.

8 That Para-8 is also incorrect & denied on the grounds that agitated in the foregoing paras of the present reply, hence, needs no further comments, however, the Respondents further submit on the following grounds inter alia:-

### ON GROUNDS.

a. Incorrect & not admitted. The appellant has been treated as per law & rules by the Respondent Department in the instant case, hence, the stance of the appellant is baseless & liable to be rejected.

b. Incorrect & not admitted. The appellant has been treated as per law, rules & policy by the Respondent Department in the instant case, wherein, he has been made not entitled for promotion as SS B-17 in the Respondent Department, hence, the stance of the appellant is baseless & liable to be rejected.

Incorrect & not admitted. The statement of the appellant is without any cogent reason & justification on the grounds as agitated in the foregoing paras of the present reply by the Respondents, hence, the plea of the appellant is without any justification.

f. Incorrect & not admitted. The stand of the appellant is without any cogent reason & legal justification & liable to be rejected.

g. Incorrect & not admitted. The plea of the appellant is without legal justification & liable to be rejected as the appellant has been treated as per law, rules & policy by the Respondent Department in the instant case, hence, the stance of the appellant is baseless & liable to be rejected.

h. Incorrect & not admitted. The plea of the appellant is without legal justification & liable to be rejected as the appellant has been treated as per law, rules & policy by the Respondent Department in the instant case, hence, the stance of the appellant is baseless & liable to be rejected.

i. Incorrect & not admitted. The stand of the appellant is without any cogent reason & legal justification & liable to be rejected.





**Prayer in Appeal.**

On acceptance of the instant service appeal this Hon'able Service Tribunal may very graciously be pleased to promote the appellant to the post of Subject Specialist (S.S) Statistic BPS-17 on the basis of promotion policy Page-52 **Length of Service** (b) (i) half of the service in BS-16 and one fourth in Basic Scales lower than 16; if any shall be counted as service in Basic Scale-17 whereas the appellant has completed total 22 years & 09 months service and as per policy the appellant has served in BS-16 for period of 03 years & 08 months half become **01 year & 10 months** while served lower than BS-16 for period of 19 years one fourth of 19 years become **04 years & 09 months**. Total half service in BS-16 and one fourth lower than BPS- 16 become 06 years & 07 months

Respectfully Sheweth :-

This service appeal arises out of the following facts.

**FACTS:-**

1. That the appellant was initially appointed as C.T Teacher BPS-14 on **28<sup>th</sup> June, 1997** keeping in view the academic qualification of **M.Sc Statistics and B.Ed with 1<sup>st</sup> Division** from Peshawar University. (Photocopy of appointment order dated 28/06/1997 as CT is annexed as **Annexure "A"**).
2. That the appellant was given BPS-15 in the year 2015 in light of the notification of Director Elementary & Secondary Education Department KP, Peshawar through it was directed to appoint C.T teacher in BPS-15 initially and in this respect entry made in his service book on 01/07/2008 available on page No. 18 of Service Book. (Photocopy of Service Book is annexed as **Annexure "B"**). 12  
1/2007 23
3. That the appellant being senior having 18 years service was promoted to Senior C.T BPS-16 on **25<sup>th</sup> May, 2016** on the basis of one step promotion and in this respect entry is made in his Service Book available on page No. 20. (Photocopy of Service Book is already annexed as **Annexure "B"**).
4. That other colleagues of the appellant were promoted to S.S.T (Sc-II) BPS-16 and then promoted to S.S.T BPS-17 on the basis of M.Sc + B.Ed but the appellant was not promoted to S.S.T (Sc-II) BPS-16 and S.S.T BPS-17 **due to B.Sc without Physic subject**, then the appellant obtained Physics as additional subject and then the appellant was promoted to **S.S. T (Sc-II) BPS-16 on 19<sup>th</sup> March, 2019**. Now the appellant is teaching Maths & Physics. ----- (Photocopy of promotion SST (Sc-II) BPS-16 on March, 2019 is annexed as **Annexure "C"**). 13
5. That now the total service of appellant is becomes 22 years & 05 months and is entitled to be promoted to



37 S.S (Statistics) BPS-17 on the basis of promotion policy Page-52 which reads as Length of Service (b) (i) half of the service in BS-16 and one fourth in Basic Scales lower than 16, if any shall be counted as service in Basic Scale-17. (Photocopy of Promotion Policy is attached as **Annexure "D"**).

6. That due to non promotion of the appellant to the post of SS (Sc-II) Statistic BPS-17 by the respondents, the appellant then filed departmental appeal through proper channel vide which the Principal Govt: Higher Secondary School Nari Panos, Karak, has forwarded the departmental appeal of appellant vide his Memo No. 2095 /NPKK/ dated 28/09/2019 to respondent No. 3 (District Education Officer Male, Karak) but the respondent No. 3 has refused to submit the departmental appeal to Director Elementary & Secondary Education Department Khyber Pakhtunkhwa, Peshawar for decision on departmental appeal vide office letter No. 7285/ACRs/Promotion /Gazetted dated Karak the 01/11/2019. (Photocopy of Memo No. 2095/ NPKK/ dated 28/09/2019 and letter No. 7285/ACRs/Promotion /Gazetted dated Karak the 01/11/2019 are annexed as **Annexure "E&F"**).
7. That the appellant then submitted an advance copy of the departmental appeal to respondent No. 2 (Director E & SED KP, Peshawar) dated 02/10/2019 vide registry receipt No. 1552 but till date no response is forthcoming from the respondents. (Photocopy of Registry Receipt No. 1552 dated 02/10/2019 is annexed as **Annexure "G"**).
8. That by not promoting the appellant to the post of Subject Specialist (S.S) Statistic BPS-17 and being eligible thus and entitled for the same but refusal of respondent No. 3 to submit the departmental appeal of the appellant to respondent No. 2 and non response of the departmental appeal by the respondent No. 2 to the appellant's appeal, therefore, the instant service appeal before this honourable Service Tribunal on the following grounds.

**Grounds.**

- a. That non promotion to the post of S.S Statistic BPS-17 and being eligible and entitled for the same but refusal of respondent No. 3 to forward the departmental appeal of the appellant to respondent No. 2 and non response of the departmental appeal by the respondent No. 2 to the appellant is illegal, unlawful and against the law & facts.
- b. That the appellant has served in BS-16 for period of 03 years & 08 months half become **01 year & 10 months** whereas the appellant served lower than BS-16 for period of 19 years approximately while one fourth of 19 years become **04 years & 09 months**. Total half service in BS-16 and **one fourth** lower than 16 become 06 years & 07 months so as per policy mentioned above 05 years required for promotion while the appellant's service become 06 years & 07 months, therefore, the appellant is entitled to be promoted to the post of S.S Statistic BPS-17.
- c. That on the basis of promotion policy mentioned above at Page No. 52, the appellant is entitled to be promoted to S.S (Statistics) BS-17.
- f. That the policy referred by the appellant fully support the case of appellant to be promoted to the post of S.S Statistic BPS-17 as the requisite criteria for promotion is fulfilled by the appellant.
- g. That the respondent No. 3 was duty bound to forward the departmental appeal of the appellant to the respondent No. 2 for decision on departmental appeal but the respondent No. 3 has acted illegal and unlawful act.
- h. That respondent No. 2 was under obligation to respond to appellant of regarding his departmental appeal but the respondent No. 2 failed to dispose off the departmental appeal as per law and rules.
- i. That fundamental rights of the appellant has been violated by the respondents.
- j. That the appellant has been discriminated as other colleagues of the appellant have been promoted to the

post of S.S Statistic BPS-17 while the appellant has been ignored.

- k. That any other ground will be agitated at the time of argument with permission of this honourable Tribunal.

**Prayer.**

### Promotion Policy

In order to consolidate the existing Promotion Policy, which is embodied in several circular letters issued in piecemeal from time to time, and to facilitate the line departments at every level in prompt processing of promotion cases of Provincial civil servants, it has been decided to issue the "North-West Frontier Province Civil Servants Promotion Policy, 2009" duly approved by the competent authority, for information and compliance by all concerned. This Policy will apply to promotions of all civil servants holding appointment on regular basis and will come into effect immediately. The Policy consists of the provisions given hereunder:-

I. Length of service.

(a) Minimum length of service for promotion to posts in various basic scales will be as under:

Basic Scale 18 :	5 years' service in BS-17
Basic Scale 19 :	12 years' service in BS-17 & above
Basic Scale 20 :	17 years' service in BS-17 & above

No proposal for promotion shall be entertained unless the condition of the prescribed length of service is fulfilled.

// (b) Service in the lower pay scales for promotion to BP-18 shall be counted as follows:

- (i) Half of the service in BS-16 and one fourth in Basic Scales lower than 16, if any, shall be counted as service in Basic Scale 17.
- (ii) Where initial recruitment takes place in Basic Scale 18 and 19, the length of service prescribed for promotion to higher Basic Scales shall be reduced as indicated below:

Basic Scale 19 :	7 years' service in BS-18
Basic Scale 20 :	10 years' service in BS-18 and above. or 3 years' service in BS-19.

II. Linking of promotion with training:

(a) Successful completion of the following trainings is mandatory for promotion of officers of the Provincial Civil Service / Provincial Management Service to various Basic Scales:

- Mid-Career Management Course at National Institute of Management (NIM) for promotion to BS-19
- Senior Management Course at National Management College, Lahore for promotion to BS-20
- National Management Course at National Management College, Lahore for promotion to BS-21

(b) This condition will not be applicable to civil servants in specialized cadres such as Doctors, Teachers, Professors, Research Scientists and incumbents of posts



7. That on the basis of promotion policy mentioned above at Page No. 52, the appellant is entitled to be promoted to S.S (Statistics) BS-17.




