REPLY ON BEHALF OF RESPONDENTS

Respectfully Sheweth: -

PRELIMINARY OBJECTIONS: -

- 1. That the appellant has got no cause of action and locus standi to file the appeal.
- 2. That the appeal is badly barred by law and limitation.
- 3. That the appellant is estopped by his own conduct to file the instant appeal.
- 4. That the appeal is not maintainable in its present form.
- 5. That the appellant has not come to the Honourable Tribunal with clean hands.
- 6. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.

Reply on Facts: -

- 1. Para pertains to record, hence, needs no comments.
- 2. Incorrect. Service record of the appellant is tainted with bad entries. (Detail of bad entries is annexure "A").
- 3. Incorrect. Plea of the appellant is not appealable to a prudent mind as appellant stated that due to some domestic problem he was unable to perform his duty while in his reply to the charge sheet he stated that he was suffering from backache. (Copy of reply to the charge sheet is annexure "B").

Facts are that, appellant while posted at Casualty Mian Rashid Hussain Shaheed Hospital Pabbi on 23-12-2013, he was transferred to Police Station, Akora Khattak but he did not report at Police Station, Akora Khattak and thus he willfully/deliberately absented himself from lawful duty from 23-12-2013 to 20-01-2014. (Copy of daily diary reports No. 21 dated 10-01-2014 and 17 dated 20-01-2014 is annexure "C"). Later on he

was transferred to Police Station, Azakhel on 17-04-2014 and again absented himself from duty with effect from 21-05-2014 and reported on 26-05-2014, however, on the same day i.e 26-05-2014 he remained absent from duty till the date of his dismissal. (Copy of daily diary report No. 24 dated 21-05-2014 and No. 28 dated 26-05-2014 are annexure "D").

- 4. Para correct to the extent that appellant was dismissed from service on 12-01-2015.
- 5. Incorrect. Plea of the appellant is not plausible that he within one month from the communication of dismissal order submitted departmental appeal. As appellant was dismissed from service on 12-01-2015 while he moved departmental appeal on 14-12-2017, which was dismissed on 19-02-2018 by the appellate authority. (Copy of departmental appeal and rejection order is annexure "E").
- 6. Incorrect. Departmental appeal of the appellant was rejected being badly time barred on 19-02-2018, while he moved revision petition before the respondent No. 03 on 08-03-2022 with a delay of almost 04 years. (Copy of revision petition is annexed as annexure "F").
- 7. Appeal of the appellant is liable to be dismissed inter alia on the following grounds: -

Reply on GROUNDS

- A. Incorrect. Orders passed by the respondents are in accordance with law and rules and were passed after fulfillment of all legal and codal formalities.
- B. Incorrect. Before awarding penalty, proper departmental enquiry was conducted against the appellant. (Copy of enquiry report is annexure "G").
- C. Incorrect. Before awarding punishment, appellant was issued Final Show Cause Notice to which he did not bother to submit his reply. (Copy of Final Show Cause Notice is annexure "H"). Moreover, he was also heard in person by the appellate authority in Orderly Room on 14-02-2018, but he did not produce any cogent reason for his long absence.
- D. Para already explained above.
- E. Incorrect. Charge Sheet and statement of allegation were communicated to the appellant to which he also submitted his reply. The same has already been annexed as annexure-B.
- F. Incorrect. Despite providing so many opportunities, appellant did not mend his way as he was habitual absentee. Hence, punishment awarded to the appellant does commensurate with the gravity of his misconduct.



G. The respondents also seek permission of this Honourable Tribunal to advance additional grounds at the time of arguments.

Prayers

It is, therefore, most humbly prayed that on acceptance of above submissions, the appeal of the appellant may very kindly be dismissed with costs, please.



ORDER.

This order will dispose-off the appeal preferred by Ex- Constable Waqar Hussain No. 1233 of Nowshera District Police against the order of District Police Officer, Nowshera, whereby he was awarded Major punishment of dismissal from service vide District Police Officer, Nowshera OB No. 57 dated 12.01.2015.

Brief facts of the case are that the appellant while posted at Casualty Mian Rashid Hussain Shaheed Hospital Pabbi on 23.12.2013 he was transferred to Police Station Akora but he did not report at Police Station Akora and thus he willfully/deliberately absented himself from lawful duty from 23.12.2013 to 10.01.2014. Later on he was transferred to Police Station Azakhel on 17.04.2014 & again absented from duty with effect from 26.05.2014 till the date of his dismissal. On account of which he was issued charge Sheet and statement of allegations & Committee consisting of Mr. Wagar Ahmad the then Deputy Superintendent of Police Pabbi and Inspector Mehar Ali the then SHO Police Station Pabbi was constituted to conduct departmental enquiry against the alleged Constable. The Enquiry Committee submitted his finding report wherein the defaulter official was found guilty of misconduct and recommended for Major Punishment. He was issued Final. Show Cause Notice and served upon him on 17.12.2014. He was bound to submit his written reply in the stipulated time but he failed. It is pertinent to mention here that the alleged Constable is habitual absentee and is still absent. His continuous absence clearly indicates disinterest disobedience and he was no more interest in Police Job. Therefore he was awarded Major punishment of dismissal from service.

He was called in orderly room held in this office on 14.02.2018 and heard him in person. The appellant did not produce any cogent reason for his long absence. Therefore, I find no grounds to intervene the order passed by District Police Officer, Nowshera. Appeal is rejected being

badly time barred.

DEPARTMENTAL ENQUIRY AGAINST CONSTABLE WAQAR HUSSAIN 1233.

This enquiry was conduced against Constable Waqar Hussain No.1233, who posted at Casualty MRHS Hospital Pabbi was transferred to Police Station Akora on 23.12.2013 but he did not bother to report there.

In the light of the above allegations, he was issued Charge Sheet/Summary of allegations and the undersigned Police Officers were appointed to conduct an enquiry against him under the Police Rules 1975.

The defaulter official was summoned and the Charge Sheet/Summary of allegations was served upon him. He submitted his reply in response to Charge Sheet/Summary of allegations which is enclosed.

He was also called and his statement was recorded which is on the file.

According to his reply/statement, he was suffering from Backache and was unable to attend the duty. He was unable to attend the duty. He has produced Medical Certificates issued vide OPD Mod 23.12 2013 wherein he has been advised bed rest of 16 days from 23.12.2013 to 08.01.2013. However, he has resumed his duty on 20.01.2014.

During the course of enquiry, it was noticed that the defaulter official was then transferred from Police Station Akora to Police Station Azakhel and reported arrival there, but absented himself from duty for 5 days and after making he again absented himself from duty on the same day and is absent till date. In this connection, copy of DD No.28 dated 26.5.2014 is attached herewith which is worth perusal.

From the above details the Enquiry Committee has revealed to the conclusion that the defaulter official (Constable Waqar Hussain No.1233) has not adopted proper way for getting treatment/medical leave which is a misconduct on his part. Moreover, he is still absent from 26.5.2014 to date and there is no likelihood of his resuming duty in the near future. Therefore, the Enquiry Committee recommends that he may be awarded a major punishment.

FINAL SHOW CAUSE NOTICE
