#### **Preliminary Objection:**

#### On Facts:

- 1. Incorrect, appellant was appointed on 01/01/2011 but the appellant was found habitual absent from her duties.
- 2. Incorrect, as reported by respondent No. 4 bearing No. 22/20 dated 29/01/2020 that appellant was found absent from duties since (3) three years consecutively without prior permission or sanction of leave.
- 3. Incorrect, appellant and her husband have not performed their duties at Type-D Hospital Sarai Naimat Khan and they also have not joined new place of duty at TDH Ghazi.
- 4. That the appellant joined her duty on 15/01/2014 in Sarai Naimat Khan as a result of disciplinary proceeding against her by DHO Haripur vide letter NO. 4444-48 dated 29/04/2014 (enclosed Annex-A), in this order her absent period was adjusted as leave without pay in her favour and she was warned to remain careful otherwise her services shall be removed straightaway. The appellant submitted complaint to Superintendent of Police Haripur on dated 13/03/2019, appellant was found absent on 11/06/2019 but attendance was marked in all these days which was fake and tempered, the same issue of over writing and tempering is reflected in the report of IMU as received in preliminary report. (letter No. 4444-48 dated 29/04/20214) IMU report attached Annex-B.
- 5. After as above para-4.
- 6. That in the earlier preliminary inquiry, the appellant was pleased to deny all the allegations and blamed incharge for his personal grievances. Upon presentation of initials / signature by the appellant, it was found out that the signatures are totally different the signatures marked on the attendance register, honour, astonishingly when her husband (Mr. Asif) has asked to put on initials / signatures, they were matching with the signature on attendance register.
- 7. Incorrect. Upon departmental approval a factual position was asked by the respondent No. 2 to respondent No. 3 and accordingly a full-fledged report was sent to him vide letter No. 327 dated 14/01/2021.

8. Appellant and her husband Mr. Asif remained willfully absent from his duties since 19/02/2020 to till date appellant was directed to report and explain his position of absence but the appellant did not resume duty neither submit his answer. Afterward respondent No. 3 issued show cause notice 29/04/2020 later no 4732-38 dated directed to explain your position in writing within seven days or not more than fifteen days of its delivery but there is no response received from his side. Finally at last an absence notice was published in daily newspaper on 29/09/2020 and directed to delinquent official to report for duty and submit cogent reason of willful absent to this office within seven days of the publication but he did not so, in pursuance of rule 9 of Khyber Pakhtunkhwa Govt. servant E&D rules respondent No. 3 impose major penalty of removal from service. (Inquiry report attached as Annex-D).

In response to your office letter No. 13598/AE-VI Dated 11/12/2020 on the subject cited above, please find below the requisite comments:

- 1. The I/C Medical Officer of Type-D Hospital Sarai Naimat Khan submitted absent report of the said official Mrs. Shahida Jabeen (Ex-Clinical Technician Anesthesia) through his letter No. 22/20 TDH S.N. Khan dated 29-01-2020 (Enclosed as annex-I). He mentioned that she is habitually absent since 03 years. It is pertinent to mention that the husband of said official Mr. Muhammad Asif (Ex-Clinical Technician Surgical) was also posted at TDH Sarai Nemat Khan.
- 2. She was served an explanation letter from the undersigned vide No. 1862-64 dated 06-02-2020 (Enclosed as annex-II), to explain her position. Later, I/C Medical Officer of Type-D:Hospital Sarai Naimat Khan submitted an application to surrender the services of Mr. Muhammad Asif S/O Muhammad Safdar (Ex-Clinical Technician Surgical) and his wife Mrs. Shahida Jabeen (Ex-Clinical Technician Aneshthesia) through his letter No. 28/20 TDH S.N. Khan dated 11-02-2020 (Enclosed as annex-III).
- 3. Consequently, the above-mentioned officials were transferred to Type D Hospital Ghazi vide this office order No. 2141-45/Estab/D/Posting/Transf; Dated Haripur the 13/02/2020 (Enclosed as annex-IV), but the said officials did not comply to this order. In this connection office of the Medical Superintendent/DDHO Type-D Hospital Ghazi also submitted non-compliance report of said official on 19/02/2020 through letter No. 39/TDH(G) (Enclosed as annex-V)
- 4. Consequently, they were served with an expalanation letter for non-compliance of office orders on 02/03/2020 through No. 2496-99/Estab/D/Expl. (Enclosed as annex-VI)A fact-finding inquiry was conducted in his case, which revealed they did not join the duty and were also absent from TD Hospital Sarai Nimat Khan.
- 5. Despite repeated telephonic warnings and official contacts, the above mentioned officals did not join the place of duty.
- 6. Subsequently, a show-cause notice was served to the above-mentioned officials vide letter No. 4732-38/Estab/D/Discip.action Dated Haripur the 29/04/2020 (Enclosed as annex-VII). This office did not receive any reply by the said officials within prescribed time.
- 7. Furthermore, an administrative inquiry was conducted vide this office letter No. 4732-38/Estab/D/Discip.action Dated Haripur the 29/04/2020 (Enclosed as annex-VII) whereas the said officials were called for personal hearing before the committee.
- 8. The inquiry committee concluded that the said officials were found unwilling workers as there is not a signle evidence to prove their efficiency for the publice service.
- 9. The officials were involved in misconduct (Neither replied to show cause notice nor appeared before the administrative inquiry officers). The explicit conduct of the said officials prejudicial to good order and service descipline rendering them as guilty of misconduct.

#### Background

The I/C Medical Officer of Cat-D Hospital Sarai Naimat Khan reported absent report of Mst Shahida Jabeen on 29/01/2020 and she was called to explain her position in front of competent authority through letter No. 1862-64 Dated 06/02/2020. As a result she submitted an explanation to your good self on 10/02/2020, instead of explaining her position, she contested the MO:I/C for his absence and hence was directed to undersigned to conduct the inquiry and report. In the meanwhile Medical Officer I/C again submitted an application to surrender the services of Mr. Asif (Clinical) Technician Surgical) and Mst. Shahida Jabeen (anesthesia Technician) as the OT in the said hospital is nonfunctional and the staff is underutilised. Later both of the above mentioned officials were transferred to Type D Hospital Ghazi vide your office order No. 2141-45/Estab/D/Posting/Transf; Dated Haripr the 13/02/2020on administrative grounds. Consequent upon this order, both officials did not join their place of duty till date and an expalanation for non-compliance of office ordrs was called by your office on 02/03/2020 through No. 2496-99/Estab/D/Expl. In this connection office of the Medical Superintendent/DDHO Type-D Hospital Ghazi submitted non-compliance report of both said officials on 19/02/2020 through letter No. 39/TDH(G). Meanwhile record was reviewed by the inquiry officers and preliminary findings suggested that attendance register was tampered and signatures/initials of Mst. Shahida Jabeen did not match with her own hand writing. Despite repeated telephonic warnings and official contacts, both above mentioned officals did not join their place of duties. As a result your office issued a show cause notice to both of them and directed to reply within seven days of issuance of show cause to competent authority which was not replied till date. Furthermore an administrative inquiry was marked to the undersigned officers. In compliance to your orders in show cause notice and to proceed the inquiry, a call letter was issued to both officials to appear before inquiry committee through DHIS Letter No. 4797-4804 Dated 04/05/2020 despatched at their home addresses through record brance of your office which submitted the courier reciepts to the undersigned officer. (All material and referred letters are annexed in the personal files of both officials and presented with this naulry report to your goodself)

- 8. In her statement which was submitted in prelimenary inquiry, she denied for charg levelled against her and instead blamed I/C for his personal grievances with her. Howe she was asked to provide initials/signs which she used to do in attendance register, provided which does not look similar as in attendance register, while her husband when the same thing was similar to one in attendance register.
- Mr. Asif who is charged for misconduct and absenteeism and falure to comply with t orders of comptent authority was contacted to appear before the undersigned inqu committee but he did not appear during the prescribed time. #### Conclusion

/ in the light of above findings and detailed review it is concluded;

- Both officials were found unwilling health workers as there is not a signle evidence to prove their efficiency for the publice service
- 2. Both officials were involved in misconduct (Neither replied to show cause notice nor appear before the administrative inquiry officers) Both officials (Mr. Asif & Mst. Shahida) explicit conduct prejudicial to good order and service descipline rendering themselves as guilty of misconduct
- 3. Both officials are proved to remain absent since their posting to TDH Ghazi for a period 03 months from 13-02-2020 to till date (20-05-2020) & habitual absent from their places of duty

#### Recommendations

- 1. As inquiry committee is satisfied that both official upon which inquiry was made namely Mr. Asif Clinical Technician Surgical & Mst. Shahida Jabeen are guilty of misconduct as defined in E&D Rules 2011 of Civil Servant Act 1973, therefore, rendering themselves to be removed from civil service, dismissed or compulsory retirement awarded as the competent authority considers necessary under the prevailing rules.
- 2. Both said officials were also found habitual absent from their places of duties, therefore, inquiry committee is satisfied to recommend their removal from service under the relevant section of the aforementioned service rules.


