- 5. Incorrect, the Departmental Representation was against law & rules hence was turned down.
- 6. Incorrect, hence denied in toto.
- 7. Totally incorrect and denied.
- 8. Incorrect, hence denied.
- 9. Incorrect, the appellant was well aware of the facts that her representation was regretted by competent authority.

10. Incorrect, appeal of the appellant was not maintainable.
