SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 22.02.2019 WHEREBY THE APPELLANT HAS BEEN PROMOTED TO THE POST OF SST BPS-16 (BIO/CHEM) WITH IMMEDIATE EFFECT INSTEAD OF W.E.F 28.10.2014 WHEN COLEAGUES AND JUNIORS OF THE APPELLANT WERE PROMOTED AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned notification dated 22.02.2019 may very kindly be modified/rectified to the extent of appellant and the respondents may kindly be directed to consider the appellant for promotion to the post of SST BPS-16 (Bio/Chem) w.e.f 28.10.2014, the date when colleagues and junior colleagues of the appellant were promoted to the post of SST BPS-16 (Bio/Chem) with all consequential back benefits including seniority. Any other remedy which this Honorable Tribunal deems appropriate may also be awarded in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving raise to the instant appeal are as

under:

- 2- That through notification dated 21.02.2013 upon the proper recommendation of the Departmental Promotion Committee the appellant has been promoted to the post of SCT BPS-16 and started performing his duty quite efficiently and up to the entire satisfaction of his superiors. Copy of Notification dated 21.02.2013 is attached as Annexure
- 4- That feeling aggrieved from the inaction of the respondent by not promoting the appellant time and again approached to the respondent department for his promotion to the post of SST BPS-16 (Bio/Chem) as per his colleagues and juniors but of no avail.
- 6- That the appellant feeling aggrieved from impugned notification dated 22.02.2019 preferred departmental appeal before the respondent but the same has not been decided within the stipulated period of ninety days. Copy of the departmental appeal is attached as Annexure
- 7- That the appellant feeling aggrieved and having no other remedy filed the instance service appeal on following grounds inter alia.

GROUNDS:

A- That the impugned notification dated 22.02.2019 issued by the respondents is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.

- B- That appellant has not been treated by the respondents department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That despite the appellant was on promotion zone but the respondent ignored the appellant and promoted the colleague and junior to the appellant and lastly issued the impugned notification dated 22.02.2019 whereby appellant was promoted with immediate effect instead of w.e.f 28.10.2014.
- D-That the respondent department acted in arbitrary and malafide manner by not promoting the appellant to the post of SST BPS-16 (Bio/Chem) with effect from 28.10.2014.
- E- That the impugned notification dated 22.02.2019 is violative of section 9 of the Civil Servant Act read with rule 7 of the Appointment, Promotion and Transfer Rules 1989.
- F- That not considering the appellant for promotion to the post of SST BPS-16 (Bio/Chem) with effect from 28.10.2014, the respondents acted in discriminatory manner.
- G- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed far.
