In the light of statements, replies of the accused officers, staff of offices of EDO E&SE, appointed candidates on individual appeals. The opportunity of cross examination for sufficient time was already given was arranged in the office of DEO(F) Mansehra on 2013 in the presence of both accused officers and the concerned staff (Annex-XC).

**CROSS EXAMINATION OPPORTUNITY**

Mr. Umer Khan Ex- EDO Manshera , Miss Shamim Akhtar DEO(F) Manshera , M.Farooq EDO Office Manshera, Sajida Bibi ADO (member scrutiny committee), Naseera Begum EDO Office , Mohammad Ikram J/C and Mohammad Arshid dispatch clerk were present (Annex-XCI).

All the officers/officials present on the occasion were given the opportunity to raise questions and reply, accept or deny, explain or verify or put anything which they further want in their defense or against any one. Mr. Umer Khan Ex-EDO Manshera insisted on his reply submitted and posed the question to Miss Shamim Akhtar, DEO(F), Mansehra that whether she was not involved in the all process of appointment as she had signed the merit lists and attended the DSC?

Shamim Akhtar, however, denied her involvement in appointment process and claimed that the appointment process was completed by EDO Umer Khan and supdtt: Farooq as all the records/files were kept in their custody. She had not signed the merit lists during the appointment process, she added. During the fact-finding inquiry conducted by Mr. Riaz Khan Mr. Umer Khan came into her office and requested her to sign the merit lists to complete the process. She signed in the presence of inquiry officer i.e. after the appointment process.

Mr Umer Khan Kundi in yet another question asked DEO (F) whether she had authorized the Chairman DSC) to decide the appeals for appointments?

The DEO(F) rebutted this also and explained that this point was not even discussed in the office and she had not authorized the chairman/EDO to decide or accept the appeals.

likewise, Miss Shamim Akhtar, DEO(F) also questioned Mr. Farooq supdtt: regarding the custody of appointment which was kept with him. Mr. Farooq supdtt: clarified that the record was maintained by the sub committee then composed in the office and kept with him.

Miss Shamim DEO(F) asked the EDO Mr Umer Khan Kundi that had she not informed the EDO regarding individual appointment orders issued by him after general orders against the merit?

Mr. Umer Khan the then-EDO explained that the letter was properly responded. The DEO(F) questioned the EDO about the individual orders issued on the appeal under the jurisdiction of EDO E &SE Mansehra. The EDO responded that all the appeals were decided on

Regarding custody of dispatch Register, Mr. Umer Khan rebutted the statement of M. J/C and M. Arshid dispatcher and clarified that on the information of irregularities and ambiguous orders, he took the register for checking purpose.

Sajida Bibi ADO (member scrutiny committee) and Naseera Begum ASDO Estt: asked supdt: about the composing of final merit lists. He admitted that the corrected list was proposed in his office and then the signatures of the committee members were obtained.

The following additional discoveries were also noticed in the office regarding the appointment of different cadres of female;

All the appointment orders of AT, QARI, DM, PET, PST, CT (F) were issued under the signature of Mr. Umer Khan Kundi EDO E & SE Mansehra but no file work, note sheet, procedure, office routine, draft, proposal and approval on file could be found.

Letter No 9485 dated 19.9.2012 regarding appointment /adjustment addressed to EDO E & SE Mansehra sent by DEO (F) Manshera is available on file regarding issuance of single appointment order of Saba Khaleeq under No. 6850-59 dated: 29.5.2012 under the signature of EDO E & SE Manshera was against the merit and she was further transferred to GGPS Bandi Mohammad. (Annex-XCII).

Similarly DEO(F) Manshera through official letter No.5124/AE-II (F) dated 22.6.2013 sent appointment orders to Mr Umer Khan Kundi DEO (M) Haripur issued by him ( as EDO E & SE Manshera) for verification for release of pay of three PSTs issued under Endst No.6850-59 (F) Appoint: Estt;(F) 2011-12 dated 31,5,2012 (Annex-XCIII).

The DEO (M) Haripur Mr. Umer Khan (Ex-EDO, Mansehra) Vide his No.6770 dated 22.6.2013 responded through letter No. 5124/AE-II of 22.6.2013 with the remarks that appointment of Rafia Mussadaq, Nazma Bibi and Saba Kaleeq based on the merit of UC Lissan are confirmed as genuine (Annex-XCIV).

The Health and Age certificate attached with the letter reveal that Saba Khaleeq appeared for medical examination for health and age before MS on 4.6.2012 and Nazama Bibi on 22.12.2012. The signature of MS of King Abdul Aziz Teaching Hospital Manshera dated 4.6.2012 and 22.12.2012 reveal the same fact. The appointment orders of three ladies were issued on 31.5.2012. However, medical was carried out after 7 months. This abnormal delay in medical checkup for health/age for initial appointment is against the spirit of appointment orders (Annex-XCV).

Another letter of DEO (F) Manshera was sent to EDO E & SE Manshera Vide No. 5124/AE-II dated 17.12.2012 after receiving seven individual orders of PET, AT and CT stating that as per recruitment policy the vacant posts were declared till the meeting of DSC. Candidates were appointed on merit and further appointment cannot be made without advertisement. Individual orders have been made on the acceptance of appeals whereas the members of DSC have not been involved and being a member of DSC she was unaware of these orders. "your honor has passed these appointment orders against the recruitment rules, without the approval of DSC. Such orders are bogus and not valid for implementation." She requested for verification of these orders and guidance in this regard. The same letter was also endorsed to PA to Secretary E & SE Peshawar, Director E & SE Peshawar and District Coordination Officer Manshera. (Annex-XCVI).



List of vacant posts of PSTs Union Council-wise, which was prepared before the appointment by the then-Deputy District Officer (Female), is available on the record which has been annexed at (Annex-XCVII).

Copy of Source 1 form relating to first drawl of salary was obtained from the office of DAO, Mansehra in respect of Saman Naz, newly appointed PET. It was returned by DAO, Mansehra with the observations dated: 15-03-2013, asking for clarification regarding late submission of the claim, fake signatures of the DDO and copy of previous order, record of orders and approval of Competent Authority be produced to the pre-Audit. It is pertinent that appointment order was issued on 31-05-2012 (Annex-XCVIII).

The previous Dispatch Register which was kept in the office of EDO was closed even though many pages of the said register were blank / yet to be used. Opening of a new register while the previous register was being utilized is astonishing. The page numbers were not found on the register and columns of stamp / remarks was also not filled. Appointment orders of different cadres were not dispatched to the candidates rather delivered by hand or other source (Annex-XCIX).

As per photocopy of scale audit register obtained by the office of DAO, Mansehra, number of filled PSTs posts in the month of April, 2012 was 1590 (one thousand five hundred ninety only) and in the month of June, 2013 pay was drawn of 1648 (one thousand six hundred and forty eight) (Annex-C).

The DO(F), Mansehra produced the detail of 18 (Eighteen) appointment orders of candidates whose pay was drawn or otherwise and the candidates were appointed on appeals (Annex-CI).

Copy of the Notification issued under the signature of Mr. Umar Khan Kundi EDO, E&SE, Mansehra Erst. No: 610-15 dated: 30-11-2012 was presented to the enquiry committee in which appointment orders of 16 (Sixteen) male and female was recorded as cancelled being false or scanned copies. Among them Bibi Nageena AT (female) appointment order No: 4399-409 dated: 23-07-2012 is also included as cancelled by the EDO at S.No.14 of the same notification which was received to the Deputy DO (Female) on 23-04-2013 at 04:00 P.M i.e. notification letter dated: 30-11-2012 which was endorsed to the Deputy DO(F) vide No: 610-15 dated: 30-11-2012 handed over to the DEO(F), Mansehra on 23-04-2012 i.e. after the separation of both offices after 4 (four) months and 03 (three) days, when the newly appointed candidates had already taken over charge in different schools. Mr. Umar Khan Kundi Ex-EDO, Mansehra in his reply to the questionnaire dated: 03-08-2012 admitted that the candidate at S.No. 14 was added in the merit list as she was entitled for appointment and in the best interests of justice her order was issued separately. It is very astonishing that at one end he is endorsing her appointment as just on merit and on the other hand he has already cancelled/withdrawn his order No: 4399-409 dated: 23-07-2012 on 30-11-2012 (Annex-CII).

Mr. Jamil-ur-Rehman, Budget and Accounts Officer O/O the EDO(E&SE) Mansehra in his statement disclosed that general appointment orders were issued on 18-05-2012 and thereafter the EDO were issuing further individual orders under the assumption that nobody would know about such willful orders on his part. The B&A Officer did advise the EDO about the nature of such individual orders issued by him. However, he turned deaf ear to his advice (Annex-CIII).

It is also on the record that corrigendum of the appointment orders were signed by the Superintendent Mr. Farooq under the seal of DO (F), Mansehra, whereas the EDO, E&SE, Mansehra didn't mark the corrigendum's to DO(F) and she was not consulted/involved in the process (Annex-CIV).

**REMARKS OF MEMBER DISTRICT SELECTION COMMITTEE FOR THE RECRUITMENT OF TEACHERS.**

Mr. Umar Khan Ex-EDO (E&SE) Mansehra in his reply to the charge sheet, questionnaire takes the stand that he was duly authorized by the DSC for acceptance of appeal of the candidates as the same has been recorded at Page: 2/Last Para of the minutes of DSC. The DO(F) Member DSC, Mr. Naik Muhammad Ex-HRDO O/O DCO Mansehra (Member) and Mr. Muhammad, District Officer (Schools) Mansehra member DSC in their replies has denied the stand of EDO(E&SE) Mansehra.

Mr. Naik Muhammad Ex HR DO Mansehra (Member DSC) submitted that no such decision was made by the recruitment committee in which EDO(E&SE) was authorized to accept any appeal etc for the said recruitments. He disowned the last Para of the minutes and didn't verify the authenticity of the last Para of the minutes (Annex-CV).

Mr. Khan Muhammad DO(M) Mansehra (Member DSC) also submitted that the members cannot authorized any officer to work on behalf of DSC and attendance of the members dated: 14-05-2012 was taken on a separate page of the letter. (Annex-CVI).

Miss. Shamim Akhtar DO(F) (Member DSC) in her statement has denied for any authorization to the EDO/Chairman to accept or decide any appeal regarding the appointments. Her point was not discussed in the DSC meetings. She also disowned the last Para of the minutes recorded at page 2 of the minutes. (Annex-CVII).

He was given one week time period for the reply of the charge sheet. (Annex-CVIII).

The enquiry committee vide No: PS/SSA/Enquiry/20-13 dated 26/09/2013 also intimated the accused to the accused with the directives to submit the reply in his defense within stipulated time (Annex-CIX).

He further recorded that names and particulars of irregular appointees if any, were not reflected in the revised charge sheet statement of allegations, and nature of irregularities committed were not brought into his notice, and that it was imperative upon the Authority / Department to point out the names and other particulars of irregular appointees and nature of irregularity committed in each case, so that he may be able to offer his views / comments in his defense. He has also desired to be heard in person. He requested for exoneration from the Charges and withdrawal of charges sheet served upon him. He has also attached photocopies of the General orders and individual appointment orders issued on appeals under his signature (Annex-CX (A-K)).

On the receipt of his reply to the enquiry committee on 01-10-2013. The committee informed the accused officer Mr. Umar Khan Ex-EDO Mansehra vide letter No: SS-AD/Enquiry/2013 dated: 03-10-2013, the illegalities and irregularities committed by him in the appointments of Female teachers noticed in the enquiry process and gave him seven days period for reply / comments or anything which he further wants to put in his defense (Annex-CXI).

REPLY OF MISS. SHAMIM AKHTAR DEO(F) MANSEHRA REGARDING  
IRREGULARITIES/ILLEGALITIES IN THE APPOINTMENT ORDERS.

In her reply to illegalities/irregularities pointed out in the appointment of female teachers in the subject enquiry, she submitted that she was neither appointing authority nor any appointment order bear her signature. Being controlling authority of female side she had brought into the notice of Competent Authority some irregularities / illegalities through letter dated: 17-12-2012, and the same was brought into the notice of worthy Secretary, Elementary and Secondary Education Department. She was not informed / discussed regarding changes in the merit lists, acceptance of appeals and changes in the vacant posts of PSTs, and she was totally bypassed during the process. Merit lists were composed by Mr. Farooq, Superintendent, made changes in merit lists and also signed the adjustment orders keeping her name. The vacancies of PSTs which were declared vacant were filled by transfer due to which some of the teachers were appointed. She then Dy. DO (F) and she herself brought into the notice to the Competent Authority that the original post filled up after advertisement be vacated by transfer back. She concluded that she was not appointing authority and no appointment order was issued under her signature. She did not make any irregularity/illegalities and prayed for consideration (Annex-CXIV).

## **FINDINGS:-**

In view of the facts narrated above, perusal of the available record of appointments of different cadres of female teachers, replies to the charge sheets/statement of allegations, statement on affidavits, cross examination of the accused officers and the concerned staff, statements and replies of the available newly appointed candidates, members of the DSC and their statements and thorough scrutiny of the available record placed before the committee, **the following findings have come to the fore:**

The appointment process of all the cadres referred to in enquiry was checked in the light of rules and recruitment policy of Government of Khyber Pakhtunkhwa, Elementary and Secondary Education Department Notification No: SO (PE) 4-5/SSRC/Vol-III dated: 18-01-2011;

1. The merit lists of candidates were not properly scrutinized by the appointing authority, even random checking was not carried out before issuance of orders, leading to irregular appointments.  
The merit lists of all the cadres of female teachers i.e CT, DM, PET, AT, Qari and PST were not found signed by Mr. Umar Khan Kundi, Executive District Officer, E&SE, Mansehra;
2. Proposal, opinion, suggestions of District Officer Female for appointment in different girls schools were not sought by the then EDO (E&SE) Mansehra;
3. No proper file work, note sheets, DFAs were found for the decision of appeals.
4. Merit lists were composed and changes after test and interview/scrutiny of documents of the applicants were made by Superintendent Mr. Farooq and all the record of appointments / files were kept by him and the EDO E&SE Mansehra Mr. Umer Khan.
5. **All the appointment orders of AT, PET, CT, DM, Qaria and PSTs (Female) were signed and issued under the signature of Mr. Umar Khan Kundi, the then-EDO E&SE, Mansehra;**
6. **No appointment order of female teachers referred to in enquiry were found signed by Miss. Shamim Akhtar District Officer (Female) Mansehra.**
7. The individual applications/appeals for appointments were received by the EDO, E&SE, Mansehra after the issuance of general appointment orders of AT, PET, CT, DM, Qaria, PSTs and **accepted by him without any proper procedure and DSC for which he was not competent/authorized.**
8. District Officer (female) E & SE Mansehra Miss: Shamim Akhtar took notice of individual appointments orders issued by Mr. Umer Khan on acceptance of appeals. She informed the EDO E&SE Mansehra Vide No. 9485 dated 19.9.2012 and 1721 dated 17.12.2012 that such appointment orders are out of merit and can not be issued with out the approval of DSC/proper procedure. She also brought in to the notice of high ups regarding the out of merit/irregular appointment orders being issued by the EDO E&SE Mansehra Mr. Umer Khan. Copy already annexed with a **para-18.**
9. Some adjustment orders of the newly appointed teachers were found issued under the signature of Superintendent Mr. Farooq without the approval/permission of DO (F). Copy already **annexed** with the reply of DO (F).
10. The EDO E&SE Mansehra Mr. Umer Khan vide his letter no. Nil / (with out Dispatch No) "Confidential" dated 31-12-2012 addressed to Shamim Akhtar DO (F) accepted the appointment of Sanam Naz, Sadaf Riaz, Rabia Aziz PETs and Maimoona Naz CT as issued by him but 3 appointment orders of AT i.e Madiha Yaqoob, Saniatul Kubra and Sanam as not found in his office record. It is astonishing that the same letter was not sent to the District Accounts office Mansehra for stoppage of pay and District Coordination Officer Mansehra who was competent authority for the approval of ATs (B-15) .(Copy already Annexed with reply of Mr. Umer Khan).

11. An other notification issued under Endst: No. 610-15 dated 30-11-2012 under the signature of Mr. Umer Khan EDO E&SE Mansehra is available with the reply of Mr. Umer Khan in which 16 appointment order (Male & Female) under different Endst: No. w.e.f 18-05-2012 to 31-07-2012 were shown cancelled being scanned or photo state and does not exist in office record. Among them Bibi Nagina AT also exist at S.No 14 but in his replies to the questionnaire /annotated reply of irregularities Mr. Umer Khan again admitted her appointment as eligible and valid. The letter of 30-11-2012 was delivered to D.O (Female) on 23-04-2013 i.e on the last day of his tenure in Mansehra. It is astonishing that the same notification contained the date of issue as 13.11.2012 but kept with him for about 4 months and delivered to DO (F) on his last day in Mansehra. (Copies already Annexed with the reply of Mr. Umer Khan and Miss Shamim Akhtar D.O (Female)).
  12. The matter of photo state orders /scanned copies was neither probed nor was any inquiry/action found taken against any officer/official of his office. Despatch Numbers of the appointment orders and the signature exist on the orders and copies are available in the office record.
  13. The District Selection Committee in its meeting held under the Chairmanship of District Coordination Officer, Mansehra on 07-06-2012, approved 18 (Eighteen) female candidates for the post of AT (BPS-15), but excessive appointment orders were issued by Mr. Umar Khan EDO(E&SE), Mansehra on the basis of individual applications/appeals of the candidates after the issuance of general order on the plea that the appeals were accepted on the approval of competent authority. This is illegal as he was not competent because without the approval of DSC, working paper, minutes of meeting, approval and prescribed procedure no appointment could be made.
- Members of the then-DSC for the post of CT, PET, DM and PST held under the Chairmanship of EDO (Mansehra) had not authorized Chairman/EDO, E&SE Mansehra to decide/accept the individual appeals of the aggrieved candidates as members were not competent to do so. As such the plea of Mr. Umar Khan Kundi, the then-EDO E&SE, Mansehra regarding authorization by the DSC to decide/accept appeals is incorrect.
14. **Mr. Naik Muhammad Ex HR DO Mansehra (Member DSC)** submitted that no such decision was made by the recruitment committee in which EDO(E&SE) was authorized to accept any appeal etc for the said recruitments. He disowned the last Para of the minutes and didn't verify the authenticity of the last Para of the minutes.
  15. **Mr. Khan Muhammad DO(M) Mansehra (Member DSC)** also submitted that the members cannot authorize any officer to work on behalf of DSC and attendance of the members dated: 14-05-2012 was taken on a separate page of the letter.
  16. **Miss. Shamim Akhtar DO(F) (Member DSC)** in her statement has denied for any authorization to the EDO/Chairman to accept or decide any appeal regarding the appointments. Even this point was not discussed in the DSC meetings. She also disowned the last Para of the minutes recorded at page 2 of the minutes.
  17. It was noticed that page 2 of the minutes of DSC held under the chairman ship of EDO for the appoint of CT,DM,PET and PST was found signed only by Mr. Umer Khan and was not signed by the other members of DSC. Page 2 regarding the authorization of deciding the appeals either have been changed or recomposed after getting the signatures of members of DSC on the separate paper (Page 3).
  18. Proper procedure to decide individual appeals was not adopted as no meeting of DSC took place later on to decide the appeals as no such record in the form of working papers, minutes were found available.
  19. Mr. Umer Khan EDO E&SE Mansehra was Executive head and appointment authority of Elementary and Secondary Education of District Mansehra. DO(M) and DO(F) were his subordinate officers. Appointment order on both sides i.e. Male and Female were signed and issued under his signature. All the appointment process of Female teachers (AT, TT, CT, PET, DM, Qaria and PSTs) was carried out by him and all the appointment orders of

these cadres were issued under the signature of Mr. Umar Khan Kundi as EDO (E&SE), Mansehra in the year 2012.

20. The DSC for the post of Qari/Qarias was held on 10-03-2012 under the Chairmanship of Mr. Umar Khan Kundi EDO E&SE Mansehra. However, the minutes were found unsigned and copy thereof was also not provided to the DO (F) office.
21. 21 (twenty one) Qarias were appointed by Mr. Umar Khan Kundi vide No: 893-942/Estt: (F) Appntt: Qaria(F)2012 dated 16.6.2012 out of which only one Amber Zeb D/O Alam Zeb GGHS Phurla was valid as per her documents/certificates. Whereas, other 20 (twenty) candidates were not eligible as per recruitment policy for the post of Qaria.
22. It is also pertinent that the guide line regarding the appointment of Qari post asked by the EDO E&SE Mansehra was responded by the Govt: of KPK E&SE Depdtt: in which it was clearly clarified that "Sanads" of Registered Madaris affiliated with Wafaqul Madaris may please accepted for the purpose of recruitment of Qari/Qaria. The appointing authority could not decide that appointment rules/clarification of the Government E&SE Department supersede any other remarks/ instructions of the Director E&SE having such a clear recruitment rule / guideline issued by the government of KPK E & SE Department available on his office record.
23. The DSC for the post of Qari/Qarias was held on 10-03-2012 under the Chairmanship of Mr. Umar Khan Kundi EDO E&SE Mansehra. As per minutes of the meeting Mr. Khan Muhammad DO (M), Miss. Shamim Akhtar, DO(F), Abbas Ali Shah, Section Officer, E&SE Department, Khyber Pakhtunkhwa and Qazi Abdul Salam from the office of DCO Mansehra attended as members. The minutes of the meeting, however, were not found signed by two erstwhile members i.e. Miss Shamim Akhtar, DO(F) and representative of DCO Mansehra. Similarly the said minutes of DSC didn't contain the signature on body of the letter nor on its endorsement. Interestingly the aforementioned minutes / record of the DSC was not made available from office of the District Officer (Female) Mansehra and the same were, however, obtained through Fax from office of the DO (M) Mansehra after frequent requests. **(Copied already Annex with para 40).**
24. The District Selection Committee (DSC) in its meeting held under the Chairmanship of DCO Mansehra approved 18 (Eighteen) candidates for the post of Arabic Teacher (AT) and 09 (nine) for the post of Theology Teacher (TT), whereas, the DSC held under the Chairmanship of Mr. Umar Khan Kundi, DEO(E&SE) Mansehra approved 09(nine) PETs, 11 (Eleven) Drawing Masters (DM), 11 (Eleven) CTs, 21 (Twenty one) Qaria and 59 (fifty nine) PSTs for appointment against vacant posts but excessive appointment orders were issued under the signature of Mr. Umar Khan Kundi EDO E&SE Mansehra .

**General appointment orders of 18 (Eighteen) AT candidates issued by EDO(E&SE) Mansehra under Endorsement No: 710/52/Estt(F)Apptt:AT(F)2012 dated:14-06-2012. The following irregularities have been found in the appointment orders of Arabic teachers.**

Award of Weightage of MA certificate after the closing date of the receipt of the application/test/interview to raise the merit was irregular and against the recruitment rules/procedure.

Award of Weightage of M.A to raise the merit is not justified as she was not M.A at the time of submission of application form. Result of M.A was declared on 29-01-2012. **Award of Weightage of MA after the closing date to raise the merit was irregular and against the recruitment rules/procedure.**

Kalsoom Bibi D/O Chan Zeh, Serial No: 11 of the appointment order appointed at GGMS Bai Bohal. She was not M.A Arabic and does not possess the relevant qualification for the post. The certificate / Sanad attached with her application form was different from Wafaq-ul-Madaras Sanad. **She didn't possess the prescribed qualification at the time of test/interview. The certificate / Sanad attached with her application form was different from Wafaq-ul-Madaras Sanad. Her appointment was irregular and against the recruitment rules/procedure.**

Sidra Bibi D/O Ghulam Ahmad, Serial No: 14 of the appointment order appointed at GGMS Mohandri. She was awarded double Weightage of M.A Arabic which was minimum qualification for recruitment of AT. Award of additional Weightage of M.A on the basis of same qualification for recruitment is unjustified. Award of double Weightage of MA Arabic was illegal. MA Arabic is minimum prescribed qualification. **The appointment was irregular and against the recruitment rules/procedure.**

**ILLEGAL APPOINTMENT ORDERS OF ATs ISSUED ON ACCEPTANCE OF APPEALS BY EDO E&SE MANSEHRA Mr UMER KHAN.**

Bibi Nageena D/O Abdul Rashid, Serial No: 09A of the merit list was appointed vide Estt No: 4399-409/Estt(F)/Apptt;AT/2012 dated: 23-07-2012 at GGMS Chamial, her name was inserted at S.No 09A of the merit list at later stage under initials of EDO and signature of Superintendent. Certificate of M.A Urdu is irrelevant qualification for the post and has been issued on 08-02-2012 i.e. after the closing date of the applications/test/interview. She had submitted appeal for the post of T.T but appointed as AT without DSC/proper procedure. Her name was included in the merit list at S.No 09A after meeting of DSC without proper procedure / approval. Her appointment order was withdrawn by the EDO(E&SE) vide No: 6130-15 dated: 30-11-2012. Copy of the order was delivered to DO(F) on 23-04-2013 i.e. the last day of the EDO(E&SE) Mansehra. **Interestingly now in his reply the EDO Mr. Umer Khan is accepting this order as valid. The DO(F) was not aware of this appointment. The appointment is illegal and against the recruitment rules/procedure.**

Robina Naz Gillani D/O Ghulam Gillani appointed as A.T at GGHS Kaghan vide Estt No: 6508-13/Estt(F)/AT dated: 11-08-2012. Her name was not found in the merit list. Appointment order was issued on the acceptance of appeal by the EDO, Mansehra without proper procedure/DSC. Her name does not exist in the merit list. Appointed on the acceptance of appeal by the Competent Authority i.e. DCO. No meeting, working order, minutes/prescribed procedure were carried out. The plea of EDO that the order was issued on the earth quick quota is not valid as no provision of appointment on earth quick quota has been allotted in the recruitment policy/rules and advertisement. **The appointment is illegal and against the recruitment rules/procedure.**

Mediha Yaqoob D/O Muhammad Yaqoob, appointed at GGMS, Soka by Endst. No: 4399-409/Estt (F)Apptt/A.T/2012 dated: 23-07-2012 and then adjusted at GGMS Kamal. Her appointment order was issued by the EDO (E&SE) Mansehra, the entry of the order in the register shows that appointment order was made in compliance of the judgment of Hon'ble High Court but no record / copy of the judgment was produced.

No DSC was held. As per her written statement she has served more than one year. **The appointment is illegal illegal and against the recruitment rules/procedure.**

**Sanila-tul-Kubra D/O Muhammad Hilal Khan**, appointed at GGMS Agla Garah vide Endst. No. 1466-76/Estt"Apptt"A.T/2011-12 dated: 26-06-2012. She was appointed on the acceptance of appeal by the EDO(E&SE) Mansehra. Her name was not available in the merit list and copy of appeal has not been produced to the enquiry committee. No DSC held to decide the appeal. She was appointed on acceptance of appeal on 26-06-2012 and appointment order withdrawn by the EDO on 30-11-2012, delivered to the DO(F) on 23-04-2013 i.e. on the last day of EDO(E&SE) Mansehra. **The appointment is illegal illegal and against the recruitment rules/procedure.**

**Tayyuba Bibi D/O Muhammad Rashid**, appointed at GGMS Kawai, vide Endst. No: 5514-19/Estt:Apptt(F)/A.T/2011-12 dated: 11-08-2012. Her appointment order was issued on the acceptance of appeal by the EDO(E&SE), Mansehra. No DSC held / no procedure adopted to decide the appeal. No proper procedure was adopted, no DSC held to decide the appeal. **The appointment is illegal and against the recruitment rules/procedure.**

It was noted that the appointing authority has not complied with the recruitment rules / policy of Government of Khyber Pakhtunkhwa, E&SE Department Notification No: SO(PE 4-5/SSRC/Vol-III) dated: 18-01-2011 regarding the minimum qualification for initial appointment of Qaria. The guidelines of the department issued on the request of EDO (E&SE) Mansehra regarding the Sanad of the Madrassa/Institution was not taken into consideration before issuing the orders of Qaria. The perusal of the record/application forms alongwith Sanads reveal that 20 (twenty) candidates appointed as Qaria did not possess the relevant Sanad from the recognized institutions and were not eligible for appointment. Only one candidate Amber Zeb D/O Alam Zeb appointed as GGHS Qaria was eligible as per her documents / certificates.

- The EDO E& SE Mansehra Vide his No. 51341 dated 14.5.2012 addressed to Director, E&SE Khyber Pakhtunkhwa Peshawar has requested for guidance regarding the sandas of Madaris/Registered Institutions. The same letter was returned with the remarks of Director E&SE on the face of the letter that " As per service structure and prescribed rules the sanad of Qirat from recognized Institution means a certificate obtained from a Madrassa/ Institute registered with Government of Khyber Pakhtunkhwa (Annex-CXVII).

- It is also pertinent that the guideline regarding the appointment of Qari post asked by the EDO E&SE Mansehra was responded by the Govt: of KPK E&SE Depdtt: in which it was clearly clarified that "Sanads" of Registered Madaris affiliated with Wafaqul Madaris may please be accepted for the purpose of recruitment of Qari/Qaria. The same letter was received to the EDO E&SE Mansehra is also available on the record entered at Dairy No. 3396 dated 14-6-2012 but the directivities / clarification of the Government of Khyber Pakhtunkhwa E&SE No. SO (PE 5-12/Darul Uloom Swat/Chitral/10 dated 7-6-2012 was neither brought into the notice of

**CONCLUSION**

- b) The charge of making illegal appointments of CT, DM, PET, AT, QARIAS and PSTs (female) during the year 2012 in violation of rules and prescribed procedure in District Mansehra, against Miss. Shamim Akhtar DO(F), Mansehra, **HAS NOT BEEN PROVED.**
