The petitioner through instant Execution Petition seeks implementation of the order dated 21.06.2019 of this Tribunal, whereby the respondents were directed to issue final seniority list of Tehsil Revenue Accountants (TRA). The copy of the order dated 21.06.2019 has been annexed with the execution petition. According to the said order, the appeal of the appellant/petitioner was disposed of seemingly at the stage of preliminary hearing because only presence of the appellant's counsel is marked with no mention about the attendance of the respondents. The official respondents were required to issue final seniority list of TRAs in accordance with law/rules within a period of 60 days from the receipt of copy of the order and the appeal was disposed of accordingly.
- 3. After entertainment of the Execution Petition in office, when it came before the Bench for hearing on 22.01.2020, direction was given to issue notices to the respondents for submission of implementation report. The report thereafter was submitted on 17.03.2021 as to lack of fitness of the incumbency of petitioner for seniority claimed by him. The implementation report was placed on file.

The petitioner in Para-I of the execution petition stated that he is serving as TRA Havelian w.e.f. 04.12.2010 and annexed the copy of the order of his appointment as Patwari with the execution petition. According to the copy of order annexure-A, the petitioner being newly appointed was adjusted as TRA Havelian in his own pay scale. The petitioner, may be under impression of his having got transfer as TRA Havelian to be posted as such as matter of right, filed the Service Appeal which was disposed of unilaterally without issuing notices to the respondents by a Single Bench. The said order having been passed on backup of the respondents is not binding upon them on one hand and on the other in view of the implementation report submitted by the respondents, the petitioner has no locus-standi to seek any relief on the basis of order dated 21.06.2019 when the said order is not meant to declare status of his appointment as TRA. The respondents in their comments have not admitted the ground of petitioner as to his status revealed in Para-1 of the execution petition. They have given clarification about actual status of petitioner as Patwari in their comments and he was

shown to have been appointed as such vide order bearing No. 4991-3504, dated 30.11.2010. It is an admitted position on behalf of the respondents that he was posted as TRA in his own pay scale vide order dated 04.12.2010 but with the explanation that cadre of the post of Petitioner was not changed from Patwari to TRA as he was posted as such through transfer from the post of Patwari in his own pay scale and not through appointment by transfer to the post of TRA on regular basis. The petitioner seeks to get all benefits on the basis of order of this Tribunal, otherwise not executable under the facts and law, in negation of the factual position of his actual status brought forth through the comments of respondents. This execution petition being frivolous is dismissed. File be consigned to the record room.



This is an appeal filed by Mr. Yasir Khan Patwari working as Tehsil Accountant, Havellian District Abbottabad against the order dated 08.06.2020 whereby Mr. Aquel Ahmad Kanungo was posted as District Revenue Accountant (OPS) Abbottabad against the vacant post.

Facts of the case are that the appellant was appointed as Patwari on 30.11.2010. He was posted as Tehsil Accountant in (OPS) on 04.12.2010 and is still working as such till date. The main contention of the appellant is, that Mr. Aquel Ahmad is Kanurigo of Torghar District and cannot be posted as District Revenue Accountant (OPS) in Abbottabad District as he is working as Tehsil Accountant and may be posted/promoted as District Revenue Accountant Abbottabad.

Under the rules, the post of District Revenue Accountant shall be filled by promotion, on the basis of seniority-cum-fitness, from amongst the Tehsil Accountant (BS-07) of the district with at least three years service as such.

Perusal of the record reveals that the appellant is basically Patwari of Abbottabad District. Pay Roll of the appellant also reveals that he is still receiving the pay of Patwari BS-09 while the post of Tehsil Accountant is in BS-07. The request of the appellant for adjustment as Tehsil Accountant is not covered under the rules and is hereby dismissed. However, Deputy Commissioner Abbottabad is directed to place his case for promotion as Kanungo before the DPC for consideration strictly in accordance with law/rules on his own turn on availability of posts.



APPLICATION FOR IMPLEMENTATION OF ORDER DATED 21.06.2019 OF THIS

HONOURABLE TRIBUNAL WHEREIN THE RESPONDENT WAS DIRECTED TO ISSUE FINAL
SENIORITY LIST OF TRAS I.E TEHSIL REVENUE ACCOUNTANTS.

The comments are submitted as under:-

Preliminary Objections

- 1. That the appellant has no cause of action to file instant application.
- 2. That the appellant has not come to this Honourable Tribunal with clean hands.
- 3. That the appeal is time barred, hence, liable to be dismissed.
- 4. That the appellant has suppressed the material facts from the Honorable Tribunal, hence, not entitled for any relief and application is liable to be dismissed without any further proceeding.
- 5. That the appeal is liable to be dismissed due to mis-joinder and non-joinder of necessary parties.
- 6. That the appellant is stopped by his own conduct, hence, appeal is liable to be dismissed.
- 7. That both the orders issued by the authorities are true and correct as per law and rules, hence, appeal is liable to be dismissed.

Facts.

1. Incorrect:

Currently the appellant is posted as Patwari Halqa Karach Riala. The appellant was appointed as Patwari vide order bearing No. 3491-3504 dated 30/11/2010 (Annex-A). Then he was posted as TRA in own-pay-scale vide order No. 3566-78 dated 04/12/2010 (Annex-B), but it is pertinent to mention here that cadre of the post of the appellant didn't change from Patwari to TRA as he was posted as TRA through transfer from the post of Patwari in his own pay scale i.e. he was not promoted to TRA on regular basis rather he was/is Patwari by designation and remained posted as TRA in his own-pay-scale for the period from 04/12/2010 to 15/10/2019. Though the Department is crystal clear on its stance, but yet for the sake of safeguard of the rights of the appellant, clarification was solicited from Provincial Government and according to Board of Revenue KPK letter No. 30216 dated 19/09/2019 (Annex-C).

Patwari BS-09 cannot be included in the seniority list of TRA BS-07, hence the appellant (being Patwari by designation) cannot be included in the list of regular TRAs. After the ibid clarification read with Board of Revenue letter No. 5099-113 dated 21/02/2019 (Annex-D), the appellant has been posted as Patwari Halqa Karach Riala (Tehsil Havelian).

2. Incorrect:

No such seniority list was ever maintained as both the officials (the appellant and his rival

Mr.-Muhammad Hanif Khan) are Patwari by their designation and were not promoted to TRAs on regular basis, hence they cannot be placed in the seniority list of TRAs. However the list mentioned by the appellant was actually the list of incumbents who were working as TRAs was furnished to Board of Revenue vide this office letter No. 1564 dated 16.11.2015 (Annex-E).

3. Incorrect.

The Enquiry Officer clearly mentioned in his enquiry report (para-2) that the official was appointed as Patwari and posted against the post of TRA in his own pay and scale. The name of said official was shown/placed at proper place/cadre of seniority list maintained for Patwaris and the official never raised any objection on it. The seniority list of Patwari for the year ending 2018 is at (Annexure-E).

4. Incorrect:

As for as non-payment of allowances is concerned, the official deliberately not claimed/obtained the said allowance and also his case is subjudice in the various courts of law regarding maintaining the seniority list of TRAs or otherwise. Now, on receipt of clarification from Board of Revenue the Source Form-II for activation of said allowances has been submitted / presented in District Accounts Office, Abbottabad w.e.f 01.11.2019 (Annexure- F).

5. Incorrect.

This office has complied the rules/instructions of the government as well as court order in letter and spirit. The official has claimed the seniority among TRAs without any legal right/rules as the appellant is Patwari and he cannot be placed in seniority list of TRAs that is reason why his stance has not been favoured by any appellant authority/court.

6. Incorrect.

As the appellant has no base to file appeal against the authority.

PRAYER:

As elucidated comprehensively above that the appellant is basically Patwari and was posted against the then existing post of TRA in his own pay & scale i.e. he was not promoted as TRA on regular basis, hence his seniority is being maintained with Patwaris and cannot be placed in the list of TRAs.

It is therefore prayed that appeal of the appellant being baseless may be dismissed on above factual grounds please.
