Learned counsel for the appellant present. Mr. Kabir Ullah Khattak learned Additional Advocate General for official respondents present. Learned counsel for private respondent No.4 also present.</p> <p>2. The appellant (Subject Specialist Biology BS-18) has filed the present service appeal against the order dated 12.02.2019 whereby the appellant was transferred to the post of Vice Principal GHSS</p>

19.9.2019

Kohi Barmol Mardan after one (01) month of his posting/adjustment at GHSS Takkar Mardan. In place of the appellant, private respondent No.4 Tahir Khan (Subject Specialist Biology BS-18) was posted/transferred at GHSS Takkar Mardan.

3. Learned counsel for the appellant assailed the impugned order of transfer and posting on the ground that the same is illegal, arbitrary, premature and against the Khyber Pakhtunkhwa Posting Transfer Policy.

4. As against that learned AAG assisted by learned counsel for private respondent No.4, argued that it is the exclusive domain of the department to transfer a civil servant in the best interest of public and the civil servant is bound to obey the order. Further argued that private respondent No.4 is a disable person while place of posting i.e. GHSS Kohi Barmol is at a distance of 35/40 Kilometers from the abode of the private respondent No.4 moreover wife of private respondent No.4 is also performing her duty against the post of CT situated in the same area where private respondent No.4 is performing his duties i.e. GHSS Takkar Mardan. Further argued that the impugned order was issued upon the acceptance of departmental representation of the private respondent No.4 against his transfer to GHSS Kohi Barmol.

5. Arguments heard. File perused.


6. During the course of arguments it surfaced that private respondent No.4 has been serving at GHSS Takkar Mardan since 30.09.2008 and every time when he is transferred out, from that

school, he got his transfer cancelled.

7. In these circumstances, when the private respondent No.4 has been enjoying his service at his choice posting at GHSS Takkar Mardan since 30.09.2008, the excuse of disability of private respondent No.4 and the spouse policy can no longer be termed as a valid reason for posting at the same school in as much as the private respondent No.4 cannot be allowed to hold the post in BS-18 in one and the same school till his retirement and thereby to defeat the right of other civil servant to serve at GHSS Takkar Mardan. Admittedly the appellant was transferred out from GHSS Takkar Mardan just after one (01) month of his posting at the said school.

8. In the light of above the present service appeal is accepted and the impugned order dated 12.02.2019 in relation to the appellant and private respondent No.4 (Tahir Khan) is set aside. Needless to mention that in case private respondent No.4 Tahir Khan faces any hardship in approaching at his place of duty, he may shift his abode for convenience. Parties are left to bear their own costs. File be consigned to the record room.





Contends that on 01.01.2019 the appellant was promoted ~~as S.S (Biology)~~ as S.S (Biology) and posted at GHSS Takar Mardan through notification issued by Government of Khyber Pakhtunkhwa, E&SE Department. On 12.02.2019 yet another notification was issued by the respondents whereby the appellant was once again transferred and posted as Vice Principal (BS-18) GHSS Kohi Barmol Mardan. The impugned notification of 12.02.2019 was in utter violation of the posting/transfer policy of the Provincial Government wherein normal tenure of posting is prescribed as two years. The notification, therefore, requires to be struck down to the extent of appellant, it was argued.

In view of the available record and arguments of learned counsel, instant appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 18.06.2019 before S.B.

On acceptance of the instant appeal the order dated 12.02.2019 may please be set aside being void ab-initio, illegal and without any legal justification.

Respectfully Sheweth:

Brief Facts:-

1. That the appellant was promoted from BPS-17 to BPS-18 vide promotion notification dated 22.10.2018.
2. That consequent upon the promotion notification dated 22.10.2018 the Respondent No.2 issued notification dated 01.01.2019 in respect of posting/transfer/adjustments of the promoted Teaching Cadre Officers. **(Copy of the Notification is attached as Annexure "A")**.
3. That in compliance to the posting/transfer notification dated 01.01.2019 the appellant assumed charge of the subject Specialist (Biology) at Govt Higher Secondary School Takkar. **(Copy of the Charge Report is attached as Annexure "B")**.
4. That all of sudden the Respondent NO.2 issued an other notification dated 12.02.2019 in respect of officers of E&SE Department vide which further posting/transfer was made and the appellant has been transferred to GHSS Kohi Barmol as Vice-Principle and Respondent No.4 has been adjusted transferred to GHSS Takkar,

meaning there by that the appellant's position and Respondent No-4 were exchanged mutually. **(Copy of Notification dated 12.02.2019 is annexed as Annexure "C")**.

5. That the appellant assumed charge of the new assignment under protest in compliance to the order/notification dated 12.02.2019. **(Copy of the Charge Report is annexed as Annexure "D")**.
6. That the appellant preferred Departmental Appeal against the notification dated 12.02.2019 before the competent authority. **(Copy of the Departmental Appeal is attached as Annexure "E")**.
7. That the Departmental Authority has not decided appeal of the appellant till now, hence the instant appeal before the Hon'ble Tribunal on the following grounds.

GROUND S:

- A. That the impugned order is illegal and arbitrary in nature, against the rules, hence needs to be struck down.
- B. That the impugned order dated 12.02.2019 is against the Khyber Pakhtunkhwa Posting and

Transfer Policy, which clearly provides for tenure of office.

- C. That the impugned order is result of political interference in the Education Department.
- D. That the impugned notification/order is against the basic norms of justice.
- E. That any other ground will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

Therefore, it is humbly submitted that the notification/order dated 12.02.2019 may please be set aside/struck down being illegal, illogical void-ab-initio and against the norms of natural justice.

Respectfully Sheweth,

Preliminary objections.

- I. That as per Section-10 of Khyber Pakhtunkhwa Civil Servants Act, 1973, every civil servant shall be liable to serve anywhere within or outside the Province against any post under the Federal Government or any Provincial Government or Local Authority thus the instant appeal is liable to be dismissed.
- II. That as per Section-22 of Khyber Pakhtunkhwa Civil Servants Act, 1973 the instant appeal is also liable to be dismissed on the ground that no Representation shall lie on matters relating to the determination of fitness of a person to hold a particular post.
- III. That the appellant has concealed material facts from the Hon'ble Tribunal and has not approached the Hon'ble Tribunal with clean hands, therefore, the instant appeal merits outright rejection.
- IV. That the appellant is estopped by his own conduct to file the instant appeal.
- V. That the instant appeal is time barred.

Reply to Facts:

1. Para-1 of the appeal needs no reply.

2. Regarding Para-2 of the appeal it is asserted that by order dated 22.08.2010 promotion from BPS-17 to BPS-18 was made, in pursuance of the same vide Notification dated 01.01.2019 posting/transfer were notified wherein Replying Respondent was transferred from GHSS Takkar, Mardan to the post of Vice Principal (BPS-18) GHSS Koi Barmol, Mardan. It is significant to mention here that maximum promotees were placed at their existing place of posting.
3. Para-3 of the appeal needs no reply.
4. Reference to Para-4 of the appeal has already been submitted herein above that it is exclusive domain of the Department to transfer a civil servant within or outside the Province in the best interest of public while a civil servant under the law is bound to obey the order. It is worth mentioning that Replying Respondent No.4 is a disable person vide Certificate and Medical Prescriptions (**Annex:-Reply/1**) who had earlier been transferred from GHSS Takkar, Mardan to GHSS Sher Garh, Mardan. Being aggrieved of the same he had preferred Departmental Representation against the same on the ground of disability on 03.12.2015 (**Annex:-Reply/2**) which was accepted thereby he was posted at his earlier place of posting. Furthermore, Replying Respondent was aggrieved from the Notification dated 01.01.2019 whereby he was transferred from GHSS Takkar, Mardan to the post of Vice Principal (BPS-18) GHSS Koi Barmol, Mardan. It has also been explained that Replying Respondent is a disabled person while the new place of posting is at a distance of 35/40 Kilometers. Moreover, wife of the Replying Respondent is also performing her duty against the post of C.T. at GGMS Gulshan Abad vide Certificate (**Annex:-Reply/3**) which is situated in the same area where the Replying Respondent had been performing his duties. Section-ix of the Posting/Transfer Policy of the Provincial Government *“Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station”* hence being aggrieved of the same replying Respondent preferred Departmental Representation dated 02.01.2019 (**Annex:-Reply/4**) which was accepted vide Notification dated 12.02.2019 (*Page-32 Annexure-E of the main Service Appeal*) by transferring him at GHSS Takkar Mardan.


5. Regarding Para-5 of the appeal it is averred that appellant has assumed the charge of new assignment, hence the order is acted upon which cannot be withdrawn under the Rules.
6. Regarding Para-6 of the appeal it is submitted that under the law no Representation can be filed against the order of posting and transfer rather under the law appellant is duty bound to serve anywhere as per mandate of the Department.
7. Para-7 of the appeal needs no reply.

GROUND:

- A. Ground-A of the appeal is incorrect hence not admitted. The impugned Notification was issued according to the posting/transfer policy. As already submitted herein above that Replying Respondent is a disabled person while his wife is also performing her duties in the same area thus it is a settled principle of law that the posting of husband/wife, both in Provincial services, efforts should be made to post the spouses at one station.
- B-D. Grounds B to D of the appeal are incorrect hence not admitted. The detailed reply has already been given in the preceding paras.
- E. Ground-E of the appeal needs no reply.

It is, therefore, humbly prayed that on acceptance of this reply, the appeal of appellant may graciously be dismissed with costs.

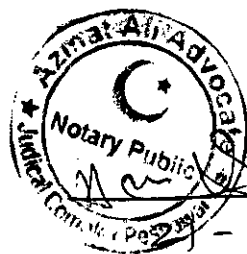


