

**Prayer:-**

- (i) **Declare** the action and omission of the respondents by not releasing the current and outstanding salaries of the Appellant with effect from 17-09-2022 till the date as illegal, unlawful, without lawful authority and set aside the same.
- (ii) **Direct** the respondents to release the outstanding salaries of the appellant with effect from 17-09-2022 till the date and onward.

- (iii) Any other relief as deemed appropriate in the circumstances of case not specifically asked for may also be graciously granted to appellant.

Respectfully Sheweth,

The concise facts giving rise to the present service appeal are as under:-

1. That appellant is the bonafide and law abiding resident of the Khyber Pakhtunkhwa. He was appointed as Chowkidar vide order dated 10-10-2020 and resume his charge on 11-10-2020. Copy of Appointment order and charge assumption report are attached as **Annexure-A**.
2. That later on appellant was transferred and adjusted at Govt: Girls Primary School, Aza Khel Bala No.1 vide order dated 15-02-2022.

Copy of Transfer/adjustment order dated 15-02-2022 and charge assumption report dated 15-02-2022 are attached as **Annexure-B**.

3. That the pay of the appellant was stopped and then was released w.e.from 01-06-2022 to 17-09-2022 vide order Endst No.4582-87 dated 17-09-2022.

Copy of order Endst No.4582-87 dated 17-09-2022 is attached as **Annexure-C**.

4. That respondent No.1 approached respondent No.4 and submitted statement of monthly pay alongwith outstanding salaries, but still the pay of the appellant has not been released.

Copy of salaries statement is attached as **Annexure-D**.

5. That the appellant is still serving as Chowkidar at GGPS No.1 Aza Khel Bala, but the salaries of the appellant has been withheld since 19-09-2022 till the date.

Copy of the attendance register is attached as **Annexure-E**.

6. That appellant made hectic efforts for the release of his salary and outstanding salaries and submitted departmental appeal/representation, but till the date no heed has paid to the legitimate expectancy of the appellant.

Copy of departmental appeal/representation is attached as **Annexure-F**

Hence petitioners being aggrieved and finding no adequate and efficacious remedy is constrained to file this Service Appeal on the following amongst other *grounds*:

- A. That the respondents has not treated the appellant in accordance with law, rules and policy on the subject and acted in violation of Article 4 of the Constitution of Pakistan, 1973. Appellant has been serving continuously as evident from the attached attendance register, but his salaries have been withhold without any legal reason, which is against the provision of fundamental right guaranteed under Chapter No.1, part-II of the Constitution of Pakistan, 1973.
- B. That appellant is low paid employee with dependents and more so his daughter is seriously ill therefore, withholding of salaries is not only against the provision of law, but also against the spirits of our Holy Religion and highly unwarranted and undesirable.
- C. That all public powers are in the nature of most secret trust and a very high onus was cost upon a functionary to uphold the highest degree of rectitude while dealing with the fate of Public servant. Since respondents were under legal obligation to release the current salary along with outstanding salaries but failed to perform their legal obligation in due course of time therefore, petitioner has legitimate right to ask for the release of his salaries through the instant service appeal.
- D. That appellant is entitled to be treated in accordance with law and also entitled to be treated fairly, justly under the provision and spirit of Article 10A of the Constitution of Islamic Republic of Pakistan, 1973.

E. That appellant would like to seek the permission of this Hon'ble Tribunal to advance more grounds at the time of hearing.

Consequent upon the recommendation of the Departmental selection committee (DSC) Mr. Mujahid Khan S/o Muhammad Hayat is hereby appointed as Chowkidar at GGPS Khudrazi # 2 Against the vacant post BPS-3 (RS. 9610-390-21310) Plus usual Allowances as admissible under the rules on regular basis in the interest of public service with effect from the date of his/her taking over charge in school with the terms and condition noted below:

TERMS AND CONDITIONS:

1. No TA/DA etc. is allowed for joining their duty.
2. He/she will be governed by Khyber Pakhtunkhwa Civil Servant Act, 1973 and the rules made thereunder.
3. His service shall be considered regular and he will be eligible for pension /deduction of GP fund in terms of Khyber Pakhtunkhwa Civil Servant Act, 1973 as amended in 2013.
4. He will be on probation for initial period of one year extendable for further one year as per rules.
5. His service can be terminated at any time, in case of his performance is found unsatisfactory during probationary period. In case of misconduct, he will be proceeded under the rules framed from time to time.
6. His service is liable to termination on one month's notice from either side. In case of resignation without notice his one month Pay/allowances shall be forfeited to the Government.
