- 2. Para-2 is correct.
- 3. Para-3 of the facts is incorrect, hence denied. And further stated that she was not transferred, but adjusted in GGHS Khall. in detail, it is stated that the respondent No.4 was appointed as D.M (BPS-15) at GGHS Namaz Kot, Lal qillah Maidan vide officer dated 21-02-2020, as she(Respondent No.4) gone for charge to the said school .it was sought out that the post in question was filled by transfer, and there was no any vacant of D.M (BPS-15) at that time, so she (the Respondent No.4) was re adjusted vide order dated 29-06-2020 at G.G.H.S Khall on wrong post of Senior Drawing Master (BPS-16) as no post of D.M (BPS-15) was vacant at that time. Mean while a letter was issued from the Principal G.G.H.S Khall that there is no vacant post of D.M (BPS-15), and she (Respondent No.4) may be adjusted against any vacant Post of D.M (BPS-15) and the adjustment order dated 29-06-2020 may kindly be withdrawn. (Copy of the appointment order Dated 21-02-2020 and adjustment order dated 29-06-2020 of the Respondent No.4 is attached as "A". Copy of the letter

dated 13-07-2020 is attached as "B").

Para-5 of the facts is incorrect, hence denied and it is further stated that the Respondent No.4 was not transferred as she was adjusted at G.G.H.S Khall koz kalay vide adjustment order dated 28-01-2021.it is pertinent to mention here that the Respondents No.4 was serving on wrong post of D.M (BPS 16) and after promotion of the teachers from D.M (BPS-15) TO S.D.M (BPS-16), Mst Rabia Naz was also promoted to S.D.M and after promotion she was adjusted as S.D.M (BPS-16) at GGMS Khall Payeen while the respondent No.4 was re adjusted at G.G.H.S Khall Koz Kalay on the post vacated from Mst.Rabia Naz .(Copy of the promotion order of the Rabia Naz is attached as "C", while Copy of the adjustment order of the Respondent No.4 is attached as "D").
