The learned counsel for the appellant argued that a post of Electrical Supervisor was advertised by the Health Department in the newspapers. That the appellant was at that time serving as Electrician in BPS-6 in Benazir Bhutto Shaheed Hospital, Abbottabad. That private respondent No. 6 was also serving at DHQ Hospital as Laundry Operator . That the appellant applied for the post through proper channel. But the appellant was not appointed despite having more qualification and experience than respondent 6.

This Tribunal observed that though the appellant was civil servant at the time when he applied for the post but the post was filled through initial appointment. In such situation, the matter does not fall within the terms and conditions of a civil servant who only applied for the post which is the subject matter of this appeal.

In view of this Tribunal, the matter being one of initial appointment does not fall within the jurisdiction of this Tribunal within the meaning of Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974. The present appeal is dismissed in limine, and the appellant is directed to approach the proper forum of preliminary jurisdiction, if so advised. File be consigned to the record room.






