



Counsel for the appellant present. Preliminary arguments heard.

The learned counsel for the appellant argued that a post of Electrical Supervisor was advertised by the Health Department in the newspapers. That the appellant was at that time serving as Electrician in BPS-6 in Benazir Bhutto Shaheed Hospital, Abbottabad. That private respondent No. 6 was also serving at DHQ Hospital as Laundry Operator. That the appellant applied for the post through proper channel. But the appellant was not appointed despite having more qualification and experience than respondent 6.

This Tribunal observed that though the appellant was civil servant at the time when he applied for the post but the post was filled through initial appointment. In such situation, the matter does not fall within the terms and conditions of a civil servant who only applied for the post which is the subject matter of this appeal.

In view of this Tribunal, the matter being one of initial appointment does not fall within the jurisdiction of this Tribunal within the meaning of Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974. The present appeal is dismissed in limine, and the appellant is directed to approach the proper forum of preliminary jurisdiction, if so advised. File be consigned to the record room.

APPEAL AGAINST THE OFFICE ORDER NO. 5248-51/ESTB DATED ABBOTTABAD THE 05/10/2017 WHEREBY THE RESPONDENTS ILLEGALLY, WITHOUT FOLLOWING THE RULES, AGAINST

THE CRITERIA SET AND ADVERTISED IN ADVERTISEMENT FOR THE APPOINTMENT OF ELECTRICAL SUPERVISOR BPS-II, AND WITHOUT LAWFUL AUTHORITY APPOINTED RESPONDENT NO. 5 AGAINST THE POST OF ELECTRICAL SUPERVISOR BPS-11 AT BBS TEACHING HOSPITAL, ABBOTTABAD.

PRAYER; ON ACCEPTANCE OF THIS APPEAL THE OFFICE ORDER NO. 5248-51/ ESTB DATED ABBOTTABAD THE 05/10/2017 ISSUED BY RESPONDENT NO. 3 BE DECLARED AS AGAINST THE LAW, ILLEGAL, WITHOUT LAWFUL AUTHORITY AND JURISDICTION, AGAINST RULES, AGAINST THE CRITERIA SET AND ADVERTISED FOR THE APPOINTMENT OF ELECTRICAL SUPERVISOR BPS-11 IN BBS TEACHING HOSPITAL ABBOTTABAD AND BE CANCELLED AND RESPONDENTS BE DIRECTED TO APPOINT THE APPELLANT BEING FULLY QUALIFIED FOR APPOINTMENT AS ELECTRICAL SUPERVISOR PBS-11 AGAINST THE ADVERTISED POST IN BBS TEACHING HOSPITAL ABBOTTABAD.

Respectfully Sheweth;-

1. That on 18/09/2013 the appellant was appointed as Electration in PBS-6 in Health Department KPK. Copy of appointment letter is annexed as Annexure "A".
2. That prior to appointment as Electration in Health Department the appellant served in COMSATS, Abbottabad from August 2012 to August 2013. Copy of Experience Certificate is annexed as Annexure "B".
3. That respondent No. 5 who was working as ward orderly in BPS-2 and was attached to type "D" Hospital Havellian, was adjusted on 17/02/2014 against the post of laundry Operator BPS-5 against the vacant post in BBS, Teaching Hospital, Abbottabad. Copy of adjustment order is annexed as Annexure "C".
4. That through an advertisement in Newspaper respondent No. 3 invited the applications for appointment against the post of Electrical

Supervisor BPS-11. Copy of advertisement is annexed as Annexure "D".

5. That in the advertisement the criteria fixed for appointment as Electrical Supervisor was given as under;-

- (a) Application must reach in the office of respondent No. 3 on or before 18/09/2017.
- (b) Candidate must possess certificate of SSC from a recognized Board.
- (c) Diploma of Associate Engineering (Electrical) from BTE KPK, Peshawar.
- (d) Three years working experience in Govt. /Semi Govt. Department.
- (e) Age limit 18 to 30. Copy of advertisement is annexed as Annexure "E".

6. That on 14/09/2017 the appellant applied for appointment against the post of Electrical supervisor through proper channel alongwith all the relevant documents.

- i. Copy of application is annexed as Annexure "F".

- ii. Copy of NOC by DHQ Abbottabad is annexed as Annexure "G".
- iii. Copy of Detailed Marks Certificate Bachelor Part-II, is annexed as Annexure "H".
- iv. Copy of Diploma of Associate Engineering is annexed as Annexure "I".
- v. Copy of Detail marks Certificate of Diploma is annexure "J".
- vi. Copy of SSC Certificate is annexed as Annexure "K".
- vii. Copy of DMC is annexed as Annexure "L".
- viii. Copy of provisional Certificate is annexed as Annexure "M".
- ix. Copy of Certificate of Excellence is annexed as Annexure "N".

7. That the respondents called the appellant for interview and the appellant was sure with respect to his appointment.

8. That without following the criteria the respondents appointed respondent No. 5 against the advertised post. Copy of appointment letter of respondent No. 5 and impugned through this appeal is annexed as Annexure "P".
9. That on 02/11/2017 the appellant filed a representation before respondent No. 2 against the order No. 5248-51 dated 05/10/2017 in favour of respondent No. 5 through post AD. Copy of representation is annexed as annexure "Q" and receipt is annexed as Annexure "R".
10. That respondent No. 2 has not decided the representation filed by the appellant, hence this appeal.
11. That appointment letter No. 5248-51 dated 05/10/2017 issued by respondent No. 3 in favour of respondent No. 5 is against law, criteria set and advertised for appointment of electrical supervisor is without lawful authority and jurisdiction and is liable to be cancelled and the appellant is entitle

for the appointment of the said post on the following amongst other grounds:-

GROUND:-

- (a) That the appellant was fully qualified and was entitle to have been appointed as Electrical Supervisor BPS-11.
- (b) That the respondent No. 5 has got no working experience as he remained ward orderly and thereafter as "Laundry Operator" whereas the appellant had more than 03 years experience in relevant filed.
- (c) That the appointment of respondent No. 5 as Electrical Supervisor is a result of nepotism and political favoritism and the same is liable to be cancelled.
- (d) That the appellants qualification is higher than respondent No. 5 which also has been ignored by respondents illegally.

(e) That appellant had been illegally deprived from his right of appointment.


(f) That this appeal is being filed in time.

It is, therefore, humbly prayed that on acceptance of this appeal the office order No. 5248-51/ Estb dated Abbottabad the 05/10/2017 issued by respondent No. 3 be declared as against the law, illegal, without lawful authority and jurisdiction, against rules, against the criteria set and advertised for the appointment of Electrical Supervisor BPS-11 in BBS Teaching Hospital Abbottabad and be cancelled and respondents be directed to appoint the appellant being fully qualified for appointment as Electrical Supervisor PBS-11 against the advertised post in BBS Teaching Hospital Abbottabad.
