JUDGMENT

AHMAD HASSAN, MEMBER:- Arguments of the learned counsel for  
the parties heard and record perused.

ARGUMENTS

2. Learned counsel for the appellant argued that he joined the Education  
Department as PTC on 25.8.1977. Presently, he is serving as PSHT (BPS-15). He  
has served the department for 39 years. In the relevant seniority list his name is  
appearing at Sr. no.2, while his date of birth is 12.09.1959. After passing B.Ed  
Examination from Allama Iqbal Open University on 17.01.2017, he became  
eligible for promotion to the post of SST (General). However, in the DPC meeting  
his case was deferred on the sole ground that entry B.Ed Degree was not made in

his service book and was also medically unfit. He preferred departmental appeal which remained unanswered, hence, the present service appeal. The onus of making entry in the service book lie on the respondents and nothing adverse is available on record to proof that he was medically unfit. The appellant was deprived of his due right due to casual attitude of the respondents.

3. On the other hand learned Assistant Advocate General argued that at the time of preparation of working paper for promotion to the post of SST (General) entry of acquiring B.Ed Degree was not made and being medically unfit his promotion case was deferred. Show cause notice was also served on him. Action taken by the respondents was supported by law and rules.

#### CONCLUSION

4. We have observed that after acquiring B.Ed Degree relevant record was provided to the respondents by the appellant. It was not a valid reason to defer his promotion case for want of entry in the service book and being not medically fit. Making entry in the relevant document was the responsibility of the respondents. Nothing on record was available to substantiate that he was not medically fit. Moreover, he had more than 39 years service at his credit and deserved to be promoted to the next higher scale subject to fulfillment of required formalities. As his case was deferred so a post must have been reserved for him to be considered for promotion after meeting deficiencies pointed out above.

5. As a sequel to the above, the appeal is accepted, impugned order dated 10.08.2017 is set aside. The respondents are directed to place his case for

promotion in the next meeting of DPC for consideration. Parties are left to bear their own costs. File be consigned to the record room.

Learned counsel for the appellant argued that the appellant joined the Education Department as PTC Teacher on 25.08.1977 and is presently working ~~as~~ and has served for more than 39 years and at the moment <sup>appellant</sup> is serving as PSH Teacher (B-15) at GPS Ganjey Tehsil Takht Bhai, District Mardan. That as per the current seniority list, 2017 of PSHT maintained for promotion of SST (G), appellant is at Sr. No.2 while his date of birth is 12.09.1959. That the appellant passed his B.Ed. Examination from the Allama Iqbal Open University, Islamabad on 17.01.2017. That the qualification of the appellant was duly verified by the University vide letter dated 28.07.2017 and the Degree was issued on 14.07.2017. That the appellant was fully hopeful that he would be considered for promotion to the next higher grade, however, vide impugned notification dated 10.08.2017, the appellant was ignored, while juniors to him were promoted to the next higher grade in violation of law. That the appellant submitted departmental appeal before respondent no. 1 on 18.08.2017 but the same was not disposed of within the statutory period of 90 days.

Points raised need consideration. Admitted for regular hearing subject to all legal objections including limitation. The appellant is also directed to deposit security and process fee within (10) days, whereafter notice be issued to the respondents department for written reply/comments on 19.02.2018 before S.B.

SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT-1974 AGAINST THE IMPUGNED NOTIFICATION DATED 10.08.2017 WHEREBY JUNIORS TO THE APPELLANT WERE PROMOTED TO THE POST OF SST (G) WHILE THE APPELLANT WAS IGNORED INSPITE OF HIS ELIGIBILITY AND QUALIFICATION AGAINST WHICH THE APPELLANT PREFERRED DEPARTMENTAL REPRESENTATION ON 18.08.2017 BUT THE SAME WAS NOT DISPOSED OF WITHIN THE STATUTORY PERIOD OF 90 DAYS.

**PRAYER:**

On acceptance of the instant appeal, the impugned Notification dated 10.08.2017 may graciously be modified and appellant may graciously be promoted to the post of SST (G) w.e.f. 10.08.2017 the date juniors were promoted to the post of SST (G), with all consequential back benefits.

Facts giving rise to the present appeal are as under:-

1. That appellant joined the Education Department as PTC Teacher on 25.08.1977 and served as such till date for a period of more than 39 years and at the moment

is serving as Primary School Head Teacher (BPS-15) posted at GPS Ganjey Tehsil Takht Bhai, District Mardan.

2. **That** as per the current Seniority List, 2017 (*Annex:-A*) of PSHT maintained for promotion of SST (G) appellant is at Serial No.2 while his date of birth is 12.09.1959. Appellant passed his B.Ed. Examination from the Allama Iqbal Open University, Islamabad on 17.01.2017 and the Sub-Divisional Education Officer (Male), Takht Bhai vide letter No.7078 dated 24.06.2017 sent the B.Ed. Transcript of the appellant for verification to the University and issued a Certificate (*Annex:-B*) to that effect while requesting for considering the appellant for promotion to SST (G).
3. **That** the qualification of the appellant was duly verified by the University vide letter dated 28.07.2017 (*Annex:-C*) and meanwhile, the appellant was also issued the B.Ed. Degree on 14.07.2017 (*Annex:-D*). The entry regarding the B.Ed. qualification was also made in the Service Book vide Extracts from the Service Book (*Annex:-E*).
4. **That** in view of eligibility and qualification, the appellant was fully hopeful that he would be considered for promotion to the next higher grade, however, vide impugned Notification dated 10.08.2017 (*Annex:-F*), the appellant was ignored while juniors to him were promoted to the next higher grade in violation of the law. Subsequently, the promotees were adjusted vide adjustment orders dated 11.08.2017 (*Annex:-G*).
5. **That** being aggrieved of the impugned Notification *ibid*, the appellant called in question the same through Departmental Representation (*Annex:-H*) before Respondent No.1 on 18.08.2017 but the same was not disposed of within the statutory period of 90 days, hence this Service Appeal *inter-alia* on the following grounds:-

**Grounds:**

- A. **That** Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Notification which is unjust, unfair and hence not sustainable in the eye of law.

- B. **That** the appellant was discriminated as juniors to him were promoted to the post of SST (G) while appellant being senior and entitled for the requisite promotion under the policy was ignored which is against the principle of equality as per Article-25 of Constitution of the Islamic Republic of Pakistan, 1973 read with Rules-7(3) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
- C. **That** the appellant was fully qualified and eligible for the subject post but was malafide ignored and juniors to him were promoted without any lawful justification which has resulted in serious miscarriage of justice.
- D. **That** the verification of the qualification was timely received and even before that the case/file of the appellant for promotion to the next higher grade was forwarded to the quarter concerned by the Sub Divisional Education Officer (M), Takht Bhai for forwarding the same to the Departmental Promotion Committee to be considered for promotion but inspite of the same, appellant was not promoted and illegally deprived of his lawful rights.
- E. **That** the delay in entering the qualification of the appellant in the Service Book was the responsibility of the Department and for that lapse the appellant cannot be made to suffer.
- F. **That** appellant would like to offer some other grounds during the course of arguments.

It is, therefore, humbly prayed that the instant appeal may graciously be accepted as prayed for above.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for, may also be granted to appellant.

**Preliminary Objections:**

Preliminary objections raised by answering respondents are erroneous and frivolous, the detailed replies thereof are as under:-

1. That appellant has got cause of action as well as locus standi to file the instant appeal.
2. That the instant appeal is competent in its present form and shape hence liable to be accepted.
3. That the instant appeal has been filed well within time.
4. That the appeal is very much maintainable in its present form.
5. That the appellant has come to this Hon'ble Tribunal with clean hands.

6. That the case of appellant does not hit by the principle of estoppel and has rightly filed the present appeal.
7. That all the facts relevant for the disposal of the instant appeal concisely have been incorporated in the appeal and nothing has been concealed from the Hon'ble Tribunal.
8. That all necessary and proper parties have been arrayed as Respondents in the instant appeal, hence the question of mis-joinder and non-joinder is misconceived.
9. That the instant appeal has been filed with fair intention and hence liable to be accepted.
10. That the instant appeal has been filed in accordance with the prevailing law and rules.
11. Incorrect. The appellant having ability to perform his duties against the higher post being medically and physically fit as is evident from Medical Certificates as issued by the Assessment Board as well as In-charge Medical DHQ Hospital Mardan (*Annex:-Rj/1*) duly verified by the Assistant Sub Divisional Education Officer (Male) Primary Mardan. The Department unlawfully deprived the appellant. Furthermore the entry of B.ED Degree upon the service book of the appellant was a duty of the Respondent hence appellant was unlawfully deferred for the promotion to the post SST (G).
12. Mere explanation/show cause notice is nothing until and unless the same has not been proved. The appellant duly replied the charges vide his Reply to the Show Cause Notice (*Annex:-Rj/2*).



**Facts:**

- 1-3 Paras 1 to 3 of the appeal have been admitted by the Respondents.
4. Incorrect hence vehemently denied. As explained above appellant having ability to perform his duties against the higher post it is further clarified from the record that appellant was entitled for the promotion against the subject post but respondent department unlawfully deprived appellant. The making of entry in the Service Book is the job of the Department for the appellant cannot be held responsible.
5. Incorrect.

**Grounds:**

- A. Incorrect. The appellant has not been dealt in accordance with law and Rules on the subject.
- B-D. Incorrect. The ground-B of the appeal is against the law. In spite of eligibility, Petitioner was highly discriminated and Juniors were promoted to the post of SST (G) against the policy which is against the Article-25 of the Constitution of the Islamic Republic of Pakistan 1973, read with Rules-7(3) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989. It is further submitted the appellant fully eligible for promotion but the Petitioner has been discriminated and unlawfully not considered. Rest of the Para is misconceived.
- E. Incorrect hence denied. The entry of the qualification of the appellant in the service book was the responsibility of the

department and for that lapse the appellant cannot be made to suffer.

F. No need for rejoinder.


It is, therefore, humbly prayed that the reply of answering Respondents may graciously be rejected and the appeal as prayed for may graciously be accepted with costs.



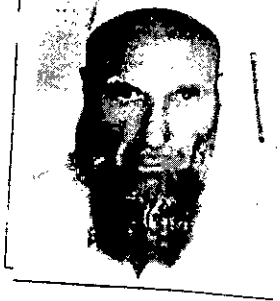
