Joint Para-wise comments on behalf of respondents

Respectfully Sheweth:

Preliminary objections

- 1) That the appellant has no cause of action/locus standi to file the instant appeal.
- 2) That the appellant has concealed the material facts from the honorable tribunal
- 3) That the appellant has not come to this honorable tribunal with clean hands.
- 4) That the appellant has filed the instant appeal on mala fide grounds.
- 5) That the appeal is against the prevailing law and rule.
- 6) That the appellant is estopped by his own conduct to file instant appeal.
- 7) That the claim of the appellant is unlawful, hence the appeal is liable to dismissed.
- 8) That the act of the respondent is within the ambit of law and rules. Order dated 27.06.2019 is issued after fulfillment of the codal formalities hence appeal is liable to be dismissed.

FACTUAL OBJECTIONS

- 1) Para No.1 of the appeal relates to appellant's service record, hence no comment.
- 2) Para No.2 is incorrect as the appellant has not submitted valid application for leave purpose and the application attached with service appeal is manipulated while the statement of the appellant regarding FIR and detention in jail period

- is not clear as no such order sheet and bail order was presented by the appellant with appeal.
- 3) Para No.3 of the appeal is incorrect hence denied as there is not any bail/release order of court and he has neither came to school nor he properly responded any show cause notice. The attached replies of show cause notices is self designed by the appellant. Further appellant has not clearly mentioned when he was released from jail and on which date he was arrested. Whereas he was absent from duties prior to the FIR, he referred in annexures.
- 4) Para No.4 is incorrect hence denied as appellant on one side claimed that he was unaware of proceedings against him whereas on the other hand he himself presented an application with remarks of then District Education Officer recorded on 27/06/2019 which is the same date on which his removal from service order was issued. Further removal from service passed on 27/06/2019 and appellant filed departmental appeal against removal from service order on dated 18/12/2019 which was time barred. (Departmental appeal attached as A)
- 5) Para No.5 is subject to proof.
- 6) Para No.6 is incorrect as he is not an aggrieved person he has no cause of action as he has already lost the opportunity of filing departmental appeal well in time.

GROUNDS

- a) Para of the ground 'a' is incorrect, hence denied as there is not found any kind of authentic record of the appellant regarding illness and detention in jail. The appellant is mispresenting the court and concealing the facts by not clearly mentioning illness period and detention period in jail with solid proofs i.e court order sheets.
- b) Para of ground 'b' is incorrect as the appellant mispresenting the court regarding non-issuing of show causes, opportunity of personal hearing. Show cause notices, opportunity of personal hearing notice are annexed with service appeal by appellant himself which shows that he was extended all kinds of opportunity. (show causes noticed+personal hearing notice are attached as B&C respectively).

reply of remaining para as below:-

- Appellant was reported absent by IMU on dated 06/09/2018,22/11/2018,14/01/2019,23/02/2019,05/03/2019,08/04/2019 and 17/05/2019 without proper permission of the competent authority.
- II. Appellant was served show cause notice on his absence from duties vide No.925 dated 07/02/2019 but no reply was received.

- III. Appellant was also reported absent by Head Master and on the report of HM, DEO male directed SDEO palas to conduct fact finding enquiry. SDEO palas found the appellant absent for 42 days consecutively and recommend major penalty after proper inquiry. (SDEO report attached as D)
- IV. On SDEO report department had initiated formal enquiry through enquiry committee in which appellant was found still absent for 93 days also which was endorsed by the Head Master concerned. (statement of HM, attendance register and enquiry committee report are attached as E,F&G respectively)
- V. Keeping in view the enquiry report department has issued final notice for personal hearing vide no.2826-33 dated 14/06/2019 but appellant failed to defend himself against the charges. The defensive statement with service appeal is self-designed and manipulated.(submitted reply attached as H)
- c) Para of ground C is incorrect, Appellant was properly proceeded according to E&D rules and further enquiries were conducted show cause notices were served and opportunity for personal hearing was provided.
- d) Para of ground D is incorrect as impugned act of respondent is according to the laid down procedure and was in the best interest of students.
- e) Para of ground E is incorrect as Remedy of departmental appeal was not timely availed himself by the appellant.
- f) Respondents seek leave to raised additional grounds at the time of arguments.

Prayers

It is therefore humbly prayed that in the light of forgoing comments the appeal may graciously be dismissed with cost throughout.
