APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974

PRAYER:

On the acceptance of this appeal, this august tribunal may very graciously be pleased to order in favour of appellant to the effect;

- i. Proforma Promotion retrospectively/grant of selection grade BPS 16 from the year 1996, along with back benefits/ payment of arrears of pay/ allowances and re-fixation of pay in light of Finance Department Letter No. (SR1)1-95/84, Vol-2 dated 15/2/1986 as despite being eligible and qualified he was never given the due benefit.
- Proforma Promotion retrospectively, to BPS 17 from June 2006, along with back benefits/ payment of arrears of pay/ allowances and re-fixation of pay as per Provincial Government Rules 2003 for Drawing Establishment (administrative department) Irrigation KPK as despite being eligible and qualified in 2006 he was lately promoted in 2010.
- iii. Release the Additional Charge Allowance to the appellant from 1st August 2003 till his regular appointment as Chief Draftsman in light of letter No. FD (PRC)1-1/2005.
- iv. Also to grant any other adequate remedy deems fit by this august tribunal, though not specifically prayed, to uphold the constitution and rule of law.

Respectfully Sheweth:

Facts and circumstances leading the institution of the instant appeal by the appellant are humbly submitted as below;

- A. That the appellant is a law abiding citizen of Pakistan, who was initially recruited & appointed as Draftsman in the year 1985 in the Irrigation Department Civil Secretariat Peshawar and was later on promoted as Head Draftsman BPS 14 in the year 2003 (copy of initial recruitment as draftsman BPS 11 and promotion to head draftsman BPS 14 Annexed A & B respectively).
- B. That the appellant was also given the additional charge duty of Chief Draftsman in the year 2003, which he performed diligently till his promotion and taking charge on regular basis as Chief Draftsman BPS 17 in the year 2010, however the additional charge allowance @ 20 % of the Basic Pay subject to maximum of Rs 6000/- per month has not been granted to the appellant as per Revised Basic Pay Scales, Allowances and Pension of Civil Employees (BPS 1-22) of the NWFP Government vide letter No. FD (PRC)1-1/2005. (copy of notification of additional charge of chief draftsman, regular promotion order as chief draftsman, Notification of revised basic pay scales/allowances and pension of civil employees 2005 Annexed C, D, E respectively)
- C. That the appellant had requisite qualifications in the year 1996 for grant of selection grade BPS 16, as per Finance Department Letter No. (SR1)1-95/84, Vol-2 dated 15/2/1986 under the Scheme of Basic Pay Scale and Fringe Benefits, as 25 % posts in the cadre of draftsmen combined together (draftsmen, divisional head draftsman, circle head draftsman, chief draftsman) were going to be filled on the basis of seniority cum fitness and subject to ten years service and passing of the prescribed departmental examination however such benefits were never extended to the appellant nor his case considered to be put up before the relevant promotion committee. (copy of scheme of basic pay scale and fringe benefit 1986, departmental representation for grant of selection grade are Annexed F, G).
- D. That as per Provincial Government Rules 2003 for Drawing Establishment (administrative department) Irrigation KPK vide letter No. E & A, (Irr:)/1-118/85, the method of recruitment to the post of Chief Draftsman was by promotion, on the basis of seniority cum fitness, from the amongst the holder of the post of head draftsman with three year service as such and by that the appellant qualified to the post of chief draftsman BPS 17 in year 2006 however his case was not considered in due time. (copy of recruitment rule 2003 for Drawing establishment Irrigation Establishment Irrigation, departmental representation for promotion as chief draftsman Annexed H, I)

E. That the appellant time and again filed representation in the department however no heed is paid to the requests of the appellant for lawful compliance till his retirement on 11/01/2023. Earlier the appellant had filed a writ before the august High Court Peshawar, however with permission of the high court to approach proper forum as being service matter, the same was withdrawn and the appellant was directed to approach proper forum, hence this appeal on the following grounds:(copy of writ petition 4911-P/2022 annexed J)

Grounds:

- That there exists no other expedient-cum-expeditious and adequate remedy available to the appellant, hence the instant appeal under the jurisdiction of this august tribunal.
- 2. That where similar placed persons are to be dealt with in terms of treatment to be meted
- out to them, must always be on equal footing, must always be just, fair & transparent without any sort of discrimination and where so many other employees in past & even in present have been extended seniority & back benefit as a result of proforma promotion, then in no case the appellant can be deprived of the same in stricto sense of Art- 25 of the Constitution.
- 3. That from all prospective & from all four facets of law, the appellant has every right to be dealt with accordance to the law & constitution and to be certainly meted out fair and just treatment.
- 4. That the respondents have resorted to policy of pick and chose and thus quiet competent candidates were left to be considered without any fault on their, followed a mechanism of pick and choose of blue-eyed ones.
- 5. That worthy tribunal always preferred and encouraged the Rules and Law and have always discouraged, deplored and deprecated any variation from the Rules/law or its violation etc.
- 6. That the appellant was entitled to be promoted from the desired dates, but for no fault of appellant, he was wrongfully prevented from rendering service in the higher post, hence the appellant is very much entitled for proforma promotion retrospectively and back benefits/ payment of arrears of pay/ allowances/ re-fixation of pay.
- 7. That as per rules the only criteria as postulated therein is the seniority-cum-fitness and besides the appellant had all the requisite qualifications and met the post criterion and he had a good service record.

- 8. That despite being the most senior in the department, his case was never forwarded for consideration before the relevant committee for appraisal.
- 9. That the appellant has a clean record and reputation in service and till date of retirement no complaint/enquiry was pending or disciplinary action taken against the appellant.
- 10. That the appellant, time and again, approached the respondents & have knocked the doors of all responsible officials of the respondent authority, but because of redtapisim & extreme pragmatism all endeavors & strives of the appellant went futile & all of them ended in fiasco.

It is therefore most humbly prayed that on the acceptance of this appeal, this august tribunal may very graciously be pleased to order in favour of appellant to the effect;

- Proforma Promotion retrospectively/grant of selection grade BPS 16 from the year \$1996, í. along with back benefits/ payment of arrears of pay/ allowances and re-fixation of pay in light of Finance Department Letter No. (SR1)1-95/84, Vol-2 dated 15/2/1986 as despite being eligible and qualified he was never given the benefit.
- Proforma Promotion retrospectively, to BPS 17 from June 2006, along with back ii. benefits/ payment of arrears of pay/ allowances and re-fixation of pay as per Provincial Government Rules 2003 for Drawing Establishment (administrative department) Irrigation KPK as despite being eligible and qualified in 2006 he was lately promoted in 2010.
- Release the Additional Charge Allowance to the appellant from 1st August 2003 till his iii. regular appointment as Chief Draftsman in light of letter No. FD (PRC)1-1/2005.
- Also to grant any other adequate remedy deems fit by this august tribunal, though not iv. specifically prayed, to uphold the constitution and rule of law.







I am directed to state that the Governor PTWFP has been pleased to sanction the revision of Basic Pay Scales, Allowances and Pension w.e.f 1st July 2005, for the civil employees of the Provincial Government as detailed in the following paragraphs:-

PART-I (BASIC PAY SCALES)

REVISED BASIC PAY SCALES

The revised Basic Pay Scales, 2005 shall replace the exiting Basic

Pay Scales, 2001 as shown in Annexure to this letter.

PLNATION OF PAY OF THE EXISTING EMPLOYEES:

- The basic pay of an employee in service on 30-6-2005 shall be fixed in the Revised Basic Pay Scale on point to point basis i.e at the stage corresponding to that occupied by him above the minimum of 2001 Basic Pay Scales.

scale and the amount beyond the maximum of the prescribed stage in the revised Basic Pay Scales shall be allowed as personal pay.

Annual increment shall continue to be admissible subject to the existing conditions, on le of December ouch years.

- SPECIAL ADDITIONAL ALLOWANCE: Special Additional Allowance shall continue to be admissible at frozen level on exiting conditions.

- Proforma Promotion retrospectively/grant of selection grade BPS 16 from the year 1996, along with back benefits/ payment of arrears of pay/ allowances and re-fixation of pay in light of Finance Department Letter No. (SR1)1-95/84, Vol-2 dated 15/2/1986 as despite being eligible and qualified he was never given the benefit.
- Proforma Promotion retrospectively, to BPS 17 from June 2006, along with back benefits/ payment of arrears of pay/ allowances and re-fixation of pay as per Provincial Government Rules 2003 for Drawing Establishment (administrative department) Irrigation KPK as despite being eligible and qualified in 2006 he was lately promoted in 2010.
- Upgradation of pay scale of the petitioner from BPS 17 to BPS 18 as per Provincial Government up guadation policy made vester of persons Department KPK, NO. SO (FR)/FD/7-2/2008.



- iv. Release the Additional Charge Allowance to the petitioner from 1st August 2003 till his regular appointment as Chief Draftsman in light of letter No. FD (PRC)1-1/2005.
 - v. Also to grant any other adequate remedy deems fit by this august Court, though not specifically prayed, to uphold the constitution and rule of law.

Respectfully Sheweth:

Facts and circumstances leading the institution of the instant constitutional petition by the petitioner are humbly submitted as below;

- A. That the petitioner is a law abiding citizen of Pakistan, who was initially recruited & appointed as Draftsman in the year 1985 in the Irrigation Department Civil Secretarial Peshawar and was later on promoted as Head Draftsman BPS 14 in the year 2003 (copy of initial recruitment as draftsman BPS 11 and promotion to head draftsman BPS 14 Annexed B & C respectively).
- B. That the petitioner was also given the additional charge duty of Chief Draftsman in the year 2003, which he performed diligently till his promotion and taking charge on regular basis as Chief Draftsman BPS 17 in the year 2010, however the additional charge allowance @ 20 % of the Basic Pay subject to maximum of Rs 6000/- per month has not been granted to the petitioner as per Revised Basic Pay Scales, Allowances and Pension of Civil Employees (BPS 1-22) of the NWFP Government vide letter No. FD (PRC)1-1/2005.  - Release the Additional Charge Allowance to the petitioner from 1st August 2003 till his regular appointment as Chief Draftsman in light of letter No. FD (PRC)1-1/2005.
 - Also to grant any other adequate remedy deems fit by this august Court, though not specifically prayed, to uphold the constitution and rule of law.
