PRAYER:

ON ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY BE DIRECTED TO COUNT THE SERVICE OF APPELLANT FOR RETIREMENT FROM 1-4-1961 WHICH 45 HIS CORRECT DATE OF BIRTH AS GIVEN IN HIS SCHOOL LEAVING CERTIFICATE AS WELL AS IN HIS IDENTITY CARD. (COPIES ARE ATTACHED AT ANNEXURE "D" & "E" RESPECTIVELY).

Brief Facts loading to instant appeal are as under:-

- 1. That the appellant having initially been inducted in service as class-IV employee on 27.12.1987 and he took over the charge in Govt primary School Bachai Tehsil Swabi, District Mardan. (Copy is attached at annexure "A").
- 2. That appellant throughout his whole service has performed his duties very efficiently and satisfactorily and to the entire satisfaction of his superiors.
- 3. That the respondent No.3 has entered the wrong date of birth dated 25.12.1955 in appellants service book and the appellants premature retirement is thus illegal and void.

4. That the appellant has submitted his departmental appeal dated 31.12.2022 to respondent No.2 vide annexure "C" and 90 days have been elapsed and no reply has been received so for and hence this appeal inter alia on the following grounds.

GROUNDS:

yr.

- A. That the best proof of appellants date of birth is 01.04.1961 which is mentioned in his school leaving certificate as well as in his National Identity card vide annexure "D&E". Therefore, the appellant shall be paid correct pension which is his legal right and he can not be deprived from it under the law.
- **B.** That the appellant has been punished for wrongful act of respondent No.3 which is not permission able under the law.
- C. That the respondents denial for not paying correct amount of pension to the appellant is illegal, wrong, incorrect and without jurisdiction requesting for interference under the law.
- **D**. That the appellant seeks leave of this Hon'ble Tribunal to rely on additional grounds at the time of arguments.

It is therefore, prayed that on acceptance of appeal, the appellants correct date of birth which is 01.04.1961 may be considered for his retirement and therefore he may be granted correct amount of pension basing on his correct date of birth which is 01.04.1961.




