APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST PROMOTION NOTIFICATION DATED 05.09.2022 WHEREBY APPELLANT HAS BEEN DEFERRED / NOT CONSIDERED FOR PROMOTION ON ILLEGAL AND UNLAWFUL GROUNDS AND JUNIORS TO THE APPELLANT HAVE BEEN PROMOTED.

Respectfully Sheweth,

Short facts giving rise to the present Service Appeal, are as under:-

1. That, Appellant was initially appointed by the Police Department of Province of Baluchistan, copy of Appointment Order of Appellant is attached as Annexure A.
2. That, the Appellant was Intra-Provincially Transferred from his Province, where he was initially appointed, to the Province of Khyber Pakhtunkhwa through proper channel, followed by absorption in Khyber Pakhtunkhwa Police Department, copies of the Intra-Provincial Transfer Order along with other Relevant Documents are attached as Annexure B.
3. That, in consequence of above stated Intra Provincial Transfer, the Appellant was absorbed in Police Service of Khyber Pakhtunkhwa, the Service Book etc was prepared and maintained and was placed at bottom of the Seniority List at the relevant time.
4. That, Appellant entry into service of the Province of Khyber Pakhtunkhwa was also recorded by the Respondents / Police Department, copies of the Relevant Documents / Orders regarding the entries into Police Department Khyber Pakhtunkhwa are attached as Annexure C.
5. That, thereafter, the Appellant was promoted from the rank of Assistant Sub-Inspector to the rank of Sub-Inspector followed by confirmation, keeping in view the Relevant seniority position of Appellant, copy of the Promotion Order of Appellant to the Rank of Sub-Inspector and Confirmation Order, are attached as Annexure D.

6. That, the Appellant was again promoted from the rank of Sub-Inspector to the rank of Inspector by the Respondent / Police Department followed by his Confirmation as Inspector, copies of the Promotion Order from Sub-Inspector to Inspector and Confirmation Order are attached as Annexure E.
7. That, finally all the Appellant was promoted from the rank of Inspector to the rank of Deputy Superintendent of Police [DSP] and was confirmed as well by the Respondents / Police Department, copies of the Promotion Order and Conformation Order to the rank of DSP is attached as Annexure F.
8. That, as per law, the name of the Appellant was also born on the Seniority List of each cadre when he was performing duties. It merits mentioning here that in all the issued Tentative, Revised and Final Seniority Lists, the name of the Appellant was entered at his respective position, copies of one such Tentative Seniority List, Revised Seniority List and Final Seniority List are attached as Annexure G.
9. That, as per Rules, since the Appellant acquired the required length of service and other criteria for the purpose of promotion to the rank of Superintendent of Police BS-18, hence his Working Paper was prepared and sent for the purpose of consideration for Promotion to the Provincial Promotion Board, copy of the Rules and Working Paper of the Appellant for the purpose of Promotion are attached as Annexure H.
10. That, Appellant was astonished to know that the Promotion Board had acted in utter violation of law as the Appellant was not considered by the Board on the analogy that since the Appellant was not initially appointed by the Provincial Police Department of Khyber Pakhtunkhwa rather he was Intra Provincially Transferred from other Province, therefore, he was not considered, copy of the relevant minutes of the Meeting of the Promotion Committee and Impugned Promotion Order are attached as Annexure I.
11. That, as per law applicable, the Appellant submitted his Departmental Appeal / Representation before the Competent Authority, copies of the Departmental Appeal / Representation is attached as Annexure K.
12. That, the Department / Respondents failed to communicate the fate of the Departmental Appeal / Representation within

requisite statutory period of 90 days, hence this Service Appeal on the following amongst other grounds:-


GROUND:

- A. That, the non-consideration and non-promotion of the Appellant, is illegal, unlawful, void and ineffective.
- B. That, the same is against the principles of Natural Justice, also.
- C. That, Appellant was legally and legitimately inducted into service, intra-provincially transferred from other Province to Province of Khyber Pakhtunkhwa, absorbed, validly promoted on various occasions from lower rank to higher rank and inserted in the Seniority List hence the verbal plea of the Respondents are not in accordance with law.
- D. That, if the Appellant was appointed in other province and then was intra-provincially transferred to the Province of Khyber Pakhtunkhwa, than why he was retained, promoted and inserted in the Seniority List of the Deputy Superintendent of Police.
- E. That, if the name of the Appellant is reflected in the Seniority List of Deputy Superintendent of Police, than he is eligible to be considered for promotion to the rank of Superintendent of Police.
- F. That, after intra-Provincial Transfer from other Province to the Province of Khyber Pakhtunkhwa, the Appellant was validly absorbed by the Respondents / Police Department.
- G. That, even after every promotion i.e. from ASI to SI, SI to Inspector and Inspector to DSP, the Appellant was sent for Training etc for the purpose of promotion and was also confirmed in his respective Promotion Cadres per law i.e. Police Rules.
- H. That, the Respondents Department had acted in violation of law as the Appellant deserve to be considered for promotion and be treated in accordance with law.

- I. That, there is no adverse entry in the PER(s) of the Appellant nor any disciplinary or departmental Inquiry is pending against them.
- J. That, it was incumbent upon the Respondents Department, to have considered the Appellant and then recommended for promotion or else deferred or superseded.
- K. That, the term "not considered" is not allowed in the Service Laws / ESTACODE of the Province for a person who is otherwise eligible for promotion, properly reflected in the Seniority List and whose Working Papers are also available with the Board.
- L. That, it is noteworthy to mention here that the soon after the confirmation of the Appellant in the Province of Khyber Pakhtunkhwa, the lien of the Appellant was terminated.
- M. That, the Appellant had been discriminated and the act of the Respondents is against Article 4, 18, 25 & 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- N. That, the fundamental, legal and constitutional rights of the Appellant is being violated by the Respondents.
- O. That, the Respondents Department, being public office, cannot be allowed to exercise its powers, in sheer violation of law nor are they allowed to promote nepotism and favoritism.
- P. That, the Departments are also not allowed to damage the honor and prestige of seniority, moreover the actions of the Department are without any just and legal ground.
- Q. That, it seems that in order to favor selected and blue eyed incumbents, the whole process has been dramatized, moreover the Respondents have proceeded in violation of transparency and merit, as well.
- R. That, the Respondents have violated Articles 4, 9, 10-A, 25, 27 and 37 of the Constitution of the Islamic Republic of Pakistan, 1973. The indulgence of this august court was, therefore, all the more necessary and indispensable in order to save the ends of justice and to prevent the abuse of the process of the court.


S. The Appellant seeks permission to raise any other additional legal grounds at the time of hearing of this Service Appeal.

It is, therefore, requested that on acceptance of this Service Appeal, the Respondents Department / Board may please be directed to consider the name of the Appellant for the purpose of promotion, at par with and ahead of his colleagues / batch mates / juniors and the term "not considered" due to any reason, may please be declared as illegal and unlawful moreover Seniority of the Appellant may also be restored, with such other relief as may deem fit in the circumstances of the case may also be granted.

3. The meeting started with recitation from the Holy Quran. 5. 





Prayer:

On acceptance of this Departmental Appeal / Representation,
the Notification No.SO-(E-1) E&A-2022, dated 05.09.2022
may please be set aside and the Department/ Board may
please be directed to consider the name of the Appellant for
the purpose of promotion, at par with and ahead of his
colleagues / batch mates / juniors and the term "not
considered" due to any reason, may please be set aside, with
such other relief as may deem fit in the circumstances of the
case may also be granted.

Respectfully Sheweth,

Short facts giving rise to present Departmental Appeal / Representation, are as under:

1. That, Appellant was initially appointed by the Police Department of Khyber Pakhtunkhwa as Assistant Sub-Inspector on 22.04.1987. Consequent upon his Appointment as ASI, then Appellant was confirmed.
2. That, thereafter, the Appellant was promoted from the rank of Assistant Sub-Inspector to the rank of Sub-Inspector and from the rank of Sub-Inspector to the rank of Inspector by the Department followed by Confirmation.
3. That, finally the Appellant was promoted from the rank of Inspector to the rank of Deputy Superintendent of Police (DSP) and was confirmed as well by the Department.
4. That, as per law, the name of the Appellant is also reflected in the Final Seniority List at Serial No. 01.
5. That, as per Rules, since the Appellant acquired the required length of service and other criteria for the purpose of promotion to the rank of Superintendent of Police BS-18, hence his Working Papers were prepared and sent for the purpose of consideration for Promotion to the Provincial Promotion Board.
6. That, Appellant was astonished to see that the Promotion Board had acted in utter violation of law as the Appellant was not considered by the Board because he was absorbed from Baluchistan Police and falls under the Supreme Court Judgment regarding absorption.
7. That, the factum of non-consideration of the Appellant has been reflected in the minutes of the meeting of Provincial Selection Board held on 19.08.2022.
8. That, the non-consideration of the Appellant in the meeting of PSB due to absorption is illegal; unlawful, void and Ineffective.
9. That, the same is against the principles of Natural Justice, also.
10. That, Appellant is a fit person to be promoted to the rank of Superintendent of Police ahead of his juniors who were granted the same benefit.
11. That, if the name of the Appellant is reflected in the Seniority List of Deputy Superintendent of Police, than he is eligible to be considered for promotion to the rank of Superintendent of Police.
12. That, even after every promotion i.e. from ASI to SI, SI to Inspector and Inspector to DSP, the Appellant was sent for required training for the purpose of promotion and was also confirmed in his respective Promotion Cadre us per law i.e. Police Rules.
13. That, the Respondents Department had acted in violation of law as the Appellant deserves to be considered for promotion and be treated in accordance with law.
14. That, there is no adverse entry in the PER(S) of the Appellant nor any disciplinary or departmental Inquiry is pending against him.
15. That, it was incumbent upon the Respondents Department, to have considered the Appellant and then recommended for promotion.

16. That, the expression "not considered" is an alien terminology in terms of Service Laws / ESTACODE of the Province for a person who is otherwise eligible for promotion, properly reflected in the Seniority List and whose Working Papers are also available with the Board.
17. That, the Appellant has been discriminated moreover the act of the Respondents is against Article 4, 18, 25 & 27 of the Constitution of Islamic Republic of Pakistan, 1973.
18. That, the fundamental, legal and constitutional rights of the Appellant have been violated by the Respondents.
19. That, the Respondents Department, being public office, is not allowed to exercise its powers, in sheer violation of law nor are they allowed to promote nepotism and favoritism.
20. That, the Departments are also not allowed to damage the honor and prestige of seniority, moreover the actions of the Department are without any just and legal ground.
21. That, it seems that in order to favor selected and blue eyed incumbents, the whole process has been dramatized, moreover the Respondents have proceeded in violation of transparency and merit, as well.
22. That, the Respondents have violated Articles 4, 9, 10-A, 25, 27 and 37 of the Constitution of the Islamic Republic of Pakistan, 1973. The Indulgence of this august court was, therefore, all the more necessary and Indispensable in order to save the ends of Justice and to prevent the abuse of the process of the court.
23. The Appellant seeks permission to raise any other additional legal grounds at the time of hearing of this writ petition.

It is, therefore, requested that Departmental Appeal / Representation may please be accepted as prayed for.
