



**APPEAL UNDER SECTION 4 OF KHYBER

AGAINST ILLEGAL AND MALAFIDE REMOVAL  
FROM SERVICE ORDER DATED 10-10-2022 ON  
THE BACK OF APPELLANT.**

That the brief facts of the case are as under:

1. That the appellant was appointed as chowkidar at GPS Kirri Shamoza No-2 vide  
Office order dated; 16-03-2017. Copy of Appointment Order is Annexure A.
2. That the services rendered by the appellant remained up-to the mark and no  
deficiency, inefficiency, negligence or irregularity of the appellant was

reported. The appellant was removed from service vide Order dated: 10.10.2022 on the basis of absent from duty while appellant never ever absented himself from duty which is evident from attendance register of the school. Copies of attendance Register and removal order are Annexure B & C.

3. That feeling aggrieved, the appellant filed departmental appeal against the removal order to respondent No.1 on 02-11-2022 but till now appeal is not decided. Copy of departmental appeal along with postal receipt is Annexure C.
4. That feeling aggrieved from above said action appellant is constrained to approaches this honorable court on the following amongst other:

**GROUND:**

1. That the appellant is not treated in accordance with law and the actions of the respondents are malafide besides being discriminatory and harsh.
2. That appellant is being penalized without giving him any opportunity of hearing, he was neither associated with any proceeding nor have given any show cause notice by the department, which is against the principal of natural justice.
3. It is also an admitted fact that appellant was condemned unheard. The appellant is residing nearby the school premises so there is no possibility of non-attendance of school which is also evident from attendance register.

In view of the above, It is, therefore, most respectfully prayed that on acceptance this appeal this honorable court may

please to declare the office order No. 24209-13/PF dated; 10-10-2022 is illegal, void, without lawful authority and of no legal effect and respondents may pleased be directed to reinstate the appellant with all back benefits.


