APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER DATED 26.11.2018 PASSED BY THE DEPUTY INSPECTOR GENERAL OF POLICE (RESPONDENT NO. 2) WHEREBY THE APPELLANT WAS AWARDED MAJOR PENALTY OF REDUCTION FROM THE POST OF HEAD CONSTABLE TO A LOWER POST OF CONSTABLE AGAINST WHICH A DEPARTMENTAL APPEAL WAS FILED BUT THE SAME WAS REJECTED ON 03.05.2019.

JUDGMENT

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Counsel for the appellant and Mr. Riaz Ahmad Paindakheil, Assistant Advocate General alongwith Mr. Ibrahim Shah, Office Superintendent for the respondents present. Learned counsel for the appellant submitted rejoinder which is placed on record. Arguments heard and record perused.



- 2. Brief facts of the case as per present service appeal are that the appellant was serving in Police Department as Head Constable (Auto Electrician). He was imposed major penalty of reduction in rank from Head Constable to the rank of Constable on the allegation that front bonnet of Government Vehicle Corolla Motor Car No. A-1004 (off-Road) was misplaced by the appellant. The appellant filed departmental appeal on 19.12.2018 which was rejected on 03.05.2019 hence, the present service appeal on 20.05.2019.
- 3. Respondents were summoned who contested the appeal by filing written reply/comments.
- Learned counsel for the appellant contended that the appellant was imposed major penalty of reduction in rank from Head Constable to lower rank of Constable on the aforesaid allegation but neither charge sheet, statement of allegation was framed or served upon the appellant nor proper inquiry was conducted nor the appellant was associated in any inquiry proceeding nor the appellant was issued any show-cause notice alongwith copy of inquiry therefore, the appellant was condemned unheard. It was further contended that the respondent-department was also required to fix a period of reduction to rank as required under FR-29 but the respondent-department has not mentioned any period in the impugned order. It was also contended that the competent authority was DPO but the major penalty of reduction from Head Constable to Constable was awarded by the DIG Telecommunication & Transport Khyber Pakhtunkhwa Peshawar vide order dated 26.11.2018 therefore, the impugned order is also void being passed by the incompetent authority therefore, prayed for acceptance of appeal. In support of his arguments he also relied on PLD 1980 Supreme Court 310, PLD 1982 Peshawar 165, 1989 SCMR 1690, 2002 SCMR 1034, 2000 SCMR 1743, 2006 PLC (C.S) 604, 2006 SCMR 1641, PLD

2008 Supreme Court 663, PLD 2008 Supreme Court 412 and 2014 SCMR 1189.

- 5. On the other hand, learned Assistant Advocate General for the respondents opposed the contention of learned counsel for the appellant and contended that it was proved from the available record that the appellant had misplaced the front bonnet of Government Vehicle Corolla Motor Car No. A-1004 (off-Road). It was also contended that proper inquiry was conducted and the appellant was proved guilty by the inquiry officer therefore, it was vehemently contended that the appellant was rightly imposed major penalty of reduction from rank of Head Constable to the rank of Constable after fulfilling all the codal formalities and prayed for dismissal of appeal.
- Perusal of the record reveals that the appellant was serving in Police 6. Department as Head Constable (Auto Electrician). He was imposed major penalty of reduction from the rank of Head Constable to the rank of Constable vide order dated 26.11.2018 on the aforesaid allegation but neither charge sheet, statement of allegation was framed or served upon the appellant nor proper inquiry was conducted nor the appellant was associated during the inquiry proceeding appellant was provided nor the opportunity examination/personal hearing therefore, the appellant was condemned unheard which has rendered the whole proceeding illegal and liable to be set-aside. Moreover, the impugned order was also passed in violation of FR-29 therefore, we partially accept the appeal, set-aside the impugned order and direct the respondent-department to conduct regular inquiry including faming of charge sheet, statement of allegation, opportunity of cross examination, personal hearing etc and issuing of show-cause notice alongwith copy of inquiry report within a period of 90 days from the date of receiving of copy of this judgment.

Counsel for the appellant present.

Learned counsel, at the outset referred to the impugned order dated 26.11.2018 issued by the Deputy Inspector General of Police, Telecommunication & Transport, Khyber Pakhtunkhwa Peshawar and contended that the officer signing the order was not the competent authority in cases of departmental proceedings against Head Constable. As a matter of fact, under the Khyber Pakhtunkhwa Police Rules, 1975 DPO/SSP/S.P are the competent officers for the purpose. The impugned order was, therefore, coram-non-judice, it was added. Learned counsel further contended that the proceedings taken against the appellant departmentally were not in accordance with the rules as no charge sheet and statement of allegations was communicated to the appellant nor any witness was examined. He relied on PLD-1980-S.C-310.

In view of the available record and arguments of learned counsel, instant appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 24.07.2019 before S.B.

APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA **SERVICE** TRIBUNAL ACT, 1974 AGAINST THE ORDER DATED 26-11-2018 PASSED BY DEPUTY INSPECTOR GENERAL OF POLICE (RESPONDENT NO. WAS WHEREBY THE <u>APPELLANT</u> AWARDED _ **MAJOR** PENALTY REDUCTION FROM THE POST OF HEAD CONSTABLE TO A LOWER POST OF WHICH CONSTABLE AGAINST DEPARTMENTAL APPEAL WAS FILED BUT THE SAME WAS REJECTED ON <u>03-05-2019</u>.

Prayer in Appeal

By accepting this appeal, the impugned orders dated 26-11-2018 and 03-05-2019 may very graciously be set aside and the appellant may kindly be restored against his original rank of Head Constable alongwith consequential benefits.

Any other relief deemed appropriate in the circumstances of the case, not specifically asked for, may also be granted to the appellant.

RESPECTFULLY SHEWETH,

Short facts giving rise to the present appeal are as under:-

- 1. That the appellant joined the Police department in-capacity as Constable (Auto Electrician) on 02-05-1998. He rose up to the post of Head Constable on account of his dedication, devotion and commitment to his job. He had 21 years unblemished service record to his credit.
- That the appellant was performing his duty with great zeal, zest and devotion. But strangely, he was awarded major penalty of reduction from the post of Head Constable to a lower post of Constable in utter violation of law vide order dated 26-11-2018 passed by the Deputy Inspector General of Police (respondent No.2). It was added in the said order that Enquiry Committee was constituted to conduct enquiry into the following allegations:

"It has been reported by Incharge MT Store Peshawar that on 26-10-2018 at 1000 hours that Incharge MT Store and Line Officer Tele Peshawar has checked the old/new vehicles (on charge of MT Store) in Police Line Ground Peshawar, during checking the front bonnet of Govt: vehicle Corolla Motor Car No. 8-1004 (off-Road) has been replaced, the said report was also registered in Daily Diary (Roznamcha) vide No. 20 dated 23-10-2018".

It was further added that the Enquiry Committee held the appellant guilty of the allegations and the above penalty was awarded to him.

(Copy of impugned order is appended as Annex-A)

neither any witness was examined in the presence of appellant nor he was provided any opportunity of cross-examination. Similarly, he was also not provided any opportunity to produce his defence. Akin, the appellant was neither served with a show cause notice alongwith copy of enquiry report nor he was provided any opportunity of personal hearing. Moreover, prior to the enquiry, no charge sheet alongwith statement of allegations was served on the appellant to explain his position. It is worthwhile to mention here that the respondent No.2 vide letter No. 2901 dated 04-03-2019 has candidly admitted that the appellant was neither served with a charge sheet alongwith statement of allegations nor he was issued any show cause notice. This admission on the part of above respondent alone is sufficient to nullify the impugned orders as illegal, unlawful and without lawful authority.

(Copy of letter is appended as Annex-B)

4. That the appellant felt aggrieved by the said order, filed a departmental appeal with the Deputy Inspector General of Police (respondent No.2) on 19-12-2018 which was received by the office on the same date vide diary No. 5168.

(Copy of departmental appeal is appended as Annex-C)

5. That on 06-01-2019, the respondent No.2 directed the appellant to prefer such departmental appeal with the respondent No.1 through proper channel despite the fact that he was required to have forwarded

it to proper authority if the same was submitted to a wrong authority as per law laid down by august Supreme Court of Pakistan in various judgments. However, the appellant duly complied with the above direction and submitted a departmental appeal on 08-01-2019 which was then forwarded to the Provincial Police Officer Khyber Pakhtunkhwa, Peshawar (respondent No.1) vide letter No. 439 dated 08-01-2019. But the same was rejected on 03-05-2019.

(Copy of departmental appeal, letter and rejection order are appended as Annex-D, E & F)

That the appellant now files this appeal before this Hon'ble Tribunal inter-alia on the following grounds within the statutory period of law.

GROUNDS OF APPEAL

- A. That respondents have not treated appellant in accordance with law, rules and policy on the subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973. Therefore, the impugned orders are not sustainable in the eye of law.
- B. That the appellant was awarded major penalty of reduction from the post of Head Constable to a lower post of Constable but he was not served with a charge sheet alongwith statement of allegations in order to explain his position regarding the so-called allegations if any levelled against him as required under Rule 6 (1)(a) of the Khyber Pakhtunkhwa Police Rules, 1975 (Amended in 2014). But the Competent Authority failed to do so and blatantly violated the above provisions of law. Therefore, the impugned orders are against the spirit of administration of Justice.
- C. That departmental enquiry was not conducted in a manner prescribed by law as neither any witness was examined in the presence of appellant nor he was provided any opportunity of cross examination.

in order to impeach the credibility of the witnesses if any appeared against him. Similarly, he was also not provided any chance to produce his defence in support of his version. The above defect in enquiry proceeding is sufficient to declare entire process as sham and distrustful. Right of fair trial is a fundamental right by dint of which a person is entitled to a fair trial and due process of law. The appellant has been deprived of his indispensable fundamental right of fair trial as enshrined in Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973. Thus, the impugned orders are bad in law.

- D. That the Deputy Inspector General of Police (respondent No.2) was under statutory obligation to have considered the case of appellant in its true perspective and also in accordance with law and to see whether the enquiry was conducted in consonance with law and that the allegations thereof were proved against the appellant without any shadow of doubt or otherwise. But he has overlooked this important aspect of the case without any cogent and valid reasons and awarded him major penalty of reduction from the post of Head Constable to a lower post of Constable despite the fact that there was no iota of evidence to connect the appellant with the commission of misconduct. Thus, the impugned orders are not warranted under the law.
- That it was incumbent upon the respondent No.2 to have served the appellant with a show cause notice before passing the impugned order but he failed to do so and blatantly violated the law laid down by august Supreme Court of Pakistan reported in 1989-SCMR-1690 (citation-a). It would be advantageous to reproduce herein the relevant citation for facility of reference:

1989 S C M R 1690 (citation-a)

---S.6--Constitution of Pakistan (1973), Art. 203-F--Repugnancy to Injunctions of Islam--Disclosure by a show-cause notice of grounds on which action under of the Act was proposed to be taken and of an

opportunity of hearing to the person concerned against whom an action was required to be taken, held, was necessary and its absence from a statute was repugnant to the Injunctions of Islam.

Hence, the impugned orders are not tenable under the law.

That the respondent No.2 was also legally bound to have provided an opportunity of personal hearing to the appellant before awarding him major penalty being the requirement of law. But he failed to do so and blatantly violated law laid down by august Supreme Court of Pakistan reported in 2002-SCMR-1034 (citation-o), 2006-SCMR-1641 (citation-c) and PLD-2008-SC-412 (citation-a). The relevant citations are as under:

2002-SCMR-1034 (citation-o)

----Audi alteram partem----Application Principle enshrined in maxim "Audi alteram partem" has to be applied in all judicial and non-judicial proceedings notwithstanding the fact that right of hearing has not been expressly provided by the statute governing the proceedings.

2006-SCMR-1641 (citation-c)

----Rr. 4(b), 5 & 6---Inquiry proceedings----Major penalty, imposition of---Personal hearing to civil servant, opportunity of----Scope----Such opportunity must be afforded by the authority competent to impose major penalty or his delegatee.

PLD-2008-SC-412 (citation-a)

----Natural justice, principles of--Opportunity of hearing---Scope--Order adverse to interest of a person
cannot be passed without providing
him an opportunity of hearing--Departure from such rule may
render such order illegal.

Thus, the impugned orders are against the legal norms of justice.

G. That the disciplinary proceedings were initiated against the appellant and taken to its logical conclusion by the Deputy Inspector General of Police (respondent No.2) who was not competent under the law i.e., under Rule 2(ii) read with Schedule-I of Khyber Pakhtunkhwa Police Rules, 1975 to do so. Therefore, the entire proceedings from the top to bottom are "coram non-judice". It is well settled law that when the basic order is illegal and without lawful authority the entire superstructure built on it would fall on the ground automatically. Reliance can be placed on the judgment of august Supreme Court of Pakistan reported in PLD-2008-Supreme Court-663 (citation-b). Relevant citation is as under:

PLD-2008-Supreme Court-663 (citation-b)

When the basic order is without lawful authority and void ab initio, then the entire superstructure raised thereon falls on the ground automatically.

Thus, the impugned orders are liable to be set aside on this score alone.

H. That the Appellant Authority (respondent No.1) was under statutory obligation to have applied his independent mind to the merit of the case by taking notice about the illegality and lapses committed by the Enquiry Committee as well as the respondent No.2 as

enumerated in earlier paras. But he failed to do so and rejected the departmental appeal without any cogent reasons. Therefore, the impugned orders are not tenable under the law.

- I. That the appellant was awarded major penalty of reduction from the post of Head Constable to a lower post of Constable for indefinite period in utter violation of FR-29 as well as law laid down by august Supreme Court of Pakistan in various judgments. Thus, the impugned orders are against the legal norms of justice.
- J. That it is evident from the rejection order dated 03-05-2019 that 03 other Police officials were also found guilty of the said allegations. But they were awarded minor punishment while the appellant was imposed harsh and extreme penalty of reduction from the post of Head Constable to a lower post of Constable. This is a disparity and anomaly and is also violation of Article 25 of the Constitution of Islamic Republic of Pakistan, 1973 which has unequivocally laid down that all citizens placed in similar circumstances are entitled to equal treatment and protection of law. The Hon'ble Supreme Court of Pakistan through various judgments has maintained that equal treatment is the fundamental right of every citizen. Reliance can be placed on 2002-SCMR-71 & 2007-SCMR-410(d). The relevant citation is as under:-

2002-SCMR-71 (citation-c)

----Art. 25---Equality of citizens---Two groups of persons similarly placed could not be treated differently---Dictates of law, justice and equity required exercise of power by all concerned to advance the cause of justice and not to thwart it.

2007-SCMR-410(d) (citation-d)

---Art. 25---Equal protection of law--Principles---Concept of equal protection of law envisages that a person or class of persons should not be denied the rights, which are enjoyed by other persons in the same situation.

Hence, the impugned orders are not tenable under the law.

- K. That the impugned orders are against law, facts of the case and norms of natural justice. Therefore, the same are not warranted under the law.
- L. That the respondent No. 1 & 2 have passed the impugned orders in mechanical manner and the same are perfunctory as well as non-speaking and also against the basic principle of administration of justice. Thus, the impugned orders are bad in law.
- M. That the impugned orders are based on conjectures and surmises.

 Hence, the same are against the legal norms of justice.
- N. That the appellant would like to seek the permission of this Hon'ble Tribunal to advance some more grounds at the time of arguments.

In view of the above narrated facts and grounds, it is, therefore, humbly prayed that the impugned orders dated 26-11-2018 and 03-05-2019 may very graciously be set aside and the appellant may kindly be restored against his original rank of Head Constable alongwith consequential benefits.

Any other relief deemed proper and just in the circumstances of the

case, may also be granted.

This order will dispose off the departmental enquiry initiated against Head Constable Amjid Ali No. 431 (Auto Electrician) now under suspension. An enquiry committee comprising of Foreman/MT and Lines Officer Tele Peshawar was constituted for scrutinizing the conduct with reference to the allegations that he while-posted Incharge Auto-Electrician Telecommunication Unit Peshawar.

The allegations are as under:-

"It has been reported by Incharge MT Store Peshawar that on 23.10.2018 at 1000 hours that Incharge MT Store and Line Officer Tele Peshawar has checked the old/new vehicles (on charge of MT Store) in Police Line Ground Peshawar, during checking the front bonnet of Govt: vehicle Corolla Motor Car No. A-1004 (off-Road) has been replaced, the said report was also registered in Daily Diary (Roznamcha) vide No. 20 dated 23.10.2018"

The Enquiry Committee reached to the conclusion that from the perusal of available record and examination of concerned officials of MT Section as well as the defaulter official statement admitted his guilt. The charges of direct involvement of him have been proved. The enquiry committee therefore, recommended Head Constable Amiid No. 431 for major punishment under Khyber Pakhtunkhwa Police Rules 1975 (Amended 2014) on account of above allegations.

Keeping in view the findings of the Enquiry Committee and material on record. I, Syed Fida Hassan Shah, Deputy Inspector General of Police, Telecommunication, Khyber Pakhtunkhwa is hereby awarded major punishment to Head Constable Amjid Ali No. 431 of "Reduction in the Rank "from Head Constable to the rank of Constable.

It is submitted that proper departmental enquiry has been conducted and all the officials included HC/431 Amjid Ali were served with Show cause Notice and then awarded the punishments. Charge Sheets, Statement of allegations & Final Show Cause Notices were not been issued to them please.

On acceptance this departmental appeal, the impugned orders of DIG/Telecommunication, Khyber Pakhtunkhwa, Peshawar vide his office Endst. No. 14485-94, dated 26.11.2018 whereby the appellant was awarded Major Punishment of Reduction in rank from Head Constable (List D) to Constable may kindly be set-aside with full back wages and benefits of service or any other relief may deemed proper also be allowed.

Brief facts:- That the appellant was enlisted as Auto Electrician in MT Staff Tele-Communication, Police Department, Khyber Pakhtunkhwa, Peshawar since last 21 years. After qualifying basic departmental training, the appellant remained in serving the department to the best satisfaction of his Senior Command. During entire service carrier, no chance of complaint was provided which is evident from his Service Record. But, all of a sudden, the appellant was blemished for replacement of Front Banet of condemned (Off Road) Corolla Motor Car bearing Regn. No. A-1004 being on the charge of MT Store, KP Peshawar for which an Inquiry Committee was constituted to scrutinize the matter. The Inquiry Committee, without examining the appellant has submitted faulty and defective finding report to the Competent Authority. No chance of self-defense was provided upon which without initiating any departmental proceedings which is mandatory under the relevant law / rules, the Competent Authority has awarded Major Punishment of Reduction in Rank from Head Constable (List D) to Constable vide Order Endst. No. 14485,94, dated 26.11.2018 which is illegal and requires to be set aside forthwith..

Respectfully submitted:-

- **a.** That the appellant was posted as Auto Electrician in MT Staff Khyber Pakhtunkhwa Peshawar and serving to the best satisfaction of his Senior Command. No chance of complaint was provided.
- b. That the appellant while posted in MT Store Police Deptt: KP, Peshawar was charged for replacement of front bonnet of condemned (Off Road) Corolla Motor Car No. A-1004 upon which Inquiry Committee was constituted.
- c. That during enquiry, the Inquiry Committee did not provide any chance of self defense to the appellant and submitted faulty and defective finding report against the appellant and violative of relevant law / rules.
- d. That the appellant was neither charge sheeted nor any chance of self defense / personal hearing was provided to the appellant even any witness was also not examined in his presence which is mandatory under the relevant law / rules.
- e. That the Inquiry Committee has submitted a faulty and defective finding report which is against the norms of justice.
- f. That the Authority without fulfillment of codal formalities as required under the rules, announced a impugned order of Major Punishment of Reduction in rank from Head Constable to Constable which is illegal and unjustified.
- g. That the Impugned Order of DIG/Tele: KP Peshawar is against the justice and express Provisions of law thus liable to be set aside inter alia on the following grounds:-

GROUNDS OF APPEAL:-

- > That the appellant was neither charge sheeted nor any witness was examined in his presence which was the result of personal ill will and was based on false statement, the charge was never proved in the enquiry thus the departmental proceedings so conducted were a mere eye wash and nullity in the eyes of law.
- That after receipt of defective finding enquiry report neither charge sheet was issued / served upon the appellant nor any chance of self defense or personal hearing was provided thus proceedings conducted and completed against the appellant are illegal, malafide and not tenable.
- ➤ That all the proceedings conducted against the appellant were violative of law and against the mandatory provision of Khyber Pakhtunkhwa Police Rules 1975 amendment 2014, the orders impugned are thus liable to be set at naught.
- That the departmental proceeding conducted against the appellant did not adhered to the mandatory provisions of Khyber Pakhtunkhwa, Police Rules 1975, but in a novel way.

<u>ORDER</u>

This order is hereby passed to dispose of Revision Petition under Rule 11-A of Khyber Pakhtunkhwa Police Rule-1975 (amended 2014) submitted by Constable Amjid Ali No. 431 (the then HC). The petitioner was awarded penalty of reduction in the rank from Head Constable to the rank of Constable by DIG/Telecommunication, Khyber Pakhtunkhwa, Peshawar vide order Endst: No. 14485-94, dated 26.11.2018 on the allegations that he while posted as Incharge Auto Electrician Telecommunication Unit Peshawar was departmentally proceeded on the following allegations:-

"It has been reported by Incharge MT Store Peshawar that on 23 10.2018 at 1000 hours that Incharge MT Store and Line Officer Tele Peshawar has checked the old/new vehicles (on charge of MT Store) in Police Line Ground Peshawar, during checking the front bonnet of Govt: vehicle Corolla Motor Car No. A-1004 (off-Road) has been replaced, the said report was also registered in Daily Diary (Roznamcha) vide No. 20, dated 23.10.2018".

Meeting of Appellate Board was held on 07,03.2019 wherein petitioner was heard in person. During hearing petitioner denied the allegations leveled against him.

Penalty of reduction in rank from Head Constable to the rank of Constable was imposed on petitioner by DIG/Telecommunication, Khyber Pakhtunkhwa, Peshawar vide order Endst: No. 14485-94, dated 26.11.2018 on the allegations of replacing front bonnet of Govt: vehicle Corolla Motor Car No. A-1004 (off-Road). The other staff of MT Section namely Constable Farman Ullah No. 1104 of MT Section was awarded minor punishment of stoppage of 03 years increments with cumulative effect, Constable Kifayat Ullah No. 725 and Constable Shahid Ahmad No. 566 were awarded minor punishment of stoppage of 01 year increment without cumulative effect while Constable Irfan Ullah No. 323 was awarded minor punishment of censure.

The Board examined the enquiry papers which reveals that allegation levelled against the petitioner are proved and he was found guilty to the charges and the petitioner also admitted his guilt during the enquiry.

Petitioner failed to advance plausible explanation in rebuttal of the charges. Therefore, as recommended by the Board his petition is hereby rejected.

This order is issued with the approval by the Competent Authority.

PRELIMINARY OBJECTIONS:-

- a) The appeal is not based on facts.
- b) The appeal is not maintainable in the present form.
- c) The appeal is bad for miss-joinder and non-joinder of necessary parties.
- d) The appellant is estopped to file the appeal by his own conduct.
- e) The appellant has not come to this Honorable Court with clean hands.
- f) The appellant has got no cause of action to file present Service Appeal.

FACTS

- 1. Correct to the extent that the appellant was enlisted as Constable (Auto-Electrician) on 02.05.1998, in Police Telecommunication Department, however the remaining portion of the Para is subject to proof.
- 2. Correct to the extent of charges and punishment awarded to the appellant. The remaining Para is totally incorrect.
- Incorrect, hence denied. The appellant while posted as incharge Auto-3. Electrician Telecommunication Unit Peshawar has been proceeded against departmentally wherein Incharge MT Store Peshawar reported that on 23.10.2018, at 1000 hours, MT Store and Line Officer Telecommunication, Peshawar have checked the old/ new vehicles (on charge of MT Store) in Police Lines ground Peshawar. During checking, it has been noted/ found that the front bonnet of Govt: vehicle Corolla Motor Car No. A-004 (offroad) has been replaced, the said report was also incorporated in Daily Diary No. 20 dated 23.10.2018. In order to dig out the real facts, proper departmental inquiry has been initiated against the appellant. Charge sheet, statement of allegations was served upon the appellant by giving him ample opportunity of cross-examination but he could not prove his innocence during the course of inquiry. The inquiry committee in their finding reports held guilty the appellant for the above mentioned allegation hence, he was rightly recommended for major punishment.

4. Correct to the extent that the appellant submitted departmental appeal before the Competent Authority however, after examining the departmental appeal of appellant, the same were filed as the petitioner failed to advance plausible explanation in rebuttal of charges leveled against him. (Copy of departmental appeal is annexed as "A").

- 5. This Para is incorrect and misleading one. In-fact, respondent No. 2 forwarded a departmental appeal filed by the appellant to respondent No. 1 vide his Office Letter No. 439/ Tele/OASI dated 08-01-2019, however the plea advanced by the appellant in his appeal was not satisfactory hence the same was filed by Respondent No.1 as per law/rules. (Copy of said Letter is annexed as "B").
- 6. That the instant appeal is meritless and not maintainable on the following grounds.

GROUNDS:-

- A. Incorrect. The appellant has been treated in accordance with Law and Rules. No article of Constitution of Islamic Republic of Pakistan 1973 has been violated by the respondents.
- beyond any shadow of doubt during course of departmental inquiry.

 Furthermore, all the codal formalities have been fulfilled during course of inquiry. The appellant has been proceeded under Khyber Pakhtunkhwa, Police Rules 1975, Amended in 2014.
- c. Incorrect. Inquiry against the appellant has been conducted as per law/
 rules by giving him reasonable opportunity of defence but he failed to
 advance plausible explanation in rebuttal of charges leveled against him.
 Hence, fair trial as enshrined in Article 10-A of the Constitution of Islamic
 Republic of Pakistan was provided to the appellant.
- D. Incorrect. Respondent No. 2 has rightly awarded major penalty to the appellant as per rules/ law. In order to dig out the real facts, inquiry committee has been constituted who after fulfilling all codal formalities, recommended the appellant for major punishment as the allegations leveled against him was proved during course of inquiry. Furthermore, respondent No. 2 was the Competent Authority to award the punishment to the appellant.
- **E.** Incorrect. As explained in above Paras.

- **F.** Incorrect as already explained above.
- **G.** Incorrect. Hence, denied. Respondent No. 2 being Competent Authority, rightly awarded punishment to the appellant.
- H. Incorrect and rebutted.
- I. Incorrect. As explained in above Paras.
- J. Incorrect hence denied. The charges leveled against the appellant were proved beyond any shadow of doubt during course of inquiry.

 Furthermore, no discrimination has been done to the appellant and he was treated in accordance with Law and Rules.
- K. Incorrect. The order passed by respondents is quite legal and no principle of natural justice has been infringed by the respondents.
- L. Incorrect. As explained above at Para No.K of Grounds.
- M. Incorrect. As explained in above Paras.
- N. The respondents may also be allowed to advance additional grounds at the time of hearing.

In view of the above, it is humbly prayed that on acceptance of Para-wise comments, the instant Service Appeal may kindly be dismissed being meritless.

PRELIMINARY OBJECTIONS

a-f. All the preliminary objections raised by the respondents are incorrect, baseless and not in accordance with law and rules rather the respondents are estopped by their own conduct to raise any objection.

ON FACTS

1. Para-1 is incorrect as the respondents were legally bound to have scanned the relevant record and confirmed the real

position of appellant. But they failed to do so and "beat around the bush" hence, para is deemed as admitted by the respondents.

- 2. Para No. 2 is incorrect, misconceived and hence, denied as the appellant was awarded major penalty of reduction from the post of Head Constable to that of Constable without observing legal and codal formalities.
- 3. Para No.3 is incorrect and that of appeal is correct.
- 4. Para-4 is incorrect as the departmental appeal filed by the appellant was based on sound reasons and correct appreciation of law. But despite thereof it was rejected illegally.
- 5. Para-5 is incorrect and detail reply offered in Para-4 above.
- 6. Para-6 is also incorrect as the appellant has a good primafacie case to invoke the jurisdiction of this Hon'ble Tribunal.

ON GROUNDS

- **A.** Para-A is incorrect and that of appeal is correct.
- **B.** Para-B is incorrect, misconceived and hence, denied as the inquiry in question was conducted in utter violation of

law as neither any witness was examined in the presence of appellant nor he was provided any opportunity of cross examination in order to impeach the credibility of the witnesses if any appeared against him. Similarly, he was also not provided any chance to produce his defence in support of his version. The above defect in enquiry proceeding is sufficient to declare entire process as sham and distrustful. Right of fair trial is a fundamental right by dint of which a person is entitled to a fair trial and due process of law. The appellant has been deprived of his indispensable fundamental right of fair trial as enshrined in Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973. Therefore, the impugned orders are not sustainable in the eye of law.

- **C.** Same reply as furnished in Para-B above.
- D. Para-D is incorrect and detail reply offered in Para-B above. Besides, the respondent No. 2 was not declared as Competent Authority in Schedule-I of Khyber Pakhtunkhwa Police Rules, 1975 and as such the impugned order was passed by incompetent Authority which has no sanctity under the law.
- **E.** Para-E is incorrect and that of appeal is correct.
- **F.** Para-F is also incorrect and that of appeal is correct.
- **G.** Para-G is incorrect and that of appeal is correct.
- **H.** Para-H is also incorrect and that of appeal is correct.
- I. Para-I is incorrect as the impugned order was passed in utter violation of FR-29.

- J. Para-J is incorrect and detail reply offered in Para-B above.
- **K.** Para-K is incorrect as the impugned order was passed against the spirit of administration of justice.
- **L.** Same reply as offered in Para-K above.
- M. Para-M is incorrect and that of appeal is correct.
- N. Arguments are restricted to the positions taken in the pleadings.

It is therefore, respectfully prayed that while considering the above rejoinder, the appeal may kindly be accepted with special costs.



R/Sir,

acceptance this departmental appeal, the impugned orders DIG/Telecommunication, Khyber Pakhtunkhwa, Peshawar vide his office Endst. No. 14485-94, dated 26.11.2018 whereby the appellant was awarded Major Punishment of Reduction in rank from Head Constable (Intermediate qualified List "D") to Constable may kindly be set-aside with full back wages and benefits of service or any other relief if deemed proper may also be allowed.

BRIEF FACTS :-That the appellant was enlisted as Auto Electrician in MT Staff Tele-Communication, Police Department, Khyber Pakhtunkhwa, Peshawar since last 21 years. After qualifying basic departmental training, the appellant remained in serving the department to the best satisfaction of his Senior Command. During entire service carrier, no chance of complaint was provided which is evident from his Service Record. But, all of a sudden, the appellant was blemished for replacement of Front Banet of condemned (Off Road) Corolla Motor Car bearing Regn. No. A-1004 being on the charge of MT Store, KP Peshawar for which an Inquiry Committee was constituted to scrutinize the matter. The Inquiry Committee, without examining the appellant has submitted faulty and defective finding report to the Competent Authority. No chance of selfdefense was provided upon which without initiating any departmental proceedings which is mandatory under the relevant law / rules, the Competent Authority has awarded Major Punishment of Reduction in Rank from Head Constable (List D) to Constable vide Order Endst. No. 14485,94, dated 26.11.2018 which is illegal and requires to be set aside forthwith.

Respectfully submitted:-

- a. That the appellant was posted as Auto Electrician in MT Staff Khyber Pakhtunkhwa Peshawar and serving to the best satisfaction of his Senior Command. No chance of complaint was provided.
- b. That the appellant while posted in MT Section Police Deptt: KP, Peshawar was charged for replacement of front bonnet of condemned (Off Road) Corolla Motor Car No. A-1004 upon which Inquiry Committee was constituted.
- c. That during enquiry, the Inquiry Committee did not provide any chance of self defense to the appellant and submitted faulty and defective finding report against the appellant and violative of relevant law / rules.

- d. That the appellant was neither charge sheeted nor any chance of self defense / personal hearing was provided to the appellant even any witness was also not examined in his presence which is mandatory under the relevant law / rules.
- e. That the Inquiry Committee has submitted a faulty and defective finding report which is against the norms of justice.
- That the Authority without fulfillment of codal formalities as required under the rules, announced a impugned order of Major Punishment of Reduction in rank from Head Constable to Constable which is illegal and unjustified.
- g. That the Impugned Order of DIG/Tele: KP Peshawar is against the justice and express Provisions of law thus liable to be set aside inter alia on the following grounds:-

GROUNDS OF APPEAL:-

- > That the appellant was neither charge sheeted nor any witness was examined in his presence which was the result of personal ill will and was based on false statement, the charge was never proved in the enquiry thus the departmental proceedings so conducted were a mere eye wash and nullity in the eyes of law.

 - > That the departmental proceeding conducted against the appellant did not adhered to the mandatory provisions of Khyber Pakhtunkhwa, Police Rules 1975, but in a novel way.
 - > That all the proceedings conducted against the appellant were illegal and unlawful as it run counter to the express provisions of the Khyber Pakhtunkhwa Police Rules 1975.
 - That during departmental proceedings the allegation of his involvement in replacement of front bonnet of condemned/off Road Motor Car bearing Regn. No. A-1004 were not proved and thus the proceedings conducted against the appellant are illegal, malafide and not tenable.
 - > That in impugned order of his reduction from the Rank of Head Constable to Constable, the required period of reduction is not mentioned in the order which is mandatory under the rules thus order passed against the appellant is harsh and violative of law.

- That the impugned order of DIG/Tele: KP, Peshawar is not based on justice, thus the order impugned is liable to be set at naught.
 - > That the appellant seeks the permission of Hon 'able Appellant Authority to rely on additional grounds at the disposal of this appeal.

It is, therefore requested that on acceptance of this departmental appeal the impugned orders of DIG/Tele Communication, Khyber Pakhtunkhwa, Peshawar may kindly be set aside and the appellant may be restored in the rank of Head Constable (Intermediate qualified List "D") with all back benefits as admissible under the rules so as to meet the requirements of justice, please.

acceptance this departmental appeal the DIG/Telecommunication, Khyber Pakhtunkhwa, Peshawar vide his office Endst. No. 14485-94, impugned orders dated 26.11.2018 whereby the appellant was awarded Major Punishment of Reduction in rank from Head Constable (Intermediate qualified List "D") to Constable may kindly be set-aside with full back wages and benefits of service or any other relief if deemed proper may also be allowed.

BRIEF FACTS :-That the appellant was enlisted as Auto Electrician in MT Staff Tele-Communication, Police Department, Khyber Pakhtunkhwa, Peshawar since last 21 years. After qualifying basic departmental training, the appellant remained in serving the department to the best satisfaction of his Senior Command. During entire service carrier, no chance of complaint was provided which is evident from his Service Record. But, all of a sudden, the appellant was blemished for replacement of Front Banet of condemned (Off-Road) Corolla Motor Car bearing Regn. No. A-1004 being on the charge of MT Store, KP Peshawar for which an Inquiry Committee was constituted to scrutinize the matter. The Inquiry Committee, without examining the appellant has submitted faulty and defective finding report to the Competent Authority. No chance of selfdefense was provided upon which without initiating any departmental proceedings which is mandatory under the relevant law / rules, the Competent Authority has awarded Major Punishment of Reduction in Rank from Head Constable (List D) to Constable vide Order Endst. No. 14485,94, dated 26.11.2018 which is illegal and requires to be set aside forthwith.

Respectfully submitted:-

- a. That the appellant was posted as Auto Electrician in MT Staff Khyber Pakhtunkhwa Peshawar and serving to the best satisfaction of his Senior Command. No chance of complaint was provided.
- b. That the appellant while posted in MT Section Police Deptt: KP, Peshawar was charged for replacement of front bonnet of condemned (Off Road) Corolla Motor Car No. A-1004 upon which Inquiry Committee was constituted.

- e. That the Inquiry Committee has submitted a faulty and defective finding report which is against the norms of justice.
- f. That the Authority without fulfillment of codal formalities as required under the rules, announced a impugned order of Major Punishment of Reduction in rank from Head Constable to Constable which is illegal and unjustified.



<u>ORDER:</u>

This order is hereby passed to dispose of Revision Petition under Rule 11-A of Khyber Pakhtunkhwa Police Rule-1975 (amended 2014) submitted by Constable Amiid Ali No. 431 (the then HC). The petitioner was awarded penalty of reduction in the rank from Head Constable to the rank of Constable by DIG/Telecommunication. Khyber Pakhtunkhwa. Peshawar vide order Endst: No. 14485-94, dated 26.11.2018 on the allegations that he while posted as Incharge Auto Electrician Telecommunication Unit Peshawar was departmentally proceeded on the following allegations:-

"It has been reported by Incharge MT Store Peshawar that on 23 10.2018 at 1000 hours that Incharge MT Store and Line Officer Tele Peshawar has checked the old/new vehicles (on charge of MT Store) in Police Line Ground Peshawar, during checking the front bonnet of Govt: vehicle Corolla Motor Car No. A-1004 (off-Road) has theen replaced, the said report was also registered in Daily Diary (Roznamcha) vide No. 20, dated 23.10.2018".

Meeting of Appellate Board was held on 07.03.2019 wherein petitioner was heard in person, During hearing petitioner denied the allegations leveled against him.

Penalty of reduction in rank from Head Constable to the rank of Constable was imposed on petitioner by DIG/Telecommunication, Khyber Pakhtunkhwa, Peshawar vide order Endst: No. 14485-94, dated 26.11.2018 on the allegations of replacing front bonnet of Govt: vehicle Corolla Motor Car No. A-1004 (off-Road). The other staff of MT Section namely Constable Farman Ullah No. 1104 of MT Section was awarded minor punishment of stoppage of 03 years increments with cumulative effect, Constable Kifayat Ullah No. 725 and Constable Shahid Ahmad No. 566 were awarded minor punishment of stoppage of 01 year increment without cumulative effect while Constable Irfan Ullah No. 323 was awarded minor punishment of censure.

The Board examined the enquiry papers which reveals that allegation levelled against the petitioner are proved and he was found guilty to the charges and the petitioner also admitted his guilt during the enquiry.

Petitioner failed to advance plausible explanation in rebuttal of the charges. Therefore, as recommended by the Board his petition is hereby rejected.

This order is issued with the approval by the Competent Authority.
