



- 3) That as the appellant having his date of birth 1958 got retired on 30.06.2018 and was relieved from service and pension paper, fund etc. were prepared for the appellant.
- 4) That during the preparation of pension etc the respondents calculated/ commencement of service the appellant from 16.12.1996 and retirement was determined on the basis of service since 2008.

That the appellant filed departmental appeal before respondent No.2 however the same not finalized.

- 6) That the appellant being aggrieved from the orders of respondent i.e. regularization since 2008 and retirement approaches this Hon'ble Tribunal on the following grounds amongst others:

GROUND:

- a) That the orders of respondents are illegal, against law, against the facts and are liable to be set aside.
- b) That the appellant was appointed on 01.12.1996 and was regularly performing his duties without any break or otherwise, hence cannot be considered since 2008.
- c) That the respondents have not taken into consideration the Regularization Act 2005 and law and rules on the subject.
- d) That it is established law on the subject that if a person is appointed on contract and subsequently regularized then the service of such person be regularized/ considered as regular servant since from the date of the initial appointment and not from the date of regularization.
- e) That the appellant is entitled to the regularization from 16.12.1996 and not from 2008 hence the length of service calculated by respondent is liable to be modified from initial appointment.
- f) That the acts of the respondents is the violation of the law on the subject and against the constitution as the appellant has been discriminated and not dealt in accordance with law.

It is, therefore, most humbly prayed that on acceptance of this appeal, respondents may please be directed to correct the date of appointment and retirement as per law and rules and the services of the appellant may please be regularized since 01.12.1996 from initial appointment, correcting the length of service and be declared retired

from service as per law and rules with all benefits in terms of C.P. fund, gratuity, pension etc.

Any other relief which this hon'ble court deems appropriate in the circumstances of the case and not specifically asked for may kindly also be granted.
