Thereafter, the Departmental Committee in its meeting held on 13.02.2019 promoted ineligible candidates, while the appellant was ignored. Feeling aggrieved, he preferred departmental appeal on 18.02.2019 which remained unanswered, hence the present service appeal. Had ineligible officials not been considered for promotion, the appellant would have got a chance to be promoted as Shop Assistant BPS-7. He was not treated in accordance with law and rules.

Points raised need consideration. The appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 02.09.2019 before S.B.

APPEAL APPEAL U/S 4 OF THE KPK SERVICE TRIBUNAL ACT 1974 AGAINST THE OFFICE ORDER DATED 13-02-2019, TO THE EXTENT OF RESPONDENTS NO 3 TO 5WHEREBY INELIGIBLE CANDIDATES HAVE BEEN PROMOTED AS SHOP ASSISTANT(BPS-07) AND WHICH THE DEPARTMENTAL APPEAL OF THE <u>AGAINST</u> APPELLANT HAS NOT BEEN RESPONDED DESPITE THE LAPSE OF MORE THAN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:-

On acceptance of this appeal the impugned Office Order Filedto-day dated 13-02-2019 to the extent of respondents No 3 to 5 may kindly be set aside and the appellant may kindly be ordered to be promoted as Shop Assistant (BPS-07) with effect from 13-02-2019 with all back benefits.

Respectfully Submitted:-

1. That the appellant is highly qualified, has passed his SSC in the year 1990 and two years Trade Proficiency Certificate in the year 1992 andwas appointed asShop Attendant on 18-07-1994 and since then Re-submitted to day and filed.

- entire satisfaction of his high ups.(Copies of documents are enclosed as Annexure A).
 - 2. That since appointment the appellant has not been promoted while he is perfectly fit and eligible and coming up to the criteria for promotion to the post of Shop Assistant (BPS-07) and vide letter dated 12-06-2018 the appellant along with others was directed to submit verified Bio-data and their credentials were also called for from the institutions concerned for to submit their credentials to verify the same from the concerned recognized boards, which the appellant duly provided and were also verified by respondent No 1.(Copy ofletter dated 12-06-2018 isenclosed as AnnexureB).
 - 3. That there after the appellant was called for to appear before the Departmental Promotion Committee on 05-12-2018 and he accordingly appeared before the DPC on the given date and was also told that he being eligible and coming up to the criteria is going to be promoted, however to the utter shock and surprise, respondents No 3 to 5 along with others were promoted ignoring the appellant vide Office Order dated 13-02-2019.(Copy of Office Order dated 13-02-2019 isenclosed as Annexure C).
 - **4.** That the appellant filed departmental appeal on 18-02-2019 which was duly forwarded however the same has not been responded so far despite the lapse of more than ninety days. (**Copy of departmental appeal &letters are enclosed as AnnexureD**).
 - **5.** That the impugned Office Order dated 13-02-2019 to the extent of respondents No 3 and 4 is against the law, facts and principles of justice on grounds inter-alia as follows:-

GROUNDS:-~

- A. That the impugned Office Order is illegal and void ab initio.
- **B.** That mandatory provisions of law have been violated by the respondents while making the impugned promotion order and more particularly rules governing the subject.

- C. That as per letter dated 12-06-2018; respondents No 3 to 5 were declared as <u>Ineligible</u> for lacking the required Trade Proficiency Certificate but even were promoted for reasons best known to the respondents.
 - **D.** Thatnine colleagues of the appellant were promoted and if ineligible candidates are excluded, then the appellant comes to serial No 7 and as such becomes entitled to be promoted.
 - E. That even respondent No 4 did not appear before the DPC as evident from the attendance sheet and was on duty the same day in the College but even then he has been promoted. (Copy of Attendance Sheet of GCT Bannu is enclosed as Annexure E).
 - **F.** That even respondents No 3 to 5 never availed any sort of leave nor any NOC/Permission for acquiring the relevant professional/technical qualification and were also declared as ineligible thus they are not in possession of such qualification, so have managed fake Certificates for the purpose, thus their promotion order need to be struck down.
 - **G.** That the rules Notified vide Notification dated 22-04-2015, are governing the matter wherein too the Trade Proficiency Certificate from a recognized Institution is pre-requisite, as such too respondents No 3 to 5 are not eligible for promotion. (Copy of Notification dated 22-04-2015 is enclosed as Annexure F).
 - H. That even respondents No 3 and 4 were not directed for appearance before the DPC as per letter dated 01-11-2018 but have been promoted for reasons other than fair and bonafide. (Copy of Letter dated 01-11-2018 is enclosed as Annexure G).
 - I. Thatthe appellant is perfectly fit and eligible and coming up to the criteria set forth in law and rules but malafidely has not been promoted.
 - **J.** That the impugned order is defective and as such not maintainable in the eyes of law.
 - **K.** That the appellant has about 25 years of service with unblemished service record.

Any other relief deemed appropriate in the circumstances of the case and not specifically asked for may also be granted in favor of the appellant.

Nine (09) posts of Shop Assistant BPS-7 are lying vacant at Government Colleges of rehnology/ Government Polytechnic Institutes/ Government Technical Teachers Training Col. ger Government Technical Institutes which are required to be filled by promotion of the Sho. Attandants BPS-03 of the department.

2. As per the existing Service Rules, 2015, the following method of recruitment has been prescribed for filling the post of Shop Assistant BPS-07 (Annex-I).

Eighty percent by initial recruitment and
Twenty percent by promotion, from amongst the Shop Attendants having Secondary School Certificate from a recognized Board with five years service as such and Trade Proficiency Certificate from a recognized Institute:

- There are total 293 sanctioned posts of Shop Assistant BPS-07 in Government Colt ges of Technology/ Government Polytechnic Institutes/ Government Technical Teachers Trailing College/Govt.
